



NARRATIVE

On June 3rd, 2026, at 1805 hours, I was patrolling the 6600 block of 20th Street when my License Plate Reader (LPR) alerted on a Florida tag ISWJ64, attached to an aluminum-colored Toyota Corolla, for a revoked driver's license.

I began following the vehicle and confirmed through D.A.V.I.D. that the vehicle registration was suspended and that the registered owner's driver's license had been suspended since December 18th, 2025. As I followed the vehicle northbound on 66th Avenue and State Road 60, the vehicle slowed down due to a traffic crash scene near the west entrance of the Indian River Mall. This allowed me to confirm that the driver was the registered owner, as I was able to observe her reflection in both the driver's side mirror and the interior rearview mirror.

I then conducted a traffic stop and made contact with the driver and registered owner, Lindsey Marie Sclafani. I informed Sclafani that I had stopped her because the vehicle registration was suspended. Sclafani stated she believed she had taken care of the issue. When asked what she meant, Sclafani advised that she had enrolled in a payment plan and that it was possible she had missed a payment.

I requested her driver's license, registration, and proof of insurance. Sclafani provided her registration and driver's license. I observed that the top right corner of the driver's license had been clipped off. Additionally, the back of the license contained the handwritten notation, "Suspended 12/8/2025."

I informed Sclafani that the clipped corner of the driver's license indicated she had previously been notified that her driving privilege had been suspended. Sclafani responded, "Yeah, I know." To clarify, I asked if she knew she was currently driving with a suspended driver's license, to which she replied, "Yes."

Sclafani was unable to provide proof of insurance and stated that she had been attempting to find an insurance policy she could afford.

I conducted a records check through D.A.V.I.D., which revealed that on December 18th, 2025, at 1122 hours, Sclafani was issued traffic citation AMNYX7E for unknowingly driving while license suspended/revoked. A further query revealed a disposition of guilty on June 14th, 2023, for citation AG04YBE, with the charge description "Driving While License Cancelled, Revoked, or Suspended" in Indian River County.

D.A.V.I.D. also showed that her insurance policy with Direct General Insurance Company had been cancelled and displayed a "No Insurance on File" alert.

Based on the totality of the circumstances, including Sclafani's admission that she knew her driver's license was suspended, her prior conviction for Driving While License Suspended/Revoked, and the records obtained through D.A.V.I.D., I placed Sclafani under arrest and transported her to the Indian River County Jail for the following charge.

1. Driving While License Suspended/Revoked (Knowledge), Second Offense, in violation of F.S.S. 322.34(2) (b).

NARRATIVE

On Wednesday, 06/03/2026, at approximately 1723, I was dispatched to 5300 US Highway One, Vero Beach, Florida 32967, in reference to a reckless driver.

The Indian River County Sheriff's Office Public Safety Dispatch received a 911 call in reference to a White Toyota Tundra driving southbound on US One, the complainant stated the vehicle was swerving between lanes, onto the median, riding between both lanes of traffic and almost crashed into another vehicle on the roadway.

I located a White Toyota Tundra bearing Florida tag HTGQ69 at 4300 US Highway One, going southbound. I got behind the vehicle and observed it cross over the middle line twice, building probable cause for a potential violation of F.S.S 316.089(1) - fail to drive in a single lane. I conducted a traffic stop at 4100 US Highway One.

I made contact with the driver, identified as Christopher Edward Lesage by his Florida's drivers license, and requested his license, registration and proof of insurance. Lesage did not want to make eye contact with me, had difficulty locating his documents and was unable to answer basic questions. While speaking with Lesage I smelled an odor of an adult beverage emitting from his breath. After further conversation with Lesage, I noticed his eyes to appear glossy and watery. I observed a plastic cup in the center consol of the vehicle, the liquid inside of the cup had a dark tint to it. I asked Lesage what he was drinking and he stated that he did not know. Lesage appeared to get more nervous as I asked him questions and started to look around, based on Lesage's behavior I had him exit the vehicle while I continued my investigation. When Lesage stepped out of the car he immediately reached into his waistband, prompting myself and other deputies to detain him in handcuffs. I conducted a pat-down on Lesage to verify that he was not reaching for a weapon, at which time I noticed his pants where wet. I asked Lesage why his pants where wet, to which he stated he had urinated on himself.

Based on my observations I asked Lesage if he would be willing to complete field sobriety exercises so that I could verify he was safe to drive, which Lesage refused. I advised Lesage that if he did not want to complete the exercise, I would have to make a determination based on his driving pattern, behavior, and circumstances involved in the investigation, which could result in his arrest. Lesage continued to refuse to complete the exercises after my warning, at which time I placed him under arrest for a violation of F.S.S 316.193(1)(A) – Driving under the Influence.

While inventorying Lesage's vehicle Deputy Macias and I located 4 empty and 1 half full bottles of Jim Beam Kentucky Straight Bourbon Whiskey 100ML 40% ALC/VOL (80% proof). I took pictures of these utilizing Axon Capture.

NARRATIVE (Continuation)

Lesage was taken to Cleveland Clinic Indian River Hospital for medical clearance due to [REDACTED] [REDACTED]. While at the Hospital, Lesage advised medical staff that he bought the alcohol at noon on 06/03/2026 and had been consuming them up until he was stopped by law enforcement. Medical staff advised me that Lesage stated he was attempting to check into rehab for the second time for alcohol abuse and that he got lost when trying to locate a rehab center in Brevard County. Lesage told medical staff that he has previously driven while intoxicated and believed he was safe to do so because of the consistent regular consumption of alcohol.

After receiving medical clearance at Cleveland Clinic Indian River Hospital, I transported Lesage to the Indian River County Jail. While at the county jail, Lesage refused to submit to a lawful breath test and was provided with implied consent by the breath test operator, which he continued to refuse after being informed of implied consent.

Based on the totality of circumstances, I placed Christopher Edward Lesage under arrest for the following violations:

- F.S.S 316.193(1)(A) – Driving under the Influence.
- F.S.S 316.1939.1 – Refusal to submit to DUI Testing.

Lesage was booked into the Indian River County Jail without further incident.
