NARRATIVE

On April 10, 2025, at approximately 0406 hours, I responded to Cleveland Clinic, located at 1000 36th Street, Vero Beach, Florida, in reference to a trespass.

Upon arrival, I met with Deputy Quint, who advised Viviana Suarez had been trespassed from the property, reference Indian River County Sheriff's Office Case Number: 2025-12333.

During tonight's encounter Viviana was discharged, and began to wonder inside the hospital. Viviana, according to hospital security went inside a bathroom for a long period of time, when she exited, she was informed she had to leave the property, she refused. Hospital Security contacted Deputy Quint, who was working an off-duty detail at the location. Deputy Quint contacted Indian River County Dispatch and confirmed there was a trespass warning on file for the location, reference the aforementioned case number. 



NARRATIVE

On April 10, 2025 I responded to 1235 S Us1 Starbucks in reference to a criminal mischief that just occurred. Indian River County Dispatched advised that a w/m dressed in all black had smashed out a vehicles headlights with a metal object. On arrival I made contact with witness George Moulton and his son. He told me that he witnessed a white male use a metal object to smash the head light out of a vehicle that was parked. After the criminal act the suspect got into a small silver vehicle and fled the scene. The vehicles tag was provided as Florida Tag XH473. The registered owner is Nester Collozo and the identified as the suspect. Contact was made with the victim Bryce Bronson. A short time later the defendant's vehicle was located at 53rd Street and US1 in the Publix parking lot. The vehicle I observed in the same vehicle described by the witness. The item used in the criminal mischief was recovered on scene which was a vehicle anti-theft device. Contact was made with the defendant he stated he didn't wish to speak to me about the incident. He was placed under arrest and transported to the Indian River County Jail.




NARRATIVE

On April 11th, 2025, at 2256 hours, I responded to [REDACTED] in reference to a disturbance.

While en route, I was advised that the complainant was waiting for law enforcement outside in her vehicle, which was described as a blue Toyota Camry. As I was arriving on the scene, I observed a blue Toyota sedan down the road, in front of the house located at the aforementioned address, and two shadows moving around the vehicle. I then turned my headlights on and observed a male subject, later identified as Trevonte Frederick Spicer, walking towards my vehicle from the driver's side of the Toyota Camry.

The following statements are paraphrased. Upon making contact with Spicer, he informed me that he was sleeping in his room when he heard some knocking on his window. His girlfriend, later identified as Reagan Ashley Newman, walked in his room and began to argue with him. The argument escalated to Newman punching him several times in the face. Spicer stated that he grabbed her to keep her from punching him further, and because he has long nails, he caused her to sustain a scratch on her neck and possibly on her hands.

During my interview with Spicer, I did not observe any injuries on his person or his hands. I did confirm he had long nails.

I then made contact with Newman, who informed me that he arrived at Spicer's home to grab her house keys. She knocked on his window to wake him up but was greeted by Spicer's mother, Kaleena Bonita Deluca, who allowed her to enter the house. Newman stated that when she entered Spicer's room, he woke up angry and stated, "You're in trouble now" and "You shouldn't have done that." Newman had her house keys in her hands when Spicer snatched them from her and stated that he was going to go to her house with her. They both continue to verbally argue their way out of the house and onto the front porch, where Spicer grabbed her by her hair aggressively. Newman stated that she became scared and began to walk to the neighbor's house; Spicer then told her, "Nobody's there, bitch." Newman then pulled out her phone and stated that she was going to call the police. Spicer snatched her phone from her hand, preventing her from calling 911. Newman stated that Spicer then grabbed her by her arms and threw her in the car and to the roadway several times while putting his belongings in the vehicle. Newman stated that while she was in the driver's seat, Spicer hit her on the side of her head and face area. Spicer then grabbed his belongings out of the vehicle, and shortly after, law enforcement arrived on the scene.

While I was interviewing Newman, I observed a bloody scratch on the right side of her neck and redness on the left side of her neck. I also observed dry blood on her left hand on the ring finger and a small scratch on her right hand. I also observed white dirt on her legs, which matched the dirt road we were on, and a small scratch on her leg, consistent with Newman's statements.

I then reinterviewed Spicer to get clarification on his side of the events. I advised Spicer of his Miranda rights, to which he stated he understood them and agreed to speak with me. I asked Spicer to clarify where exactly the fight took place. Spicer informed me that they were arguing in a low tone inside of his room to prevent anyone from waking up. Spicer stated that when they were outside of the house, the argument escalated to Newman punching him in the face several times. Spicer admitted that when Newman grabbed her phone, she told him that she was going to call the police. He took the phone from her hands. Spicer stated that [REDACTED]

[REDACTED] Spicer also stated that they're constantly fighting and arguing about their insecurities about each other and that they both drank alcohol today.

Deputy M. Matthews made contact with Spicer's mother, and she informed him that she did not see any physical fight, but she did hear an altercation outside of the house and Newman yelling, "Let me go."

Due to the totality of the circumstances. I placed Trevonte Frederick Spicer under arrest and charged him with the following:

1. Battery (dating violence), consistent with FSS 784.03.1a.
2. Assault, consistent with FSS 784.011.
3. Burglary with assault or battery, consistent with FSS 810.02.2a.
4. Robbery by sudden snatching, consistent with FSS 812.131.2b.
5. Hinder with communication to law enforcement, consistent with FSS 914.22.1e.
