NARRATIVE

On Thursday, July 9, 2026 at approximately 1420 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with the caller, [REDACTED] who stated the following in summary:

[REDACTED] and a male named "Bindo" got into a physical altercation.

[REDACTED] and Bindo have only known each other for 4 weeks. They do not reside together. They have gone on approximately three dates. [REDACTED] is currently 4 weeks pregnant and Bindo is the father. [REDACTED] recently told him this and he has been upset since.

Yesterday, they were driving by Cumberland Farms (27th AVE SW/OSLO RD) having an argument. Paul laid hands on [REDACTED] first and started grabbing [REDACTED] shirt in the car and pushing [REDACTED] started pushing back. They drove to the aforementioned residence and they continued to verbally fight over the [REDACTED] He made some comments about [REDACTED] father and got out of the car. While he was out of the car, [REDACTED] started throwing air fresheners at him but missed. Then, he got back in the car and put his hands around [REDACTED] neck and squeezed until [REDACTED] almost passed out [REDACTED] attempted to defend [REDACTED] and starting pushing, hitting and scratching him back. He let go and [REDACTED] got out of the vehicle. This happened at approximately 1500 hours.

It should be noted [REDACTED] also accused him of trying to run [REDACTED] over but kept changing [REDACTED] story and provided a different timeline.

Today, he came back to [REDACTED] house and [REDACTED] was concerned another altercation would occur so [REDACTED] to report the incident [REDACTED] is currently denying EMS or medical attention.

I observed [REDACTED] neck and did see some bruising on the left side, approximately one finger length/size [REDACTED] has some scabbing on [REDACTED] hands.

Real Time Crime Center assisted in identifying the suspect as Bernado Paul, via his cell-phone and vehicle information. I observed Paul to match "Bindo's" description.

Cpl. Rollando informed me he had Paul in custody, on a traffic stop, with separate charges pending.

I made contact with Paul, who had been read his Miranda rights, who stated the following in summary:

Yesterday, he and [REDACTED] got into a confrontation and that they both got physical, and couldn't stop arguing. This happened over [REDACTED] being pregnant and he did not want to deal with this. The fight was in the car and [REDACTED] kept throwing things at him so he kept shoving [REDACTED] back.

I asked him what the bruising marks on [REDACTED] neck were from, to which he stated from his shoving.

He kept stating that [REDACTED] would throw objects at him in the car and he shoved [REDACTED] neck in self defense for [REDACTED] to get away from him. However, he denied squeezing.

It should be noted Paul is a 6'1" male, weight 180 pounds. [REDACTED]

Paul confirmed he knew [REDACTED] was pregnant and Cpl Rollando told me Paul had multiple positive pregnancy tests in his car.

Based on my investigation, statements by both parties, and physical marks on [REDACTED] neck, probable cause exists to charge Paul with Aggravated Battery on a Pregnant Female.

NARRATIVE

On Thursday, 7/9/2026, at approximately 1427 hours I responded to the area of Oslo and 27th Avenue SW, in reference to a past disturbance.

It was advised that the suspect in the disturbance was driving a black in color Dodge sedan. Prior to my arrival the Indian River County Sheriff's Office Real Time Crime Center (RTCC) was able to obtain identification for a possible suspect as Paul Bernado. 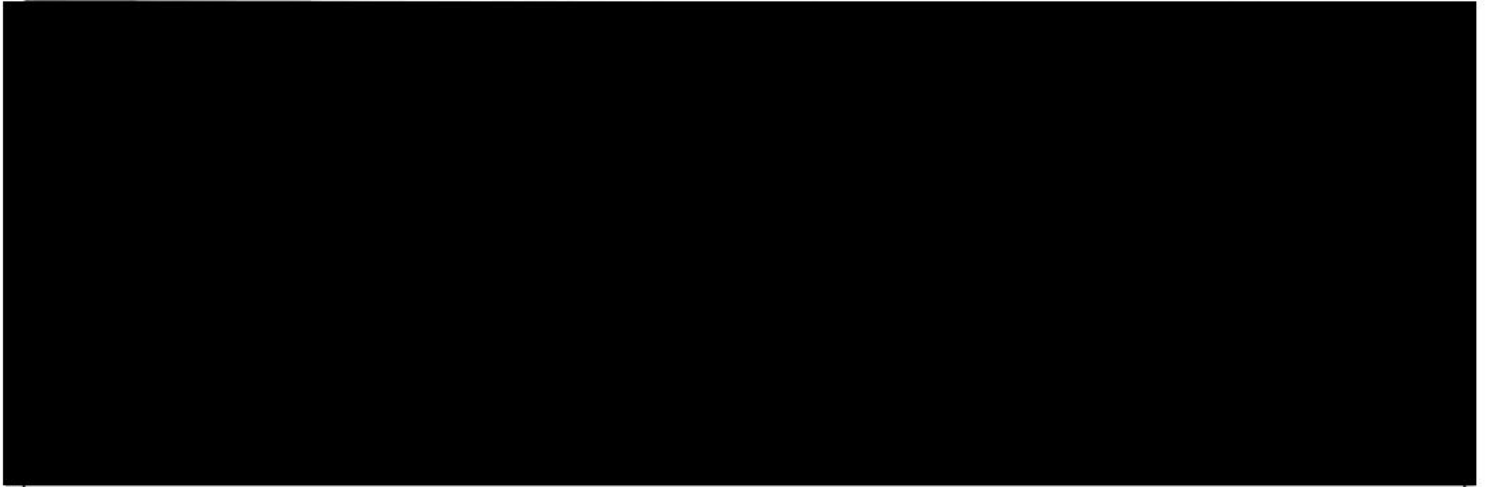

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On _____, at _____ (Specifically include facts constituting cause for arrest.)

On Thursday, July 9, 2026, at approximately 1645 hours, I responded to the area of Pelican Island Place and Schumann Drive in reference to a traffic crash involving a motor vehicle and an electrical utility box.

Upon my arrival, I observed a black Mercedes-Benz bearing Florida registration 84DTCX that had traveled through a chain-link fence and come to rest on top of an electrical utility box. Fire Rescue personnel and para medics were on scene rendering aid to the driver and sole occupant of the vehicle.

As I approached the vehicle, a Fire Rescue employee advised that the driver was actively inhaling from a can of compressed air. Fire Rescue personnel further advised that the driver was refusing to exit the vehicle.

I also observed that the crash scene was located immediately adjacent to an elementary school during afternoon student dismissal. Parents and children participating in the schools after-school program were actively present in the parking lot while emergency personnel were responding to the incident.

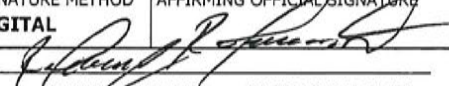
I immediately recognized both the vehicle and the driver as being involved in an earlier incident that I had responded to on this same date. The driver was identified as Hope Griffin. Earlier in the day, Hope had been transported to Orlando Health Sebastian Medical Center after her brother reported that she had been inhaling compressed air and subsequently became unresponsive.

I made contact with Hope and instructed her to exit the vehicle. Hope refused to comply with my lawful commands. Due to her refusal and for the safety of emergency personnel and those present, another officer and I physically escorted Hope from the vehicle and secured her in handcuffs without further incident. Hope was then transported to Orlando Health Sebastian Medical Center for medical clearance.

While on scene, I made contact with witness Laquanta Jackson. Laquanta stated she was parked in the same parking lot when she observed the black Mercedes traveling westbound in the eastbound lane of travel. She advised the vehicle then left the roadway, drove through the school's parking lot, crashed through the chain-link fence surrounding the school's electrical utility box, and came to a final rest on top of the utility box.

During my investigation, I also considered Hope's recent history involving the same dangerous behavior. On July 4, 2026, the Sebastian Police Department received multiple reports of a reckless driver traveling on Sebastian Boulevard. Officers located and conducted a traffic stop on the same black Mercedes-Benz, which was being operated by Hope. During that investigation, officers determined that Hope had been operating the vehicle while inhaling compressed air from an aerosol can.

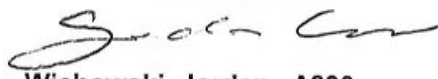

NARRATIVE

On Friday, July 10, 2026, at approximately 0057 hours, I, Deputy M. Neill #6317 conducted a traffic stop near the intersection of Old Dixie Highway SW and 9th Street SW (Oslo Road), Vero Beach, Indian River County, Florida.

Prior to the traffic stop, I was near the intersection of 4th Street and Old Dixie Highway, traveling northbound. As I was approaching the intersection, I observed a blue Dodge Ram start accelerating as they went pass me southbound. At the time, I estimated the vehicles speed to be 50MPH, in a posted 40MPH zone. My in-car radar confirmed the vehicles speed at 52MPH. Additionally, after the vehicle passed me, I did not appear to have any working tag lights illuminating the tag.

After turning around on the vehicle, I started to travel southbound to catch up to the vehicle. As I was doing so, I estimated that the vehicle was now traveling faster than it was originally. I estimated the vehicles speed to be at 55MPH now. My in-car radar confirmed the vehicles speed to be 56MPH in a posted 40MPH zone. Once I caught up to the vehicle, it slowed down and fluctuated speeds.

Once we arrived near 9th Street SW and Old Dixie Highway SW, I conducted the traffic stop.

While speaking to the driver, I observed that he had glassy / watery eyes, a slurred speech, and the odor of an alcoholic beverage emitting from his breath. In the rear of the vehicle, was a Styrofoam cup, that had ice, a straw, and condensation on the outside. The driver was identified as Mr. Casey Meltz by his Florida Drivers License.

I requested Mr. Meltz to exit the vehicle. Once outside of the vehicle, Mr. Meltz confirmed that he was at the Speakeasy Bar and had two beverages that contained Vodka in them. Based on the clues of impairment, I requested Mr. Meltz to submit to Standardized Field Sobriety Exercises (SFSE's). He agreed. They go as follows:

Horizontal Gaze Nystagmus (6/6): Mr. Meltz had a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to a 45-degree angle in both eyes. Mr. Meltz did not have a resting nystagmus. He did have equal tracking and equal pupil size.

Walk and Turn (4/8): Mr. Meltz could not keep his balance while in the instructional stance, did not touch heel to toe on some steps, made an improper turn, and took too many steps.

One leg stand (3/4): Mr. Meltz used his arms for balance, swayed while attempting to balance himself, and put his foot down during the exercises.

Based on the clues of impairment observed, I placed Mr. Meltz under arrest for DUI.

A search of Mr. Meltz vehicle revealed four open and empty twisted tea cans, the original Styrofoam cup that had a purple liquid that appeared to be a mixed drink containing alcohol, and another 7-11 cup that had another mixed drink in it as well.
