Deputy Williams told me that he observed the driver and passenger switch seats as he conducted his traffic stop. He then had everyone inside the vehicle exit just prior to my arrival. Deputy Williams stated the male who had exited the passenger seat was Armando Morales Vasquez, and he was the original driver who was driving.

Vasquez did not have a valid Florida driver's license; he had only a Florida ID card and a Guatemala ID card in his possession.

Vasquez was given the opportunity to make a phone call to notify his family.

**NARRATIVE**

On July 15<sup>th</sup>, 2024, at approximately 0739 hours I observed an orange Chevrolet Camaro bearing Florida tag 32DHAP commit multiple traffic infractions, including failing to properly yield at a stop sign at the 4200 block of 27<sup>th</sup> Ave. and again at the 4200 block of 28<sup>th</sup> Ave. whereafter I conducted a traffic stop on the vehicle.

I approached the driver, later identified by her Florida Driver's License as Victoria Frazier, and asked her to step out of the vehicle while I searched it.

Deputy Deighan would read Victoria her Miranda Warnings to which Victoria advised she would speak with him. Victoria admitted to having paraphernalia (crackpipe) on her person. In addition, Victoria would further advise that while exiting the vehicle, she attempted to conceal the crackpipe from deputies' investigation when she reached behind her person with it in her hand and placed it between her buttocks.

After obtaining consent from Victoria to search her person, Vero Beach Police Department Officer Brumley would locate the crackpipe underneath Victoria's clothing between her buttocks.

Probable cause was found for F.S.S. 918.13(1)(a) when Victoria concealed the crackpipe from Deputies' investigation and F.S.S. 893.147(1)(a) for possessing the crackpipe.

Victoria was placed into my custody and transported to the Indian River County Jail without further incident.

NARRATIVE

On July 15th, 2024, at approximately 1314 hours I responded to 4055 41st Avenue (Indian River County Jail) in reference to a disturbance. Upon arrival, I met with Sergeant D. Hamilton who advised that two inmates who are currently housed in [redacted] were involved in a disturbance. Sergeant Hamilton identified both inmates as Katelyn Johnson (victim) and Sylvia Stansbury (suspect). Sergeant Hamilton further explained that Stansbury threw an unknown chemical fluid into Johnson's face which prompted medical staff to intervene. Sergeant Hamilton accessed the cameras in the dorm which showed the following:

At approximately 1256 hours I observed Stansbury using a mop bucket while doing so in front of [redacted] which Johnson was in. I observed Johnson standing near the grates of her cell door. Stansbury used a cup and scooped the chemicals from the mop bucket. Stansbury is then observed throwing the chemical fluid into Johnson's face. During the entire incident, Johnson was in her cell which was locked/secured. Stansbury was using her 1 hour out of cell time. Both subjects during this incident were housed in confinement.

I met with Johnson who was separated from Stansbury. Johnson was in medical receiving treatment from the medical staff. Johnson stated that she and Stansbury have a history of not getting along. Stansbury and her were involved in a verbal dispute. Johnson stated that during the altercation Stansbury threw a chemical fluid into her face. Johnson advised that it was an unwanted touch and that she wished to pursue criminal charges. I observe Johnson face to be slightly red in color and that her eyes were red/watery.

I met with Stansbury and read her Miranda warnings which she confirmed understanding. Stansbury stated that Johnson had been using harsh language to her, which caused a verbal altercation. During the altercation, Stansbury admitted to using a cup to scoop a chemical fluid from the mop bucket and threw it into Johnson's face.

I found probable cause that Stansbury committed FSS 784.082.3, battery by a detained person.

Stansbury remained at the Indian River County Jail.

NARRATIVE

On July 15th, 2024, at approximately 0138 hours, I responded to [REDACTED] in reference to a burglary.

Upon my arrival, I made contact with the homeowner, an adult male who identified himself as Kenneth Murray. Kenneth advised that he was sleeping when he heard a knocking at his back patio door. When he went to look, he observed a male that he did not know, standing inside of his enclosed patio. He then told the male to leave. He stated that the male told him to "let me in" twice. Kenneth then told the male to leave again. At that point, the male left. Kenneth advised that he had a six (6) foot tall, closed fence surrounding his backyard. Inside of his backyard was an enclosed patio that had closed doors.

Deputies that were boling the area observed a male walking eastbound on Coral Way. Deputies then made contact with a white male who identified himself as Christian Yergens. Post Miranda, Christian stated that he approached the front door and attempted to open it. When he noticed that it was locked, he walked to the fence on the "right side" of the home, opened the closed fence, and went into the backyard. He then opened the screened patio door, entered, and knocked on the back sliding glass door. He stated that he attempted to open the door but that it was locked. He then stated that he observed the homeowner. He admitted to saying "let me in" and also admitted to the homeowner telling him to leave the property.

It should be noted that Christian acknowledged that he did not have any family that lived at that home. He acknowledged that he lived with his brother at a separate address, that his father lived out of state, and his mother was deceased.

Due to the surrounding circumstances, probable cause was established that Christian Yergens was in violation of F.S.S 810.02.3a Burglary Occupied Dwelling Unarmed and F.S.S 856.021 Loitering and Prowling. Christian was subsequently placed under arrest and transported to the Indian River County Jail for booking.

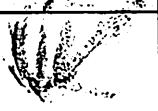

NARRATIVE

On Monday, July 15<sup>th</sup>, 2024, at 0012 hours, I conducted a traffic stop at approximately the 700 block of 27<sup>th</sup> Avenue SW in Vero Beach, FL, on two white subjects riding bicycles. Upon the activation of my emergency lights in my agency issued patrol vehicle, I chirped my siren multiple times. I observed the white male stop his bicycle while the white female who was riding next to the male subject, continued to ride her bicycle southbound. I then used my PA horn and advised the subjects "Both of you." When I observed the female keep riding, I then stated "You too Ma'am." The Woman continued, so I advised the male subject to continue riding his bike up to the female. Finally, I stated "You too, Ma'am." one final time before exiting my patrol vehicle. The male subject came to a stop while the female continued. Upon approaching the male subject, I observed the white female walking her bicycle back towards me.

While attempting to identify the subjects, I questioned the female as to why she was no longer in possession of the bag I observed her to have on her person when I initiated the traffic stop. The female subject stated that the bag was her purse. I then asked the female if there was a reason, she had left her bag and she stated she left it out of "habit". I concluded my traffic stop with the male subject and advised him that he was free to go. I then instructed the female to bring me to the location where she had left the bag, I observed her to be wearing at the time of the stop. The female subject led me to a nearby hedge, where I observed the brown "fannie-pack" styled bag, concealed within the brush. I instructed the female to retrieve the bag after she advised she only had a "little bit of weed" inside the bag.

Once the female retrieved the bag, she started to search through the bag swiftly before I stopped her. I retrieved the bag from her possession and immediately observed an orange straw between her purple wallet. I then found a glass pipe smoking device with an unknown residue inside in a separate pocket. I detained the female subject and placed her in the rear passenger compartment of my agency issued patrol vehicle. After securing her in my vehicle, I continued to search her belongings and located a clear plastic baggie with 4 separate pills inside the bag, located in a zipper pouch on her wallet. I used Drugs.com pill identifier and was able to ID the pills as;

- 1mg tablet of Clonazepam (Schedule IV)
- 2mg tablet of Alprazolam (Schedule IV)
- 50mg tablet of Tramadol (Schedule IV)
- a piece of a separate branded, 2mg tablet of Alprazolam (Schedule IV)

I was able to identify the female via her PN issued driver's license as, Angelica Carbone. I then requested Public Safety Dispatch to conduct a query of the subject via FCIC/NCIC databases. The query results revealed that Carbone had two active warrants out of Indian River County; reference warrant numbers: BW2023735, and RB2023735.

I transported Carbone to the Indian River County Jail without incident. Through my investigation, I found Carbone to be in violation of (3 counts) FSS 893.13, reference possession of a controlled substance; FSS 918.13, reference concealing her brown Nike bag in a nearby bush after being directed to stop at the initiation of the traffic stop; and FSS 893.147(1b), reference her being in possession of glass smoking device that I believe, from my training and experience, to be what's




The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:  
On 07/15/2024 at 17:53 (Specifically Include facts constituting cause for arrest.)

On 7/15/24 at 1753 hours, I was dispatched to 2001 US 1, Sebastian FL for shoplifting in progress.

Prior to my arrival Ofc. Singh #431 and Ofc. Hatton #432 located the female in question, later identified as Danyel Burke, and detained her outside of the general merchandise exit.

Upon my arrival I made contact with loss prevention employee, Dawn Ethier, who stated she had witnessed Danyel make several selections in the automotive section, clearance section, sporting goods, and electronics. Danyel proceeded to the garden center, concealing certain items in her purse and a Walmart shopping bag, such as lipstick and cosmetic items. Danyel exited the store through the garden center, passing all points of sale and making no attempts to purchase the items inside her purse. Danyel located her vehicle and placed several automotive care items which were concealed, inside the passenger side compartment. Danyel then returned back inside where she was then taken into custody. Located inside the Walmart bag and Danyel's purse were phone cases, fishing bait, make-up, and acetone.

I made contact with Danyel who was read her Miranda Rights to which she stated she understood and agreed to speak with me on scene. While speaking with Danyel, she informed me there were more items in her car from her concealing them and placing them inside a container. Danyel admitted to making no attempt to purchase the items located and intentionally exited the store without purchasing the items. Danyel further stated, she has an addition to stealing and has struggled with it for the majority of her life.

Loss prevention employee, Dawn provided a receipt with all of the concealed and unpaid merchandise which were a total of 15 items totaling \$104.18. Walmart wished for prosecution and Danyel was placed under arrest. Danyel was transported to Indian River County Jail where she was then booked.
