




NARRATIVE

On Tuesday, October 7, 2025, at approximately 0332 hours, I, Deputy M. Neill #6317 conducted a traffic stop near 14th Street SW and 26th Court SW, Vero Beach, Florida, 32962. This traffic stop was in reference to a tag light violation. Every time the driver stepped on the break, it would turn the tag light off, making it inoperable at times while the vehicle was driving.

Upon catching up to the vehicle, I activated my blue and red emergency lights as well as my siren to initiate the traffic stop. The vehicle continued to travel northbound from the intersection of 14th Street SW and 26th Court SW, until reaching 13th Place SW. The vehicle then slowed down, turned right, then sped back up to approximately 30 miles per hour. Based on the indicators that the vehicle was not stopping, I deactivated my lights and sirens. The vehicle continued to 26th Avenue SW and pulled in to the residence at 1305 26th Avenue SW. As the vehicle was pulling in to the residence, I reactivated my emergency lights.

I made contact with the driver, who was later identified as Ms. Cheyanne Perry. She advised she did not have her license on her and provided the name "Shayna Cheyanne Rafter (DOB 01/30/2006). I ran this subject in FCIC/NCIC. Using the drivers license photo, I did not believe that the driver was the same photo. I questioned Ms. Perry about it and she originally denied providing a false name. After some time, Ms. Perry confessed that she provided her sisters name and provided her real name.

Upon checking FCIC/NCIC, I observed that Ms. Perry has a suspended Florida license. She has the following suspensions:

According to FCIC/NCIC, Ms. Perry has received notice either by court order, UTC, or prior moving violation.

Ms. Perry was then placed under arrest. Upon searching the vehicle, I located a black purse. Within the black purse was a cut blue straw, which had a powdery substance within it. I field tested the substance which confirmed to be Fentanyl residue.

I advised Ms. Perry of her Miranda Rights. She advised she understood and was willing to speak to me. Ms. Perry advised she continued driving to make it to the above residence, but was not attempting to flee. She confirmed that she provided her sisters name to avoid getting in trouble. She confirmed she uses drugs but the drug paraphernalia found was not hers, but it was her purse I located.

Based on the above statements and actions, I believe there is probable cause to arrest Ms. Cheyenne Catherine Perry for the offense of Flee and Elude Lights and Sirens, pursuant to FSS 316.1935(2), Driving While License Suspended – Habitual Traffic Offender, pursuant to FSS 322.34(5), Provide a False Name to LEO, pursuant to FSS 901.36.1, and Possession of Drug Paraphernalia, pursuant to FSS 893.147.1.

NARRATIVE

On Tuesday, October 7, 2025, at approximately 0535 hours, while on routine patrol in the area of Interstate 95 near mile marker 152, Vero Beach, FL, I observed a vehicle driving recklessly.

As I traveled southbound on I-95 in the far-left lane, I observed in my side mirror a blue Mercedes-Benz bearing Louisiana tag #621HZV cutting in and out of traffic at a high rate of speed, which I visually estimated to be approximately 100 MPH. The Mercedes merged from the left lane all the way to the right, nearly striking other vehicles without signaling. It then crossed back into the middle lane without signaling, cutting off another vehicle and causing it to slam on its brakes. The Mercedes then accelerated rapidly, emitting black smoke from the exhaust as it passed me.

Due to the previously mentioned erratic driving pattern, I attempted to get behind the vehicle. As I accelerated to catch up, I observed my vehicle's speedometer displaying 100 MPH. I verified this speed using my onboard Garmin GPS unit, which confirmed my speed as 100 MPH. As I approached the suspect vehicle to initiate a traffic stop, the driver again accelerated, producing black smoke from the exhaust, and our speeds reached 105 MPH.

I immediately activated my overhead emergency lights and siren to signal the driver to stop. The vehicle yielded, and I made contact with the driver, later identified as Luke Hunter Bassingthwaite. I advised Luke of the reason for the stop and inquired why he was driving 105 MPH. Luke apologized, acknowledged that he was traveling 105 MPH, and stated that he needed to get to the Miami area quickly to go to his bank. Due to his spontaneous utterance, I confirmed that he was aware of and voluntarily admitted to driving at 105 MPH. Luke further explained that he needed to withdraw \$10,000 to help his girlfriend with something.

I requested Luke's driver's license, vehicle registration, and proof of insurance. Luke immediately stated, "I don't have insurance on this vehicle." He explained that he had purchased the vehicle the previous day from someone in Louisiana and had not yet registered or insured it. When I asked if he could provide any form of identification, Luke began searching through the vehicle but was unable to locate his driver's license. He stated that he had it "about an hour ago" when he was stopped by the St. John County Sheriff's Office and issued two citations.

Luke provided one of the citations, which listed a New Hampshire driver's license number (NHL17065898). I ran the number through dispatch, which confirmed that the license was valid. I then verified the information through my CAD system and confirmed Luke's identity using the photograph provided by NCIC.

Due to Luke's reckless and erratic driving, his confirmed speed of 105 MPH (verified by both my speedometer and GPS unit), and his voluntary admission to driving without insurance, I established probable cause to arrest him for the following Florida State Statutes violations:

- F.S.S. 324.221(2) – Failure of owner/operator to maintain required insurance (citation #AM2M4PE)
- F.S.S. 316.1922(1) – Dangerous excessive speeding at 100 MPH or more in a reckless manner (citation

NARRATIVE

On October 7th, 2025, at approximately 2021 hours, I observed a white Audi bearing Florida temporary tag DXP2612 traveling westbound on 45th Street. While behind the vehicle, I observed the vehicle to not have a functioning tag light violating F.S. 316.221(2). I initiated a traffic stop activating my emergency red and blue lights at 38th Avenue and 45th Street.

I made contact with the driver at the driver's door. I observed the driver to have his seatbelt buckled behind his body. I asked the driver for his license, insurance, and registration. The driver identified himself as Antawn Williams. Williams immediately stated that he did not have a valid driver's license due to child support. Williams provided me with a Florida Identification which I used to confirm his identity. As I was speaking with Williams, I could smell the strong odor of marijuana emanating from inside of the vehicle. I also observed a marijuana cigarette in the ash tray of the vehicle along with loose marijuana on the center console area. I knew the green leafy substance to be marijuana based on my training and experience. I asked Williams if he possessed a medical marijuana card, which she stated he did not. I asked Williams if he had just smoked marijuana which he said he just did. I asked Williams if there was any more marijuana in the vehicle. Williams then handed me a cigarillo baggie and said there was more marijuana in there. At this time, I asked Williams to exit his vehicle and asked him to stand at the front of my patrol vehicle.

I started to search the vehicle and located marijuana in the cigarillo bag Williams had in his hands. As I was searching the front seat, Sergeant Hoilett called me to the backseat of the vehicle. Sergeant Hoilett had located a black zippered bag under the front passenger seat. I opened this zippered bag and observed what I believed to be a plastic bag containing Methamphetamine and multiple other clear plastic baggies containing a white powdery substance. I turned my attention to Williams.

As I turned to walk towards Williams who was actively watching me search the vehicle, he immediately took off running on foot. I chased after Williams continuing to give him verbal commands to stop which he refused to do and continued to resist and flee. Williams ran southbound down 38th Avenue and turned down 44th Street. Williams was ultimately located hiding in a wooded area at the end of 44th Street. Williams was transported back to the scene after he was detained.

I read Williams Miranda Warnings which he verbally stated he understood. Post Miranda, I asked Williams why he had fled. Williams stated he had a lot to lose. I asked Williams if he ran because he saw us locate the black bag under the passenger seat. At this time Williams became quiet. I questioned Williams if the bag belonged to him and he replied no.

Upon returning to the vehicle, I continued my search. In the trunk of the vehicle, I located a black trash bag. Inside this trash bag contained two vacuumed sealed bags of marijuana. Each bag of marijuana weighed 483.3 grams and 529.4 grams. I located a sealed United States postal service package in the trunk. Upon opening the package, I located three more vacuum sealed bags of marijuana. Each of these bags weighed 531.4 grams, 529.4 grams, and 533.17 grams. Inside the trunk I further located a Ninja blender with a white powder substance inside of one of the blender cups. This white substance in the blender was field tested and yield positive results for the presence of Cocaine. I also located a vacuum sealing machine with a new unused roll of vacuum sealing bags which were the same as the vacuum seal bags that

contained the marijuana located in the black trash bag.

I continued to search the black zippered bag that Sergeant Hoilett had located. In this bag contained the following:

- 4 Hydrocodone 5mg pills. Three of these pills were individually packaged in a small plastic bags and one being loose
- 19 grams of Methamphetamine in clear plastic bag
- 24.45 grams of Cocaine in a zip clear bag
- 10.59 grams of brown powder substance which field tested positive for Fentanyl in clear sandwich bag
- 16.63 grams of "crack" cocaine in a zippered clear plastic bag
- 3.55 grams Cocaine
- 32 Alprazolam 2mg pills in a clear plastic sandwich bag
- .45 grams MDPV (Methylenedioxypyrovalerone)
- Electronic scale with powder cocaine residue on it
- \$403 Dollars in low demonization bills

Based on my training, experience, and education I recognized the Hydrocodone pills to be package in individual plastic bags was consistent with the sales and delivery of a controlled substance. Due to locating the vacuum sealing machine, the roll of vacuum seal bags, and the marijuana to be vacuumed sealed in the same type of bag, I recognized this to also be consistent with the sales and delivery of a controlled substance based on my training and experience. All of this coupled with the lower denomination of currency and electronic scale located with the narcotics is consistent with street level drug sales. I know the average user amount of marijuana to be only between one and three grams.

Upon a DAVID query of Williams license, I learned that his license was revoked on 3/20/2025. Williams had multiple suspensions on the following dates:

- 8/4/25 For Child support delinquency
- 6/2/25 Fail to pay Traffic Fine Citation #AKFQVOE
- 3/20/2025 Revocation for Habitual Traffic Offender Citation #AH5SJBEThis information along with Williams' admittance to knowing his license was suspended, I find that he was in violation of F.S. 322.35 Driving while license suspended habitual offender.





NARRATIVE

On 10/7/2025, I was patrolling in the area of Indian River Boulevard and 12th Street. FTD Moon, received information from a Flock camera hit, that a Gray Nissan Ultima bearing FL Tag# FNCR74, was headed our direction, and she had prior knowledge that the driver could be operating the vehicle while knowingly having their driver's license suspended.

While sitting in the intersection, we observed the vehicle pass us Southbound on Indian River Boulevard. The vehicle appeared to have illegal dark window tint, which made us unable to identify who was driving the vehicle. I initiated a traffic stop, activating my emergency lights and siren on the vehicle, at the area of 800 Indian River Boulevard. The vehicle continued South on Indian River Boulevard and eventually pulled over in the area of Indian River Boulevard and 4th Circle.

I approached the vehicle and asked the driver for her driver's license. She stated she didn't have her license on her, and identified herself as Jennifer Buffaloe 03/28/1991. FTD Moon came to the driver side of the vehicle, and asked the driver for her name again. She stated Jennifer Buffaloe, and FTD Moon informed her that she knew that was not her legal name. The driver was removed from the vehicle and placed in mechanical wrist restraints. She then identified herself as Jessica Buffaloe 7/13/1988. When asked why she gave the fake name of Jennifer, she stated because her license is suspended. A driver's license inquiry was done on Jessica, and it was discovered her license status has been revoked since 4/22/2015. FTD Moon stated she believed Jessica was also on felony probation. Dispatched confirmed Jessica is on felony probation for possession of a controlled substance. Jessica has probation stipulations that include she must submit to search, and she is not allowed to drive due to her license status.

I transported Jessica to the Indian River County Jail without incident. Once there, Jessica was placed under jail staff supervision and booked for the following charges:




NARRATIVE

On Wednesday, October 8, 2025, at approximately 0107 hours, I, Deputy M. Neill #6317 responded to [REDACTED] in reference to a disturbance.

I made contact with Ms. Brianna Gordon, who provided the following statement: She woke up to her boyfriend, Mr. Robert Braddy, going through her phone. She attempted to get the phone back. Mr. Braddy then held her phone up in the air. While attempting to get her phone, Mr. Braddy would not return it. She then bit him in order to get the phone back. Mr. Braddy pushed Ms. Gordon after being bitten which resulted in Ms. Gordon falling to the floor.

Ms. Gordon had a bloody nose which she obtained from being pushed to the ground.

I was able to call Mr. Braddy from Ms. Gordon's phone. He agreed to meet with law enforcement as he had left the residence already. I responded to the intersection of 13th Ave SW and 12th St SW and made contact with Mr. Braddy.

Mr. Braddy provided the following sworn statement: Mr. Braddy advised he was going through Ms. Gordon's phone, which they mutually agreed prior to that any one can go through the other subject's phone when desired. Upon going through her phone, Ms. Gordon started to act out and started to attack Mr. Braddy. Mr. Gordon got on Mr. Braddy's back, and started to bite him. He then pushed her off and walked out of the residence. He walked away until being contact by law enforcement.

Mr. Braddy had three separate bite marks on his back. He had one on each arm, and one on the center of his back.

Based on above physical injuries and statements, I believe there is probable cause to arrest Ms. Brianna Gordon for the offense of Battery – Domestic Violence, pursuant to FSS 784.03.

I responded back to the residence and placed Ms. Gordon under arrest. She was secured in handcuff restraints.

I advised Ms. Gordon of her Miranda Rights. She advised she understood her rights and was willing to speak to me. Ms. Gordon confirmed again that she got in to an argument with Mr. Braddy due to him going through her phone. She advised this time that Mr. Braddy was holding the phone above his head and pushing her back, away from her, preventing her access to her phone still. She then bit him because he was preventing her access to his phone. She confirmed she bit him once and denied biting him three times. She advised the other injuries Mr. Braddy has are either fabricated injuries or ingrown hairs.

Ms. Gordon was transported to the Indian River County Jail without issue.
