**NARRATIVE**

On April 14<sup>th</sup>, 2026, at approximately 2355 hours, I responded to a sober living residence located in the [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with Dustin McCane at the intersection of 27<sup>th</sup> Avenue and 8<sup>th</sup> Street. McCane stated he had been attacked by his roommate, later identified as Justin Scott.

McCane advised that prior to the physical altercation, he confronted Scott about the odor of an alcoholic beverage emitting from his breath and expressed concern about its impact on other residents' recovery. McCane stated Scott entered the downstairs bathroom fully clothed and began yelling words, which McCane described as sounding like prayer. When McCane opened the bathroom door, he observed Scott wearing only boxer shorts and kneeling on the floor. Scott became agitated and told McCane he would "regret it later" for interrupting him.

McCane stated he continued attempting to calm Scott and encouraged him to brush his teeth and go to bed. Scott then went upstairs, and shortly thereafter McCane followed. While McCane was lying in bed using his phone, Scott confronted him and accused him of recording. McCane showed Scott his phone and denied recording him. McCane stated Scott approached him in an aggressive manner. In response, McCane placed his foot on Scott's waistband to create distance. Scott then grabbed McCane's phone and, in the process, pulled the charging cord, and used it to wrap it around McCane's left ankle.

McCane stated Scott then struck him once in the shoulder with a closed fist and immediately engaged in a physical struggle. The two wrestled, ultimately falling to the ground, where McCane ended up on top of Scott until other roommates intervened and separated them.

While speaking with McCane, I observed visible injuries including scratches on his back, left side of his face, forehead, and around his left ankle, which were consistent with his statement.

I then made contact with Michael Ronald Pastor. Pastor stated he was in his room when he heard Scott yelling from the bathroom in what sounded like prayer. A short time later, he heard yelling coming from upstairs. Pastor stated that when he looked toward the stairwell, he observed Scott in a dominant position over McCane during an active physical altercation. Pastor stated he responded upstairs and physically intervened by grabbing and twisting Scott's hand and twisting it until he released McCane.

I then made contact with Justin Scott and advised him of his Miranda rights, which he stated he understood. Scott stated he was praying in the bathroom when McCane interrupted him. Scott further stated that once upstairs, McCane attacked him by striking him on the top of his head. Scott stated the altercation ended with McCane on top of him. When asked additional questions, Scott declined to provide further information.

Based on the totality of the circumstances, Justin Scott was taken into custody and transported to the Indian River County Jail for Battery, consistent with F.S.S. 784.03(1)(a)1.

While en route to the jail, Scott made spontaneous statements that the incident was "a movie" and that he had been

**NARRATIVE**

On April 15, 2026 at approximately 03:11 hours I observed a blue 4 door Volkswagen sedan (bearing FL tag QPJQ13) traveling Eastbound at the 6100 block of 20<sup>th</sup> Street. I observed the vehicle to have a broken driver's side rear tail light that was emitting bright white light. I activated my emergency lights on my agency issued patrol vehicle and conducted a traffic stop at the 5800 block of 20<sup>th</sup> Street and the final resting stop was approximately the 5300 block of 20<sup>th</sup> Street.

Upon my approach to the vehicle, I observed the vehicle to be solely occupied by a black male driver. I identified myself as law enforcement and explained the reason for the traffic stop. I requested all the necessary documentation which included; valid driver's license, vehicle registration, and proof of vehicle insurance.

The driver was later identified as Montago Shamund Rodgers. Montago was only able to provide vehicle registration at the time of the traffic stop. Montago stated he did not have a valid driver's license and only had a Florida identification card. Montago stated that his drivers license has been suspended. Montago stated he was knowingly driving the vehicle with knowledge that his license was suspended. Indian River County Dispatch channel 1 confirmed that Montago's drivers license was suspended and he had numerous previous suspensions.

Deputy D. Magill arrived on scene to assist. I requested Montago to exit his vehicle. Montago complied and was placed into custody. Montago was transported to my marked agency issued patrol vehicle and placed inside. Montago was read his Miranda Warnings and he advised he understood them. Post Miranda, Montago stated he knew he was not supposed to be driving and stated his license was suspended.

It was later found out via Indian River County Channel 1 dispatch, that Montago also has two active warrants out of Indian River County, reference warrant # BW202510936 -MISD FTA and warrant # SM202510936 – No valid Drivers License.

This entire interaction was captured on my agency issued Axon body worn camera.

NARRATIVE

On Wednesday, 4/15/2026, at approximately 0936 hours I responded to the area of 2540 89th Drive, in reference to an improper exhibition of a weapon.

Prior to my arrival it was advised that the subject, later identified as Cameron Chapman, had threatened a subject with a machete.

Once on scene I made contact with the victim, Jarad Cade, who advised me of the following. He showed up at the residence because he was hired by the homeowner to do fencing work. Once he was in the back yard of the residence the son of the homeowner (Cameron), came out of a camper that was in the backyard, with a machete. Cameron began to yell at Cade and asking if he had a gun. Cade advised Cameron that he did not have a gun and lifted his shirt to show him. Cameron continued to yell at Cade. Cade then walked through the backyard in order to exit to the front of the residence. Once at the front of the residence Cade decided that he was no longer going to do the work but needed to collect his equipment and supplies that were in the front yard up by the fence. Cade went to go collect his belongings when Cameron jumped on top of the fence and began to swing the machete around threatening him with it. While Cade was gathering his things he advised that Cameron swung the machete and he felt that he was going to "stick" him with it.

Cameron was taken into custody and read his Miranda warnings which he advised that he understood. Cameron advised me of the following. He was yelling at no one in particular. While he was yelling a guy came up and asked if he was talking to him. Cameron asked the guy if he had a gun. The other subject then went into the front yard and tried to draw him out of the yard to fight. Cameron advised that he had a machete but he did not swing it at anyone and was just trying to protect himself because there was four guys. Cameron advised that the other subject was threatening him with a Ruger that was in the vehicle and that he was just "trying to not get hit". Cameron advised that he knew the people were there to work. Cameron advised that the subject had called him a "bitch" so that's when he jumped on the fence to see who it was.

I spoke with multiple neighbors who advised that they saw Cameron standing up on the fence swinging something around and yelling at the fence workers, but they were unsure what the item that he was swinging was.

I spoke with the neighbor directly next to Cameron's residence who advised me of the following. He was inside of his residence and heard commotion outside. Once the neighbor, Olimpio Torres, exited he residence he saw Cameron standing on top the fence with a machete yelling at the fence workers. Cameron then turned his attention to Torres and began yelling at him to fight. Torres began to yell back and argue with Cameron.

Torres advised me that he had video footage of the incident on his home security cameras. Torres allowed me into his residence to view the footage. Torres showed me one camera angle which showed where Cameron had jumped up onto the fence with a machete while yelling at the fence workers. While Cade was retrieving supplies up by the fence Cameron continued to yell and swing the machete around.

Based on the above facts I believe Cameron Chapman violated F.S. 784.021(1a) aggravated assault with a deadly weapon without intent to kill.

It should be noted that the mother of Cameron advised me that Cameron is currently out on bond. Cameron's mother also advised that she believed her son to have a mental health issue and pleaded with Deputies on scene to put him in mental health court.




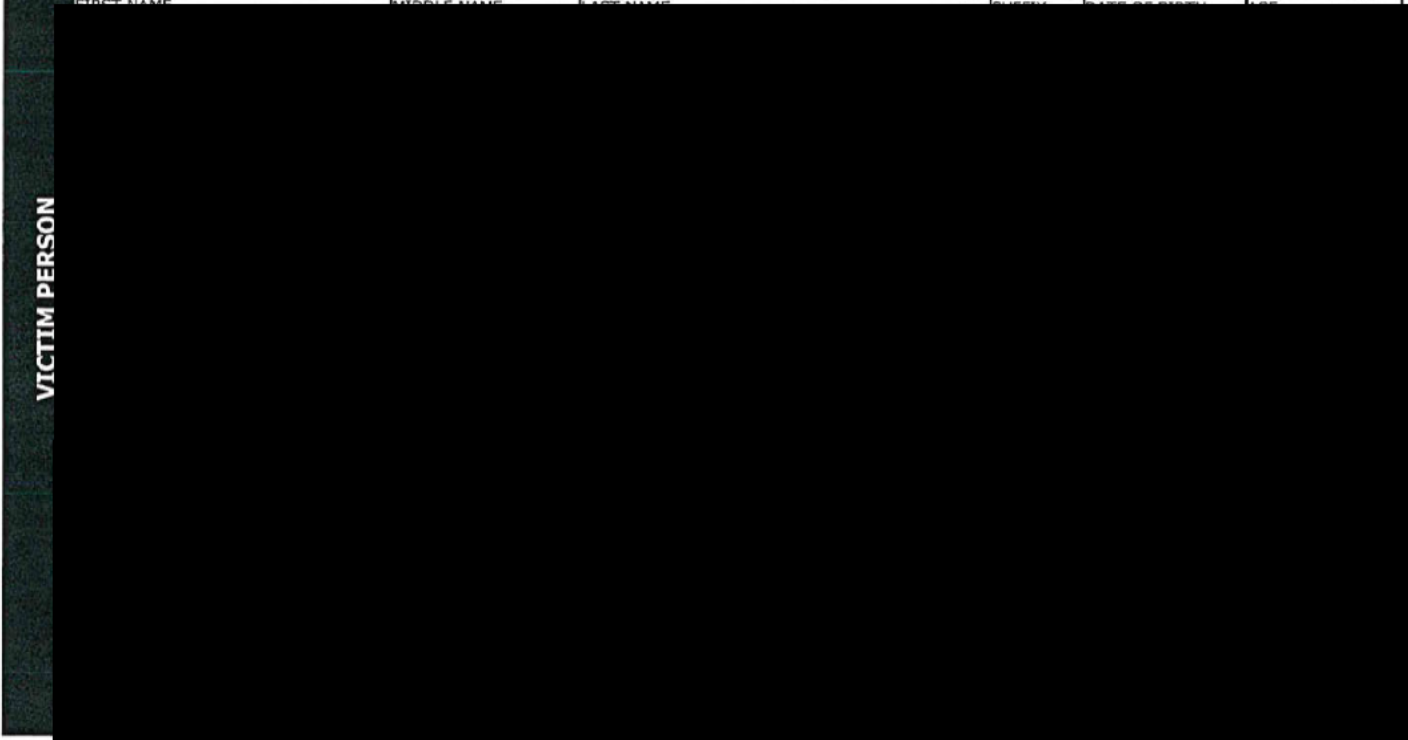

On April 15, 2026, at approximately 2028 hours, I responded to [redacted] in reference to a Disturbance.

Upon arrival, I made contact with the victim, [redacted] who stated that [redacted] refused to pick up [redacted] arrestee, Tamera R. Stuber, and Tamera's boyfriend, John Blay, after they had a date night out. [redacted] stated that Tamera had been drinking, and [redacted] did not want to deal with her in that state. [redacted] stated that [redacted] was also experiencing stomach issues prior to the couple requesting [redacted] to pick them up. [redacted] stated that when Tamera entered the residence, she walked up to her face, yelling and cursing. [redacted] stated that Tamera proceeded to chest bump [redacted] which caused [redacted] to be pushed back. [redacted] stated that Tamera had chest bumped [redacted] a few more times until Blay intervened. [redacted] stated that [redacted] retreated to [redacted] room, locking the door behind [redacted] and [redacted] thought Tamera would eventually go to sleep. [redacted] stated that Tamera did not touch [redacted] with her hands and that [redacted] did not sustain any injuries.

The witness/boyfriend, John, stated that they went out to have a drink, and Tamera proceeded to drink uncontrollably. Blay stated that when [redacted] refused to pick them up from the bar, Tamera became angry with [redacted] and Tamera started speaking negatively about [redacted]. John stated he told Tamera to calm down and that they could ride the bus home. John stated that he told Tamera that [redacted] was older and that she needed to understand that [redacted] was not feeling well. John stated that when Tamera entered the residence, she immediately walked into [redacted] face, yelling and screaming at [redacted]. John stated that he watched Tamera chest-bump [redacted] numerous times before pulling Tamera away from [redacted]. John stated that he also witnessed Tamera put her finger in [redacted] face, eventually touching [redacted] on the head.

The arrestee, Tamera, stated that she was upset with [redacted] for refusing to pick her up from the bar. NARRATIVE

On April 15, 2026, at approximately 2357 hours, I was stationary in the area of 9250 US Highway 1, Sebastian, Florida, when I observed a male traveling northbound on US Highway 1 on a bicycle without any lights, in violation of Florida traffic law.

I conducted a lawful traffic stop on the male in the area of 9250 US Highway 1. Upon making contact, I requested the male's name and identifying information in order to conduct a records check and determine the appropriate enforcement action.

The male initially stated his name was "Antijo" with a last name of "C." As I continued my investigation, the male then stated his name was "Paul Christ." When asked to clarify his identity, the male provided inconsistent and incoherent responses, including stating that he did not have a name. Despite multiple attempts to obtain accurate identifying information, the male failed to provide valid identification or consistent identifying details.

Due to the male's inability and/or refusal to provide accurate identifying information, I was unable to complete a records check or proceed with the traffic stop in a timely manner. Corporal Moon, ID# 6015, responded to the scene with a RapidID device, which was utilized to positively identify the male as Phillip Thomas Desanto (DOB: 11/18/1991).

Based on the male's repeated provision of false and misleading identifying information, which hindered my ability to carry out my lawful duties during the traffic stop, he was placed under arrest for resisting an officer without violence.

Mr. Desanto was placed into handcuffs, which were checked for proper fit and double-locked. He was transported to the Indian River County Jail without incident.

Mr. Desanto was also issued a citation for operating a bicycle without required lighting (Citation #: AMOOCLE).
