


NARRATIVE

On Monday, August 18th, 2025, at approximately 1154 hours, Corporal Munni and I responded to Dillard's, located at 6200 20th Street, Unit 900, in reference to a shoplifting.

Upon arrival, I observed a white female sitting in an office, along with Dillard's manager Dodi Brown-Thompson. Brown-Thompson advised the female, Christina Perry, put two purses inside her purse and proceeded to pass all points of sale without paying, and exit the store. Brown-Thompson stopped Perry at the entrance of the mall and brought her back to the store.

On the table, I observed two purses. A black Michael Kors purse which cost \$198.00, and a brown Dooney & Burke purse that cost \$228.00. The subtotal of the merchandise that was stolen was \$426.00. I read Perry her Miranda Rights which she understood and advised she wanted to answer any questions. When asked about the theft, she advised she knew she shouldn't have done it but she wasn't thinking.

I placed Perry in the back of my agency issued patrol car and upon searching her purse, I observed a small brown Michael Kors wallet with the tag still on. I showed Perry the wallet and she advised she didn't realize it was in her purse. I returned the wallet to Brown-Thompson and was advised the wallet costed \$78.00. The subtotal for all merchandise taken passed all points of sale without paying was \$504.00.

Perry was transported to the IRCISO Jail without incident, and turned over to Booking Deputies where she was charged with MISD 2ND DEG PETIT THEFT.

This was recorded on my agency-issued body worn camera.







NARRATIVE

On Monday, August 18, 2025, at approximately 1552 hours, Indian River County Sheriff's Office [REDACTED] advised via radio there was a green sports motorcycle with green headlights traveling in and out of vehicles. The following is the probable cause [REDACTED] transferred to me:

"On Monday, August 18th, 2025 at approximately 1617 hours, I, [REDACTED] was patrolling the area of 1600 block of South US Highway 1 when I observed a green sports bike with green headlights traveling at a high rate of speed, northbound, in and out of traffic, and traveling on the right shoulder, almost causing a collision with two other vehicles. I estimated the bike to be traveling at 80 miles per hour."

I was in an agency issued marked patrol vehicle with Sergeant Avila. We observed the motorcycle matching the aforementioned description provided by [REDACTED] at the intersection of 4th Street and US-1 (Indian River County). The motorcycle was facing northbound at the intersection. Once the light turned green, the motorcycle passed us at the 400 block of US-1 still northbound. I initiated a traffic stop on the aforementioned vehicle at the 500 block of US -1 activating my lights and sirens. The motorcycle continued to travel northbound on US -1 at approximately 40 mph, once the motorcycle reached 6th Avenue and US-1 it veered to the east and continued to travel northbound on 6th Avenue, failing to stop while my lights and sirens were activated. It should be noted that the motorcycle was the only vehicle on the roadway in front of me. The motorcycle proceeded passed several areas to safely pull over and come to a complete stop.

As the motorcycle approached the intersection of 8th Street and 6th Avenue, the motorcycle proceeded to slow down for a steady red light. Once the vehicle came to a complete stop, Sergeant Avila exited my clearly marked patrol vehicle from the passenger side, grabbed the driver, and escorted him off the motorcycle and on to the ground. It should be noted the driver sustained a small, minor abrasion to his right ankle, however he did not complain of any injuries and denied medical attention on scene. The driver was quickly placed in mechanical hand restraints.

While speaking with the driver, later identified as Ryan Rosewarne, I could smell the odor of an alcoholic beverage emitting from his breath and his person as he spoke. A query of Rosewarne was ran through the Indian River County Sheriff's Office Public Safety Dispatch and I was advised that Rosewarne did not have a valid driver's license. A query of Rosewarne was ran through DAVID which confirmed Rosewarne's license was revoked on September 29th, 2015. Rosewarne has 9 previous convictions for DWLS. Rosewarne was transported to the Indian River County Jail.

Once at the Indian River County Jail, I requested Rosewarne to submit to Standardized Field Sobriety Exercises which he stated he would.

The first exercise I began with was Horizontal Gaze Nystagmus; I explained the exercise to Rosewarne and he verbally stated he understood the exercise. While conducting the exercise, Rosewarne was unable to keep his head still and had to be reminded to keep his head still. I observed Rosewarne to have a lack of smooth pursuit in both

eyes, maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes.

The next exercise I explained and demonstrated was the walk and turn to which Rosewarne stated he understood. Rosewarne was unable to maintain the starting position. While completing the exercise Rosewarne was unable to maintain his balance, he missed heel to toe on several steps, stepped off the line, and conducted an improper turn.

The third exercise I attempted to conduct was the one-leg stand. During this exercise, Rosewarne failed to keep his hands down by his side – using them for balance. Rosewarne's heel maintained contact with the ground for the beginning of the exercise, and he failed to hold his foot 6 inches off the ground.

The final exercise I explained and demonstrated was the finger-to-nose exercise to which Rosewarne stated he understood. Rosewarne failed to complete this exercise correctly, missing the tip of his finger to the tip of his nose on every attempt.

Once I completed the SFSE's, Deputy Rudolph (#5729) requested Rosewarne to provide a lawful breath sample, he refused. Carlsen was read implied consent and he again refused. A query through DAVID revealed that on Rosewarne refused to submit to a lawful test of his breath/urine/blood reference CITATION/CASE # 4763XBR.

It should be noted that Rosewarne was operating a 600CC Kawasaki motorcycle without a required endorsement.

Based on the aforementioned facts, Roswarne is found to be in violation of the following:




NARRATIVE

On Monday, August 18, 2025, at approximately 1543 hours, I responded to the address of [REDACTED] in reference to a disturbance that was in progress. Upon my arrival, I made contact with [REDACTED] Mr. William Earl Rutherford III, who is also identified as the suspect. Mr. Rutherford stated that he and the victim, Ms. Luckyshia McIntosh, had been engaged in a verbal altercation shortly before my arrival, indicating that Ms. McIntosh had initiated the confrontation by coming to the aforementioned address. While speaking with Mr. Rutherford, I observed blood stains on his shirt, but I did not observe any injuries on Mr. Rutherford person he advised nothing physical happened between the two of them.

I subsequently spoke with Ms. McIntosh, who provided the following sworn written statement:

"We was on 27 when he grab my phone out of my hand and thru it on the ground so thats when I walk to his house and broke his window cuz he broke my and trash his room. and then grab me by my throat and slam me on the ground and punch me and my face 2 time. and when he grab me by my throat I couldn breath."

Ms. McIntosh reported that an altercation occurred between her and Mr. Rutherford III at her residence located at [REDACTED]. During the incident, he forcibly took her phone from her hand and subsequently damaged it. Following this event, she proceeded to his residence at [REDACTED] where she caused damage to his property and broke his windows in retaliation for the damage to her phone. He then grabbed her by her neck and choked her until she could not breathe and picked her up to then slam her on the ground, while on the ground he punched her in the faces several times.

On scene, I observed dry blood and cuts on both of her hands, her clothing had blood on them. Her face on the right-hand side just below her eye was swollen and turning purple from Mr. Rutherford III punching her in the face. Ms. McIntosh appearance was dirty and was full of dirt and sand as if she was on the ground.

It should be known that, both parties have been in engaging in physical intimacy and have been in a relationship since June of 2025 [REDACTED]

Based on the statements and evidence given Mr. Rutherford III is in violation of FSS 784.03.1a1 Battery Touch or Strike and FSS 784.041 (2)(b) Felony Battery (Strangulation)



NARRATIVE

On Monday, August 18th, 2025 at 1640 hours, I was traveling Westbound on CR512 when I observed a blue Chevrolet pickup bearing Florida tag# KS802S with heavy, dark non-transparent tint on its front and back windows. I activated my emergency lights and conducted a traffic stop on the vehicle at South Elm Street and County Road 512.

Upon approach of the vehicle, I made contact with the driver and sole occupant, who was later identified as Luis Rojas. Prior to requesting Rojas' drivers license, registration and proof of insurance, I measured the front right and back right rear windows using an agency issued tint meter. The tint resulted in 6%(front) and 1%(back). While interacting with Rojas and waiting for him to provide me with the requested documents, I observed him to show several signs of nervousness such as talking in a fast pace, fumbling through the requested documents and scrambling around the vehicle. I then asked Rojas why he was nervous, he stated because Law Enforcement makes him nervous. I asked Rojas if there would be anything illegal within the vehicle in which he stated no. I then asked Rojas if he would voluntarily provide me with consent to search his vehicle, in which he stated yes. It should be noted that Rojas is the registered owner of the vehicle.

Throughout the search of the vehicle, I located a white clear baggie containing a white powdery substance in between the lower right driver side panel underneath the seatbelt. Through previous training and experience, I identified the white powdery substance as cocaine. I then tested the white powdery substance using an agency issued cobalt field test kit, which positively resulted for the presence of cocaine.

I then placed Rojas in handcuffs and in the back of my marked patrol vehicle. I then advised Rojas of his Miranda warnings, in which he acknowledged and declined to speak with me.

Rojas was then transported to the Indian River County Jail without further incident.

Due to the above mentioned, I criminally charged Rojas with the following charges:

F.S.S 893.13 Possession of a Controlled Substance(Cocaine)

NARRATIVE

On August 18th, 2025, at approximately 1750 hours, I responded to the area of 58th Avenue and 1st Street SW, Vero Beach, Florida, in reference to a crash.

While en route, Indian River County Sheriff's Office dispatch advised multiple callers stated a blue SUV with a male driver struck a wall or guardrail on 58th Avenue SW near 1st Street SW; however, the vehicle continued northbound on 58th Avenue while failing to maintain a single lane.

Corporal R. Matthews, ID# 6226, subsequently advised he located the vehicle near 58th Avenue and 4th Street in the roadway. He stated the vehicle had front end damage and was missing a tire.

Upon arrival, I witnessed a blue Lincoln SUV (bearing FL tag NDY8) stationary on 4th Street just west of 58th Avenue. The vehicle was missing the front passenger tire and there was damage to the passenger side, front quarter panel. Additionally, there was a large gouge in the roadway starting on 58th Avenue south of 4th Street and ending at the Lincoln SUV. I also witnessed a tire in the roadway on 58th Avenue south of 4th Street. There was also damage to the guard rail with blue transfer paint (approximately \$1200 in damages).

I then made contact with Corporal Matthews, who stated he witnessed a blue Lincoln SUV stationary on 4th Street just west of 58th Avenue. While driving in the area, he observed a male, later identified as Mr. Ronnie Walker, walking from the driver's door area of the blue Lincoln. Mr. Walker then stood near the front driver's side quarter panel of the vehicle. Corporal Matthews stated Mr. Walker appeared extremely unsteady on his feet, as well.

After Corporal Matthews completed his crash investigation, I advised Mr. Walker I was conducting a DUI investigation and read him his Miranda Rights. Mr. Walker stated he would speak with us.

While speaking with Mr. Walker, he had thick, slurred speech, he appeared unsteady on his feet, he was swaying, and had body tremors. He also appeared disoriented and kept stating that he had to swerve around another vehicle; however, a witness advised there was no other vehicle that caused him to swerve. Mr. Walker also had the keys to the vehicle and later advised he was operating the vehicle when it crashed. There were also no other people on foot in the area when deputies arrived.

Based on my observations, I requested Mr. Walker complete Standardized Field Sobriety Exercises (SFSE's) and Mr. Walker stated he would complete them. During the medical questionnaire, Mr. Walker advised [REDACTED]

He explained he [REDACTED] Mr. Walker also stated [REDACTED] He further explained that he does not have any other medical conditions.

The first exercise was Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions for the exercise and Mr. Walker stated he understood and did not have any questions. During the exercise, Mr. Walker was swaying and moved his head. Additionally, as I progressed through the exercise, Mr. Walker's eyelids continued to droop until they were almost

completely closed. I requested Mr. Walker open his eyes, to which he stated it was difficult, and he continued to close his eyes. Therefore, I was unable to complete this exercise.

I then attempted to have Mr. Walker complete the Walk and Turn exercise; however, Mr. Walker began stating that due to [REDACTED] he was unable to complete the exercise.

Subsequently, the next exercise was the Fingertip to Nose exercise. I explained the instructions and demonstrated the exercise and Mr. Walker stated he did not have any questions. During the exercise, Mr. Walker had eyelid tremors, and missed touching the tip of his nose multiple times. He also began to use his right finger when I advised him to use his left. During the exercise, Mr. Walker was also swaying.

The final exercise was the Modified Romberg exercise. I explained the instructions and demonstrated the exercise and Mr. Walker stated he did not have any questions. During the exercise, Mr. Walker had eyelid tremors, and was swaying. He estimated 30 seconds elapsed after 11 seconds.

Based on Mr. Walker having had actual physical control of the vehicle and had the ability to operate the vehicle, as well as, my observations, Mr. Walker was placed under arrest for the offense of DUI. He was placed under handcuffs that were checked for proper fit and double-locked. He was then transported to the Indian River County Jail without incident.

After being transported to the Indian River County Jail, booking staff requested Mr. Walker provide breath samples, to which Mr. Walker provided the following samples: 0.102 and 0.108.

Mr. Walker was issued three citations for: DUI (citation #: AM5W7UE), leaving the scene of a crash with property damage (citation #: ADKN41E), and driving while license suspended, without knowledge (citation #: ADKN42E).





NARRATIVE

On August 19th, 2025, at 0113 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with Zaleeyah Ortiz and Angela Marx. Both stated they were out walking their dog when they observed a disturbance between a white male, later identified as Todd Barker, and a white female, later identified as Catherine Willis, at the [REDACTED]. The following statements are paraphrased.

Ortiz and Marx reported observing Barker dragging Willis out of the apartment while Willis was screaming and crying for help. They stated they could clearly see Barker pulling what appeared to be a female by her arms, which were flailing, as she cried, screamed for help, and gasped for air.

I then approached the scene and made contact with Willis, who stated she had been involved in an argument with Barker that escalated when he dragged her out of the apartment, causing a bloody injury to her right knee. Willis advised [REDACTED]

I then made contact with Barker. After advising him of his Miranda rights, which he stated he understood and waived. Barker admitted to becoming upset when he discovered Willis allegedly brought a stranger into the apartment to sleep with her for money. He stated he told Willis to leave and placed her belongings outside. Barker reported that Willis then re-entered the apartment through the kitchen window. The argument continued to the front door where he attempted to block her from re-entering by using his shoulder. Barker denied ever striking Willis or putting his hands on her and further denied any intimate relationship with her.

Barker was placed in handcuffs and escorted to my patrol vehicle. While seated in the rear of my patrol car, Barker was allowed to make a phone call to his family. With his permission, I assisted him in unlocking his phone when I observed that the phone's wallpaper displayed a photo of Willis surrounded by hearts.

I later made contact with [REDACTED] Sean Labrec, who advised [REDACTED]
[REDACTED] Labrec [REDACTED]

It should be noted that I have previously responded to incidents involving these subjects at their former residence near Wawa on 12th Street and U.S. Highway 1, [REDACTED] Deputy Ciofalo also previously made contact with Willis and Barker at this location. At that time, Willis disclosed she was in a relationship with Barker, and Barker implied the same.
