NARRATIVE

On the night of 07/10/24, I responded to a disturbance in progress at [REDACTED]. Upon my arrival I made contact with the victim William Jones who is 76 years old. Mr. Jones stated that he and his wife of thirty years, Regina had been involved in a verbal altercation. He proceeded to tell me the altercation turned physical when Regina pushed him, causing him to fall. He then raised his left arm and showed me a small laceration on the inside of the arm that was bleeding. Mr. Jones told me the laceration occurred when he struck a scooter (medical use for those with leg injuries) as he fell after being pushed by Regina.

I then spoke with Regina. She stated the altercation was due to William being out of town for two weeks and visiting his ex-wife while he was gone. She stated that during the argument, William called her a "fucking bitch." I asked her how William's wrist became injured to which she replied she did not know. She also made the statement nobody is going to call her a fucking bitch.

I asked William to take me in to the residence and show me where he had fallen. We walked in to the residence and approximately five feet in to the residence there was a table. He stopped and turned to face me and stated he was standing in the area of the table and pointed to a scooter that was knocked over. He told me, Regina had exited her bedroom, gotten in his face and pushed him one time causing him to fall and land on the scooter.

Based upon the injury I observed, the statements from both parties, and the evidence I observed. I placed Regina under arrest for Battery on a person over the age of 65 years of age.





On **07/10/2024**, at **03:04** (Specifically include facts constituting cause for arrest.)

On **07/10/2024**, at approximately **0304** hours, I, **Officer Hernandez (#443)**, responded to a call at **1976 43rd Avenue (7-Eleven)**, in reference to an unresponsive male inside of a black truck.

Upon arrival, I noticed a black Chevrolet truck (FL tag # **90DRFV**), parked in front of the above mentioned establishment. I observed the rear tail lights were activated and bright red. Upon approaching the black truck, I noticed a Hispanic male sitting in the front driver side seat, slightly hunched with his head facing down. The male had his eyes closed and appeared to be asleep.

At that time, I walked to the front passenger side door, and established that the black truck was unlocked and the vehicle was turned off. I then, walked back to the front driver side door and made contact with the Hispanic male. I used my hand to nudge him several times, attempting to wake him up. The Hispanic male was later identified as **Felipe Gutierrez Hernandez (DOB: 06/16/1990)**.

During that time, I noticed two glass beer bottles, in the cup holder of the center console. One being a 24 fl oz Corona Extra beer bottle and another being a 12 fl oz Corona Extra beer bottle. The 24 fl oz Corona Extra beer bottle was inside of a brown bag and was cold to the touch (visible condensation around the exterior of the bottle). It should be noted that, I later located an additional two empty 12 fl oz Corona Extra beer bottles, one 24 fl oz Corona Extra beer bottle, and an empty Corona box on the back passenger floorboard.

Moreover, I observed Gutierrez Hernandez right foot, pressing on the brake, which was consistent with the rear tail lights being activated and bright red, prior to making contact with him.

Gutierrez Hernandez eventually awoke and appeared confused, looking around. Upon speaking to Gutierrez Hernandez, I realized that he only spoke Spanish. I then spoke to Gutierrez Hernandez in Spanish, during the entirety of my interaction with him.

While speaking to Gutierrez Hernandez, I noticed a moderate odor of an alcoholic beverage emanating from the vehicle and his mouth as he spoke. I noticed Gutierrez Hernandez's speech was slurred and he had red, glossy eyes. Gutierrez Hernandez appeared to have trouble maintaining his eyes open while speaking, and repeatedly rubbed both eyes with his hands.

I asked Gutierrez Hernandez several times why he was sleeping in the parking lot of 1976 43rd Avenue (7-Eleven) but he had trouble answering the question. He was also unable to tell me where he had been coming from, where he was headed too, nor was he able to provide me with his address.

I then asked Gutierrez Hernandez if he had a drivers license or any form of identification. He stated he did have one, inside his wallet. Gutierrez Hernandez was unable to locate his wallet and eventually stated he did not have any identification nor was he ever issued a drivers license. Gutierrez Hernandez then stated he had a passport but he left it at home. Eventually, I was able to identify him with his name and date of birth.

Gutierrez Hernandez stated he had two Corona beers earlier in the night and had also been consuming the two glass beers in the cup holder of the center console. He then, mentioned that he had just left a house (unknown address) and that he was dropped off at 1976 43rd Avenue by his friend. Gutierrez Hernandez stated that he fell asleep inside the black truck because he was waiting for that friend to return and pick him up. He stated he was aware he did not have a drivers license and was aware he could not operate a motor vehicle without one.

I then asked Gutierrez Hernandez where the black truck keys were, and he stated they were in his pocket. At that time, Gutierrez Hernandez, reached into his left front pocket and revealed the vehicle keys. It should be noted that Gutierrez Hernandez pointed to the "push to start" button, located to the right of the steering wheel, indicating that the black truck starts without the key having to be placed in the ignition. Also, at that time, Corporal Dominguez (#498), was on scene and later advised me that the hood of the black truck was warm to the touch, indicating that the engine of the truck, had recently been on.

Based on all my observations, I had reasonable suspicion to believe that Gutierrez Hernandez was impaired. I then, asked Gutierrez Hernandez to step out of the vehicle and he does so, accordingly. I informed Gutierrez Hernandez that based on my observations, I had a concern that he might be impaired and that I would be conducting Standard Field Sobriety Exercises to determine if he was impaired.

Before starting, I asked Gutierrez Hernandez if he had any injuries, illnesses or disabilities to which he stated he had a left knee injury about 3 years ago. (All questions were asked in Spanish).

I then began the Standard Field Sobriety Exercises. Each exercises were demonstrated and explained to Gutierrez Hernandez, in Spanish, prior to having him perform them and Gutierrez Hernandez stated that he understood them.

PROBABLE CAUSE STATEMENT

It should be noted that the area was well lit and the ground was level and free of debris.

The results of the field sobriety exercises are as follows:

**HGN (Horizontal Gaze Nystagmus)**

- Noticeable side to side sway;
- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes).

**WALK AND TURN**

- Unable to maintain balance and stepped off the line during instruction phase;
- Missed heel-to-toe on step 3, 5, 6, and 7
- Missed heel-to-toe on returning steps 1, 2, and 3;
- Improper turn (turned other than as instructed);
- Used arms for balance

**ONE LEG STAND (Used right leg for exercise)**

- Noticeable sway;
- Right leg up slightly bent at the knee;
- Failed to Raise leg 6 inches;
- Unable to maintain balance
- Used arms for balance
- Placed foot down at "one thousand 7" and stopped exercise prior to instructed (had to be told to continue)
- Placed foot down at "one thousand 9" and stopped exercise prior to instructed

Based on the foregoing, I placed Gutierrez Hernandez under arrest at 0330 hours, for Driving Under the Influence (DUI) and informed him accordingly.

I then, made contact with the store clerk, Pamela Nettles (W/F DOB: 11/16/1990) at 1976 43rd Avenue (7-Eleven). Nettles stated she observed Gutierrez Hernandez arrive (07/10/2024) and enter 1976 43rd Avenue between 0100-0130 hours. Nettles stated that Gutierrez Hernandez purchased two 24fl oz Corona beer bottles and did not see him accompanied by anyone else. Nettles stated that Gutierrez Hernandez paid and exited the establishment. Then, at approximately 0302 hours, she noticed him sleeping inside of the black Chevrolet truck (FL Tag #: 90DRFV). Nettles stated she then called law enforcement.

Gutierrez Hernandez was then, transported to the Indian River County Jail for booking and processing.

Gutierrez Hernandez was placed in the Indian River County Jail Intox Room under video surveillance. After an approximate 20 minute observation period, Gutierrez Hernandez was asked by D/S Rodriguez of the Indian River County Sheriff's Office, who is a certified Breath Test Operator, if he would provide a sample of his breath for the purpose of determining its alcohol content to which Gutierrez Hernandez agreed. At approximately 0418 hours, Gutierrez Hernandez provided the first sample which read 0.177 g/210L and the second sample at approximately 0421 hours which read 0.179 g/210L.

It should be noted that due to the language barrier, I assisted with translating in Spanish, during the entirety of the observation and Breath Test. D/S Rodriguez then read Gutierrez Hernandez his Miranda Warning from a prepared text, to which he stated he understood and stated he did wish to speak to D/S Rodriguez. It should be noted that I assisted in translating and read Gutierrez Hernandez his Miranda Warning in Spanish.

Gutierrez Hernandez told D/S Rodriguez and I, that he went to do laundry (4226 20th Street) at approximately 0000 hours and then went to 7-Eleven (1976 43rd Ave). Gutierrez Hernandez stated he had approximately 3-4 Corona glass beers.

Based on a totality of the foregoing, Gutierrez Hernandez was charged as follows:

I) F.S.S. 316.193(4) DUI in that Gutierrez Hernandez was:

- Driving and/or in actual physical control of a motor vehicle;
- Under the influence of alcoholic beverages;
