NARRATIVE

On Thursday, November 13, 2025, I responded to the area of 1200 Indian River Blvd in reference to a trespassing.

Dispatch stated that the Go line (bus 4) had an occupant on the bus that had been previously trespassed. The subject has been trespassed for punching windows on the bus. The subject was described as a black male wearing a blue and white cap, sunglasses and camo pants.

I made with the bus driver and the occupants of the bus near the 1300 block of Indian River Blvd. The driver identified the male subject, later identified as Robert Sullivan, as a male who she believed had been trespassed from the Go line bus. I made contact with Robert and requested him to identify himself. He responded by saying he was my boss and I can call him Chief. I advised Robert to step off the bus but he refused. Robert began yelling that he is my boss and made random erratic statement's. At this point, I had asked Robert to identify himself several times but he refused.

When an assisting deputy arrived, Robert provided him with his Florida DL. Robert's identity was confirmed and he was ruled out as the subject who had been previously trespassed. Dispatch advised Robert had a warrant out of our county - CT1 FSS 810.09.1(A) Trespass on land 2025-MM000497A, No bond.

Based on my investigation, I placed Robert under arrest for violating FSS. 843.02 Resisting without violence, \$500 bond. Robert was transported to Indian River County Jail without incident.

At the jail, I served him with his warrant - see the pickup commitment form for further.

NARRATIVE

On Thursday, November 13,2025 at approximately 1138 hours, I responded to 1015 Commerce Avenue (The Source) reference to a disturbance. Upon my arrival, contact was made with the caller Linda Cutler (Employee).

Cutler stated a black male sitting at table # 3 in the dining area later identified as Ladravrus Willis was causing issues and was asked to leave several times and would not leave. Cutler stated she did not feel safe approaching Willis and contacted law enforcement.

Willis was located in the dining room sitting at table #3 and explained the reason for our contact with him. Willis was advised he was not welcome at the aforementioned address and was asked to leave several times. Willis kept repeating himself that he was not trespassing and he did not have to leave.

Willis was advised by your affiant to vacate the property several times and he stated he was not going anywhere. Willis requested a supervisor who was already on scene and he became argumentative with him as well. I again advised Willis he had to leave or he would be placed into custody for violating F.S.S. 810.08 Trespass. Willis revised to leave and was placed into custody and transported to the IRC jail.

I find probable cause for violation of F.S.S 810.08 trespass.

NARRATIVE

On Thursday, November 13, 2025 at approximately 1041 hours, I responded to the area of 45th Street/27th Ave, Vero Beach in reference to an auto accident leaving the scene.

Upon my arrival I made contact with the victim Mariah Diaz who was driving a silver Lincoln sedan bearing FL tag CM77JD. Mariah advised she was driving east on 45th Street and while turning onto 27th Ave she was struck from behind by a silver Dodge Neon which pulled over several houses down. Upon stepping out she photographed the vehicle on the side and then the vehicle left the area eastbound on 45th Street. Mariah advised she was having pains in her back and her head from the accident. I read Kimberly Miranda Warnings to which she said she understood and wished to talk. I explained I was investigating a hit and run accident with property damages/injury. Kimberly advised she was driving to the hospital and heard something. Kimberly stated she then pulled over and checked her vehicle out which she could not observe any new damages to the front end of her silver Dodge Neon bearing FL tag 57EKXW. Kimberly then looked back and heard a female screaming her way so she decided to go to the hospital. Kimberly stated that when you are in an accident you are supposed to go to the emergency room to be checked out. Kimberly stated she was seat belted during the accident.

The victim was being scene at the hospital for her injuries. The victim's vehicle had roughly \$1,000.00 in damages.

Kimberly was placed under arrest for leaving the scene of an accident with property damage (citation # AJ5SADE). Kimberly was also cited for fail to display registration, temporary Internet receipt, possession required.

Kimberly was brought to the Cleveland Clinic Indian River Hospital for medical clearance. Kimberly once cleared was transported to the Indian River County Jail Complex without incident.

NARRATIVE

On Thursday, November 13, 2025, at approximately 1439 hours, I observed a white Chevrolet pickup truck bearing Florida tag RFGJ22 traveling southbound in the northbound lane near the 2400 block of S. Old Dixie Highway. The vehicle then abruptly pulled off to the left due to oncoming traffic.

When the driver noticed my marked patrol vehicle, he turned into the driveway of 2409 S. Old Dixie Highway. I made contact with the driver and asked the driver if he was okay. He stated he was "checking his phone." I instructed the driver to pull his vehicle in front of my patrol car; however, he exited the driveway and continued northbound on S. Old Dixie Highway.

I activated my emergency lights and sirens and attempted to conduct a traffic stop. The driver failed to stop and continued northbound. I used my PA system multiple times to instruct the driver to pull over, but he continued to disregard my commands. As the vehicle approached the intersection of Highlands Drive SE and S. Old Dixie Highway, the driver failed to come to a complete stop and continued northbound. The driver then made a left turn into N. 19th Circle SW (Plantation Ridge development). He traveled westbound until pulling into the driveway of 131 S. 19th Circle SW.

The driver exited the vehicle. I issued verbal commands instructing him to remain inside the vehicle, but he refused to comply. I approached the driver, took hold of the collar of his shirt, and redirected him to the ground. While the suspect was on the ground, I straddled his back and ordered him to stop resisting. The suspect continued to disregard my lawful commands and attempted to reach back toward his vehicle, appearing to try to lock the doors. The suspect continued to passively resist. I drew my agency-issued Taser and deployed it, making contact with four prongs. The suspect eventually complied and was taken into custody.

The suspect was identified as Gregory Embler. It should be noted that Embler exhibited a strong odor of an alcoholic beverage on his person.

I attempted to gain access to Embler's vehicle; however, all doors were secured. Through the driver-side window, I observed approximately sixty (60) beer cans scattered on the passenger-side floorboard and seat area.

A field sobriety exercise was not conducted due to Embler injury from the taser. Embler was transported to Cleveland Clinic for evalution and medical clearance at approximately 1600 hours.

I read Embler his Miranda rights and he advised that he was will to speak with me. Post Miranda, Embler advised that he was scared of law enforcement and he wanted to get home. I asked him how much alcohol did he have today and he stated that he had no alcohol today. I asked Embler if he saw my marked agency vehicle behind him with the lights and sirens activated. He stated that he saw my vehicle but did not hear the lights and sirens.

Embler was transported to the county jail for further DUI processing. Booking staff attempted to obtain a breath sample. The first breath sample indicated that Embler did not provide a valid sample. The second breath sample recorded a 0.064 BAC. It should be noted that Embler was arrested at approximately 1450 hours, and the breath

NARRATIVE

On Thursday, November 13, 2025, at approximately 1846 hours, I, Deputy M. Neill #6317 responded to the Home

Depot located at 1885 58th Avenue, Vero Beach, Indian River County, Florida, 32966 in reference to a shop lifting in progress.
The complainant, who was later identified as Mr. Keith Weinberg to report the theft. He advised he was a Home Depot employee and the loss prevention officer for the location. He had a subject who had attempted to steal multiple items and passed all points of sale. Mr. Weinberg attempted to apprehend the suspect but he took flight. Mr. Weinberg provided a description of the suspect to who was able to relay it to responding units. Mr. Weinberg advised the suspect was a white male wearing a white shirt and a hat walking towards the McDonalds.
Sgt. Hoilett was the first deputy to arrive in the area. As Sgt. Hoilett arrived at the last seen point of the suspect, he observed a white male wearing a white shirt holding a Dyson Vacuum that was still in the box. As Sgt. Hoilett got closer, the male dropped the vacuum and started to walk away from him. Sgt. Hoilett informed the subject to stop and to not run, as he was closing the distance in on the subject. The subject then fled on foot prompting a foot pursuit. After a foot pursuit, the suspect was apprehended approximately one quarter mile away. He was then identified as Mr. David Mohan.
I made contact with Mr. Weinberg. He advised he observed the male on camera and started to watch him based on his suspicious behavior. The male would walk around the store picking random items. He also would not check or appear to care about the price of the item and was quickly placing items in the cart. After approximately thirty minutes of walking in the store, the suspect exited out of the garden center. He had multiple items within a new garbage container that was inside of a shopping cart. On the bottom rack of the shopping cart was the dyson vacuum. The male passed all points of sale and continued in to the parking lot. Mr. Weinberg identified himself as an employee of Home Depot and grabbed the shopping cart. The male then grabbed the Dyson Vacuum and flees from the store, heading towards the McDonalds. Mr. Weinberg then was able to recover the items in the garbage bin on scene.
Mr. Weinberg was able to provide video surveillance which supported his above statement. Based on the driver's license photo of Mr. Mohan and the video surveillance, I was able to confirm that Mr. Mohan is the suspect for the theft.

advised that Mr. Mohan walked up to the exit pushing a shopping cart with a garbage bin and a Dyson Vacuum in the cart. She asked to see his receipt. Mr. Mohan advised he did not have a receipt and then continued to the exit,

During this encounter, Mr. Weinberg made the statement to Mr. Mohan "all you had to do was stop and we could have

NARRATIVE

On Thursday, November 13, 2025, at approximately 2039 hours, I was conducting routine patrol traveling eastbound in the 7000 block of State Road 60. NARRATIVE

On November 13, 2025, at approximately 2248 hours, I was sitting stationary on Interstate 95 at approximately Mile Marker 153, facing south, when I observed a black in color Dodge Challenger traveling south without tag lights.

After observing the violation of Florida State Statue 316.221(2), I conducted a traffic stop by activating the emergency lights on my marked patrol car on the aforementioned vehicle bearing Florida tag FNAW76, at approximately Mile Marker 151 south.

I approached the passenger side of the vehicle, and made contact with the driver and sole occupant, Mark Hadden. I requested Mark's driver's license, registration, and proof of insurance. Mark handed me his Florida driver's license, and began looking for the other documents. I asked Mark if the car was registered to him, he confirmed it was. I told Mark I would look up his registration and insurance information.

I returned to my patrol car and conducted an NCIC/ FCIC query of Mark. I discovered that Mark's Florida driver's license had been suspended on June 30, 2025, and there was a seize tag order on the vehicle if the driver was the owner. I also discovered that Mark was a registered sex offender, for crimes against a information from NCIC/ FCIC on the Driver and Vehicle Information Database (DAVID).

I returned to Mark and requested his phone number, at which point he questioned why I was asking for his phone number. I informed Mark that his Florida driver's license was suspended, and I needed the phone number for the paperwork, (tow sheet, and tickets).

I returned to my vehicle and noticed that the phone number Mark provided was not listed as one of his registered phone numbers as a sex offender in NCIC/ FCIC. I contacted Detective York, and asked if he would check the phone number Mark provided in the sexual offender/ predator system, (SOPS). Detective York advised the number provided by Mark was listed.

During my queries of Mark, I noticed a possible failure to register violation for Mark's vehicle, I asked Detective York if he could check the vehicle as well.

While I was talking with Detective York, I observed Mark waving papers out the driver's side window, and I could hear him yelling. Detective York informed me to be careful while dealing with Mark. Detective York informed me he would call me back with the information I requested on the vehicle.

I contacted Deputy Ortega and requested him to respond to my traffic stop.

Deputy Ortega arrived, and I informed him of what was occurring. Deputy Ortega approached the passenger side of the vehicle and began speaking with Mark. During their conversation, I could hear Mark yelling. I exited my vehicle and made contact with Mark and attempted to calm him down. Mark began getting load, at which point I became very direct with Mark and informed him to stop yelling. Mark provided me with his vehicle registration for the 2015 black Dodge Challenger bearing VIN: 2C3CDZAG1FH758214, which showed the vehicle was registered on August 25, 2025. Mark, also provided me with the buyer's order/ bill of sale, which showed Mark purchased the 2015 black Dodge Challenger bearing VIN: 2C3CDZAG1FH758214, on August 25, 2025.

Detective York called and informed me that after viewing SOPS, Mark did not register the 2015 black Dodge Challenger bearing VIN: 2C3CDZAG1FH758214, with the Sheriff's office and the Florida Department of Law Enforcement (FDLE)

until September 18, 2025, which is longer than 48 hours, a violation of his sex offender status and a felony; reference Florida State Statute 943.0435(2)(b)3.

It should be noted, FDLE warned Mark on July 7, 2025 to update his vehicles accurately, due to discrepancies between his active vehicles registered with the Sheriff's Office and FDLE and what the Department of Highway Safety Motor and Vehicles (DHSMV) has reported.

I approached the passenger side of the vehicle and requested Mark exit and walk back to my vehicle, he told me no. I walked to the driver's side and informed Mark he was coming out of the vehicle, at which point he exited and stood next to the interstate. I told him to walk back to my vehicle, so he did not get hit by a car. At the front of my vehicle, I began to place Mark in handcuff restraints, at which point he began to tense up, Deputy Ortega stepped over and secured Mark's left arm. Mark was placed in handcuff restraints and checked for proper fit. I walked Mark to the back of my patrol car, prior to placing him inside, I asked him to spread his feet and lean towards my vehicle, so I could search him. Mark again, began to tense up and began moving his feet. I pushed Mark against my vehicle and told him stop. I searched Mark and placed him inside the rear of my patrol car.

Deputy Ortega contacted the next rotation wrecker to tow Mark's vehicle, prior to the wrecker arriving we conducted an inventory search of the vehicle. I removed three (3) cell phones and a laptop computer from inside the vehicle, and placed them on my front seat. Mark asked what I was doing. I informed him I was not leaving electronic devices inside his vehicle that was being towed. I informed him that they would be place into evidence for safe keeping and he could get them when he gets out of jail.

I removed Mark's Florida tag from his vehicle, per the seize tag order, which was later placed into the records bin.

I departed the interstate for the county jail, while Deputy Ortega waited for the tow truck. A tow sheet was provided to the tow truck driver, one was placed in Mark's property, and one was placed in records.

At the county jail Mark requested all three (3) of his cell phones be placed in his property at the jail.

During booking, I placed Mark's three (3) phones on the counter. While Mark was being booked, and his phones were on the counter, I observed messages from X, Instagram, and Tik Tok pop up on the screen. I queried NCIC/ FCIC and did not see those internet identifiers listed. Due to possible more failure to register crimes, I secured the phones and placed them into evidence.

I cited Mark for his tag lights and driving while license suspended, both tickets were placed into his property.

This investigation was captured on my body worn camera, and the dash camera of my patrol vehicle.

This investigation is cleared by arrest.
