#### **NARRATIVE**

On Thursday, December 4, 2025 at approximately 1210 hours Cpl. A. Munni and I were dispatched to 5555 20th street (Walmart) in reference to a retail theft.

Upon arrival, loss prevention officer (LPO) Jacob Parker advised us that the subject had fled the scene and got onto a GoLine bus #277 heading East bound on 20th street. Officer Jacob showed us camera footage of the suspect, later identified as Ebony Hall walking through the store and taking items off of the shelf and placing them within her cart. Unbeknownst at the time Ms. Hall was also secretly placing small hygiene items into her backpack she was wearing as well.

LPO Parker advised us the suspect was a black female, wearing a pink tank top with spaghetti straps, black pants, and a grey bonnet on her hair, and wearing a black backpack. On footage the LPO showed us one of the items she took which was a black and yellow box containing a car battery charger.

Ms. Hall then walked past all points of sale and proceeded to leave the building with the stolen items.

D/S D. Whittington made contact with the suspect on the bus and identified Ms. Hall by the description we provided him from within the LPO office. He also brough Ms. Hall back to the store in order to create and itemized list of all the items Ms. Hall took in order to determine the price amount stolen. After bringing her back into the LPO office and conducting a search incident to arrest, items were found inside of her backpack which were also stolen from Walmart.

Ms. Hall post Miranda, inside the LPO office admitted to stealing the items from Walmart and stated this was the only time she has been caught. Insinuating that she has shoplifted on multiple occasions not just this one time.

Cpl. A. Munni itemized the items stolen and provided me with a receipt showing the items taken totaled \$294.

Ms. Hall was placed under arrest for shoplifting and transported to the Indian River County Jail without incident.



On 12/4/25 at approximately 1917 hours, 1, Officer W. Brumley, conducted a traffic stop at 27th Ave and Avalon Ave on a silver honda 4 door utility, bearing FL tag# RZZC73, in reference to the vehicle not having any tag lights.

Upon approach of the vehicle, I explained to the driver, later identified as Robbie James (defendant), the reason for the stop. The defendant stated he was coming from his sisters house in Gifford and was taking his front passenger home, who he just met in Gifford, however he did not know where his front passenger lives.

I made contact with the front passenger of the vehicle, later identified as Lisa Stroyek (defendant), who stated she does not live anywhere right now but was trying to get to her daughters house that was in the area.

The defendant declined to a consent search of his vehicle, at 1927 hours, I requested VBPD communication to ask Indian River County Sheriffs Office if they had an avaliable K-9 unit, in reference to an exterior sniff of the vehicle. A 1936 hours IRCSO responded and conducted an exterior sniff of the vehicle, to which Deputy Wolf K-9 alerted on the rear drivers side door. I conducted a search of the vehicle, I observed and located a small white rock like substance from under a cup in the cup holder, just in front of the center console. I also located a clear glass pipe containing white residue under the drivers seat and another clear glass pipe containing white residue under the drivers seat and souther clear glass pipe containing white residue on the floor boar behind the front passengers seat.

A field test of the white rock like substance was conducted and had positive reaction to the presence of cocaine

The defendant stated the white rock like substance and glass pipes where not his. He then stated he gives rides to lots of different people.

The defendant was placed under arrest for violation of FSS. 893.13(6A) Possession Of A Controlled Substance, and 893.147(1) Possession Of Drug Paraphernalia.

The defendant was transported to the Indian River County Jail without incident. When Jail staff was getting the defendant out of the car they noticed white residue on the seat and floor board of the vehicle and gained my attention to it. I observed white residue on the seat and floor board on the right rear passenger side, where the defendant was sitting, and a white rock like substance. The white rock like substance was tested and had a positive reaction the presence of cocaine. Jail staff conducted a search of the defendant and found two dime size baggies containing an unknown white substance, in the defendant left boot.

Due to this discovery, The defendant is also being charged with violation of FSS. 951.22(1H) Introduction Of Drugs Into A Holding Facility.

This event was captured on my BWC and uploaded to Evidence Library. The drugs and drug paraphernalia was submitted into Evidence.

On 12/4/25 at approximately 1917 hours, 1, Officer W. Brumley, conducted a traffic stop at 27th Ave and Avalon Ave on a silver honda 4 door utility, bearing FL tag# RZZC73, in reference to the vehicle not having any tag lights.

Upon approach of the vehicle, I explained to the driver, later identified as Robbie James (defendant), the reason for the stop. The defendant stated he was coming from his sisters house in Gifford and was taking his front passenger home, who he just met in Gifford, however he did not know where his front passenger lives.

I made contact with the front passenger of the vehicle, later identified as Lisa Stroyek (defendant), who stated she does not live anywhere right now but was trying to get to her daughters house that was in the area.

The defendant declined to a consent search of his vehicle, at 1927 hours, I requested VBPD communication to ask Indian River County Sheriffs Office if they had an avaliable K-9 unit, in reference to an exterior sniff of the vehicle. A 1936 hours IRCSO responded and conducted an exterior sniff of the vehicle, to which Deputy Wolf K-9 alerted on the rear drivers side door. I conducted a search of the vehicle, I observed and located a small white rock like substance from under a cup in the cup holder, just in front of the center console. I also located a clear glass pipe containing white residue under the drivers seat and another clear glass pipe containing white residue under the drivers seat and souther clear glass pipe containing white residue on the floor boar behind the front passengers seat.

A field test of the white rock like substance was conducted and had positive reaction to the presence of cocaine

The defendant stated she does not know who the drugs and paraphernalia belongs to but it was not hers.

It should be noted, the white rock like substance in the cup holder and the clear glass pipe with white residue behind her seat, where in the defendants immediate reach.

The defendant was placed under arrest for violation of FSS. 893.13(6A) Possession Of A Controlled Substance, 893.147(1) Possession Of Drug Paraphernalia

It should be noted while at the jail, when jail staff retrieved Robbie from the car she told me he was shaking a 20 dollar bill out and white residue appeared on the seat and floor board.

This event was captured on my BWC and uploaded to Evidence Library. The drugs and paraphernalia was submitted into Evidence.

#### Programme NARRATIVE

On December 5<sup>th</sup>, 2025, at 0126 hours, I responded to the 4200 block of US Highway 1 to assist Deputy Henry with a traffic stop on a black Honda sedan bearing FL/ 52AHFP. Upon my arrival, I made contact with the passenger in the suspect vehicle. While engaging with the subject, I asked him what his name was. The subject identified himself as "Bob Bernus" then refused to provide a date of birth and stated I don't have to tell you shit, I know my rights. Shortly after, Deputy Henry requested that the driver exit the vehicle so he could further his DUI investigation. I then requested the passenger to exit the vehicle, too which he complied. While assisting deputies stood by with the passenger of the vehicle and Deputy Henry continued his DUI investigation with the driver of the vehicle, I began to search the interior of the vehicle based on probable cause due to there being marijuana shake (loose marijuana) all over the interior of the vehicle.

While searching the interior of the vehicle, I opened the center console of the vehicle and located a black Glock pistol. After locating the firearm, I immediately walked back to the passenger and ordered him to place his hands behind his back, advising him he was detained and not free to leave. The subject responded by pulling away from myself and an assisting deputy, attempting to flee. I pulled the subject back by his left arm and was able to successfully detain him without further incident. After securing the subject, I removed his property from his person, which included 2 keys, a lighter, an empty bag of cigars, and a cellphone in a leather wallet case. Within the phone case wallet, was a FL issue driver's license for Johnny Akeem Unique Mccoy, the subject's true identity.

After securing Mccoy in the rear passenger compartment of my agency issued patrol vehicle, I requested Public Safety Dispatch (PSD) to run him through FCIC/NCIC databases as well as a criminal history check. PSD advised that Mccoy had a felony warrant out of Indian River County, reference warrant # WR20241146, and had 6 prior felony convictions in the State of Florida.

Assisting deputies located 3 small plastic bags, weighing approximately 9grams, containing suspected marijuana inside the center console where the firearm was located. I field tested the green leafy substance for the presence of THC with an agency issued field drug test kit; resulting in a positive test result.

Through my investigation, I found Johnny Akeem Unique Mccoy to be in violation of;

- FSS 901.36(1), Giving a false name while detained
- FSS 843.01 (Resisting arrest without violence
- FSS 790.23(1)(a), Possession of a firearm by convicted felon

#### NARRATIVE

On December 5<sup>th</sup>, 2025, at approximately 0229 hours, I was traveling southbound on 41<sup>st</sup> Avenue from 20<sup>th</sup> Street, Vero Beach, Florida, when I witnessed a black pickup truck (bearing FL tag NWSJ64) traveling southbound ahead of me with not tag light. I subsequently conducted a traffic stop on the vehicle in the area of 1600 40<sup>th</sup> Avenue, Vero Beach.

I then made contact with the driver, Mr. Craig Terry, who I identified by his Florida-issued driver's license. As I introduced myself, a female in the front passenger seat (who refused to identify herself) stated they were aware the tag light was broken and they were cited for it recently. A male, later identified as Mr. Nicholas Tinch, and a female, identified as Ms. Amanda Mcfarland, were seated in the backseat. Ms. Mcfarland was clutching a black purse.

While writing my citation, K9 Deputy McKay, ID# 5941, also responded to the traffic stop. Deputy McKay's K9 partner, Tobi, conducted a free-air sniff of the vehicle. Deputy McKay then advised his K9 positively alerted to the presence of narcotics within the vehicle.

During a search of the vehicle, I located Ms. Mcfarland's purse in the backseat. While searching the purse, I located a capped needle and syringe, as well as a light-colored glasses case. Inside the glasses case was an uncapped needle and syringe with blood inside, a small blue metal container, and a blue straw with residue.

Ms. Mcfarland was subsequently placed under arrest for the offense of possession of paraphernalia. She was placed into handcuffs that were checked for proper fit and double-locked. During a search of Ms. Mcfarland's person, I located an orange needle cap inside her jacket pocket.

During a post-Miranda interview, Ms. Mcfarland stated the needles, glasses case, and straw were hers. She also advised that she used fentanyl several hours prior and was upset that she got a bad batch.

Ms. Mcfarland was transported to the Indian River County Jail without incident.
