On 04/13/2024, at 14:08 hours, I was dispatched 1426 43rd Avenue in reference to a report of a bicycle theft. On scene, I first spoke to Michael C. Mckillop (complainant) who stated that someone snuck onto his property and tried to steal a bicycle that belonged to his guest. Mr. Mckillop then advised me of the following:

According to Mr. Mckillop, on 04/12/2024, Mr. Mckillop had a few friends over at his residence. These guests planned to spend the night and one guest left their electric bicycles in Mr. Mckillop's dirt driveway (right next to the back porch of the house). Mr. Mckillop told me that everyone went to bed late in the evening on 04/12/2024.

On 04/13/2024, at approximately 04:00 hours, an unknown male subject came onto the property while everyone was asleep. This individual grabbed the electric bicycle and tried to run away with possession of the bicycle. Mr. Mckillop told me that one of his guests, John E. Schneider, was woken up by the noise of the suspect running on the driveway. Mr. Mckillop stated that Mr. Schneider witnessed the subject steal the bicycle and chased after the suspect to recover the property. Mr. Schneider eventually caught up to the suspect and got a view of the suspect's face. Mr. Schneider recognized the suspect as "Matthew Perron", who both Mr. Schneider and Mr. Mckillop personally know.

Mr. Mckillop then pointed out a private surveillance camera that he had facing towards his property. Mr. Mckillop possessed a Ring motion-detection camera that he advised captured the incident. Mr. Mckillop allowed me to review the footage on his phone and I observed the following:

On 04/13/2024, at approximately 04:41 hours, a suspect wearing a blue hoodie, a hat, and black pants, runs up the driveway towards the curtilage located on the north side of the residence. The motion sensor lights turn on just as the suspect grabs onto an electric bicycle. The suspect then runs away while trying to mount himself onto the bicycle. The suspect quickly exits from the view of the camera, but the video continues for a few more seconds. During the remainder of the footage, I can hear a male in the background, later identified as John Schneider, yelling at the suspect. I can hear Mr. Schneider saying, "Matt" and "What are you doing with the bike Matt" as the suspect is trying to run away from the scene. The twenty-six second video then ends shortly after.

I asked Mr. Mckillop if he could provide me a copy of the footage. The ring application on his phone was unable to download a physical copy, but the app did offer the ability to email myself a link that accesses the footage on the website. The access link for the footage is addressed: https://ring.com/share/6b67ff12-ad3c-4cf9-88a1-c3aac4252a7f

I also video recorded the Ring footage with my agency body camera while my laptop was playing the footage (just as an additional measure to document the footage).

After reviewing the footage, I asked to speak with John Schneider (witness). Mr. Schneider was present at the residence and was very cooperative with this investigation. I collected a statement from Mr. Schneider while my agency body camera was recording. Mr. Schneider told me that on the night of the incident, he was asleep on a chair near the front yard of the residence. Mr. Schneider said he woke up to the sound of the suspect running towards the residence and he was unsure what was happening. Mr. Schneider stood by and witnessed the suspect steal the bicycle. Mr. Schneider told me that he was able to view the face of the suspect as he was fleeing, and Mr. Schneider recognized the suspect as Matthew Perron. Mr. Schneider explained to me that he has known Matthew Perron for a few years. When Mr. Schneider realized that the suspect was Matthew Perron, Mr. Schneider called out to Matthew and asked him what he was doing with the bicycle. Matthew then fled from the property with the stolen bicycle and Mr. Schneider chased after him onto 43rd Avenue. Mr. Schneider noted that the bicycle did not possess a battery pack to power it, and so Matthew eventually tired himself out trying to run against the resistance of the motor. Mr. Schneider caught up to Matthew and recovered the bicycle.

While speaking to Mr. Schneider and Mr. Mckillop, I was able to confirm the suspect's identity as Matthew D. Perron (W/M DOB: 09/20/2004). Both individuals also confirmed to me that Matthew Perron was never invited nor authorized to be on the property.

I then looked at the recovered bicycle, which was in good condition. The bicycle was a Speedrid 26" Fat Tire Electric Bicycle (black/red in color). I noted that the driveway where the bicycle was stored was about thirty yards from the main roadway that accesses the property. I was able to speak to the owner of the bicycle, who identified herself as Lindsey S. Watkins. Ms. Watkins stated that she was asleep when the whole incident occurred, and she did not witness anything. Ms. Watkins advised me that she did wish to prosecute charges for the theft, but Ms. Watkins wanted to invoke her Marsy's right to keep her complaint confidential. Ms. Watkins then provided me with a brief written statemen. Ms. Watkins could not provide an estimated value for her bicycle because the bicycle was gifted to her. I did an online search and was able to find the same bicycle model listed on the manufacturer's website for the value of \$959.99 in US currency.

I later submitted the aforementioned documentation into record at the police department. I also collected all footage and uploaded the footage to this case file on Evidence Library.



Probable cause affidavit:
On 04/13/2024, at approximately 04:41 hours, a suspect wearing a blue hoodie, a hat, and black pants is captured on surveillance cameras trespassing onto the driveway of 1426 43rd Avenue. The suspect continues along the driveway and runs towards the rear porch located on the north side of the residence. The suspect intentionally gains possession of an electric bicycle that was standing upright underneath the curtilage of the residence. The suspect runs away while trying to mount himself onto the bicycle. The suspect exits from the camera view while making his way to the main roadway. John Schneider was in the yard of the residence and witnessed the theft occur. Mr. Schneider proceeded to confront the suspect, causing the suspect to divert his attention and reveal his face to Mr. Schneider. Mr. Schneider was then able to identify the suspect as Mathew D. Perron (W/M DOB: 09/20/2004). Mr. Schneider proceeded to chase after Matthew Perron who left the property with possession of the bicycle. Mr. Schneider was able to recover the stolen bicycle along the 1400 block of 43rd Avenue. It should be noted that at the time that Matthew Perron trespassed onto the curtilage attached to this residence, there were multiple occupants sleeping inside of the dwelling. Matthew Perron then endeavored to take and deprive one of the occupants of their electric bicycle. This bicycle was a black and red Speedrid 26" Fat Tire Electric Bicycle valued at \$959.99 in US currency.
Based on the facts above, I found that probable cause existed for the arrest of Matthew Perron. On 04/17/24 as the on call detective, I was requested by the duty supervisor Sgt Adamski, to respond to the 1886 41nd Ave in reference to a stabbing.

Ofc Kuehn reported the below:

"On 04/16/24 at approximately 2348 hours, I responded to the area of 1886 41st Avenue in reference to a report of a stabbing.

Upon arrival to the parking lot on the west side of the aforementioned location, I observed a white female later identified as, Shanarra K. Sanders (DOB: 08/17/1989) sitting on a couch near a garbage dumpster. I observed, Ms. Sanders to be holding the lower left side of her abdomen and stating she had been stabbed. According to Ms. Sanders, she had been stabbed by an unknown subject who then fled the area on foot in a westerly direction. The only description Ms. Sanders could provide for the subject who stabbed her was a Hispanic male dressed in all black. Ms. Sanders could not provide any further information about the person who stabbed her.

I was unable to collect any further information from Ms. Sanders about this incident due to her injuries. Ms. Sanders was then transported by Indian River County Fire Rescue (Run# 10752) to Lawnwood Regional Medical Center (1700 S 23rd Street Fort Pierce, Fl. 34950) for further treatment.

On scene, I also made contact with a, Justin M. Mazyck (DOB: 10/02/1997) who advised he was in the area at the time of this incident. According to Mr. Mazyck he was walking between buildings from east to west when he heard Ms. Sanders state she had been stabbed. Mr. Mazyck stated upon making contact with Ms. Sanders he did not observe anyone else in the area. Mr. Mazyck informed me that he did not witness what occurred only heard Ms. Sanders say she had been stabbed.

On 04/17/24 at 0029 hours, CSI Gasbarrini #412 and on-call Det. Evans #672 arrived to process the crime scene and take over the investigation.

After giving Det. Evans a brief synopsis of what occurred, I responded to Lawnwood in an attempt to speak with Ms. Sanders and gather more information about this incident. Upon arrival, I made contact with Hospital staff who informed me that Ms. Sanders had already been taken to the Operating Room for surgery and I was unable to speak with her. The only information I could gather was Ms. Sanders had sustained a stab wound to the lower left quadrant of her abdomen.

This incident was turned over to Det. Evans for further investigation.

This incident was captured on body worn camera and later downloaded into a secure file at the Vero Beach Police Department".

Ofc Hogue reported the following:

"On April 16, 2024 at approximately 2350 hours, I responded to the area of 1886 41st Avenue in reference to a stabbing.

Upon my arrival, I established myself as a perimeter unit to assist in locating the suspect.

After the perimeter was broken down, I responded back to the crime scene at the aforementioned address where I established and maintained a crime scene log.

The crime scene log was submitted to records".

Sgt Adamski reported the following:

"On 4/16/24 I responded to 1886 41st Avenue. I requested K-9, perimeter support from IRCSO and EMS. Upon arrival I observed Ofc Kuehn attempting to gather information from the victim sitting on a couch in the parking lot. EMS was providing medical attention. I photographed the scene and victim. Ofc Kuehn briefed me on the incident as EMS began the transport.

At that time I requested CSI and a Detective respond to the scene. I utilized crime scene tape to secure the crime scene. I located a knife in a dumpster that was within the secured crime scene. K-9 Ofc Hatfield advised that his K-9 could not detect a trackable scent. A crime scene log was documented by Ofc Hogue.

After meeting with Detective Evans and CSI Gasbarrini, I canvassed the area for video surveillance. The following were locations video cameras could possibly be of use for the investigation:

Detective Lee Evans follow up investigation:

After receiving relative information from on scene units, I began to examine the crime scene. I noted several blood drops around and near an unregistered vehicle parked at the complex. I noted the vehicle to be a red 4 door Kia (5XXGN4A73DG207067) owned by David Davis. The trail of blood lead towards the apartment complex as well as towards the sofa chair where Shanarra was located. While observing the interior of the vehicle, I noted personal property that would indicate an individual(s) may have been using it as shelter.

While walking the scene near the sofa, I observed a blood stained sweatshirt on the sofa. At the adjacent trash dumpster I noted a smashed cell phone, however it was unknown how long it had been there. As per Sgt Adamski's report, I observed a blue folding knife with the blade extended that appeared to be covered with a fluid.

I noted that Justin Mazyck was still lingering around the area. I spoke with Justin and noted that he appeared to be under the influence of an unknown substance. Justin was unable to provide any statements of any relevance.

In the morning hours, I attempted to interview Shanarra at Lawnwood Regional, however I noted that she was still intubated and under sedation. I responded back to the VBPD and discovered that Det Somoza had obtained the surveillance footage from the outside cameras mounted to the exterior of the complex. This system is maintained by IGC Realty Rental Management. It was noted by Det Somoza that the time stamp was 40 min slower than actual time. The video has no audio. Det Somoza downloaded several outside views to include the Northwest and Southwest street views. Notably, the Northwest view captures that of the dumpster area near the sofa.

I observed the surveillance footage and observed a female who can be identified as Shanarra and a male who can be identified as Justin based on clothing and LEO contact. There was another male who is described as a B/M, 5-10/6-0, medium build with facial hair wearing a sweatshirt "Hoodie", pants, and sneakers seen with the two.

At 1142 hrs, the Northwest surveillance camera captures Shanarra using her cell phone light to look for an item. The unidentified male in the hoodie then viciously attacks Shanarra lunging at her and placing her in an arm bar chokehold forcing her into the corner of the picket fence surrounding the dumpster. It is noted that the camera has a full view of this area. Once the suspect forces Shanarra to the ground he strikes her several times. The suspect takes Shanarra's cell phone and smashes it on the ground where I later recovered it. The suspect then walks away briefly. As Shanarra stands up, he guickly returns and pushes her back in the corner. He has words with her and with his right hand, lunges an object in her abdomen. Shanarra emerges from the dumpster area hunched over, clutching the left side of her abdomen. This incident lasted approximately 2 minutes.

Shanarra then walks around the area towards the apartments and then back towards the couch only after a passerby on a bicycle noticed she was in distress. Before the suspect leaves, he is observed wiping an item off and placing it in the dumpster.

In attempts to identify the suspect I noted all calls for service that involved Shanarra, and another male, possibly her boyfriend. I noted that on 07/27/23 Shanarra and a B/M ,Trayvious Hullett, were interviewed together. I noted that while viewing the body cam footage from a call for service on 03/25/24, Shanarra was interviewed and points to her boyfriend who was sitting nearby. The image of the male sitting matched that of Trayvious.

I returned to and spoke with David Davis in and asked if he recalled any further about the incident in the night. David stated that he knew Shanarra and David knew that she had a boyfriend and only knew him as Tray or Trayvious. David stated the two frequented the area and thought at one point they were staying in David described Tray as a tall B/M, "dark skinned" with short dreds. I asked permission to look inside his red KIA which he agreed to. I noted a small white and colorful hand bag that I observed Justin retrieve from the dumpster just before the attack on Shanarra. Inside the bag was a toothbrush and toothpaste along with a small empty plastic container. In the front pouch of the bag were 3 cigars.

I spoke with the resident in apt #1, William Simon and asked about the male who he was speaking with before his wife arrived an hour before the attack. William who has a thick (Island) accent stated that he spoke with the male about doing things, "Drugs". William stated that he did not know the male but knew he was with the tall white girl and sees them together often. Det Somoza showed him an image from the surveillance footage depicting the suspect and was asked if he was the male he spoke with and the one who is with the white girl to which he stated, "Yes".

Det Somoza made contact with Justin and asked if he would speak with us further about the incident last night which he agreed to. Det Somoza and I spoke with Justin at his apartment. I asked Justin about the night and if he was keeping company with Shanarra and Trayvious. Justin stated that he was drinking and took a zanax that night. I asked what they
