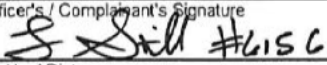

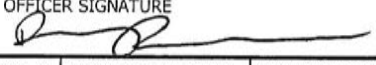
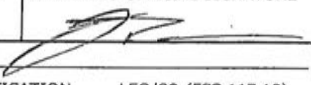

NARRATIVE

On Thursday, September 10th, 2026, at approximately 0921 hours, Corporal T. Kramer and I responded to 5235 41st Avenue, Vero Beach, Florida, 32967, in reference to a call for service to review school bus video footage of a disturbance that occurred on August 24th, 2026.

Upon my arrival I made contact with Child Protective Investigator Terrance Ware who stated the following in substance. He received an abuse report on August 28th, that on August 24th, 2026 Tracy Alpy a school bus driver with the School District of Indian River County had allegedly pushed and bent back the finger of [REDACTED] while being transported to after school care on bus #2602. Investigator Ware had already interviewed all parties involved prior to, and received conflicting statements. Investigator Ware made contact with the school district transportation office to view the video footage from the bus on that day and was instructed that they would pull the footage and let him know when it became available. Investigator Ware called us to be present in viewing the video footage incase of any criminal activity occurring.

I then made contact with the school district's Operations Manager Tony Sears, who played a portion of the recording from the bus that was captured August 24th, 2026 from 1544 hours to 1631 hours. The time on the actual footage was an hour behind so displayed 1444 hours to 1531 hours.

Upon reviewing the footage, I observed the bus stationary and waiting in the parking lot of Liberty Magnet School for an extended period of time, this was due to the bus waiting for another bus to exchange children and bring them to Gifford Youth Aquatic Center, and the Boys and Girls Club. [REDACTED] can be seen sitting in the front seat positioned behind the driver's seat. Alpy can be seen walking through the bus aisles and interacting with the children on the bus. [REDACTED] can be seen numerous times getting out of his seat to which Alpy would direct him to sit back in his seat. Throughout the recording I observed this interaction numerous times. [REDACTED] can also be seen sticking up his middle finger towards Alpy whenever her back was turned away from him.

Approximately 15 minutes into the recording Alpy then sat on the edge of [REDACTED] seat to keep [REDACTED] from getting up. At the 1526-hour mark of the recording other children are seen entering the bus from the other bus, once the children were seated Alpy returned back to the driver seat and can be seen driving. While Alpy was driving [REDACTED] is seen moving in [REDACTED] seat, standing up and facing backwards interacting with the other children on the bus. Alpy can be heard repeatedly telling [REDACTED] to sit in [REDACTED] seat which [REDACTED] did not. Alpy then pulls over, gets out of her seat, and approaches [REDACTED] she grabbed [REDACTED] by [REDACTED] and forcefully placed [REDACTED] in the seat and put [REDACTED] seatbelt on [REDACTED] is seen with [REDACTED] arm extended and middle finger sticking up towards Alpy. Alpy then grabs [REDACTED] hand and forces [REDACTED] hand into [REDACTED] lap and can be heard saying "do you want me to break this finger." Alpy then let's go of [REDACTED] and returns to the

Renee became uncooperative (not listening to commands) and began backing up towards the suspected area of the firearm which the caller stated Renee discarded the firearm. Officers shouted loud commands and deployed a series of less lethal pepper ball in front of Renee which was not successful due to her continue moving and not complying with commands. Therefore, a second series of pepper ball was deployed which Renee was struck with some of the pepper balls. This series was effective and Renee began to comply when officers moved in to handcuff Renee. Renee was taken into custody and placed in the rear of Cpl. Sanchez patrol vehicle.

A protective sweep of the residence was conducted which resulted in no other people present inside the home. A Smith and Wesson 38 S&W revolver was located on the right side of the house near the carport near a bundle of twigs. This is the location where the neighbor Lakendria stated she saw Renee throw the firearm after discharging it. Lakendria described the firearm as a black in color handgun which matched the description of the firearm recovered on scene. The firearm was taken on scene and entered into Sebastian Police Evidence. It should be noted the firearm was loaded with one of the bullets discharged, which would be consistent with the statements. Renee appeared to be highly intoxicated, admitted to heavily drinking today, and had a strong odor of alcohol emitting from her.

The complainant, Lakendria completed a sworn written statement on scene which will be submitted with this report. Photographs were taken on scene which will be submitted with this report.

Renee was transported to Orlando Health where while being treated, struck [REDACTED] with her foot by kicking [REDACTED]. It should be noted Renee was irate, combative, and screaming throughout the incident. [REDACTED] told Renee do not kick me or you will be charged. This incident at the hospital was captured on [REDACTED] body worn camera. See [REDACTED] supplement report for further information. While at the hospital, Renee stated she wished officers shot her with real bullets instead of less lethal.

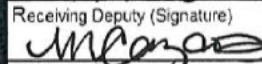
Renee stated she was upset about the Indian River Animal Control taking her dog from her earlier today. I should be noted I was also present for this incident as an agency assist. This was also captured on body worn camera. Renee locked her two dogs in her vehicle overnight which was not running and no windows down. Post Miranda, Renee stated she did not wish to speak about the incident without a lawyer.

Renee was transported to the Indian River County Jail without incident where she was charged with Battery on LEO (FSS. 784.07), Resist w/ violence (FSS. 843.01), resist w/o violence (FSS. 843.02), Disorderly intoxication (FSS. 856.011), possession or discharge of firearm while intoxicated (FSS. 790.151), discharge firearm negligently on residential property (FSS. 790.15).

This incident is cleared by arrest.

NARRATIVE

On September 4, 2026, at approximately 1948 hours, Corporal Chamberlin and I were dispatched to 5555 20th Street, Vero Beach, Fla, 32966, in reference to a shoplifting.

I arrived on scene and made contact with Ellis. Ellis informed me the suspect who was later identified as Kelsey Covington scanned one item when she had multiple in the cart, attempted to pay part with EBT, then bypassed all points of sale without paying the remaining balance.

I proceeded inside the Walmart Loss Prevention office and made contact with Sara Ingo another Walmart Asset Protection Officer. Sara provided video footage of the incident which depicted Kelsey scanning less items than she had in her possession. The list of items is as follows:

- Scanned five MRUCHIN BLOCK instead of the six total
- Scanned one makeup pack and placed the second in a bag
- Scanned two Starbucks Cold Brew containers instead of three total
- Scanned one nail file instead of the two total
- Failed to scan a bottle of body wash
- Scanned three drink cans instead of five total
- Scanned two lotion containers instead of four total
- Scanned one clothing item instead of the two total

Kelsey then attempted to pay with her EBT card. Kelsey of the \$66.84 EBT transaction only \$34.41 went through. Kelsey had to pay a remaining balance of \$135.75. Kelsey attempted to utilize Tap to pay via her CashApp card, however, it did not work as tap to pay is not enabled at this Walmart location. Due to this the transaction was canceled and her EBT card was refunded.

Kelsey then proceeded past all points of sale before she was stopped by loss prevention.

I read Kelsey her Constitutional Rights in the form of a Miranda Warning. Kelsey waived her right to a lawyer and still wished to speak with me. Kelsey informed me she suffers from a Traumatic Brain Injury

Kelsey stated that she made a mistake and thought she heard the tap go through. Kelsey informed me she has used Self-Checkout machines in the past and does obtain receipts when she purchases items.

I screened Kelsey to see if she was eligible for a Notice to Appear. Kelsey informed me she did not show up to a court case before and has previously been arrested for a Felony.

Kelsey was transported to the Indian River County Jail and turned over to booking staff.

The booking staff provided me a copy of Kelsey's NCIC/FCIC criminal history. Kelsey has been arrested and prosecuted before for Grand theft and petit theft in the State of Florida. Those cases are listed below:

Based on the totality of the circumstances Kelsey did and knowingly violate Florida State Statute 812.014 as Kelsey knowingly and intentionally failed to scan items and failed to pay the remaining balance for the scanned items prior to passing all points of sale. Furthermore, Kelsey has been convicted of two prior thefts enhancing the charge to a felony.
