On Wednesday, 06/17/2026, at approximately 2228, I was dispatched to 4100 US Highway One, Vero Beach, Florida 32968, in reference to a reckless driver.

The complainant (Identified to Dispatch as Vincent) advised Dispatch that a navy-blue SUV was travelling northbound on US highway one swerving across the roadway.

I was at the intersection of 4500 US Highway One, when I observed the vehicle stopped at the red light, still travelling northbound. When I got behind the vehicle, I observed the vehicle go into the left turn lane, then merge back into the inside lane almost striking a vehicle. The car then proceeded back northbound on U.S Highway One, bounced between the inside and outside lane, and attempt a U-turn. I conducted a traffic stop on the vehicle at 5200 U.S Highway One based on probable cause of a violation of F.S.S 316.089(1) Fail to drive in a single lane.

I made contact with the Driver, Helen Reid Fowkes, and requested her driver's license, registration and insurance. Fowkes stated she was driving home to a residence on 65<sup>th</sup> street (at the time of the traffic stop she was southbound at the 5200 block of US Highway One). While speaking with Fowkes she was attempting to cover her eyes, however I was still able to observe her eyes to appear glossy and watery, I also noticed slurred speech while communicating with Fowkes. I asked Fowkes where she was coming from, which she advised she was driving from Flithy's (1238 16<sup>th</sup> street, Vero Beach, Florida 32960). I asked Fowkes if she had anything to drink while at Flithy's and she advised me that she had one rum and coke a few hours ago. I asked Fowkes if she would participate in field sobriety exercises to make sure she was able to operate a vehicle, Fowkes stated last time she did field sobriety exercises she was taken to jail. Fowkes voluntarily agreed to complete the exercises and then pleaded for me not to take her to jail.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN) exercise. I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes. During the exercise, I observed a lack of smooth pursuit in both eyes, I observed distinct and sustained Nystagmus at maximum deviation in both eyes, I observed Nystagmus prior to 45 degrees in both eyes. I did not observe any vertical gaze Nystagmus (VGN). During this exercise Fowkes had 6 out of the 6 clues that indicate impairment.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Fowkes was unable to maintain the starting position and started the exercise without being told to do so. I had to instruct Fowkes to get back into the starting position multiples times prior to starting the exercise. After providing the instructions and demonstration I asked Fowkes if she understood the exercise and its instructions, to which she stated she did. During the exercise Fowkes stepped off the

line, did not take the proper number of steps, did not take heel to toe steps, conducted an improper turn, stopped while walking and utilized her arms to maintain balance. During this exercise Fowkes had 8 out of the 8 clues that indicate impairment.

The third exercise I demonstrated and explained was the One-Legged Stand exercise. After acknowledging the instructions, I had to re-explain the instructions to Fowkes 3 times. Fowkes started to get irate and insult myself and other law enforcement personnel on scene. I asked Fowkes if she wanted to continue the exercises, to which she stated she was ready to begin. Fowkes repeated this behavior twice before I made the determination that she was not going to continue the exercises, at which time I placed Helen Reid Fowkes under arrest for the following offenses:

- F.S.S. 316.193.4 – Driving under the Influence BAC 0.15 or higher.

Fowkes was transported to the Indian River County Jail without further incident.

At the Indian River County Jail booking staff requested Fowkes provide a lawful breath sample, to which she agreed to comply. Her first breath sample was 0.150 g/210L of breath and her second breath sample was 0.147 g/210L of breath.
