NARRATIVE

On June 4, 2025, at approximately 0309 hours,	I, Deputy Gabriel Muszynski, was dispatched to
in reference to a disturbance.	_

Upon my arrival I made contact with the complainant, Ernestine Wiggins, who stated her granddaughter and were fighting. While talking with E. Wiggins outside of the residence, I heard yelling from inside. Myself and Deputy Estrella entered the residence with E. Wiggins permission and made contact with both parties in the north most room. The suspect, later identified as Edwin Jean, was detained and escorted outside for questioning.

In a post Miranda interview with Jean, he stated that he and the victim, Jasmine Wiggins, had gotten into a verbal argument when he mentioned a female he had been in a previous relationship with. Originally, Jean stated that Wiggins had attacked him and that he did not touch her. He then altered his story by stating that the argument never got physical. I observed a small laceration on Jean's left arm and when questioned about it, he stated he had fallen onto a glass table during the argument. During the interview of Jean, when asked for his identifying information, he said his name was Jean Pierre Anderson but could not provide a date of birth. I asked Jean why he could not remember his own birthday, he stated it was because he was from Haiti and the dates were different where he was from and he had just learned English. I again asked Jean for his name and date of birth a second time, to which he replied with Pierre Jean Anderson with a date of birth of October 18, 2002. It should be noted that during this investigation, Jean provided false information to myself, Deputy Estrella and Corporal Quaglia. It took multiple attempts at questioning Jean before Jean provided his correct information to Corporal Quaglia (see supplemental reports for further information).

I spoke with the J. Wiggins who had also been detained by Deputy Estrella and escorted outside of the residence. In a post Miranda interview, J. Wiggins stated she and Jean had gotten into a verbal argument when Jean had become aggressive towards her. J. Wiggins continued to state Jean had punched her with a closed fist and slapped her with an open hand multiple times. J. Wiggins stated Jean had also wrapped his hands around her neck and choked her for approximately eight (8) seconds. During this time, J. Wiggins stated she lost consciousness for a moment and regained it during the fight. She also stated Jean had pushed her down onto a glass table, shattering it and cutting her arm. J. Wiggins stated that she and Jean

I observed slight bruising on both of J. Wiggins' arms as well as a small laceration on her left forearm. There were also scratch marks on her left shoulder and slight discoloration on her right bicep, left side of her face and neck, all consistent with her statements of the physical altercation.

I spoke with E. Wiggins who witnessed part of the altercation between J. Wiggins and Jean. E. Wiggins stated she was woken up by a loud verbal argument between J. Wiggins and Jean, when she went into the room they were in, she witnessed Jean striking J. Wiggins repeatedly and grab her by wrapping his arms around her so that she could not move.

Inside the residence, I observed a small glass coffee table that had been broken and glass all over the floor. There were blood smears on a door leading to the outside of the residence on the far side of the room where Jean was standing as myself and Deputy Estrella entered the residence and detained both parties.



NARRATIVE

On Wednesday, June 4, 2025 at approximately 1437 Hours I, along with Deputy A. Brady, was conducted a warrant check in the area of Taylor Pointe in the 3800 block of 49th Street, Vero Beach, Florida 32967 when Deputy A. Brady conducted an FCIC/NCIC query of a white BMW which may have been associated with a wanted person.

Upon FCIC/NCIC query, Deputy A. Brady observed no insurance on file within the State of Florida. Further, both Deputy A. Brady and I observed the window tint of the vehicle to be in violation of F.S.S. 316.2953 (Later measured and confirmed to be 17% on the driver's side window.). Further, I observed the vehicle to operate in inclement weather with no illuminated lighting equipment when it turned Westbound on 49th Street from Taylor Pointe, in violation of 316.217(1) - Namely rain which has been off and on for hours at this point. Further, I observed the vehicle to not have any Registration sticker displayed on the Florida License Plate, leaving only the blank "DECAL" box on the license plate.

I initiated a traffic stop in the area of Lincoln Drive and 40th Avenue, Vero Beach, Indian River County, Florida.

I requested an additional unit respond to the scene.

Upon exiting my patrol vehicle, I smelled the strong odor of burnt marijuana emitting from the vehicle. Upon contacting the driver, later identified by Florida Driver's License as Mr. D'Angelo Lumenes, I observed a twisted cellophane style bag in a cup holder which contained a green leafy substance which I recognized through my training and experience to be marijuana. I further smelled the odor of fresh marijuana.

Deputy A. Brady arrived on scene with a tint meter, which he then confirmed the tint to be in violation of Florida Statute. I requested Deputy A. Brady get Mr. Lumens out of the vehicle.

Upon contact, I asked Mr. Lumenes if he had a medical marijuana card, to which he stated he did not. He further stated he had smoked within the vehicle within the last one to two days.

Mr. Lumens acknowledged he did not currently have insurance on the vehicle. Despite this, Mr. Lumenes operated a motor vehicle upon the public roadways of the State of Florida in violation of F.S.S 324.221(2).

Mr. Lumenes was instructed to place his hands on the patrol vehicle where I then conducted a search of his person, as he also smelled of the odor of burnt cannabis.

Upon opening the driver's side door of the vehicle, where Mr. Lumenes was seated, directly within the door storage area I observed a small ziplock style bag – which I have uncovered numerous times when investigating the sale, distribution, or consumption of illegal substances – contained within this bag was a fine gray/brown powder

which I recognized through my training and experience to likely be Fentanyl.

I retrieved the bag of marijuana, later weighed at approximately 4.00 grams in packaging and placed it on the driver's seat while I conducted a field test of the suspected fentanyl.

Due to the smaller amount of powder, I was only able to retrieve small amounts to test; which I tested twice. Both times, the powder tested field presumptive positive for the presence of fentanyl; as indicated by a distinct orangish coloration change within the field test kit. The second test initially did not yield an orange coloration change, however, the test slowly darkened – indicating the presence of Fentanyl.

I showed the test kit to Mr. D'Angelo Lumenes who maintained that the bag contained "weed" at one point; when Mr. Lumenes was confronted with the presence of fentanyl, he became argumentative and began calling someone.

I have conducted traffic stops in this area previously and know through experience both with this agency and other agencies; when more people show up to a scene the likelihood for needless escalation increases greatly. As a result, for officer safety I requested Mr. Lumenes place his phone down as he was detained; I did not inform Mr. Lumenes he was prohibited from recording – merely to place the phone down. He was then informed he would be detained in handcuffs – having already established probable cause for his arrest – if he failed to comply.

Mr. Lumenes then became irate, where I then decided to place Mr. Lumens under arrest for the substances discovered within his vehicle in addition to his lack of compliance.

Mr. Lumenes immediately tensed and began pulling away from myself and Deputy A. Brady as we attempted numerous times to gain compliance over Mr. Lumenes, despite multiple repeated, lawful, concise commands to place his hands behind his back he continued to pull away and resist arrest.

As a result, Deputy A. Brady and I placed Mr. Lumenes on the ground. Mr. Lumenes continued to actively resist arrest, at which point I drew and armed my taser; where he was told he would be tased if he did not comply.

Mr. Lumenes was eventually placed in handcuffs and placed in to the rear of my patrol vehicle. Mr. Lumenes began yelling that we had "Planted" the fentanyl.

After transporting Mr. Lumenes to the Indian River County Jail Complex I weighed, on camera, the substances which I had recovered. The field presumptive positive Fentanyl weighed approximately 0.36grams in packaging; the marijuana weighed approximately 4.00 grams in packaging.

While being fingerprinted pursuant to arrest, Mr. Lumens then braced and pulled away from Corrections Deputies; resulting in him again being placed on the ground.
