NARRATIVE

On Thursday, June 26, 2025 at approximately 1800 hours, I responded to the Cleveland Clinic Hospital located at 1000 36th Street in Vero Beach, FL 32967 in reference to a Traffic Crash with property damage.

I was notified by Cpl. C. Moon #6015 that she was en-route to the Cleveland Clinic Hospital with a driver who was possibly intoxicated, later identified as Mr. Paul Severson (Arrestee).

Upon my arrival, I made contact with the Fire Rescue unit who transported Mr. Severson and they advised his vitals were all withing relative normal ranges. Corporal Moon stated Mr. Severson was in the driver's seat and his seat belt was hanging out of the door and locked in the extended position.

I met with Mr. Severson in Room #8 with Deputy R. Sides #6259 who attempted to complete a civil crash investigation. This crash caused approximately \$5,500 in property damage as estimated by the property owner Ms. Lynn Massagee (Involved Person). During this interview Mr. Severson was uncooperative to her questioning and declined to provide a statement. When asked for his phone number, Mr. Severson displayed great difficulty in communicating his phone number. He had to repeat himself several times. His speech was extremely slurred and soft spoken.

I then advised Mr. Severson I was conducting a criminal investigation into Driving under the influence and advised him of his Miranda Rights which he acknowledged and stated he understood. Mr. Severson refused to provide a statement or speak with me and no further questions were asked. Mr. Severson's eyes were watery and glassy, and I could smell the odor of alcohol emitting from his breath as he spoke.

I explained to Mr. Severson, based on the totality of the circumstances of the crash, his slurred speech and his refusal to provide a statement, that I had developed probable cause for his arrest, and placed him under arrest for Driving Under the Influence with property damage.

While waiting for medical clearance, Dr. Snogders approached me and informed me without prompt that Mr. Severson's Blood Alcohol level was 0.355 at the time of lab draws. Mr. Severson was unable to control his bodily functions and urinated all over himself to the extent it leaked onto the hospital room floor.

Mr. Severson was transported to the Indian River County Jail (IRCJ) without further incident. Upon arrival to the IRCJ, I offered Mr. Severson an attempt to complete Standard Field Sobriety Exercises (SFSE's) which he refused after a thorough explaination. Corrections Deputy F. Solomon #5815 requested Mr. Severson provide a sample of his breath, which he initially agreed to provide. After she

NARRATIVE

On Thursday, June 26th, 2025 at 1952 hours, I was traveling Southbound on 58th Avenue from 45th Street, when I observed a white Chevrolet sedan bearing Florida tag# CL70MK with an obstructed rear view mirror. I activated my emergency lights and conducted a traffic stop on the vehicle at the 3800 block of 57th Avenue.

Prior to making my approach of the vehicle, I observed the front seat passenger begin to exit the vehicle. I proceeded to request the passenger to get back in the vehicle. The front seat passenger began to question why he had to get back in the vehicle and began to flee from the traffic stop as I approached the vehicle. It should be noted that during this incident, I was wearing my agency issued Class C uniform, which identifies me as Law Enforcement. I continued to yell at the suspect to stop however he continued to flee from me.

I began to give chase to the unidentified suspect however I lost contact with him throughout the foot pursuit. It should be noted that during the pursuit, I withdrew and deployed my agency-issued Taser 10 nine times in an attempt to incapacitate the unidentified suspect however I was unsuccessful, in which the suspect continued to flee from me.

Shortly after, Public Safety Dispatch advised they received a call from a complainant, stating they believe an unidentified person ran through the back of their residence. Contact was made with the complainant, who stated the residence is a rooming house and she was in her room when she heard the noise.

A perimeter of the residence was put in place as more Deputies arrived on scene.

I then made contact with the female driver of the vehicle, who was identified as Sherlyn Cazares. Cazares provided me with identification of the suspect and identified him as Tony Montana. Cazares then stated she had his phone number and could get ahold of him. Cazares then stated Montana advised him he was going to walk out of the residence peacefully.

Shortly after, Deputies in the front perimeter of the residence made contact with Montana and placed him in custody.

I made contact with the suspect, who advised me of his real name, Billy Arriaga. Arriaga was run through FCIC/NCIC to confirm his identification. I then advised Arriaga of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda, Arriaga stated he ran from Law Enforcement because of his immigration status and was afraid of being deported back to his country.

Arriaga was placed in the back of my marked patrol vehicle and transported to the Indian River County Jail without further incident.

Due to the above mentioned, I criminally charged Arriaga with the following charges:

F.S.S 843.02 Resist Officer without violence.
