


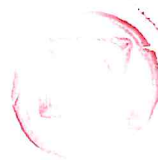

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On 06/26/2025 at 11:37 (Specifically include facts constituting cause for arrest.)

Defendant Karissa D Gennett violated Florida State Statute 784.03 Simple Battery (Domestic) by smacking her boyfriend in the face two times while in the passenger seat while he was driving through the drive thru at McDonalds.

I responded to 1925 US Highway 1, Vero Beach, Florida 32960 within the jurisdictional limits of the city of Vero Beach in reference to a disturbance. Upon my arrival I made contact with Adrian M Maige who was parked in the parking lot of the McDonalds in a silver Kia Spectra bearing Florida tag CI73QY after coming out of the drive thru with his girlfriend Karissa D Gennett and their two children K. Maige (5) and E. Maige (3). [REDACTED]
 [REDACTED] They have been in a relationship for five years.

A. Maige stated that his girlfriend Gennett was out all night at a friends house using cocaine. Gennett called him this morning to come and pick her up. Maige stated that when she got in the car she was hungry and asked him to take her to McDonald's to get something to eat. Maige stated they were not hungry he would just get her something as him and the children already ate. Maige stated that Gennett became angry and started yelling and then slapped him in the face two times from the passenger seat while the children were in the back seat. Maige stated he pulled over and called the police because he was tired of the abuse.

Gennett stated that she was at a friends house all night hanging out. Gennett stated she called her boyfriend to pick her up. Gennett stated she was hungry and asked him to bring her to McDonalds. While going through the drive thru she stated Maige was fussing at her for being out all night. Maige stated that he pulled over and called the cops to have her arrested as payback for being out all night.

I spoke with K. Maige (5) who was seated in the rear passenger seat. When I opened the door to speak with him before I could ask any questions, K. Maige stated, "mommy is being bad, she smacked daddy two times. K. Maige then illustrated it by smacking himself in the face. K. Maige then stated she needs to go to jail." E. Maige was sleep in the rear driver seat side of the vehicle.

A. Maige completed a sworn written statement and a Domestic violence packet was completed. He was given a victims rights brochure as well on scene.





I asked [REDACTED] to tell me what happened to which [REDACTED] made the following statements. [REDACTED] advised [REDACTED] had a friend by the name of Natalie Bella over as [REDACTED] lets her stay with [REDACTED] from time to time. As [REDACTED] was working on the shower [REDACTED] walked by Bella and noticed she had a bag of money [REDACTED] hides underneath [REDACTED] bed.

[REDACTED] confronted her about where she got the bag and asked what she was doing. A verbal altercation began and Bella became extremely irate. She grabbed ahold of [REDACTED] and pushed [REDACTED] up against the wall then down to the floor, causing a slight abrasion to [REDACTED] right and left elbows. After [REDACTED] fell to the floor [REDACTED] was able to stand up and get out the back door and locked [REDACTED] in the guest house. Natalie followed behind and was screaming and banging on the windows and door of the guest house.

Once [REDACTED] saw Bella go back into the main house [REDACTED] fled out the backdoor to the bushes to [REDACTED] neighbors where [REDACTED] was able to [REDACTED]

As I made contact with Bella she was laying on [REDACTED] bed acting as if she was asleep. As I got her up from the bed I observed [REDACTED] wallet on the bed that was underneath her chest. I read Bella her Miranda Rights. Post Miranda she advised "[REDACTED] knows today's the day I collect the \$11,000." That's the only statement she made pertaining to the incident.

When asked about her collecting \$11,000, [REDACTED] stated [REDACTED] had no idea what she was talking about, [REDACTED] does not give her large amounts of money. No money was actually taken during the above incident.

Bella was placed in handcuffs and sat in the back of my patrol vehicle. Shortly after she began to kick the back window of my patrol car. At that point she was taken out of the vehicle and placed in a safety wrap then put back in the vehicle.

She was transported to the IRC Jail for booking without further incident.

NARRATIVE

On Thursday, June 26, 2025 at approximately 1800 hours, I responded to the Cleveland Clinic Hospital located at 1000 36th Street in Vero Beach, FL 32967 in reference to a Traffic Crash with property damage.

I was notified by Cpl. C. Moon #6015 that she was en-route to the Cleveland Clinic Hospital with a driver who was possibly intoxicated, later identified as Mr. Paul Severson (Arrestee).

Upon my arrival, I made contact with the Fire Rescue unit who transported Mr. Severson and they advised his vitals were all withing relative normal ranges. Corporal Moon stated Mr. Severson was in the driver's seat and his seat belt was hanging out of the door and locked in the extended position.

I met with Mr. Severson in Room #8 with Deputy R. Sides #6259 who attempted to complete a civil crash investigation. This crash caused approximately \$5,500 in property damage as estimated by the property owner Ms. Lynn Massagee (Involved Person). During this interview Mr. Severson was uncooperative to her questioning and declined to provide a statement. When asked for his phone number, Mr. Severson displayed great difficulty in communicating his phone number. He had to repeat himself several times. His speech was extremely slurred and soft spoken.

I then advised Mr. Severson I was conducting a criminal investigation into Driving under the influence and advised him of his Miranda Rights which he acknowledged and stated he understood. Mr. Severson refused to provide a statement or speak with me and no further questions were asked. Mr. Severson's eyes were watery and glassy, and I could smell the odor of alcohol emitting from his breath as he spoke.

I explained to Mr. Severson, based on the totality of the circumstances of the crash, his slurred speech and his refusal to provide a statement, that I had developed probable cause for his arrest, and placed him under arrest for Driving Under the Influence with property damage.

While waiting for medical clearance, Dr. Snogders approached me and informed me without prompt that Mr. Severson's Blood Alcohol level was 0.355 at the time of lab draws. Mr. Severson was unable to control his bodily functions and urinated all over himself to the extent it leaked onto the hospital room floor.

Mr. Severson was transported to the Indian River County Jail (IRCJ) without further incident. Upon arrival to the IRCJ, I offered Mr. Severson an attempt to complete Standard Field Sobriety Exercises (SFSE's) which he refused after a thorough explanation. Corrections Deputy F. Solomon #5815 requested Mr. Severson provide a sample of his breath, which he initially agreed to provide. After she




On Thursday, June 26th, 2025 at 1952 hours, I was traveling Southbound on 58th Avenue from 45th Street, when I observed a white Chevrolet sedan bearing Florida tag# CL70MK with an obstructed rear view mirror. I activated my emergency lights and conducted a traffic stop on the vehicle at the 3800 block of 57th Avenue.

Prior to making my approach of the vehicle, I observed the front seat passenger begin to exit the vehicle. I proceeded to request the passenger to get back in the vehicle. The front seat passenger began to question why he had to get back in the vehicle and began to flee from the traffic stop as I approached the vehicle. It should be noted that during this incident, I was wearing my agency issued Class C uniform, which identifies me as Law Enforcement. I continued to yell at the suspect to stop however he continued to flee from me.

I began to give chase to the unidentified suspect however I lost contact with him throughout the foot pursuit. It should be noted that during the pursuit, I withdrew and deployed my agency-issued Taser 10 nine times in an attempt to incapacitate the unidentified suspect however I was unsuccessful, in which the suspect continued to flee from me.

Shortly after, Public Safety Dispatch advised they received a call from a complainant, stating they believe an unidentified person ran through the back of their residence. Contact was made with the complainant, who stated the residence is a rooming house and she was in her room when she heard the noise.

A perimeter of the residence was put in place as more Deputies arrived on scene.

I then made contact with the female driver of the vehicle, who was identified as Sherlyn Cazares. Cazares provided me with identification of the suspect and identified him as Tony Montana. Cazares then stated she had his phone number and could get ahold of him. Cazares then stated Montana advised him he was going to walk out of the residence peacefully.

Shortly after, Deputies in the front perimeter of the residence made contact with Montana and placed him in custody.

I made contact with the suspect, who advised me of his real name, Billy Arriaga. Arriaga was run through FCIC/NCIC to confirm his identification. I then advised Arriaga of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda, Arriaga stated he ran from Law Enforcement because of his immigration status and was afraid of being deported back to his country.

Arriaga was placed in the back of my marked patrol vehicle and transported to the Indian River County Jail without further incident.

Due to the above mentioned, I criminally charged Arriaga with the following charges:

F.S.S 843.02 Resist Officer without violence.




