NARRATIVE

On Thursday, May 21, 2026, at approximately 1048 hours, I responded to [REDACTED] in reference to a domestic disturbance.

Upon arrival, I made contact with the victim, Funmilayo Amina Onabule. Onabule advised that the father of her child and ex-romantic partner, Terrance Kennard Hodges Jr., had just been involved in an altercation with her. Onabule began inquiring about how to obtain a "restraining order" against Hodges. I inquired about what had occurred on today's date.

Onabule stated that Hodges arrived at her residence and began a verbal argument regarding visitation rights, demanding to see their child. Onabule further stated that Hodges pushed her, entered the residence, and went upstairs to see the child. Onabule advised the incident was captured on her Ring doorbell camera affixed to the front door of the residence.

I requested that Onabule pull up the footage for me to review, and she consented. Upon review of the footage, I observed Hodges and Onabule engaged in a mild verbal argument at the front door of the residence. They had a brief back-and-forth regarding Hodges seeing his child. Hodges then began entering the threshold of the residence by pushing the door open and stepping inside. Onabule shifted her body to block Hodges from entering the residence. Hodges extended his right arm and pushed Onabule out of the way. I observed Onabule continue using her body to prevent Hodges from entering while Hodges continued pushing her.

During the physical altercation, Hodges managed to push Onabule to the point where her back was facing him. Hodges then pushed her further, pinning her between the stair railing near the entranceway and his right arm. While Onabule was pinned, Hodges stepped around her and proceeded upstairs where the child was located. As Hodges proceeded upstairs, Onabule stated she was "going to call the police," retreated further into the apartment, and grabbed her phone. The footage ended when Onabule returned with her phone in hand and appeared to be dialing a number while Hodges walked upstairs and out of view.

I provided Onabule with a Community Request link through the Axon Capture App, and she uploaded the video. I confirmed the video was successfully uploaded and reviewed it further.

Due to Hodges leaving the scene, I began gathering pertinent information to assist in locating him. Onabule provided a photograph of Hodges' Florida identification card, which she had stored on her cellphone, as well as a description of the vehicle he arrived in. Onabule further advised the vehicle was registered to Hodges' mother.

I provided all gathered information to RTCC and dispatch. RTCC was able to provide a last known location through the FLOCK system, and units responded to the area in an attempt to locate Hodges.

A short time later, Hodges was located at the RaceTrac gas station located at 9490 108th Avenue, Fellsmere, FL, by Fellsmere Police Department Officer A. Irwin. Officer Irwin took Hodges into custody at my request and ultimately turned him over to Corporal Barkwell for transport to the Indian River County Jail. See Corporal Barkwell's supplement report for further details.

NARRATIVE (Continuation)

I responded to the Indian River County Jail and met with Hodges. Hodges was read his Miranda Warnings of Constitutional Rights. Hodges acknowledged understanding his rights and agreed to speak with me.

Hodges' statement is as follows, in essence:

Hodges explained that he and Onabule have a verbal agreement regarding visitation rights. He stated they do not have a court-ordered visitation agreement and instead coordinate visitation through text messages. Hodges advised that he was preparing to leave on a planned trip and wanted to see his child. Hodges affirmed that today was not a planned visitation day and that he was not invited to the residence by Onabule.

Upon his unplanned arrival, Hodges demanded to see his child, and Onabule refused him access. Hodges then explained that he wanted to see his child, so he "moved" and "pushed" Onabule out of the way before proceeding upstairs to get the child. Hodges confirmed he does not reside at the residence, does not have residential rights to the residence, and did not have permission to enter the residence. Hodges further affirmed he entered the residence by using force against Onabule in order to "see" his child after permission to enter had not been granted.

Based on Onabule's statements, the video footage, and Hodges' post-Miranda admissions, Hodges was charged with violating the following Florida State Statutes:

F.S.S. 810.02(2)(a) – Burglary with Assault or Battery (DV)

F.S.S. 784.03 – Simple Battery (DV)

Hodges was subsequently turned over to jail staff for further processing.

Corporal Munni assisted by completing a Domestic Violence Packet, which included the Domestic Violence Lethality Assessment, and by providing Onabule with a Victim's Rights pamphlet containing resources as well as the case report number for her records.

Onabule was determined to be in a potentially lethal situation based upon her responses to the lethality assessment. Corporal Munni advised he would contact Victim Services and notify them of the findings. See Corporal Munni's supplement report for further details.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On **05/21/2026** at **23:25** (Specifically include facts constituting cause for arrest.)

PROBABLE CAUSE STATEMENT

I conducted a traffic stop on a white Dodge Charger (FL tag # FQLQ90) near the 1800 block of 20th Avenue. Prior to the stop, I was traveling north on 14th Avenue, approaching 19th Street, when I observed the white Dodge traveling south on 14th Avenue and fail to stop at the white stop line where it clearly displayed a stop sign. The white Dodge drove through the white stop line making a right turn onto 19th Street heading west bound. At that time, I was unable to conduct the traffic stop due to the vehicle traveling at a high rate of speed in a residential neighborhood and the inability to catch up to the vehicle. I observed the white Dodge approach 20th Avenue from a distance and it conducted a sharp, fast, right turn, traveled north on 20th Avenue. Shortly after, I approached the same intersection but I lost visual of the white Dodge. I made a right turn onto 20th Avenue and continued north where I made a right turn onto 20th Street/19th Place, traveling east. I then turned onto 19th Avenue to travel southbound. In doing so, I observed the white Dodge again. I observed it slowly traveling southbound with its exterior lights [headlights/tail lights] completely off. As I continued driving, the white Dodge conducted a sharp left turn again, attempting to evade me and traveled east on 19th Street. At that time, the white Dodge turned his headlights on but immediately and aggressively made a right turn onto 18th Avenue. At that time, I was able to safely conduct a traffic stop and activated my emergency patrol lights in the area of 18th Avenue and 18th Street. The white Dodge made a right turn onto 18th Street traveling west bound where it eventually stopped prior to approaching the stop sign at 20th Avenue.

I then made contact with the driver and sole occupant of the vehicle who was identified as Matthew Madera (W/M 05/24/2000) through his Florida drivers license. Madera was advised the reason for the stop and claimed he was unaware that a police officer was following him. Madera claimed he was traveling in an aggressive manner due to his significant other being home alone with their newborn and he was trying to rush home. While standing by the front passenger side window, I smelled a strong odor of marijuana emanating from the vehicle. Ofc. Wickert was on scene and advised he had smelled the odor of marijuana as well and had observed a lighter and rolling paper. Madera advised him he did not have an active medical marijuana card. This information was later confirmed by Vero Beach dispatch.

A vehicle search was conducted where a small clear bag containing green leafy plant material was located directly underneath the front drivers seat, in hands reach of the driver. A rolled up "blunt" was located inside a black container in the cup holder area of the center console, and a small multicolor tray was located in the glove box compartment which contained green leafy residue and ashes.

Post Miranda, Madera claimed the marijuana was not his and he had no recollection of it being in the vehicle. Madera stated the vehicle is registered to his girlfriend however, he drives the vehicle Thursday through Sunday every week. In asking Madera about his driving pattern, he claimed he was lost however, he stated that he has been living at 1805 40th Avenue for approximately 6 months. Madera's statements on his driving pattern and evasive movements had some discrepancy based on the observations I had made. Madera did acknowledge his erratic driving but when asking about why he had turned all his exterior lights off, he claimed he was attempting to turn his fog lights on and claimed he had turned into 19th Avenue because he was unable to make a left turn onto 20th Street.

Based on the foregoing, Madera was placed under arrest for Reckless Driving and Possession of Marijuana under 20 grams. Madera is to be held on a \$650.00 bond.

Madera was issued a citation (#AMZ91AE) for Reckless Driving F.S.S. 316.192(1)(A) and a citation (#AMZ91BE) for Possession of Marijuana under 20 grams F.S.S. 893.13(6)(b).
