NARRATIVE TO A STATE OF THE STA

On November 16th, 2025, at 1938 hours, I responded to the Indian River County Jail (IRCJ) in reference to an indecent exposure incident. Upon my arrival, I made contact with Sgt. Jenkins, who advised an inmate, identified as Jahleel T. Eaton, had intentionally exposed his sexual organs to two IRCSO Correctional Deputies in a lascivious manner. It should be noted that Eaton is currently incarcerated at the IRCJ for 1 count of violating;

FSS 800.09.2a, commit lewd or lascivious exhibition in the presence of an employee

After speaking with Sgt. Jenkins, he identified the two deputies as Deputy S. Moore #6146 and Deputy T. Russakis #6330. I then went and made contact with Deputy Moore first; who advised, around 1815 hours, herself and Deputy Russakis were inside conducting their count where she observed Eaton to be standing close to the cell door with his pants lower than normal, however, Deputy Moore stated she noticed that Eaton's hands weren't near his crotch area and continued her count. Deputy Moore continued, and stated that shortly after completing their headcount; they returned to place the cleaning carts inside around 1820 hours. Deputy Moore stated she observed Eaton to be standing at the doorway of cell with his pants down.

Moore advised as they approached Eaton's cell and opened the cell door, Eaton continued to stand at the threshold and began to "grab" his sexual organs, indicated Eaton had intentionally exposed himself in a vulgar manner.

After speaking with Deputy Moore, I made contact with Deputy Russakis. Deputy Russakis advised that himself and Deputy Moore entered with cleaning carts, where he positively identified Eaton to be standing in the doorway of his cell with his pants lowered and his penis fully exposed. Deputy Russakis advised himself and Deputy Moore issued Eaton verbal commands to cover himself too which he complied; and shortly after, was transported to confinement.

Through my investigation, I found Jahleel T. Eaton, to be in violation of two counts of,

FSS 800.09.2a, commit lewd or lascivious exhibition in the presence of an employee

NARRATIVE

On Thursday, November 13, 2025, at approximately 1846 hours, I, Deputy M. Neill #6317 responded to the Home
Depot located at 1885 58th Avenue, Vero Beach, Indian River County, Florida, 32966 in reference to a shop lifting
in progress.

The complainant, who was later identified as Mr. Keith Weinberg to report the theft. He advised he was a Home Depot employee and the loss prevention officer for the location. He had a subject who had attempted to steal multiple items and passed all points of sale. Mr. Weinberg attempted to apprehend the suspect but he took flight. Mr. Weinberg provided a description of the suspect to the 911 call taker who was able to relay it to responding units. Mr. Weinberg advised the suspect was a white male wearing a white shirt and a hat walking towards the McDonalds.

Sgt. Hoilett was the first deputy to arrive in the area. As Sgt. Hoilett arrived at the last seen point of the suspect, he observed a white male wearing a white shirt holding a Dyson Vacuum that was still in the box. As Sgt. Hoilett got closer, the male dropped the vacuum and started to walk away from him. Sgt. Hoilett informed the subject to stop and to not run, as he was closing the distance in on the subject. The subject then fled on foot prompting a foot pursuit. After a foot pursuit, the suspect was apprehended approximately one quarter mile away. He was then identified as Mr. David Mohan.

I made contact with Mr. Weinberg. He advised he observed the male on camera and started to watch him based on his suspicious behavior. The male would walk around the store picking random items. He also would not check or appear to care about the price of the item and was quickly placing items in the cart. After approximately thirty minutes of walking in the store, the suspect exited out of the garden center. He had multiple items within a new garbage container that was inside of a shopping cart. On the bottom rack of the shopping cart was the dyson vacuum. The male passed all points of sale and continued in to the parking lot. Mr. Weinberg identified himself as an employee of Home Depot and grabbed the shopping cart. The male then grabbed the Dyson Vacuum and flees from the store, heading towards the McDonalds. Mr. Weinberg then to report the crime. Mr. Weinberg was able to recover the items in the garbage bin on scene.

Mr. Weinberg was able to provide video surveillance which supported his above statement. Based on the driver's license photo of Mr. Mohan and the video surveillance, I was able to confirm that Mr. Mohan is the suspect for the theft.

Mr. Mohan was transported back to the scene, as he was placed under arrest for Resisting / Obstructing without Violence. Mr. Weinberg was then able to positively identify Mr. Mohan as the suspect who stole the items. During this encounter, Mr. Weinberg made the statement to Mr. Mohan "all you had to do was stop and we could have taken care of this". Mr. Mohan response was "I thought I could get away".

I also spoke to another employee, who was working the cash registered in the Garden Center. Ms. Kerryann Scott advised that Mr. Mohan walked up to the exit pushing a shopping cart with a garbage bin and a Dyson Vacuum in the cart. She asked to see his receipt. Mr. Mohan advised he did not have a receipt and then continued to the exit,

NARRATIVE

On November 13, 2025, at approximately 2248 hours, I was sitting stationary on Interstate 95 at approximately Mile Marker 153, facing south, when I observed a black in color Dodge Challenger traveling south without tag lights.

After observing the violation of Florida State Statue 316.221(2), I conducted a traffic stop by activating the emergency lights on my marked patrol car on the aforementioned vehicle bearing Florida tag FNAW76, at approximately Mile Marker 151 south.

I approached the passenger side of the vehicle, and made contact with the driver and sole occupant, Mark Hadden. I requested Mark's driver's license, registration, and proof of insurance. Mark handed me his Florida driver's license, and began looking for the other documents. I asked Mark if the car was registered to him, he confirmed it was. I told Mark I would look up his registration and insurance information.

I returned to my patrol car and conducted an NCIC/ FCIC query of Mark. I discovered that Mark's Florida driver's license had been suspended on June 30, 2025, and there was a seize tag order on the vehicle if the driver was the owner. I also discovered that Mark was a registered sex offender, for crimes against a case #20715). I confirmed the information from NCIC/ FCIC on the Driver and Vehicle Information Database (DAVID).

I returned to Mark and requested his phone number, at which point he questioned why I was asking for his phone number. I informed Mark that his Florida driver's license was suspended, and I needed the phone number for the paperwork, (tow sheet, and tickets).

I returned to my vehicle and noticed that the phone number Mark provided was not listed as one of his registered phone numbers as a sex offender in NCIC/ FCIC. I contacted Detective York, and asked if he would check the phone number Mark provided in the sexual offender/ predator system, (SOPS). Detective York advised the number provided by Mark was listed.

During my queries of Mark, I noticed a possible failure to register violation for Mark's vehicle, I asked Detective York if he could check the vehicle as well.

While I was talking with Detective York, I observed Mark waving papers out the driver's side window, and I could hear him yelling. Detective York informed me to be careful while dealing with Mark. Detective York informed me he would call me back with the information I requested on the vehicle.

I contacted Deputy Ortega and requested him to respond to my traffic stop.

Deputy Ortega arrived, and I informed him of what was occurring. Deputy Ortega approached the passenger side of the vehicle and began speaking with Mark. During their conversation, I could hear Mark yelling. I exited my vehicle and made contact with Mark and attempted to calm him down. Mark began getting load, at which point I became very direct with Mark and informed him to stop yelling. Mark provided me with his vehicle registration for the 2015 black Dodge Challenger bearing VIN: 2C3CDZAG1FH758214, which showed the vehicle was registered on August 25, 2025. Mark, also provided me with the buyer's order/ bill of sale, which showed Mark purchased the 2015 black Dodge Challenger bearing VIN: 2C3CDZAG1FH758214, on August 25, 2025.

Detective York called and informed me that after viewing SOPS, Mark did not register the 2015 black Dodge Challenger bearing VIN: 2C3CDZAG1FH758214, with the Sheriff's office and the Florida Department of Law Enforcement (FDLE)

until September 18, 2025, which is longer than 48 hours, a violation of his sex offender status and a felony; reference Florida State Statute 943.0435(2)(b)3.

It should be noted, FDLE warned Mark on July 7, 2025 to update his vehicles accurately, due to discrepancies between his active vehicles registered with the Sheriff's Office and FDLE and what the Department of Highway Safety Motor and Vehicles (DHSMV) has reported.

I approached the passenger side of the vehicle and requested Mark exit and walk back to my vehicle, he told me no. I walked to the driver's side and informed Mark he was coming out of the vehicle, at which point he exited and stood next to the interstate. I told him to walk back to my vehicle, so he did not get hit by a car. At the front of my vehicle, I began to place Mark in handcuff restraints, at which point he began to tense up, Deputy Ortega stepped over and secured Mark's left arm. Mark was placed in handcuff restraints and checked for proper fit. I walked Mark to the back of my patrol car, prior to placing him inside, I asked him to spread his feet and lean towards my vehicle, so I could search him. Mark again, began to tense up and began moving his feet. I pushed Mark against my vehicle and told him stop. I searched Mark and placed him inside the rear of my patrol car.

Deputy Ortega contacted the next rotation wrecker to tow Mark's vehicle, prior to the wrecker arriving we conducted an inventory search of the vehicle. I removed three (3) cell phones and a laptop computer from inside the vehicle, and placed them on my front seat. Mark asked what I was doing. I informed him I was not leaving electronic devices inside his vehicle that was being towed. I informed him that they would be place into evidence for safe keeping and he could get them when he gets out of jail.

I removed Mark's Florida tag from his vehicle, per the seize tag order, which was later placed into the records bin.

I departed the interstate for the county jail, while Deputy Ortega waited for the tow truck. A tow sheet was provided to the tow truck driver, one was placed in Mark's property, and one was placed in records.

At the county jail Mark requested all three (3) of his cell phones be placed in his property at the jail.

During booking, I placed Mark's three (3) phones on the counter. While Mark was being booked, and his phones were on the counter, I observed messages from X, Instagram, and Tik Tok pop up on the screen. I queried NCIC/ FCIC and did not see those internet identifiers listed. Due to possible more failure to register crimes, I secured the phones and placed them into evidence.

I cited Mark for his tag lights and driving while license suspended, both tickets were placed into his property.

This investigation was captured on my body worn camera, and the dash camera of my patrol vehicle.

This investigation is cleared by arrest.

NARRATIVE

On November 14th 2025 at approximately 0836 Hours, I responded to the area of Granville Manor Rd in Vero Beach, in reference to a suspicious vehicle.

Multiple residents in the area called into Indian River County Dispatch and stated there was a tall white man driving a black Mercedes van around the neighborhood acting iritic. A homeowner confronted the man as he was trying to place items into their own parked vehicle. The homeowner asked the man what he was doing and he responded, "Because someone was reading my mind and they told me to do it." The man then got back into his van and drove further into the neighborhood.

I observed the van parked at the end Granville Manor and a white man seated in the driver's seat with the window down. I made contact with the man and identified him as Richard Walsh using the New York drivers license he provided.

Walsh was speaking incoherently and stated he was in the neighborhood to meet someone. Walsh was unsure on exactly where he was in Indian River County and stated he was waiting for his brother to call him to tell him where to go. Walsh's pupils were pin point, and didn't appear to react to any lighting. Walsh continued to explain that he had smoked some "Legal Marijuana" earlier in the morning. Walsh was also unsure on exactly what time it was as he was speaking with me, but stated he smoked the synthetic marijuana around 4am.

Walsh agreed to participate in standardized field sobriety tests (SFST) and I observed the following:

Horizontal Gaze Nystagmus Test

- -Lack of smooth pursuit
- Onset of nystagmus at maximum deviation

Walk and Turn Test

- -Lack of balance during instruction
- -Starts too soon
- -Misses heal to toe
- -Uses arms for balance
- -Improper Turn

One Leg Stand

- -Swaying
- -Using arms for balance

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 11/14/2025 On (Specifically include facts constituting cause for arrest.)

On November 14, 2025, at approximately 2058 hours, I was conducting traffic enforcement in my marked patrol vehicle at the 1300 Block of Sebastian Boulevard, Sebastian, Florida 32958. I observed several sedans pass by my patrol vehicle eastbound, which was parked in the center of the grass positive median of Sebastian Boulevard. I observed a large silver truck slow its speed and pull into the grass center median and next to my patrol vehicle. The male driver of the truck advised me that a silver Audi sedan that had just passed me was unable to maintain a single lane of travel and had almost struck his truck and several other vehicles.

Due to this information, I began to drive eastbound, canvassing for the silver Audi. As I approached the red light at Sebastian Boulevard and Roseland Road, I observed a silver Audi stopped in the left-hand turn lane of Sebastian Boulevard. I observed the silver Audi to be bearing Florida registration plate 65DDZN. When the traffic light turned green, I began to drive behind the silver Audi as it made the left turn onto Roseland Road. While traveling northbound on Roseland Road, I observed the silver Audi swerve within its lane of travel from the right side to the left. I then observed the silver Audi to cross over the double yellow center line as we passed the intersection of Fulton Way and Roseland Road. I observed the silver Audi make a left-hand turn onto Riviera Avenue. While traveling westbound, I observed the Silver Audi to be driving in the eastbound lane of travel. As we approached the intersection of Riviera Avenue and Blossom Drive, I observed the silver Audi drive past the stop sign while in the middle of both lanes of travel and stop in the middle of the intersection. I observed the silver Audi then made a right-hand turn onto Blossom Drive, and began to accelerate rapidly. I caught back up to the silver Audi and activated my emergency lights to conduct a traffic stop. The silver Audi made a right-hand turn into the driveway of

As I exited my patrol vehicle, the driver's side door of the silver Audi opened, and a white male began to exit. I gave the male verbal commands not to exit the vehicle, and he complied by sitting back down in the driver's seat, but leaving the driver's side front door open. As I approached the vehicle, I shone my flashlight into the rear back seat and observed a I then made contact with the white male. I requested the male's driver's license, current registration, and proof of insurance. The male provided me with his driver's license. The male picked up his cell phone and stated that his insurance was on it. When the male spoke, I observed the odor of alcoholic beverages emitting from his breath. I also observed the male's eyes to be watery and his speech to be slowed and slurred. While the male attempted to open his insurance app on his phone, I looked at his Florida-issued driver's license. I identified the driver as Joshua Matthew Oliver (Florida Driver's license number #0612569885000) While H attempting to open his insurance app, I began to speak to Joshua. Joshua stated the Joshua stated he had just picked up from residence or t should be known that this did not match where I first observed the silver Audi.

Joshua suddenly stopped looking for his insurance and opened the garage door to the residence. I advised Joshua to close it and that I needed to see his insurance and registration. Joshua stated he was locked out of his insurance app. When asked if he had a paper copy, Joshua stated no. I asked Joshua to provide me with his registration and then continue to attempt to open his insurance app. Joshua provided me with his current registration and continued to open his insurance app. When asked, Joshua stated he had not consumed any alcoholic beverages. But soon after, he spontaneously stated he was at the bowling alley. When asked again if he had consumed any alcoholic beverages, Joshua stated he had had two beers.

At this time, Officer Venegas #420 and Officer Smith #K959 arrived at the scene. Officer Venegas stood with Joshua's and I requested Joshua to step out of the vehicle. Joshua complied and exited the vehicle. I observed Joshua to be unable to walk straight, and he was uneasy on his feet. I observed Joshua to sway side to side as he walked. I asked Joshua if he would do field sobriety exercises. Joshua stated he would do the exercises.

For the horizontal gaze nystagmus exercise, I asked Joshua if he had any medical conditions that would hinder his eyes. Joshua stated no. I observed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus at maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes. I observed Joshua to be extremely unsteady on her feet, and Joshua had to be reminded three times not to move his head.

For the walk and turn exercise, I asked Joshua if the line in the middle of the road appeared to be straight and level. Joshua stated yes. I asked Joshua if he had any medical conditions that would hinder his walking. Joshua stated that his hip was hurting, but was unable to explain why. While explaining the starting position to Joshua, he was sawing side to side and stumbled out of the starting position. When Joshua started the exercise, he stated "one" but did not take a step. Joshua repetitively stepped onto his own toes after taking a step and stepped off line. Joshua made an improper turn. I explained and demonstrated the one-leg stand exercise to Joshua. Joshua stated he understood and did not need further explanation or demonstration. Joshua raised his foot and began counting. Joshua then placed his foot back onto the ground and had to be told to pick it back up and continue. Joshua then put his foot back down and again had to be told to pick it back up and continue. Joshua then began to lose his balance and had to use his arms and hop, not to put his foot down.

At this time, I placed Joshua under arrest and placed him into mechanical hand restraints, which were checked for proper fit and ensured to be double locked.

Joshua was transported to the Indian River County Jail. At the jail, Joshua consented to a breath test for Deputy Cazares.

NARRATIVE

On November 14, 2025, at approximately 2310 hours, I was sitting on Interstate 95 at approximately Mile Marker 150, facing south in the median, when I was passed by a gray sport utility vehicle (SUV) at a high rate of speed.

I pulled out onto I95 and began to proceed after the vehicle, the vehicle continued at a high-rate speed, weaving in and out of traffic. At approximately MM 149 southbound, Trooper Brady, with the Florida Highway Patrol, was stationary with his emergency lights activated conducting a traffic stop, when the aforementioned vehicle passed him at a high rate of speed, without slowing or moving over.

After passing Trooper Brady while he was conducting his traffic stop, the gray SUV crossed three lanes of traffic, without signaling, to the far-right lane, in an attempt to pass slower traffic in the left lane.

The gray SUV passed a semi-truck on the right that was traveling in the middle lane. When the gray SUV reached the front of the semi-truck, it went back across three lanes of traffic to the far-left lane, due to slower traffic in front of it. While conducting the above maneuver, the gray SUV pulled right in front of marked patrol car.

I slowed to let the gray SUV in front, when the slower traffic in front of the gray SUV moved to the center lane, I began to pace the gray Hyundai Tucson bearing Florida tag 09DEDJ, with my marked agency vehicle, which is speed odometer calibrated. The aforementioned vehicle reached 112 MPH for a short duration of time before I activated my emergency lights to conduct a traffic stop.

The gray SUV moved to the far-right lane to stop, as the vehicle was exiting the road to the shoulder, it locked up its breaks, causing the rear of the vehicle to slide to the right into the grass. When the rear tires caught traction, the rear of the vehicle jerked back left, coming to a stop.

I approached the driver's side of the vehicle, and made contact with the driver and sole occupant, Julian Ferro. I asked Julian to exit the vehicle and proceed to the front of my vehicle. At the front of my vehicle, I placed Julian in handcuff restraints and checked for proper fit, and had him sit on my front bumper.

I asked Julian if his identification was in his wallet, he advised it was. I retrieved an Australian Identification card. I asked Julian if he was an Australian citizen, he advised he was.

While I was sitting in my patrol car conducting an NCIC/ FCIC query of Julian, Trooper Brady pulled up. I-informed Trooper Brady that this was the individual that passed him during his traffic stop. Trooper Brady waited on scene with me until Deputy Lowell arrived to transport Julian to the county jail.

I contacted dispatch for the next rotation wrecker to tow the vehicle. Prior to the vehicle being towed, I began an inventory search. During my search, I located two (2) suit cases, and one (1) card board box, filled with high end leather vests, short, and jackets.

I asked Julian what he did for a living, at which point he told me, no comment.

Deputy Lowell transported Julian to the county jail, while I waited for the wrecker. I removed the two (2) suite cases, and one (1) card board box full of leather goods, and placed them in my patrol car.

Due to the route on the airline tickets on the suite cases, and Julian's direction of travel, I became suspicious of his

activities.

At the county jail, I contacted Deputy Ballester, who is a task force officer (TFO) with Immigration and Customs Enforcement (ICE). I informed Deputy Ballester that Julian had a US Visa, a China Visa, and an Indian Visa, which made me suspicious about the goods in the vehicle being counter fit. I asked Deputy Ballester to see if Julian paid duty for the aforementioned items in the vehicle, and what his purpose was inside the United States. Deputy Ballester said he would call me back, after checking the federal database.

Deputy Ballester informed me that after talking with ICE, Julian entered the United States through Los Angles approximately a month ago, with the purpose of visiting his husband, and he did not pay duty on the aforementioned items I removed from the vehicle. Deputy Ballester, also informed me that ICE informed him that Julian has criminal history in Australia. I asked for specifics on the history, but he advised he was not told.

Based on the fact that Julian was here to visit and not conduct business, and did not pay duty for the leather goods, the leather goods were seized as evidence pending further investigation.

It should be noted, no other items were located inside the vehicle besides the leather goods.

Julian tried to say he thought the odometer was in kilometers an hour, but based on Julian's two (2) visas in his passport for the United States, he has been traveling here for at least 7 years, and should be well aware of the difference, especially since his significant other is a US citizen.

Julian was charged with violation of Florida Statute 316.192(1)(A)- reckless driving, violation of Florida Statute 316.1922(1)(B)- dangerous excessive speeding, and violation of Florida Statute 316.126(1)(B)(1)- Failure to move over for emergency vehicle with lights activated.

This investigation was captured on my body worn camera, and the dash camera of my marked patrol car.

This investigation is cleared by arrest.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 11/15/2025 00:09 On

(Specifically include facts constituting cause for arrest.)

On 11/15/2025 at approximately 0009 hours, I conducted a traffic stop at the 1700 block of 23rd Street on a white GMC Yukon bearing Florida tag # IABX56. Prior to the traffic stop, I was stationary at Merrill Barber Bridge and Indian River Boulevard (facing southbound on the westbound side of Indian River Boulevard).

I was conducting laser speed enforcement for traffic traveling westbound on Merrill Barber Bridge. I did not point my laser at the aforementioned vehicle however; I did observe the vehicle's driving pattern to be concerning. The GMC Yukon made a left turn onto Indian River Boulevard from Merrill Barber Bridge and began traveling southbound on the right lane. The GMC Yukon failed to maintain its lane, swerving left to right and driving onto the bicycle lane. It should be noted that there was a bicyclist and several vehicles near the GMC Yukon at that time. Once I made that observation, I attempted to catch up to the vehicle and began traveling behind it at Royal Palm Boulevard (westbound). While traveling behind the GMC Yukon, the vehicle continued failing to maintain its lane of travel. The vehicle swerved to the left several times, where I observed the left side tires hoovering the vellow lines on the road and the vehicle straddling its lane. It should be noted that the Florida tag on the GMC Yukon was unreadable while traveling behind it.

Based on these observations, I conducted the traffic stop at the 1700 block of 23rd Street. I made contact with the driver (front driver side window). The driver/defendant was identified through her Florida drivers license as Melissa Lynn Donham-Smith (W/F DOB: 01/02/1977).

The defendant was advised of the reason for the traffic stop. The defendant denied having any medical issues and stated she was well. As I asked for her documents, the vehicle began slowly rolling forward and she had to be told to shift her vehicle into park mode. The defendant was unable to comprehend what was being asked of her and her front passenger had to interfere and help shift her vehicle from drive mode to park mode for her. While speaking with the defendant, I noticed a strong odor of an alcoholic beverage emanating from her mouth and person. I also noticed the Defendant had slurred speech, red, glossy, and watery eyes. Based on these observations I had reasonable suspicion to believe that the Defendant was impaired and requested that she exit the vehicle. The defendant appeared to have slight imbalance as she exited and walked towards the rear of her vehicle.

Based on these observations, I had reasonable suspicion to believe that the Defendant was impaired. The defendant continued speaking to me while outside of her vehicle, where she then stated she had consumed one beer (alcoholic beverage) at Riverside Cafe (3341 Bridge Plaza Drive). The defendant stated she had just left Riverside Cafe and was on her way to her residence (6150 13th St. SW Vero Beach, FL).

I then informed the Defendant that based on my observations, I had a concern that she might be impaired and that I would be conducting Standard Field Sobriety Exercises. I asked the Defendant if she had any disabilities or pain to which she denied. The defendant also denied taking any prescribed medication.

I then began the Standard Field Sobriety Exercises. Each exercise was demonstrated and explained to the Defendant prior to having her perform them and she stated that she understood them. The Defendant was given the option to keep her sandals on or remove them for the exercises. The Defendant took her sandals off.

On November 14th, 2025, at approximately 2334 hours, 1 observed a red 2018 GMC Terrain bearing Indiana tag 94500 traveling eastbound on Temple Avenue, Sebastian, Florida 32958. Upon conducting a query of this vehicle's tag via Sebastian Communications, I was advised the registration had been expired as of February 21st, 2021. Due to this, I attempted to conduct a traffic stop on the vehicle.

The vehicle in question made a left hand turn onto Louisiana Avenue. Once making a left the vehicle continued northbound on Louisiana Avenue; the vehicle began to slow down before approaching the intersection of Louisiana Avenue and Foster Road. At this time, I activated my emergency lights. The vehicle made a left hand turn onto Foster Road. After the vehicle made this turn, it quickly accelerated and began to drive at a high rate of speed, approximately 30 miles per hour. It should be noted, this is a one-way residential road. Based on previous training and experience, I determined the vehicle was not going to yield and this driving behavior was consistent with fleeing and eluding law enforcement. As a result, I repeatedly activated my emergency sirens along with my emergency lights. The vehicle proceeded to quickly make a sharp right hand turn into the front yard of 1025 Foster Road, which was a dead-end roundabout road. The vehicle began to make the turn around the roundabout, but abruptly came to a stop. Upon the vehicle coming to a stop, a white male approximately 6 feet in height, wearing a black shirt and shorts, exited from the driver seat and ran northbound on foot. I gave the male loud verbal commands to stop, however he ignored these commands and continued to flee on foot into the woods behind 1025 Foster Road. A white female also exited the vehicle from the front passenger seat. The female immediately put her hands up and was given commands at gunpoint which she complied with. The female was placed in mechanical restraints, and informed me the male driver who fled on foot was Dylan Hart. The female was secured in my patrol vehicle as I waited for additional units to arrive to safely clear the vehicle, K9 Officer Smith arrived on scene and we proceeded to clear the vehicle. No other occupants were located.

Upon clearing the vehicle, K9 Officer Smith deployed his K9 partner Ghost at approximately 2340 hours. At approximately 2347 hours, Ghost was able to track and locate the male suspect, who was hiding underneath bushes and branches deep into the woods. The male was given loud verbal commands to show his hands. These commands had to be repeated multiple times, _ however the male was ultimately placed into custody. The male was escorted back to the initial scene at this time.

The male was positively identified as Dylan Hart. It should be noted, I know Dylan Hart to have an invalid driver's license. Upon conducting a query of Dylan's name via ELVIS and Sebastian Communications, it was confirmed Dylan has no Florida license. This is in reference to multiple suspensions, which are the following:

Once Dylan was secured in the back of Officer Keiser's vehicle, I began to look into the vehicle Dylan was driving, which he had left the driver door open after fleeing on foot. Along the wall of the center console on the driver side, I observed in plain view the top of a glass bong with burnt residue. I identified this as a makeshift pipe/bong used to smoke/ingest methamphetamine. Based on this, as well as the vehicle ultimately being towed, a search of the vehicle was conducted.

During the search of the vehicle, I located a black case on the driver side floor board, where Dylan was seated. Upon opening this case, I located the following items:

A black scale containing trace amounts of white powder residue Approximately four pieces of tin foil containing burnt residue Multiple small plastic baggies utilized for packaging and storing illegal narcotics White rock like substance inside small plastic baggie, suspect crack cocaine White powdery substance inside small plastic baggie

Two small baggies containing brown powdery substance, which were both inside a small black container within the

A cut blue straw containing burnt reside on one end Two metal rods, commonly referred to as "push rods" Small baggie containing brown mushroom like substance

I also located another small, cut plastic straw containing burnt residue on the floor board of the driver's seat where Dylan was seated.

I was advised by K9 Officer Smith that Dylan informed him the keys for the vehicle were somewhere in the woods he fled in. Due to this, K9 Officer Smith deployed his K9 partner Ghost to conduct an article search. Upon doing so, I was advised by K9 Officer Smith that next to where the keys were located, there was a small black bag as well. Inside this bag, there was unused needles, as well as two more plastic straws which were cut and had burnt residue at the ends of them.

The undersigned certifies and swears that he she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 11/15/2025 02:54

(Specifically include facts constituting cause for arrest.)

On 11/15/2025 at approximately 0254 hours, I conducted a traffic stop at the 1300 block of Indian River Boulevard on a silver Acura bearing Florida tag # 66ATWI. Prior to the traffic stop, I was traveling behind the vehicle (right lane) near the 2000 block of Indian River Boulevard. While doing so, I observed the vehicle straddling its lane while occasionally swerving to the left and hoovering over the white separator lines. Upon approaching 17th Street and Indian River Boulevard, I observed the vehicle slowly swerving left, slightly entering the left lane. It should be noted that there was a vehicle on the left lane at that time. Once the silver Acura proceeded through the intersection (continuing southbound), I observed the vehicle swerve towards the right and onto the shoulder, then swerve back to the left.

Based on these observations, I activated my patrol lights at the 1500 block of Indian River Boulevard but the vehicle came to a stop at the 1300 block of Indian River Boulevard. I made contact with the driver (front driver side window). The driver/defendant was identified through his Florida drivers license as Plainson Poland Nelson III (B/M DOB: 11/14/1993).

The defendant was advised of the reason for the traffic stop. The defendant stated he was distracted due to being on the cell phone with his friend but later stated he had just left Riverside Cafe (3341 Bridge Plaza Drive). The defendant stated he was headed to his family members residence off 12th Street. The defendant stated he had some alcoholic beverages while at Riverside Cafe however, he did not elaborate further. As I asked for the defendant for the appropriate documents, I observed him attempt to retrieve his phone charger and plug it into his cell phone. While I observed him doing that, his body movement appeared to be slowed and lethargic, missing the charging port on his phone. The defendant remained with his head slightly lowered, looking towards his lap, and did not make much eye contact with me during our interaction.

While speaking with the defendant, I smelled a moderate odor of an alcoholic beverage emanating from his person. I also noticed the Defendant had mushed and mumbled speech, and glossy, watery eyes. Based on these observations, I had reasonable suspicion to believe that the Defendant was impaired and requested that he exit the vehicle.The defendant appeared to have slight imbalance as he exited and walked towards the rear of his vehicle.

I then informed the Defendant I had a concern that he might be impaired and that I would be conducting Standard Field Sobriety Exercises. I asked the Defendant if he had any disabilities or pain to which he denied. The defendant also denied taking any prescribed medication.

I then began the Standard Field Sobriety Exercises. Each exercise was demonstrated and explained to the Defendant prior to having him perform them and he stated that he understood them. The Defendant was given the option to keep his shoes on or remove them for the exercises. The Defendant took kept his shoes on.

It should be noted that I instructed the defendant to hold one end of the beige tape used for the Standard Field Sobriety Exercises while I placed the other end on the ground. The defendant was instructed not to place it down on the ground since I would be doing that for him but he disregarded my request and attempted to placed the tape down on the ground.

The results of the field sobriety exercises are as follows:

HGN (Horizontal Gaze Nystagmus)

- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes)
- Slight head movement when performing exercise
- Slight front to back swaying

NARRATIVE

On November 15, 2025, at approximately 0319 hours, I was patrolling the area of 800 US Highway 1, Vero Beach, Florida.

At that time, I witnessed a black sedan (bearing FL tag KJ229Y) traveling northbound on US Highway 1 in the right lane. While traveling northbound behind the vehicle, I witnessed the vehicle fail to maintain a single lane – the driver's side wheels crossed the dotted lines multiple times and the passenger side wheels crossed the solid white line multiple times. I subsequently conducted a traffic stop on the black sedan near 1700 US Highway 1, and the vehicle came to a stop near 2000 US Highway 1.

I then made contact with driver and front-seat passenger. The driver was identified as Mr. Calvin Barnes by his Floridaissued driver's license. The passenger was identified as Ms. Terricka Gray by her Florida-issued driver's license. While speaking with both parties, I could smell the odor of an alcoholic beverage, as well as marijuana emanating from within the vehicle.

After completing my investigation, Mr. Barnes was placed under arrest for the offense of DUI. I then had Ms. Gray exit the vehicle so it could be towed, since both occupants were intoxicated. I then advised Ms. Gray that she was free to leave so I could complete my investigation and search the vehicle; however, Ms. Gray continued to stand approximately 5 feet away from the vehicle. Ms. Gray was instructed numerous times to leave the area or move back 25 feet but she continued to refused to move. After being told numerous times to leave or move back 25 feet, Ms. Gray refused to comply and was placed under arrest for interfering my ability to perform my duties ("Halo Law").

She was placed into handcuffs that were checked for proper fit and double-locked. Ms. Gray was transported to the Indian River County Jail without incident.

I subsequently conducted a traffic stop on the black sedan near 1700 US Highway 1, and the vehicle came to a stop near 2000 US Highway 1.

I then made contact with driver and front-seat passenger. The driver was identified as Mr. Calvin Barnes by his Florida-issued driver's license. The passenger was identified as Ms. Terricka Gray by her Florida-issued driver's license. While speaking with both parties, I could smell the odor of an alcoholic beverage, as well as marijuana emanating from within the vehicle. While speaking with Mr. Barnes, he had red, water eyes. He also appeared lethargic and drowsy. Mr. Barnes advised he had consumed one "cup" of alcohol and pointed to a plastic cup in the cupholder. He also stated he had smoked weed recently.

Based on my observations, I requested Mr. Barnes exit the vehicle. Mr. Barnes initially did not want to exit the vehicle, but he eventually did so. While speaking with Mr. Barnes, I could smell the odor of an alcoholic beverage that grew as he continued to speak. I explained to Mr. Barnes that I was conducting a DUI investigation and requested he perform Standardized Field Sobriety Exercises (SFSEs), to which he stated he would complete them. During the medical questionnaire, Mr. Barnes stated he did not take any medications and did not have any medical problems.

The first exercise was the Horizontal Gaze Nystagmus exercise. I explained the instructions and Mr. Barnes stated he understood and did not have any questions. During the exercise, I observed a lack of smooth pursuit in both eyes, distinct and sustained nystagmus and maximum deviation in both eyes, and onset of nystagmus prior to 45 degrees in both eyes. I also observed a lack of convergence (LOC) with his right eye. During the exercise, Mr. Barnes was also swaying.

The next exercise was the Walk and Turn exercise. I explained the instructions and demonstrated the exercise. While explaining the instructions, Mr. Barnes was unable to keep his balance and stated he had "issues with [his] toes;" however, he would not elaborate. He then stated he understood the instructions. During the exercise, Mr. Barnes stepped off the line, took the wrong number of steps, stopped, made an improper turn, and missed heel-to-toe.

The third exercise was the One Leg Stand exercise. I explained the instructions and demonstrated the exercise; however, Mr. Barnes stated he was not going to be able to complete the exercise and stated he was shaking and nervous. During the exercise, Mr. Barnes did not hold his foot out correctly. He also put his foot down before the completing the exercise. He was also swaying.

The fourth exercise was the Modified Romberg exercise. I explained the instructions and Mr. Barnes stated he understood and did not have any questions. Mr. Barnes then advised he believed 30 seconds has elapsed after 14 seconds.

NARRATIVE

On November 15, 2025, at approximately 0510 hours, I was sitting on Interstate 95 at approximately Mile Marker 150, facing south in the median, when I was passed by a white sport utility vehicle (SUV) and a black sedan, that were side by side racing, at a high rate of speed. The black sedan tapped his breaks when he noticed my marked patrol car in the median. When I did not pull out immediately, the black sedan continued at a high rate of speed with the white SUV.

I pulled out onto I95 and began to proceed after the vehicles, I attempted to catch the vehicles, but they continued to pull away from me. It took me approximately eight (8) miles to catch up to the white SUV bearing Florida tag 40DVQU, which was doing 113 MPH with a blown out rear right tire.

I activated my emergency lights to initiate a traffic stop, and the vehicle pulled over. I approached the driver's side of the vehicle and made contact with the driver, Dieuner Innocent. I asked Dieuner to exit the vehicle and walk back to my patrol car. I informed the two (2) passengers, later identified by their Florida driver's license as, Stevenson Saint Fort and Djeson Pierre to remain in the vehicle.

I walked Dieuner to my patrol car and placed him in handcuff restraints, checked for proper fit, and placed him in the rear seat of my patrol car.

I walked back to the vehicle and detained Stevenson and Djeson in handcuff restraints, and had them sit on my front bumper, while conducted my traffic stop.

It should be noted, while taking Dieuner into custody, he did not realize the right rear tire of his vehicle had blown out and ripped the molding of the rear bumper off while he was racing.

I ran an NCIC/ FCIC query of all three individuals, during my query, I learned that Dieuner's Florida driver's license was suspended. After learning Stevenson and Djeson both had valid driver's license, I removed their handcuff restraints and asked if they could change the tire on the vehicle. They advised they could. I had the move the vehicle into the grass, so they were away from the road.

I transported Dieuner to the county jail. While driving to the county jail I advised Dieuner of his Miranda rights, which he advised he understood, and agreed to speak with me. I asked Dieuner why he was driving so fast. He stated he had to get home for work from a party he was at in Orlando. I asked him about the guy he was racing with, he advised he met him at the party, but did not know him that well. I stated to Dieuner, so you met this guy at the party, and when you left, you just decided to race home. Dieuner stated "Yes."

It should also be noted, that I believe if the right rear tire of the vehicle did not blow out from overheating, due to such high speeds, forcing Dieuner to slow to a mere 113 MPH, I don't believe I would have caught up to him.

Dieuner was charged with violation of Florida Statute 316.191(2)(A)- Racing on Highway, violation of Florida Statute 316.1922(1)(B)- Dangerous Excessive speeding, and violation of Florida Statute 322.34(1)- Unknowingly DWLSR.

This investigation was captured on my body worn camera, and the dash camera of my patrol car.

This investigation is cleared by arrest.

NARRATIVE

On Saturday, November 15th, 2025, at approximately 0728 hours, I was conducting speed enforcement around the 9800 block of State Road 60. While traveling westbound, I observed a newer-model white Honda Civic traveling eastbound at a high rate of speed. I estimated the vehicle's speed to be approximately 110 miles per hour; my calibrated Stalker DSR 2X radar indicated a speed of 106 miles per hour, with a clear and consistent Doppler tone. It is important to note that the posted speed limit for eastbound traffic is 45 miles per hour. As the vehicle passed me, it was in the right lane and dangerously approached another vehicle in the same lane, and made an improper lane change without signaling, to avoid a collision with the other vehicle. I initiated a traffic stop near the 9400 block of State Road 60. Upon making contact with the driver, who was identified through a Colombian passport as Ferney Pulido Cuervo, I instructed him to exit the vehicle and explained the reason for the traffic stop. I advised him that he was being detained for traveling 61 miles per hour over the posted speed limit. The driver was subsequently handcuffed and placed in the rear of my patrol vehicle.

Further inquiry revealed that Mr. Pulido Cuervo did not possess a valid driver's license. I contacted dispatch to conduct a warrants check using his name and date of birth; they confirmed that no record of a Florida driver's license or any other state's license was associated with him.

Based on the facts and statements presented Ferney is violation of FSS. 316.1922.(1)(A) Dangerous Excessive Speeding – 50mph or more and FSS. 322.03(1) No Valid – Never Issued. Ferney was transported to the Indian River County Jail without issue.

NARRATIVE

On November 15th, 2025, at 2025 hours, I conducted a traffic stop on a maroon Chevy sedan bearing FL/ M2BUR, at 4565 33rd Avenue for running a stop sign at the intersection of 46th Street and 33rd Avenue. After activating my emergency lights, I observed the driver of the aforementioned vehicle, exit the vehicle from the driver side front door, and flee westbound and then southbound behind 4555 33rd Avenue. The driver continued to run south behind 4541 33rd Ave and 4535 33rd Ave, before cutting through the empty lot located at 4525 33rd Ave, and continued southeast, out onto 33rd Avenue; where Deputy Henry and myself were able to safely detained him without further incident. After securing the driver, I positively identified him as Robert Omie Green Jr. DOB: 07/02/1991; and placed him in the rear passenger compartment of my marked agency issued patrol vehicle.

After securing Green, I advised him of his Miranda Rights too which he expressed his understanding of his rights, and agreed to speak with me. Post Miranda, Green advised he was not running from law enforcement but instead, he was "messing" with bystanders that were standing outside 4555 33rd Avenue. Green stated he did not know he was being pulled over and that the emergency lights from my patrol vehicle had scared him.

After questioning Green, Deputy Wolf walked his K9 partner around the exterior of the suspect vehicle, resulting in a positive alert for the odor of narcotics. Deputy Henry and myself then began searching the interior of the suspect vehicle. After opening the driver door of the suspect vehicle, I immediately located a hand rolled, partially burnt, brown in color cigarette that I suspected to contain Marijuana (commonly referred to as a joint). After unrolling the cigarette, I observed the cigarette to contain a green leafy substance which later field tested positive for the presence of THC, (loose marijuana).

After searching the entire passenger compartment of the suspect vehicle, Deputy Henry and myself then began searching the trunk of the suspect vehicle. While searching through the trunk, I located a white and multicolored shoe containing a small clear plastic bag, with blue pills inside of the bag. After closer observation, I observed the round blue pills to have "A | 51" stamped on one side of the pill. I then utilized Drugs.com pill identifier and was able to positively identify the pills as CSA Schedule 2, Oxycodone Hydrochloride 30mg (prescription only, National Drug Code 65162-0051).

After identifying the pills, I questioned Green if he had any knowledge of the medication that was located inside of one of his shoes in the trunk of his car. Green denied knowledge and ownership of the RX medication. After collecting the evidence, I transported Green to the Indian River County Jail without incident.

NARRATIVE

On November 16, 2025, at approximately 0331 hours, I was on Interstate 95 just south of Mile Marker 154 northbound, assisting the Florida Highway Patrol with traffic control, due to a vehicle crash.

There was a Road Ranger vehicle with his yellow lights activated along with traffic cones and road flares channeling traffic to the far-right lane approximately 300 feet behind the crash scene. Road Rangers and Tow Truck crews were actively sweeping debris from the middle lane.

There were seven (7) marked patrol cars (3 Deputies, 2 FHP, 2 Fellsmere), a Tow Truck, and an ambulance with their emergency lights activated on scene approximately 100 feet in front of the safety barrier provided by the road rangers cones and flares. Myself, along with the other law enforcement officers on scene were spread out in between the crews sweeping the debris to protect them from vehicles traveling past the crash scene.

While cleanup operations were being conducted, a gray sedan passed through the scene at a high rate of speed. Myself and Trooper Brady, who was working the crash, ran to our vehicles and went after the gray sedan. Trooper Brady was able to reach the gray Hyundai bearing New Jersey tag K71SLN, at Mile Marker 156 northbound and conduct a traffic stop on the aforementioned vehicle.

Trooper Brady and I made contact with the driver identified by his Florida driver's license as, Chaim Brief. Trooper Brady asked for Chaim's required documents. We returned to Trooper Brady's vehicle, where he began to conduct checks of Chaim's identification. Trooper Brady advised that due to working the crash scene, he would not be able to arrest Chaim. I informed Trooper Brady I would assume the traffic stop and conduct the arrest.

I approached Chaim's vehicle asked him to exit and placed him in handcuff restraints, and checked for proper fit. Trooper Brady informed the two passengers to remain in the vehicle. After I conducted a search of Chaim, I placed him in the rear of my patrol vehicle.

Trooper Brady stayed with the vehicle and passengers to check their license to see if they could operate the vehicle, while I transported Chaim to the county jail.

It should be noted, Trooper Brady's radar was not activated at the beginning due to him working the crash scene. By the time he activated it, Chaim had already begun to slow down because he saw us approaching with our emergency lights activated. As you can see by the time stamp on my in-car camera, and the distance covered prior to the traffic stop, Chaim was traveling faster than 78 MPH.

At the county jail I discovered that Chaim had two (2) valid New Jersey Driver's license, and two (2) valid Florida driver's license in his wallet.

Chaim was charged with violation of Florida Statute 316.192(1)(A)- reckless driving, violation of Florida Statute 316.183(2)- highway unlawful speed, violation of Florida Statute 316.126(1)(B)(1)- Failure to move over for emergency vehicle with lights activated, or slow 20 MPH below posted speed limit, and violation of Florida Statute 322.03(1)- possess more than one (1) valid Florida Driver license.

This investigation was captured on my body worn camera, and the dash camera of my marked patrol car.
