

NARRATIVE

On 03/17/2024 at 19:40 I was dispatched to the Indian River County Jail in reference to inmate, Wayne E. Schneider not providing a DNA sample as required by Florida State Statute when arrested for a felony offense.

On 03/17/2024, at 15:36, Sebastian Police Department arrest Mr. Schneider for Domestic Violence, Battery on a person 65 years of age or older, and was transported to the Indian Rive County Jail under Sebastian PD Case Number 2024-0418.

Booking staff repeatedly asked Mr. Schneider for a DNA swab, which he continued to refuse. They also advised him he would not be released until he provides a DNA swab. Given his persistent refusal, booking staff asked for the assistance of a law enforcement Deputy Sheriff to assist.

Upon my arrival, they advised me of the situation, and walked me over to his cell. I asked him to provide a DNA sample as required by Florida State Statute and his refusal would result him in getting an additional charge. He stated that he did not care if he got an additional charge and that his arrest, and the DNA request were unconstitutional.

Due to Mr. Schneider's DNA refusal, he is in violation of F.S.S. 943.325(15), REFUSAL TO PROVIDE DNA SAMPLE.

NARRATIVE

On Sunday, March 17th 2024 at approximately 2314 hours, I responded to [REDACTED] in reference to a domestic disturbance.

Upon arrival, I spoke with the caller, Jacqueline Rubin who was in tears and distraught. She stated her son Erick Rubin is highly intoxicated and on some type of sleeping drugs. Erick came into the house and told Jacqueline "I'm having a woman come inside, be quiet or I will hurt you. When he said that he put his hand to his ear and stated "did you hear me, I thought so" Jacqueline then got off the couch in fear and went into her bedroom with Erick's father, Michael Rubin and locked the door. While in the room, they heard Erick yelling and slamming the door as if he was talking to someone. He was saying come here or I will kick your ass, but they don't believe there was anyone else in the house. The believe he was hallucinating. Erick bean to punch the walls and Michael said he heard things breaking in the garage. Erick then came to the door and started to scream while banging on the door very hard. Erick stated "When I get inside the room, I'm going to kill you".

Michael stated he was sure he was going to break the door down by how hard he was kicking and banging on the door with his fists. In fear, Erick was going to make entry into the room, Michael armed himself with his pistol as Jaqueline [REDACTED] Michael also stated that if Eric kicked the door down, he was going to overpower Michael, take his gun away, and kill them both.

Jaqueline stated Erick heard her [REDACTED] and stopped and went outside and that's when law enforcement arrived. I asked Michael and Jacqueline separately if they were in fear that Erick was able to get into the room and cause great bodily harm or death and they both stated yes. When explained the process on how a no contact order works, Michael stated he will not listen to the court and he is in great fear that Erick will come to the house and kill them. Michael also stated he will be going to the court house tomorrow in file for eviction on Erick. Erick lives at the aforementioned residence with his parents as a family.

I observed a key holder in the garage to be broken and shattered in the garage and also a fist size hole in the hallway leading to Erick's bedroom.

Erick was read his Miranda Warnings but was so intoxicated he kept saying "I don't understand blah blah blah" when repeated if he understood he stated I don't understand blah blah blah".

I listened to the [REDACTED] and she stated the following: The police were here last night, if they come and dont do anything tonight and they leave we will be hurt, I am telling you". I could hear banging on the door as she was calling in.

At that time, Erick was transported to the Indian River County Jail for 2 counts of violence, F.S.S inetent threat to do violence, F.S.S 784.011.1.

NARRATIVE

On the morning of 03/16/24, I responded to the 2600 block of 1st Street in reference to conducting a DUI investigation. Upon my arrival I made contact with Sgt. Joanna Fricke. She informed me she observed a vehicle stopped at the stop sign while facing westbound on 1st Street at 27th Avenue. She advised she waited to see if the vehicle would move however it continued to sit there for an extended time. She told me as she approached the vehicle she observed a subject in the driver's seat slumped forward as if they were asleep. Upon approaching the vehicle's driver side door, according to Sgt. Fricke she observed the vehicle was still running with the transmission in park. There was a white female later identified as the defendant sitting in the driver's seat asleep. There was also a [REDACTED] asleep in the passenger seat.

I then approached the driver's door of the vehicle where I observed the defendant still in the driver's seat. She was talking on the phone, she appeared to be in an agitated state. I asked her how much she had to drink and she stated "couple beers and shots of Fireball." As she exited the vehicle upon my request, I observed an open beer can (Natural Ice) in the cup holder and an open bottle of Fire Ball whiskey in the driver's door. I also observed what appeared to be vomit between the driver's seat and door. I asked the defendant to walk to the front of my patrol vehicle during which time I observed that she was unsteady while walking. Once in front of my patrol vehicle I asked the defendant if she would be willing to perform a series of Standardized Field Sobriety Exercises (SFSE's) to which she agreed to. While speaking with the defendant I observed a mild odor of an alcoholic beverage emitting from her person and breath.

I began with the Horizontal Gaze Nystagmus. I checked for equal pupil size which they were and appeared to be constricted approximately 2.5mm, there was no resting nystagmus present and she was able to track the stimulus equally. I then checked for the lack of smooth pursuit which was present in both eyes. I observed the distinct and sustained nystagmus at maximum deviation in both eyes, there was also the onset of nystagmus prior to forty-five degrees (approximate forty degrees) in both eyes. There was no vertical nystagmus or lack of convergence.

I then explained and demonstrated the walk and turn exercise to which she stated she understood. The defendant asked to remove her shoes prior to performing the exercise. She had difficulty maintaining her balance during the instruction phase and raised her arms. While walking, she missed heel to toe on several steps while raising her arms for balance. She lost her balance while turning around improperly. She again missed heel to toe on several steps and raised her arms for balance. She took ten steps back instead of nine as instructed.

The next exercise I explained and demonstrated was the one leg stand which she stated she understood. During my instructions, the defendant spontaneously uttered "I can't even do this when I'm (paused) not drinking." She failed to keep her hands at her sides throughout the exercise, she was observed swaying, and she put her foot down numerous times before being told to do so.

The final exercise I explained and demonstrated was the finger to nose which she stated she understood. She failed to keep her head tilted back, she missed the tip of her nose on each attempt and had to search with her finger to find it.

Based upon my observations as well as her performance of the SFSE's I placed the defendant under arrest for DUI and Child Abuse. She was transported to the Indian River County Jail where we were met by Corrections Deputy J. Hiss who requested her to submit to a chemical breath test to determine her breath alcohol content. She submitted two breath samples and the results were .08% and .07% BrAC. She was then advised of her Miranda Rights which she invoked. She was further processed and held in lieu of first appearance.

On Saturday, March 16, 2024 at 1348 hours, I responded to the area of WaWa located at 1180 US Highway 1 in reference to a report of lewd behavior involving a male and female on the sidewalk.

On arrival, I was flagged down by a separate motorist who advised a male and female appeared to be having sexual intercourse on the East side of US Highway 1 in front of Popeyes, 1110 US Highway 1.

Given this information, I moved to the side walk in front of WaWa and was able to identify (2) subjects in the grass further South. On my arrival to the area of 1110 US Highway 1, I parked in the parking lot to allow me to approach on foot. As looked over the bushes onto the sidewalk, I observed a black male on top of a white female kissing. The male had his pants down and was seen making a thrusting motion while on top of the female. As I identified myself as the Sheriff's Office, The male was instructed to stand at which point the male and the female were observed adjusting there shorts. The male appeared flustered and was unable to fully pull his shorts up which left his penis fully exposed to oncoming traffic. I placed the Male in hand restraints and seated him on the ground. The female later identified as April Marie White, became verbally aggressive making comments that she did nothing wrong. April was advised to place her hands behind her back to which she initially complied but then began pulling away from me while shouting "Faggot". I gave April multiple commands to stop pulling away however she continued and kept turning her body to shout obscenities in my face. I attempted to escort April up toward my Patrol vehicle when she pulled away again. At this time, I escorted April to the ground in a grassy area and gave her verbal commands to remain in the prone position until assisting Units arrived. While attempting to detain April, I could detect a strong odor of an alcoholic beverage emitting from her breath. In addition, I discovered (4) empty bottles of "Vodka" and one full unopened bottle of rum next to them on the ground.

I made contact with the caller by phone who explained to me in a sworn statement that he was traveling North on US Highway 1 in the far right lane closest to the side walk. As he traveled North in traffic, he observed the black male on top of the female and stated he did a "double take" because he couldn't believe what he was seeing. The caller advised the female had her legs spread open and the male was "inserting his fingers" inside the female in full view of traffic.

Based on my observations and the witness statement, I determined April was in violation of FSS 800.03.1(a) exposure of sexual organs, FSS 843.02 Resisting arrest without violence and FSS 856.011 Disorderly intoxication.

D/S Barrientos who was assisting, transported April separately to the County Jail due to her behavior. April was assessed by a Nurse and Jail staff who administered a portable breath test to determine level of intoxication for treatment and identified her breath sample to be at .088.





NARRATIVE

On Saturday, March 16th, 2024 at approximately 2038 hours I was conducting stationary traffic enforcement at Highland Avenue / 16th Street. My patrol vehicle was parked on the south side of the roadway facing east. I observed a black 2002 Honda Civic bearing FL Tag #CK7807 driving from the parking lot of 1238 16th Street, Filthy's Fine Cocktails & Beer, towards the stop sign the leads onto 16th Street. I observed the Honda make no attempt to stop and run the stop sign and turn west onto 16th Street.

I conducted a traffic stop on the vehicle at the 1300 block of Old Dixie Hwy. I made contact with the driver and sole occupant of the vehicle Rodrigo F. Duran Jauregui. While speaking with Rodrigo I could smell the odor of an alcoholic beverage emitting from the vehicle. Rodrigo had bloodshot and watery eyes. I advised Rodrigo for the reason for the traffic stop and asked if he saw the stop sign, he stated, "Honestly, I didn't see, I'm gonna be honest". I again asked if he saw the stop sign, he stated, "No I did, but you know, I'm sorry I apologize". Rodrigo advised that he was never inside of the bar and that he was just driving through the parking lot. I asked Rodrigo if he consumed any alcoholic beverages tonight, he initially stated no. I asked him if he consumed any earlier this evening and he stated that he had a single beer while at the fair.

I requested Rodrigo exit his vehicle. While speaking with Rodrigo outside and away from the interior of the vehicle I could smell the odor of an alcoholic beverage emitting from his breath. Rodrigo stated that he took [REDACTED] earlier in the day and that while at the fair he was sipping on a water bottle that contained liquor. I asked Rodrigo if he was a diabetic or epileptic, he stated that he was not. Rodrigo was wearing glasses at the time. I asked Rodrigo if he had any physical defects, he stated that he has [REDACTED]. I asked Rodrigo if he would submit to the field sobriety exercises, he asked if he could get a ride home. I again asked him if he would submit to the field sobriety exercises and he verbally stated that he would.

Prior to beginning the exercises Rodrigo stated that he does not have good balance. I asked him if he wanted to wear his brace and he stated that he would. I allowed him to wear the brace prior to beginning any exercises.

-During his first attempt with his glasses off I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and I observed Nystagmus prior to 45 degrees in both eyes. I did not observe vertical gaze Nystagmus (VGN).

-During his second attempt with his glasses on I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and I observed Nystagmus prior to 45 degrees in both eyes. I did not observe vertical gaze Nystagmus (VGN).

The second exercise I demonstrated and explained was the Modified Romberg Balance.

While Rita was removing the mat from the window Wendy's daughter, Lyric Qualia, tells Rita to stop. I could identify Rita in the video from previous interactions with Rita.

Lyrics room had been previously the homes living room. However, the former living room had been converted into a bed room. The bedroom had a black sliding panel that ran the entire length of the entry way. When Rita entered the bedroom, she stepped over the black sliding panel. I then asked Wendy how much she had paid for the yoga mat. Wendy stated that she had paid \$60. I asked Wendy if Rita was related to Lyric due to them having the same last name. Wendy informed me that Rita used to be married to her husband and was not related to Lyric. However, Rita did rent a room in the home.

I was informed by the Indian River County Dispatch Center that Rita was trying to make a complaint at the Vero Beach Police Department. I made contact with Rita. Rita was read her Miranda Rights from an agency issued card. Rita acknowledged her Miranda Rights and chose to speak with law enforcement. Rita was wearing the same clothing as the Rita was wearing in the video. Rita also had the red yoga mat in her possession. Rita then informed me that she was at the Vero Beach Police Department to inform law enforcement [REDACTED] I informed Rita that I was there because of the stolen yoga mat. Rita then stated that the [REDACTED] that she wanted to report was over the yoga mat being dirty.

I informed Rita that even though the yoga mat was dirty it did not give her the right to enter someone else's room and take something that did not belong to her. Rita stated that she had been aloud there in the past and that it used to be the living room. I then informed Rita that Wendy told me that she had made it clear that you were not aloud in Lyric's bedroom. Rita acknowledged that she had been told to stay out of Lyric's room. I then told Rita that I had observed Lyric's room and that it contained nothing but children's belonging including a bed. The only item that looked like it did not belong to the child was an exercise machine. Rita then acknowledged that it was Lyrics room. I then asked Rita again if she knew that she was not suppose to be in Lyric's bedroom. Rita stated that she was aware.

Rita was then taken into custody and transported to the Indian River County Jail without further incident.




On Friday March 15, 2024 at approximately 1130 hours Ofc Smith responded to Walgreens located at 999 Sebastian Blvd, Indian River, Florida in reference to a shoplifting that had occurred approximately an hour earlier.

Indian River County Sheriff's Office was also investigating a shoplifting at the Walgreens in their jurisdiction, located at Roseland Road and US Highway 1 involving the same suspect and vehicle. IRCISO was able to pass along that the suspect was a black male amputee driving a black SUV and had a partial tag based on video from the store.

Ofc Smith arrived on scene at 999 Sebastian Blvd and met with store manager Junior Archil, who told him that there was a black male amputee in the store who stole multiple vitamin items. Junior described the male as a black male in his 50's wearing a red shirt and using a scooter due to a missing leg. Junior noticed the subject in the store, but was not aware of him stealing the vitamins until later, when he was alerted by the store manager at Roseland and US1. Junior then reviewed the video in his store and confirmed the male put numerous bottles of vitamins in a small bag attached to the front of his scooter. After doing so the male went and purchased headphones for \$4.99, which was the only item he paid for. The cashier at the time said the door alarms went off when he exited, but she did not think it was out of the ordinary.

Ofc Smith reviewed video surveillance and was able to see that a middle aged black male in a red shirt rolled into the store on his scooter. He went to the area of the vitamins and although facing away from the camera, you could see that he took numerous bottles off the shelf, put his right hand in front of him with the items in it and then reached back up with empty hand. This would make it likely that the male placed the vitamins in the bag that was attached to the front of his scooter. He did this several times, which would also indicate that he took multiple items.

Junior then compared the video of the items the male selected with the store's inventory and made a list of the actual amount of items the male took. This totaled \$407.93.

While Ofc Smith was investigating this call, IRCISO had obtained a full license plate (FL BP55ID) and was able to conduct a traffic stop on the vehicle. The driver was the same male who is seen on the video from both stores stealing items from the store. Due to the location of the traffic stop and the length of time needed to complete the investigation, it was turned over to your affiant who responded to interview the suspect.

Once on scene of the Sheriff's office traffic stop, I made contact with Deputies who had already spoken to the Defendant (identified via Florida ID card as Charles Dorsey Jr.). The Defendant was wearing similar clothing as in the description provided to me by Ofc Smith. The Defendant had been read his Miranda Warning by Deputy Patrick Ayers. Upon speaking with Dorsey, I reminded him that the Miranda Warnings read to him by Dep Ayers was still in effect and he advised he understood. Post Miranda, the Defendant confirmed he had taken several of the items from the Walgreens and hid them in plastic Walgreens' bags located in the back seat of the vehicle. Upon search of the vehicle, Dep Ayers located three plastic bags containing numerous items. Of the items located in the bags, I located 5 of the 7 items that had been reported stolen (Vitamins x 3 and First-Aid creams x2). The total of the items located was \$259.95. When asked, the Defendant advised he had taken the items because he needed them to assist with his medical conditions. When asked about the missing items, the Defendant advised he had taken some items from the shelf but had placed them elsewhere in the store prior to exiting, as he did not need them.

It should be noted the Defendant was cooperative and open regarding this incident and made no attempts to conceal his actions.

The Defendant was taken into custody by the IRCISO and transported to the jail. I meet with the Defendant and staff at the jail and completed the arrest affidavit for this incident.

On 03/15/24 at 1128 hours, I, Officer Willis #467 responded to [REDACTED] in reference to a past disturbance.

On scene, I made contact with Mary C. Abizaid Bowman (victim). Bowman stated she got into a verbal argument with her boyfriend, John Esposito (defendant), about relationship issues. Bowman said she told him that she was going to break up with Esposito and was going to remove his clothes from her bedroom. She stated as she was walking down the hallway towards her bedroom, Esposito came up behind her and put a kitchen trash bag over her head. He then started choking her with his hands. Bowman said she was choking and felt the plastic bag go inside her nostrils as she tried to breathe. She tried to rip off the plastic trash bag off her face because she couldn't breathe. Bowman also tried to swing backwards to hit Esposito to get him off of her. At this time, Esposito let go of her and got into his white Lincoln truck, bearing FL tag #87BIHV, and drove away from the residence.

Bowman stated she and Esposito have been in a boyfriend/ girlfriend relationship for approximately one year and that no one else lived with them. She advised that she and Esposito were the only ones inside the house when she was attacked by Esposito.

Bowman also mentioned that she texted Esposito after he left and I observed the following text messages from Bowman:

"You came up behind me - I was in front going to MY ROOM and you wrapped a plastic bag around my head and choked my neck."

"My neck really hurts where you squeezed Like ... how is that ok in your world?? And trying to put blame on me for that action. And what if I couldn't tear the plastic open? You wrapped it around my head I felt the horrible panic of the plastic in my nose when I took a breath."

Esposito tried to call Bowman while I was on scene and she did not want to answer the phone. She became fearful to the point where she began shaking and crying. We notified dispatch and requested an IRCISO Victim's Advocate to respond to the scene.

Bowman said her neck hurt and refused to be treated by EMS. I observed slight redness around her neck and a small scrape on her left forearm.

Cpl. J. Brumley #415 photographed the scene, Bowman's injuries, and I later placed the photographs into the Evidence Library as evidence. Lindy Coleman (IRCISO Victim's Advocate) responded to the scene and provided Bowman victim services.

Myself and Cpl. J. Brumley remained in the 1600 block of 25th Ave while Bowman gathered her belongings and left the residence. Bowman provided us a photograph of Esposito in case we came across him for questioning.

At approximately 1317 hours, a white male returned to the residence to pick up his motorcycle. I asked him if he was John Esposito in which he replied "yes." I placed him into handcuffs and Cpl. J. Brumley advised him of his Miranda Warnings in which he agreed to make a statement.

Post Miranda, Esposito stated that he was arguing with Bowman about their relationship issues. He advised that he pointed his finger in her face and told her that he was going to grab his belongings. Esposito said at this time, Bowman tried to bite his finger, but never touched him. He also said that Bowman was throwing out his personal items outside the house because they were going to break up. Esposito stated he grabbed his belongings and left in his white Lincoln truck.

I advised Esposito that Bowman claimed that he put a plastic bag over her head and choked her. He did not have a response and avoided my question.

I arrested Esposito for Battery by Strangulation (Domestic Violence) and transported him to the Indian River County Jail for booking procedures.

A Domestic Violence packet was completed.

The incident and arrest did occur in the city limits of Vero Beach, FL.





On 3/17/2024 at approximately 1528 hrs a disturbance call for service was reported at _____

Shirley Schneider (83 years old) _____ reporting that she was involved in a physical disturbance with her son, Wayne Schneider. She reported that Wayne threw a bottle at her then exited the residence going behind the residence.

At approximately 1534 hrs Sgt. Richard of the Sebastian Police Department encountered Wayne sitting on the ground in the back yard of the residence. Upon making contact Wayne was verbally confrontational and obviously agitated. Wayne began trying to stand up. Sgt. Richard ordered him to remain seated. Wayne disobeyed the order and Sgt. Richard was obligated to grab Wayne by the arm. Wayne pulled his arm trying to break free from Sgt. Richard's control. Sgt. Richard was able to restrain Wayne on the ground and place him into hand cuffs.

I (your Affiant) arrived on scene at approximately 1537 hrs and observed Sgt. Richard holding Wayne in an upright position seated on the ground. I then made contact with the victim Shirley Schneider who stated the following: her son Wayne resides with her at _____ as a member of her family. Prior to calling police she was speaking with Wayne about where the pressure washer was located because she could not find it. At that time Wayne went off on her throwing water at her while she stood near the doorway to his bedroom. Wayne yelled at her as he threw the water. The water contacted her as a result of him throwing it at her. She suspected that he was using drugs.

I observed the front of Shirley's shirt was wet along with the door located behind her at the time of the disturbance. I attempted to interview Wayne and he invoked his right to remain silent and have counsel present. Wayne's behavior continued to be loud and confrontational when he was moved into the back seat of my patrol vehicle. Wayne shouted that he was in pain but refused any medical attention. There were no obvious signs of injury.

Upon arrival at the Indian River County Jail Wayne complained of stomach pain and not being able to stand. Wayne laid himself down seemed to be breathing erratically and shaking his head. I held him in the recovery position and ensured that he did not injure himself. When asked he was unable to state any specifics regarding his alleged medical condition. The medical staff at the Indian River County Jail declined to accept custody of Wayne without first being medically cleared at the hospital. Indian River County Emergency Medical Service (Rescue 3 Run#2024-7732) responded to the jail and transported Wayne to the Cleveland Clinic for medical clearance.


Upon arriving to the emergency room, Wayne declined to cooperate with medical staff continuously invoking his Fifth Amendment rights. Wayne was seen and given medical clearance to go the jail.

I returned Wayne to the Indian River County Jail and he was turned over to their custody without incident.
