NARRATIVE

On Wednesday, April 15 2026 at approximately 2301 hours, I conducted a traffic enforcement stop on a red Nissan Sentra (FL / Z065HH) in the parking lot of Publix located at 9621 US Highway 1 in Vero Beach, Florida.

While traveling North on US Highway 1, I observed a vehicle traveling South at a high rate of speed. I could see the vehicle lights moving in a side-to-side motion. I estimated the vehicle to be traveling at 80 miles per hour. I activated my installed radar and selected the front antennae in the opposite direction. I captured the vehicles speed at 83 miles per hour in a posted 50 mile per hour zone.

I turn around and attempted to catch up to the vehicle. I switched modes and continued to get a speed measurement of 79 miles per hour. The vehicle continued to fail to drive within a single lane and traveled across multiple lanes of travel. The vehicle also made several erratic lane changes. As the vehicle approached Barber Street, the light was red and the vehicle was still traveling well above the posted speed limit. The vehicle made a wide right turn onto Barber Street and turned into the oncoming lanes of traffic. The vehicle then abruptly crossed over the center median.

I initiated my emergency lights and siren and the vehicle yielded in the Publix parking lot. The driver immediately attempted to exit the vehicle. I gave the driver clear explicit directions to stay inside the vehicle which he refused and he continued to exit the vehicle.

He leaned onto his vehicle for support after he exited. When I asked him for his driver's license, he initially attempted to hand me his red bank debit card. I then clarified I needed his driver's license and he handed me his license along with a random gift card.

I identified the driver, and sole occupant of the vehicle as Mr. Christopher Holloway by the Florida driver's license he provided me. I immediately smelled the distinct odor of an alcoholic beverage emitting from his breath as he spoke. His eyes were watery and glassy.

As he spoke, Mr. Holloway had extreme difficulty putting together complete sentences. When I asked why he was driving like that he stated "Your good though!" I asked Mr. Holloway where he was coming from and he stated he was coming from his friends' house, and further stated his friend lives on Barber Street.

Mr. Holloway's demeanor was reserved, as he continued to lean against his car with his arms crossed. I asked Mr. Holloway how much alcohol he had and he provided an incomplete sentence multiple times. Mr. Holloway denied speeding, driving on the wrong side of the road but acknowledged driving on the median.

Mr. Holloway attempted to tell me he lived off of barber street several times before being able to form a

complete sentence. Mr. Holloway then stated he lived on Barber Street off Sebastian and tried to state he was good to drive home.

When I handed Mr. Holloway back the gift card, he handed me, He stated he handed it to me and stated "But, just in case, because you the police, I'm going to check you!"

Based on the above driving pattern and observed indicators of impairment, I requested Mr. Holloway complete Standard Field Sobriety Exercises (SFSE's). Mr. Holloway refused and stated "No! I decline all those." Mr. Holloway was placed under arrest for Driving under the influence and secured in handcuffs. I explained to Mr. Holloway that his refusal could be used against him in court in accordance with Taylor v. State and he still refused.

During an inventory search of Mr. Holloway's vehicle, I observed a Styrofoam to-go style cup with a plastic lid and straw. The cup was still cold and smelled of an alcoholic beverage and was located on the passenger floorboard. I also found marijuana in a clear Ziploc bag located in the center console area as well as a rolled marijuana cigarette.

The bag of marijuana field tested presumptive positive and weighed 5.68 grams.

A query of Mr. Holloway's D.A.V.I.D. revealed a prior DUI charge from Brevard County in January of 2026. I contacted Brevard County Sheriff's Office Teletype Unit and confirmed Mr. Holloway is currently on bond from Brevard County case 05-2026-CT-011289-AXXX-BC for Driving Under the Influence and Refusal to Submit to DUI testing.

Mr. Holloway was transported to the Indian River County Jail complex. Upon arrival, a twenty-minute observation period was initiated and Mr. Holloway was requested to provide a sample of his breath to determine its alcohol content. Mr. Holloway refused and was advised of implied consent by Deputy F. Solomon (5815). Mr. Holloway again willingly refused to provide a sample.

Mr. Holloway was ultimately charged with Driving Under the Influence (2nd- Offense), Refusal to Submit (2nd – Offense), Resisting Arrest without violence, Possession of Marijuana – Less than 20 grams, and Possession of Drug Paraphernalia.

Mr. Holloway was issued the following citations: DUI (AM5WF5E), Refusal to Submit (AMO0TEE), Possession of Open Contain – Driver (AMO0TFE). Exceeding Speed limit (AMO0TGE), Failure to drive in single lane (AMO0THE), Driving on the wrong side of road (AMO0TIE), Crossing / Driving on Median (AMO0TJE) and Possession of Controlled substance (AMO0TKE).

Mr. Holloway was booked into the Indian River County Jail without incident and held on a total bond of

On **4/16/26**, at approximately 1520 hours, I responded to Wal-Mart, 2001 US1, Sebastian, FL., 32958, in reference to a theft.

Upon arrival I spoke with Christopher Matson with Wal-Mart's asset protection team and he stated the following: he was watching the CCTV when he noticed a male, now known to be Aaron Mills, in the electronics department that they had known to have stolen merchandise multiple times in the past. Aaron was seen on CCTV selecting four portable hard drives (x2 EXT 1TB SSD, x2 1TB SN7100) from the shelf. Dawn Ethier with Wal-Mart's asset protection team was notified of the location of Aaron and walked onto the floor to attempt to get visual of Aaron. Dawn located Aaron near a book aisle and visually saw Aaron removing the spider wraps (Security devices) from the hard drives and leave them behind on a shelf. Christopher then proceeded to the sales floor and got visual on Aaron and observed that Aaron concealed a hard drive down his pants in the front near the pet department. Aaron then proceeded into the household chemical section and was observed concealing a hard drive in his jacket. Aaron was then seen proceeding to the grocery exit quickly and passing all points of sale. All of this was captured on video.

Aaron's vehicle had a distinct description given by Dawn which was stated to be a grey sedan with a white sticker on the back of the vehicle. The vehicle was located by Ofc. Irwin and a traffic stop was conducted. Upon contact with Aaron on the traffic stop, he was positively identified due to the Wal-Mart CCTV footage and the description of the vehicle. Aaron was wearing a cover on his head and a black t-shirt with a black hoodie, grey pants and black slides, but when he was located, he was wearing a white t-shirt, grey pants and black slides. The black t-shirt, black hoodie, and black head cover were found thrown in the seat of his vehicle.

Aaron was given his Miranda Warning and questioned about the location of Wal-Mart's merchandise. Aaron refused to cooperate and the items were located during an inventory search of his vehicle. Two items were concealed under his driver seat (x2 EXT 1TB SSD) and two items were in plain view (1TB SN7100). The merchandise was returned to Wal-Mart, and they wish to prosecute and trespass Aaron.

Due to the facts of this investigation, Aaron will be charged with F.S.S 812.014(4)(c) Grand theft. The total for the four items are \$996.00.

Anthony was captured on camera walking around the store taking the dusters, and then going to the bathroom possibly to huff them. Two of the duster cans he possessed felt empty.

The manager of Dollar Tree, Christopher Isler was contacted and he advised he witnessed Anthony walking around the store earlier in the day at approximately 1530. Christopher witnesses Anthony stealing the duster cans then walking to the bathroom. When Anthony exited the store, he passed all points of sale and did not pay for the dusters.

Four duster cans found in Anthony's possession were photographed and returned to Dollar Tree. Dollar Tree employee Dianne Fultz provided me with a voided receipt totaling \$6.42 after tax for the dusters.

In a post-Miranda interview with Anthony, he stated the following: He is homeless in the area and has been trying to stay off methamphetamines. He took the duster cans from dollar tree earlier in the day and huffed them in the bathroom.

Based on these circumstances, I found probable cause to arrest Anthony for shoplifting/retail theft in violation of FSS 812.015.





