NARRATIVE

On Monday, June 23, 2025, at approximately 0202 hours, I responded to 8195 20th Street (BP Gas Station), in reference to a Disturbance EMS needed.

Upon my arrival, I made contact with William Seifert who advised while he was asleep in his chair, he was woken up to being punched in the face. Seifert advised as he was being continuously struck in the face, he was able to visually observe his attacker as a while male who is known as Hollywood. Seifert advised Hollywood's actual name is Christopher Fultz who he knows personally. Seirfert advised that after Fultz had finished his attack, he left the area; Seirfert along with his female friend identified as Beverly Dority called Law Enforcement and started walking out of the woods to 82nd Avenue where I made contact with them.

I observed a golf ball size bulge just off the side of Seirfert's left eye socket area. I asked Seirfert if he would like to be check out by rescue to which he declined to be transported but agreed to be evaluated. Rescue arrived on scene and evaluated Seirfert and determined that he met criteria to refuse to be transported.

Deputy Quint advised me he was was able to locate Fultz at the 8400 BLK of 20th Street where he was detained. Deputy Quint read Miranda Rights to Fultz, Fultz acknowledged his understanding of his rights and agreed to speak with him. Post Miranda Fultz admitted to striking Seirfert multiple times however, advised that when he confronted Seirfert at his camp site. They had gotten into a verbal argument and Seirfert pulled out a large knife on him and it was at this time that Fultz struck Seirfert.

I then made contact with Dority who was separated from Seirfert where I was able to question her about the incident. Dority advised she was with Seirfert at his camp when Fultz approached and slapped Seirfert approximately 6-8 times in the face. Doriety stated while Fultz was striking Seirfert he was yelling about how Seirfert owing someone forty dollars. When asked directly if there was any knife involved in the incident Dority stated "No". Dority advised Seirfert does own multiple knives however she witnessed the incident and no knife was present.

Due to the injuries observed on scene to Seirfert's face and the statements made on scene I charged defendant Christopher Fultz with violation of F.S.S 784.03(1a1) Battery.

NARRATIVE

On Monday, June 23, 2025, at approximately 0230 hours I Deputy Martin responded to Blue Cypress Lake in reference to a Marine call for service. Dispatch advised that a caller was reporting that he believes he was in a wreck on his air boat, and possibly lost consciousness. The caller further reported that he got into an argument with his girlfriend on his air boat, and that she is possibly missing.

Upon my arrival, I was further informed that the caller was reporting to Indian River County dispatch that he was bleeding from multiple places. Indian River County dispatch attempted to have the caller describe his injuries in more detail, but advised that the caller would not describe where he was bleeding from. The caller was later identified as Derek R. Howard. As Indian River County Dispatch attempted to further gather information from Howard, he then made conflicting statements with his earlier report. Stating "It is unknown if female got off on to another person's boat when they were fighting or if she was with Howard prior to this happening". Indian River County Dispatch would continually report that Howard was screaming that he was in pain, but would not provide any details on the extent of his injuries.

Later, a Fellsmere Police Department Officer located Howard's truck and trailer, at Garcias boat ramp. Two other persons on separate air boats arrived at the boat ramp, who were identified as Ernest Carrico and Derward Sapp, who stated to law enforcement that they were out on the Marsh when they found Howard's girlfriend named Kimberly R. Johnson, who was neck deep in water. They stated they observed Howard stuck in the Marsh near where they found Johnson. Carrico and Sapp gave Johnson a ride back to the boat ramp and drove her back to her residence. Law enforcement made contact with Johnson. All three witnesses stated that Howard did not crash his air boat. Only that Howard was stuck in mud in the Marsh and was uninjured. Johnson left her cell phone on the air boat, which was the phone that Howard was using to communicate with Indian River County Dispatch. Johnson would further state that she did not get into a verbal argument with Howard while on the air boat. After dropping Johnson off, Sapp and Carrico stated they re-attempted to go to the spot they last saw Howard to help him out. However, the area Howard was located in was too adverse for them to get back and could not located Howard where they last saw him.

During this investigation, Howard called Indian River Dispatch 6 times. During these phone calls Indian River County Dispatch attempted to gain more information of Howards medical status, location, and information as to how he got to his location. Indian River County Dispatch advised when they asked Howard if he wrecked, he stated "He thinks he ran out of gas and wrecked his boat". Indian River County Dispatch later advised after multiple attempts Howard stated "He is scratched up, not bleeding profusely, and his whole body is banged up". Howard would later

ate up and we need to hurry up". Indian River County Dispatch also advised that Howard stated that he was naked in the Marsh.

After involving the United State Coast guard, Florida Fish and Wildlife Conservation, Indian River County Sheriff's Office, and Fellsmere Police Department. Howard was located with his air boat. The US Coast Guard air crew informed us that when they arrived to Howard's location, he began to move the air boat under power. When I made contact with Howard, he appeared to be in good health with no life-threatening injuries and fully clothed. FWC Officers stated that Howard's air boat appeared to have some minor damage, but did not look like it was involved in a major crash. The air boat also appeared to be standing upright in its location.

Later, Howard was transported to the Indian River County Jail. There I read Howard his Miranda warnings from my agency issued warning card. Howard stated that he understood his rights and was willing to speak with me at the time. Howard stated that he started out on his air boat with his girlfriend; Johnson. At some point the two got into an argument and Johnson left with the two other air boats that were on the trail with him. Howard then began to ride his air boat down random trails, and stated that he eventually lost his sense of direction and location. Howard then stated that he must have hit a mud bank which caused his air boat to flip. Howard stated he doesn't remember the crash fully, but he woke up in saw grass and his air boat was flipped over on its side. Howard stated that he then by himself flipped his air boat back upright. He then couldn't get it started and called for help using the emergency function on Johnsons phone that she left. At the time and from experience one person could not flip an air boat back upright if it was stuck on its side in the mud. Howard stated that he was confused at the time and was not sure if Johnson was still with him.

Due to the totality of the circumstances, that myself Corporal Q. Martin of the Indian River County Sheriff's Office was conducting a missing person investigation. Howard knowingly and willfully gave false information to Indian River County Sheriff's, Florida Fish and Wildlife Conservation Office, and the United States Coast Guard. Howard intended to mislead all agencies to enact a more rapid response into searching for him and his missing girlfriend, who was never missing to start with. Howard also, accessed 911 services for the purpose of making a false alarm and reporting false information about his missing girlfriend and a severe crash that could result in the emergency response of a public safety agency to get him out of where he was stranded. This event caused local, state, and federal agencies to utilize numerous forms of equipment to attempt to locate missing and injured individuals which was falsely reported by Howard. Howard is being charged with FSS 837.055 False information to law enforcement misdemeanor with a \$500 USD bond, and FSS 365.172(14) Misuse of 911 services misdemeanor with a \$500 USD bond.

NARRATIVE

On 6/23/25 at approximately 0711 hours I responded to 8495 U.S. Highway 1 in reference to a call for service regarding a reckless driver.

This incident began with a concerned citizen's call to the Indian River County Sheriff's Office about a white Jeep SUV which left the roadway numerous times while travelling East on 85th Street. This witness observed, both physically and by vehicle dash camera, the Jeep leave the roadway in the 5100 block of 85th street and strike a Department of Motor Vehicles road sign; the vehicle continued East on 85th Street where Detective Chris Scribner conducted a traffic stop (8495 U.S. 1 - CVS Pharmacy).

Upon arrival I met with Detective Scribner and the vehicle's driver (sole occupant), Jennifer Archer. I spoke with Archer briefly about the events that occurred prior to the traffic stop. Archer seemed unable to maintain fluid conversation and appeared to be impaired by an unknown substance. Archer stated that a friend loaned her the vehicle and she was on her way to return it when she lost control and struck a sign along 85th Street. She advised that she did not want to pull over on the side of the roadway and planned to report the crash once she arrived at the CVS where she was stopped.

An inquiry through dispatch and a DAVID database search revealed that Archer's Florida driver's license was suspended indefinitely on 7/15/2024 (notice provided on 6/24/2024).

A search of Archer's purse incident to arrest revealed a small circular pill which was identified via Drugs.com as a Clonazepam, a schedule 4 controlled substance. The pill was located in the zippered pocket of a small wallet which was located inside of Archer's purse (along with a financial card with Archer's name on it). Archer advised that she does not have a presciption for this drug.

Also located in Archer's purse was a small tube that was clear in color. The tube had a small amount of steel wool-like material stuffed into one end and appeared to have been exposed to high heat and/or fire on multiple occasions. Based on my training and experience I was able to identify this tube as a pipe used to deliver illegal substances to the body via smoking.

Post Miranda, Acher advised that the Clonazapam and and the smoking pipe did not belong to her.

Based on the above listed facts and circumstances, Archer was arrested and charged with driving while license suspended or revoked, possession of a controlled substance, and possession of drug paraphernalia.

This case is cleared by arrest.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 22:52 On , at (Specifically include facts constituting cause for arrest.)

On 23 June 2025, at approximately 2021 hrs, I, a police officer for Sebastian, on routine patrol in the 1000 Block of US HWY 1, observed a Dodge white cargo van traveling south, matching the description of a vehicle that had hit on FLOCK for the registered owner being suspended.

As I proceeded behind the vehicle, I ran the registration, KR566R, through ELVIS. The vehicle information came back to a 2020 Gold Honda Accord. I confirmed through dispatch the status of the registration, and dispatch confirmed the registration should be on a Honda and not a Dodge van.

I initiated a traffic stop on the vehicle in the 400 block of Sebastian Blvd. Upon making contact with the driver of the vehicle, Anthony Lanza Jr., I requested the required documents. Anthony stated his wallet was stolen, so he didn't have his driver's license on him, but he provided me with his name and date of birth. Anthony also said he didn't have the insurance because the belonged to his boss, Juan Sanchez. I asked Anthony where he was from, and he stated Miami, and that is where Juan also lives. At this time, I explained the reason for stopping to Anthony, and he stated he didn't know anything about the plate being on the van.

Anthony stated he came to Sebastian earlier in the day to check a painting job and provide a quote; however, the guy he was supposed to meet with never showed up. I checked Anthony's status through dispatch, and they advised he had an active warrant out of Sarasota County (2025 CF 002312) for Fraud, and Anthony's License was not valid as of 11 October 2022. Once backup units arrived, I requested Anthony to step out of the vehicle, and Anthony was placed into mechanical restraints while confirmation was sent for the warrant. At this time, Anthony was Mirandized.

While I was speaking with Anthony, Ofc. Keiser and Cpl. Revis started to do an inventory of the vehicle for the tow sheet. Cpl. Revis notified me at the start of the inventory, between the driver seat and the passenger seat, sitting on top of a microwave, was a small box without a lid. In the box, there were several small white rocks believed to be cocaine. Cpl. Revis waited for me to photograph the item before proceeding further with the inventory. I removed the box from the van and used a test kit in which the substance tested positive for cocaine.

We continued to conduct the inventory and located the floorboard of the passenger side was a sunglass case containing tinfoil and straws; these are items known to be used as paraphernalia; there was a white pill in a small baggie. In the center console, there was a small torch; in the compartment of the partition separating the front of the van from the rear were needle caps and Chore Boy. On the floor, next to the driver-side seat, there was a glass pipe used for smoking methamphetamine. Due to the totality of circumstances, I collected the mentioned items as drug paraphernalia.

I asked Anthony when the last time he used it was, and he stated in the morning but did not want to speak about the items found.

At this time, I advised Anthony I was arresting him for the following:

FSS 893.13 (6)(A) Possession of a controlled substance: Anthony had in his immediate area of the vehicle a white rock substance that tested positive for cocaine.

FSS 893.147 Possession of drug paraphernalia: Anthony had in his immediate possession items that are now used in conjunction together to smoke controlled substances.

FSS 322.34 Driving While License suspended, revoked, or canceled: Anthony was operating a moving vehicle on the public roadway of the city of Sebastian without a valid driver's license.

I requested the Miami Police Department go by the registered owner of the van, Sheila Saravia, to see if she did permit Anthony to have her vehicle. Dispatch stated The deputy who responded stated he spoke to Sheila over the phone, and she stated Anthony did have permission to have the vehicle, and before he left this morning, she put the license plate on the van for him to drive it. The deputy also stated Sheila said Anthony did not know the license plate did not belong on that vehicle.
