NARRATIVE

On Monday June 15, 2026, at approximately 0345 hours, I responded to [REDACTED] in reference to a Disturbance.

Upon my arrival, I made contact with caller Jaybrille Driver who stated that, while she was sleeping, her girlfriend Reynlique Rolle had hit her and broke her phone. Driver stated after Rolle went through her phone, she woke her up by hitting her on the back left side of her head. They began to have a verbal argument and that's when Rolle threw Driver phone at the ground cracking the screen.

I asked Driver how long have her and Rolle been dating and she was unsure giving me an estimate of 5-6 months [REDACTED]

I observed Driver for injuries and notice swelling in the back of her head along with some redness. Driver denied medical attention.

I took picture of Driver's damaged phone and ask to keep it for evidence to which Driver denied. An approximate cost of Driver phone was \$420.00.

I made contact with Rolle and read her Miranda warnings and she did not want to speak to me.

Base on injuries observed on Driver's head and her phone being broken, I placed Rolle in custody.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
 On **06/15/2026**, at **20:55** (Specifically include facts constituting cause for arrest.)

PROBABLE CAUSE STATEMENT

On June 15, 2026, at approximately 1847 hours, I was conducting a routine patrol in my marked patrol vehicle in the area of Barber Street and Vocelle Avenue, Sebastian, Florida 32958. I observed a white Ford Expedition bearing Florida-issued registration plate Y426HB. I observed the white Ford driving eastbound on Vocelle Avenue, approaching the intersection of Barber Street. I observed the white Ford approach the stop sign and the white stop bar on Vocelle Avenue. I observed the white Ford slow its speed to approximately 2 miles per hour. I observed the vehicle pass the stop sign and white stop bar without stopping. I observed the vehicle begin to turn south onto Barber Street. I observed the white Ford stop when the rear tires were on top of the stop bar, and the front of the vehicle was already in the southbound lane of travel.

I followed the white Ford onto Barber Street, activated my emergency lights, and conducted a traffic stop on the vehicle. When I approached the driver's side of the vehicle, I made contact with a white male in the driver's seat. I observed the white male to be the sole occupant of the vehicle. I requested the male's driver's license, current vehicle registration, and current proof of insurance. Upon my initial contact with the driver, I observed the odor of marijuana emitting from the vehicle. The male provided me with his driver's license and current vehicle registration. I again requested the male's current proof of insurance for his vehicle. The male stated it was on his cell phone. As the male was attempting to log in to his insurance app, I asked the male about the odor of marijuana. When asked, the male stated he had not consumed marijuana, nor was there marijuana inside the vehicle. When asked again, the male stated he had consumed marijuana several hours ago. When asked again if there was marijuana inside the vehicle, the male stated yes, one Ounce. The male then showed me his current proof of insurance. I asked the male where the marijuana was located inside his vehicle; the male stated in the center console. I asked the male if he had a valid medical marijuana card. The male stated he did not possess a marijuana card.

I requested the male to exit the vehicle. The male complied. Once the male and I were at the front of my patrol vehicle, I ran the male's Florida-issued driver's license through the Sebastian Police Department's Dispatch Center and requested them to confirm the male did not have a medical marijuana card. I identified the male as Richard Allan Mathews by his Florida-issued driver's license. The Sebastian Police Department's Dispatch Center advised me Richard did not have a medical marijuana card issued to him.

At this time, Officer Venegas #420 arrived at the scene. Officer Venegas began to search Richard's vehicle. In the center console, Officer Venegas discovered a large clear ziplock bag containing green leafy buds that he knew from his training and experience to be marijuana. Officer Venegas used Corporal Keskinen's #410 portable digital scale and took a preliminary weight of 30 grams. The search of the rest of the vehicle ended with negative results.

Corporal Keskinen advised Richard of his Maranda Warning. Richard stated he understood his rights and he wanted to speak with officers. Richard did not provide any pertinent information. Richard was placed under arrest and was placed into mechanical hand restraints that were checked for proper fit and ensured to be double locked.

Richard was transported to the Indian River County Jail without incident.

Officer Venegas took custody of the bag containing the marijuana. Officer Venegas brought the marijuana to the Sebastian Police Department. Officer Venegas weighed the bag of marijuana on a certified scale. Officer Venegas advised me the total weight was 31 grams. Officer Venegas also conducted a preliminary field test. Officer Venegas advised the test was positive for marijuana.

No further actions were taken by this officer.

NARRATIVE

On Monday, June 15, 2026, at approximately 1909 hours, I responded to [REDACTED] in reference to a disturbance. While on the way to the call dispatch advised that one subject may have been in possession of a knife. They further advised that the person had dropped the knife and was still located in the residence. The caller was outside [REDACTED]

Upon arrival I met with, Oscar Vite-Nava due to a Spanish language I utilized Analyst Ruan #6006 to translate. Mr. Vite-Nava stated his Step-son Jaime Andrade-Salazar made statements towards him and his wife Mrs. Elena Cabarello-Salazar that he was going to kill them while he held a fillet knife. Oscar stated Jaime was holding a black and red handle fillet knife. Mr. Vite-Nava showed me the knife that Jaime was holding, it was located inside the kitchen by the sink. Mr. Vite-Nava stated Jaime then shoved Elena as she attempted to get the knife from Jaime. Mr. Vite-Nava was in fear that Jaime would hurt him or his wife Elena.

I then met with Elena who spoke little English, I utilized Analyst Ruan #6006 helped me in translation. Elena stated she and Jaime had a verbal disagreement over him leaving the house due to his recent drug use activity. Jaime had grabbed the knife from the kitchen, and was concealing it behind his back. Elena stated Jamie then held it out stating, "are you looking for this." Elena then stated Jaime held the knife towards Oscar as he was in the kitchen, at which point she ran and grabbed the knife from her. Elena stated she did not hear Jaime say anything to Oscar. Jaime then looked at her and stated she would kill them and make them disappear.

It should be noted that there were no visible marks or wounds on either Mr. Vite-Nava or Elena; however, Mr. Vite-Nava stated he was in fear for his and his family's safety as Jaime was crazy.

The family was overall in fear of their safety stating Jaime had been previously arrested for domestic violence, and has a history of being baker acted.

It should also be noted that Elena and Oscar have been married for approximately 10 years, [REDACTED] Oscar is Jaime's Step-Father. The knife was a red and black fillet style knife with four diamonds on the handle.

Due to the aforementioned testimonies, Deputy Lang #6136 placed Jaime under arrest under my direction and placed him into my agency patrol vehicle. Deputy Lang read Jamie his Miranda Rights to which he stated he understood. Jaime requested to speak with a lawyer and not answer questions at this time. See Deputy Lang's supplement report for further information.

Prior to my arrival to the Indian River County Jail complex, I asked Jaime if she had anything hidden or

on her person that would be considered contraband, which she stated no. Upon arrival to the jail complex, Corrections Deputies put Jaime into a body scanner and it showed a foreign object in the genital area. I then transported to Jaime, to Cleveland Clinic where she had a full body CT scan, which showed nothing. Upon arrival back to jail complex Jaime was placed back into the body scanner and Correction Deputy Hiss #5730 located earrings in Jaime's hair, which was the same foreign object from the original scan. Jaime introduced earrings that are considered a clothing item, those could also be used as a weapon, are aid in an escape. Earrings are considered contraband inside a county facility.

Due to the facts and circumstances previously mentioned, I find probable cause to charge Jaime Andrade Salazar with the following:

Count 1: F.S.S. 784.021.1A- Aggravated Assault with a Deadly Weapon Without the Intent to Kill, Domestic Violence.

Count 2: F.S.S. 784.021.1A- Aggravated Assault with a Deadly Weapon Without the Intent to Kill, Domestic Violence.

Count 3: F.S.S. 951.22 A(c)- Smuggle Contraband (Article of Food/Clothing) into County Detention

The knife was photographed by myself and was uploaded into evidence.com, via the Axon Capture application. Deputy Lang collected the knife from the scene and I placed it into evidence.

The Domestic Violence packet and Lethality Assessment was completed, and was sent to the Domestic Violence email. Oscar, and Elena were provided with the Domestic Violence brochure.

NARRATIVE

On June 15th, 2026, at approximately 2135 hours, I was traveling northbound near 14599 US Highway 1, Sebastian, Florida.

At that time, I witnessed a black Chevy pickup truck traveling southbound on US Highway 1 with a nonfunctioning passenger-side headlight. Additionally, as I began traveling southbound behind the black Chevy pickup truck (bearing FL tag KWAC03), I observed that the driver-side taillight was damaged, so only a small portion was illuminated.

Based on my observations, I conducted a traffic stop on the black Chevy pickup truck at the WalMart, located at 2001 US Highway 1, Sebastian. I subsequently made contact with the driver, and sole occupant, Mr. David Mccready, who was identified via DAVID. While speaking with Mr. Mccready, I could smell the odor of fresh marijuana emanating from the interior of the vehicle. Mr. Mccready also stated he did not have a medical marijuana card.

Sebastian Police Department, Officer Venegas, ID# 420, also arrived on scene and requested Mr. Mccready exit the vehicle. While standing at the front of my patrol vehicle, Mr. Mccready advised Officer Venegas that he had marijuana and a scale inside the vehicle.

I subsequently conducted a search of Mr. Mccready's black Chevy pickup. I located a plastic bag with a green, leafy substance between the driver's seat and the center console area. Based on my training and experience, I believed the green, leafy substance to be marijuana. A small scale was also located behind the passenger seat. Also, inside the driver's door pocket, I located two Trojan condom wrappers folded together. When I unfolded them, a small, plastic baggie with a clear-ish substance fell out. The clear-ish substance field-tested positive for the presence of Fentanyl.

Mr. Mccready was subsequently placed under arrest. He was placed into handcuffs that were checked for proper fit and double-locked. Deputy Estrella, ID# 6212, conducted a search of Mr. Mccready's person. During the search, Deputy Estrella located three plastic baggies with crystal-like substances inside Mr. Mccready's left shoe. There was crystal-like substance loose inside Mr. Mccready's shoe, as well. Based on my training and experience, I believed the crystal-like substance to be methamphetamine. The approximately 2 grams of crystal-like substance from the baggies in Mr. Mccready's shoe also field-tested positive for the presence of methamphetamine.

During a post-Miranda interview, Mr. Mccready stated the substance inside his shoe was methamphetamine.

Mr. Mccready committed the offenses of possession of methamphetamine, possession of Fentanyl, and possession of marijuana (less than 20 grams). He was transported to the Indian River County Jail, without incident.

Mr. Mccready was issued 3 citations for possession of a controlled substance (citation #'s: AMOOCQE, AMOOCRE, AMOOCSE) and 1 warning for improper headlight.
