#### NARRATIVE

On September 2<sup>nd</sup>, 2025 at approximately 1200 hours, I responded to 4495 US Highway 1, Vero Beach (Wawa) in reference to a retail theft.

Public safety dispatch advised the store manager observed a black male wearing a plaid shirt and tan colored pants and blue backpack, placing items into his pockets. While being dispatched the caller advise the male was still in the store. As I arrived on scene, the caller stated the male walked out the back door without paying for the items.

Upon my arrival, I observed a black male later identified as Mario D. Johnson, by his Florida ID card, wearing a plaid shirt and light green pants and a blue backpack exit the back door of the business then and get onto a bicycle. I approached him before he could leave the property; upon initial contact I observed several candy packages in his pockets in plane view. I instructed Mario to step off the bicycle, where I than placed him into physical hand restraints. I brought him to my patrol vehicle where I removed the contents of his pockets. I recovered 6 individual packages of sour gummy candies. Mario made a spontaneous utterance that those were all he took. As I continued to search his pockets, I located a small class pipe with residue in his shirt breast pocket.

I than placed Mario into the backseat of my patrol vehicle where I read him Miranda Warning, He waived his rights and agreed to speak with me. I asked what happened in Wawa and he informed me he took the candy from the store because he didn't have the money to pay for them. I then asked about the pipe to which he stated that he smokes crack cocaine, but he did not have any physical drugs on his person.

Based on the physical evidence recovered from Mario's person, witness statements, and Mario's post Miranda admission he is being charged with one count of shoplifting for intentionally taking items from the business passing all points of sale without paying for them with the intent to permanently deprive them of the property and is value.

Maria is also being charged with one count of possession of drug paraphernalia for knowingly possessing and admitting post Miranda to possessing a glass pipe with residue for the purpose of smoking crack-cocaine.

Mario was transported to the Indian Rover County Jail.

On Tuesday, September 2, 2025, at approximately 1907 hours, I responded to the Cleveland Clinic Emergency Room, 1000 36 <sup>th</sup> Street, Vero Beach, FL, to assist Detective McKenzie with a disturbance. Upon my arrival, Detective McKenzie had already conducted an investigation and determined there was probable cause for Disorderly Conduct. Detective McKenzie's investigation details are listed below:
"On September 02, 2025, at approximately 1900 hours, Detective McKenzie was assigned to the Cleveland Clinic Emergency Department in the capacity of a detail deputy. Deputy Hwan Choi brought in patient, as Detective McKenzie arrived to his detail - 1800 hours. The patient's name is Kristy Davis, a black female born 01/08/1996.
Upon arriving at the Emergency Department Davis was shouting and flailing her body about, screaming profanities, disrupting patients and staff members of Cleveland Clinic. Detective McKenzie spoke with Davis and advised her she would be arrested if she continued her erratic and disrupting behavior. For approximately forty-five (45) minutes Davis was calm in her bed, being treated. Detective McKenzie returned to his post, positioned at the front of the Emergency Department lobby, when nurses came running to him alerting him that his assistance was needed in room 14, Davis' room. Detective McKenzie responded to room 14 and observed Davis, now standing in the hallway outside of her room, approximately six (6) inches from RN Susan Slade's face yelling profanities with raised hands. Davis continued to yell profanities to the entire Emergency Department. Deputy Lowell was also on scene who heard Davis shout the profanities and told her to return to her room, which she refused.
Detective McKenzie placed Davis in mechanical wrist restraints with the assistance of Deputy Lowell.  While in custody, Davis slammed her head multiple times against the plastic bed railing, yelling that  Detective McKenzie further restrained her by holding her arms and pulling her back towards his body, while she was sitting in bed. Davis began to flail and scream and threw herself to the ground. Detective McKenzie collected Davis from the ground and placed her back into her hospital bed. Davis stated she was pregnant. After speaking with Davis, Davis stated she was just upset and did not want to hurt herself or her alleged unborn child.
Corporal Hatton arrived on scene and transported Davis to the Indian River County Jail.
Probable cause exists for F.S.S. 5877.03 prohibiting Disorderly Conduct."
I observed Davis to be combative and slamming her head against my prisoner partition on the way to the jail and she was uncooperative with jail deputies at the jail sallyport.
Through the above information, I determined that Davis' actions corrupted public morals and outraged the sense of public decency. Davis was charged accordingly.

#### NARRATIVE

On September 2<sup>nd</sup>, 2025, at 2136 hours, I conducted a traffic stop on a white in color Toyota sedan bearing FL/ 69FBAB, for FSS 316.237(2), No headlights. Upon making contact with the driver, later identified via his Cuba issued driver's license as Adnier Padrón Tejeda, I requested a Spanish speaking deputy to assist with translation. Deputy A. Ballester responded to the scene and translated for me. Deputy A. Ballester explained to Padrón Tejeda the reason for the stop and then questioned the driver as to when he arrived in the USA. Padrón Tejeda advised he has been living in the USA since December of 2024, and had failed to obtain a state issued driver's license due to him attempting to obtain an "internation driver's license (IDP)."

Due to Padrón Tejeda failing to obtain a Florida issued driver's license within 30 days of arriving in Florida, I found probable cause that Padrón Tejeda was violating FSS 322.031(1); violation of non-resident requirements for a driver's license. I issued Padrón Tejeda a criminal citation reference the aforementioned charge and transported him the to the Indian River County Jail.

It should be noted that USBP Agent Barrientos was contacted and he advised that Padrón Tejeda had overstayed his VISA and an immigration detainer was placed on Padrón Tejeda.





I then observed as the Defendant made a right turn onto northbound Indian River Boulevard from the bridge at which time I pulled out onto the roadway, made a u-turn and proceeded to catch up to the Defendant's vehicle.

As I traveled north on Indian River Boulevard, I pulled up behind the Defendant's vehicle approaching 37th Street and initiated a traffic stop by activating the emergency lights on my fully marked patrol vehicle.

After activating my lights, the Defendant appeared to have a delayed reaction and did not pull over despite there being ample room on the shoulder to do so. The Defendant ultimate pulled over at approximately the 4000 block of Indian River Boulevard.

I then exited my patrol vehicle and approached the Defendant's vehicle on the passenger side where I observed the Defendant for a moment before alerting him to my presence.

Upon making contact with the Defendant, he lowered his passenger-side window at which time, I could immediately detect a strong odor of an alcoholic beverage emanating from within the vehicle.

I introduced myself and requested the Defendant's license and registration. The Defendant provided his Florida drivers license but had to be asked a second time for his registration.

I then informed the Defendant as to the reason for the stop.

The Defendant stated that he was just trying to get home. Pursuant to the address on his license, the Defendant's residence was approximately one mile north of the traffic stop location.

I then asked the Defendant as to his whereabouts prior to being stopped to which the Defendant stated that he had been at The Boiler, a bar located at 3410 Ocean Drive in the City of Vero Beach.

During the foregoing, I could detect a strong odor of an alcoholic beverage emanating from the Defendant's breath as he spoke. Additionally, I noted that his speech appeared irregular in that he was tongue-tied and almost slurred. Furthermore, I noted that the Defendant's eyes appeared red and glassy.

In light of the foregoing observations, I asked the Defendant how much [alcohol] he'd had to drink.

The Defendant stated and asserted that he only consumed "two beers" prior to being stopped. Furtehrmore, the Defendant made a statement to the effect that he does not handle alcohol well.

Therefore, the totality of the foregoing gave me a cause for concern and reasonable suspicion to believe that the Defendant was impaired.

I then requested Officer H. Hogue (468) to respond to the scene for routine assistance during the remainder of the stop.

Upon Ofcr. Hogue's arrival I had her occupy the entire curb lane behind my vehicle for safety while conducting my investigation.

I then returned to the Defendant's vehicle and asked him to exit his vehicle which he did freely and willingly.

Once out of the vehicle, the Defendant appeared to have trouble comprehending and following instructions, having to be told repeatedly where to stand and what to do.
