**NARRATIVE**

On Wednesday April 24th, 2024, at approximately 1209 hours, I responded to Smith's Grocery, located at 3206 45th Street, in reference to a disturbance.

Prior to my arrival, I was advised of a shirtless white male subject, making a mess inside the store, and refusing to leave the property. As I arrived on scene, Deputy A. Brady had contacted the shirtless white male, who was identified as Paul Breslin.

While speaking with Breslin, I suspected he was under the influence of narcotics. Breslin was unable to keep his eyes open, had difficulty standing up straight, and was slurring his speech. Breslin advised he was living in the Sebastian area, in a sober living house. While standing next to Breslin on scene, I observed a small bulge in Breslin's pocket. I requested to conduct a pat down of Breslin's pockets, but Breslin began removing the items contained in his pocket instead.

While emptying his pockets, Breslin handed me a pack of cigarettes. The pack of cigarettes felt empty, but upon opening it, I observed three green, round pills at the bottom of the pack. There was additionally a Florida Lottery Ticket inside the cigarette pack. Upon removing the lottery ticket, another pill, matching the other three was located. The pills located all had a "M" imprinted on one side, and "30" imprinted on the other. The pills were identified as Oxycodone Hydrochloride 30mg via the Pill Identifier on Drugs.com. Oxycodone is a Schedule II substance under the Controlled Substances Act. Schedule II drugs, which include cocaine and methamphetamine, have a high potential for abuse.

After locating the pills, Breslin was secured in handcuffs and placed into the rear of my marked agency issued patrol vehicle. I proceeded to advise Breslin of his Miranda Rights via an agency issued Miranda Rights Card. Breslin verbally acknowledged an understanding of his rights and agreed to speak with law enforcement. Breslin advised he did not have "Oxy", and the "Oxy" did not belong to him. Breslin then advised he obtained the "Oxy" from the house he was just in, referring to Smith's Grocery.

Breslin was further transported to the Indian River County Jail for booking, where he was charged in violation of Florida State Statute 893.13 - Possession of a Controlled Substance. Breslin was additionally issued Florida Uniform Traffic Citation AJ5R2FE for the same charge.

It should be noted, prior to this encounter, Breslin had overdosed on Fentanyl on April 23rd, 2024, and was treated at the Cleveland Clinic Indian River Hospital. After being released from the hospital, Breslin had taken several dirty needles from a sharps container in the Emergency Department. Breslin was located shortly after his release, and was brought back to the hospital and [REDACTED]

NARRATIVE

On April 24<sup>th</sup>, 2024, at approximately 1258 hours I responded to 1100 2<sup>nd</sup> St in reference to a reckless driver.

Upon arrival, I observed a silver Nissan truck bearing FL tag 81BXJN that wrecked into various trees near residences. It should be noted that this vehicle was called in by a witness, Tammy Peirce, who observed the vehicle driving in an erratic pattern in addition to hitting multiple mailboxes and fleeing the scene of the crash.

Upon my approach to the vehicle, I observed a male in the driver's seat, the sole occupant of the vehicle, later identified by his Florida ID Card as Henry Garcia, who appeared too disoriented to comply with my lawful commands to roll his windows down. Due to the circumstances of the crash, I made entry into the vehicle and assisted him out. When the driver's side door opened, I smelled the strong odor of an alcoholic beverage emitting from his person. When I asked how much he drank, he stated that he was "fucked up;" in addition, he would eventually state that he drank an entire bottle of wine. When asked, Henry also advised that he did not have a valid license.

Throughout my interaction with Henry, his eyes appeared glassy and red, his breath emitted an odor of an alcoholic beverage, he slurred his speech and was not fully coherent or able to answer my concise questions, and he could not move of his own accord, rather, he required assistance while moving his person due to his incoordination and inability to stand on his own.

After initial investigation, I asked Henry to perform standardized field sobriety exercises to which he stated no. When I asked if he felt that he could safely perform the exercises due to his apparent incoordination, he stated no.

Due to his apparent inebriation, his admittance to drinking alcoholic beverages, and witness statements, Henry was placed into custody and transported to the hospital where he was medically cleared and transported to the Indian River County Jail.

Booking staffed requested Henry provide a lawful breath sample to which he refused. Henry was read implied consent, again refusing.



I made contact with Loss Prevention Officer Jacob Parker who advised the following:

"While conducting routine CCTV surveillance of the GRC self-checkout observed an individual now known to me as Tatyana Roberts under ringing while at self-checkout register #56. Tatyana Roberts held cheaper items in front of more expensive items and simultaneously passed both items across the scanner effectively only scanning the cheaper item while bagging both. Tatyana Roberts also had multiple steaks in which she never made an attempt to scan. Upon completion of the transaction Tatyana Roberts passed all points of sale by exiting the GRC exit where I stopped Tatyana Roberts while identifying myself as Wal-Mart Asset Protection. Tatyana Roberts Was escorted into the AP office where all merchandise was sorted and recovered. Tatyana Roberts scanned 24 items correctly while failing to scan (11) items totaling \$81.24. IRC SO was notified. Wal-Mart wishes to prosecute and trespass."

I observed on Walmart's CCTV cameras, Roberts scanning items under more expensive items and multiple items that were never scanned or attempted to scan. There was also items you can see the barcode facing upwards where it looked as if she was scanning, but her hand was covering the barcode. I also observed Roberts pass all points of sale where she was stopped by LPO Jacob Parker.

Post Miranda Warnings, Roberts stated she was in a rush and did not do it on purpose. She claims she is on food stamps and has no reason to steal.

Based on the totality of the circumstances, Parker was placed under arrest and transported to the Indian River County Jail for Shoplifting/ Retail Theft consistent with F.S.S 812.015.
