On July 22, 2025, at approximately 1730 hrs., I, Officer S. Gonzalez (471), responded to a call regarding an intoxicated white male at the Cumberland Farms gas station and convenience store, located at 1690 U.S. Highway 1, Vero Beach, Indian River County, Florida. The individual was intoxicated had been trespassed from the premises the previous evening, July 21, 2025.

Based on the initial description, I identified the subject as Michael F. Nolan. While en route to the location, I contacted dispatch to confirm the standing trespass warning for the Cumberland Farms property. Dispatch verified that a standing trespass warning was in effect and, specifically, that one had been issued to Mr. Nolan the previous night.

Upon my arrival, I observed Mr. Nolan exiting the store and walking across the property towards the southwest corner of 17th Street and U.S. Highway 1. I recognized Mr. Nolan from prior encounters.

I made contact with Mr. Nolan and confronted him about being on the property after having been trespassed the previous evening (refer to VBPD CFS no.: 072125-78). Mr. Nolan initially feigned forgetfulness, then alleged he had forgotten about the trespass warning.

However, based on previous interactions, I was aware this was a tactic he commonly employed to conceal intentional actions.

While I was speaking with Mr. Nolan, a Cumberland Farms clerk approached, carrying Mr. Nolan's personal belongings. The clerk, an individual authorized by the property owner to act on their behalf, confirmed he had called to report Mr. Nolan's presence on the premises. The clerk also stated he had reported Mr. Nolan to VBPD officers the previous night for loitering and intoxication, at which time the trespass warning was issued.

Based on the totality of the circumstances, I determined that Mr. Nolan had entered and remained on the premises without license, authorization, or invitation, and after having been trespassed. Consequently, I placed Mr. Nolan under arrest and informed him of the charge.

I then transported Mr. Nolan to the Indian River County Jail without incident, where he was turned over to corrections personnel for processing and booking.

NARRATIVE

On 07/22/2025, at approximately 2104 hours, I responded to [REDACTED] in reference to a physical disturbance.

Upon my arrival, I made contact with Karin Civisca, who was standing in the driveway of the above mention location. Karin stated approximately 1 hour prior, she was in a verbal disturbance with her husband Michael Civisca, due to him being intoxicated attempting to leave their residence. During the course of the argument, Karin stated Michael grabbed her by the neck. When Michael grabbed her, she stuck him in the face, causing him to let go of her.

While interviewing Karin, Deputy Consalo and myself, did not observe any physical marks or redness on her neck or face. Karin then stated, that it could be a possibility that Michael didn't leave any physical marks on her, when he choked her. Karin then recanted her statement twice and explained, to Deputy Consalo and myself, that while in an argument, that Michael did not touch her first, but due to him approaching her in an aggressive manor, she hit him in the side of the face as a precaution, because she believed Michael was going to harm her.

During my interview with Karin, I could smell the very heavy strong odor of an alcoholic beverage emitting from her breath. I also noticed, several times that Karin was having a difficult time maintaining her balance while standing up right.

Next, I made contact with Michael in the garage area of the residence. At first, Michael was hesitant to speak about the incident and only stated that him and his wife were good and that nothing occurred during their argument. While standing directly in front of Michael, I noticed on the left side of his face were three scratches, that were approximately 1-inch along, that contained dried blood and were visibly red in color. Michael later explained, that him and his wife were in a verbal argument over their adult children that live in California, when Karin became upset and scratched the left side of his face. Michael also explained, that Karin and him throughout the evening, had been consuming alcoholic beverages. Michael declined ever grabbing Karin by her throat or touching her.

I later discovered, that Karin and Michael have been married [REDACTED] and the couple share two adult children in common.

Michael declined medical attention on scene.

Based on my investigation, it was determined that Karin was the primary aggressor during the incident.

Karin was transported to the Indian River County Jail for processing.
