On September 17th, 2025, at approximately 0922 hours, I observed a red 2005 Ford Escape bearing Florida tag KASA84 exiting the parking lot of 957 Sebastian Boulevard Suite A (Cumberland Farms), to go south on Barber Street. While behind the vehicle, I observed the only functioning brake light to be on the driver side. The passenger side and top center brake light were both out. Due to this, I conducted a traffic stop on the vehicle in the 500 block of Quarry Lane.

The vehicle pulled into the driveway of 541 Quarry Lane. Upon the vehicle pulling into the driveway, I observed a white male exit from the driver seat and look back at my marked patrol car. The male turned around and began walking toward the front door of the residence. I exited my vehicle and told the male to stop and get back in his vehicle. The male failed to comply and continued to approach the front door. At this time, I ran toward the male and told him to stop. I gained physical control of the male as he was attempting to open the front door of the residence, even though I ordered him to stop. Once I had control of the male, I escorted him back to the front of the vehicle he was driving and placed him in mechanical restraints.

I was able to identify the male as Robert Nagel due to previous law enforcement contacts. I know Robert to not have a valid driver's license. This was confirmed via Sebastian Communications and DAVID, which advised Robert has multiple suspensions from August 2024, to the most the recent being from January 2025. According to DAVID, Robert was also previously convicted of Driving while license canceled/revoked/suspended/disqualified in St. Lucie County (CASE/CITATION #AJMH5XE).

Robert was advised of his Miranda Rights which he understood. Post Miranda, Robert stated he was driving in order to go to Cumberland Farms. Robert stated it was only a two-minute drive and only wanted to get something to eat. Robert also stated he saw he was getting pulled over and knew he was going to jail. Due to this, Robert was going to enter his residence to tell his girlfriend he was going to jail. Robert stated he did not think it was a big deal which is why he failed to comply with my commands.

Based on the totality of circumstances and statements made on scene, I found probable cause to place Robert under arrest for violation of FSS 322.34(2A) DRIVING WHILE LICENSE SUSPENDED/REVOCATION/ EQUIV STATUS and FSS 843.02 RESIST OFFICER WO VIOLENCE.

Robert was transported to the Indian River County Jail without incident.

WELLENGTH THE STREET OF THE ST

On Wednesday, September 17, 2025, at approximately 1026 hours, while on routine patrol in the 8400 block of 20th Street, Vero Beach, Florida, I conducted a check of the wooded area that was recently posted for trespassing.

As I entered the woods near a homeless camp, I immediately observed Jason Edward Thompson riding a bicycle through the area. I recognized Jason from a previous investigation I conducted under case #2025-87488, in which Jason was a co-defendant. An arrest warrant for Jason had been filed and approved under warrant #WR20251000.

Upon contact, I asked the subject to identify himself, and he confirmed he was Jason Thompson. I immediately began taking Jason into custody. Jason advised me to use caution because he had a hypodermic needle in his right shorts pocket. Once Jason was secured in handcuffs, I conducted a search incident to arrest. During the search, I recovered the needle from his pocket, at which time a white, rock-like substance fell to the ground. When I picked up the substance, it crumbled into a powder-like form. I placed the substance, along with the needle, into my latex glove for safekeeping.

Jason was then escorted to my patrol vehicle near 20th Street and placed in the rear seat. I read Jason his Miranda Warnings of Constitutional Rights, which he acknowledged and stated he understood. Jason further agreed to speak with me.

While I read Jason his rights, Corporal Hoffman took possession of the substance to conduct a field test. A short time later, Cpl. Hoffman advised the substance tested positive for Fentanyl using a department-issued test kit. Jason denied the result, stating the substance a similar form like Suboxone, which he claimed had been prescribed to him. To confirm the result, I joined Cpl. Hoffman at the rear of my patrol vehicle, and we tested the substance with a second field test kit. The second test again yielded a positive result for Fentanyl.

During this time, dispatch confirmed the arrest warrant for Jason was still active.

Jason was transported to the Indian River County Sheriff's Office Jail, where he was turned over to jail staff for processing. He was served with warrant #WR20251000 (bond set at \$15,000) and additionally charged with violating the following Florida State Statutes:

- FSS 893.13 Possession of a Controlled Substance (Fentanyl)
- FSS 893.147(1) Possession of Drug Paraphernalia

The incident was recorded on my department-issued Axon body-worn camera and Fleet 3 in-car audio/video system.

This case is Inactive/Closed by arrest of Jason Edward Thompson.

Arrest Affidavit Report

NARRATIVE

On Wednesday, September 17, 2025, at approximately 1050 hours, I responded to 953 Old Dixie Highway 1 in reference to an auto burglary.

Upon arrival, I made contact with the victim, Todd Dubose, who stated the following: On today's date, he parked his black F250 bearing FL/Z83DZV, in the back of the plaza while he went to work. Todd works in unit 15. He became aware by the neighboring business that someone had broken into his vehicle. Upon review of the camera's, he discovered that a black male entered his unlocked vehicle by the driver door. The subject stole approximately three to five dollars' worth of loose change.

The business owner from unit 16, Tamara Harris, was able to show me camera footage. I reviewed the following on camera footage: At approximately, 1008 hours, a black male wearing a striped shirt and shorts, is seen tugging on the driver door of a red SUV. This SUV was parked on the NW side of the plaza. The suspect was unable to get it due to it being locked. The suspect then walks over to a black F250 (later identified as Dubose's vehicle), opens the driver door and leans in. That's when the camera clip ends. At 10:09 hours, the camera captures the suspect walking south behind the plaza from the pickup.

The camera footage was emailed to RTCC who was able to identify the suspect as Rocky Bishop. Corporal Szott provided a suspect description to surrounding deputies.

I then spoke to the second victim, Angelica Gallego, who stated the following: She became aware of her vehicle, red SUV bearing FL/59ANGT, being broken into by camera footage. Angelica confirmed her vehicle was locked therefore the suspect could not get it.

While on scene processing the vehicles, Corporal Newberry located my suspect at 800 Old Dixie Highway. Corporal Newberry transported Rocky back to my location. I read Rocky his Miranda Right's in which he stated he understood. Rocky then stated he was competent for trial but wanted an attorney

It should be noted that Rocky was wearing the same exact clothing on in the camera footage. He also had the same physical features and haircut as the suspect in the camera footage. A search incident to arrest of Rocky was conducted and two nickels and a penny was discovered.

Based on the totality of the circumstance's, I developed probable cause to charge Rocky with violating FSS. 810.02.4(A) Auto burglary (2X) and FSS. 812.014 petit theft.

NARRATIVE

On Wednesday, September 17th, 2025 at approximately 1906 hours, I responded to Stix Billiards located at 939 14th Lane, Vero Beach, Indian River County, Florida, 32960, in reference to an intoxicated driver.

Prior to my arrival Indian River County Communications Center (Dispatch) received a call there was an intoxicated male laying on the ground beside a Gold Toyota Pickup bearing Florida Tag (Z307AR). The caller then advised the intoxicated male got into the driver seat of the vehicle.

Upon my arrival I observed a white male in the driver seat of the gold Toyota pickup, he was later identified as Mr. Dale Janson (Arrestee) by his Florida License.

Mr. Janson was observed to have thick slow slurred speech, and watery eyes. I requested Mr. Janson to step out of the vehicle and walk to the front of my patrol car. Upon exiting Mr. Janson was uneasy on his feet. I could smell the distinct odor of alcoholic beverage emit from Mr. Janson's breath as he spoke.

I then spoke with Ms. Kaliana Castillo (Witness) who stated the following in substance. She was putting her grandmother's walker in the trunk of her car when she saw Mr. Janson laying on the ground beside the gold Toyota pickup. Ms. Castillo saw two young males help Mr. Janson from the ground. Mr. Janson then used the bed of the truck to guide himself into the driver's seat of the truck. She watched the passenger of the gold Toyota pickup unlock and open the door for Mr. Janson.

Due to my observations, I requested Mr. Janson to submit to Standardized Field Sobriety Exercises (SFSE's). Mr. Janson denied at first, then decided to submit to SFSE's.

I questioned Mr. Janson about his medical history and received no alarming responses. Mr. Janson was wearing contacts during the incident.

The first exercise I conducted was the Horizontal Gaze Nystagmus exercise. Mr. Janson's pupils were equal size and tracked simultaneously. I observed the Lack of Smooth pursuit, Distinct and Sustained Nystagmus at Maximum Deviation and immediate Onset of nystagmus at an angle of approximately 30 degrees. Mr. Janson was reminded multiple times to not move his head.


The second exercise I conducted was the Walk and Turn (WAT) exercise. I explained and demonstrated the exercise to Mr. Janson who stated he understood the instructions. Mr. Janson displayed difficulty balancing and was unable to maintain the starting position while listening to the instructions. Mr. Janson missed heel to toe, stepped off the line, took an incorrect number of steps and only went one direction, and raised his arms away from his body to balance. Mr. Janson did not complete this exercise to standard.

The third exercise I administered was the One Leg Stand (OLS) exercise: I explained and demonstrated the

exercise to Mr. Janson who stated he understood the instructions. Mr. Janson lifted his left foot off the ground for
approximately (2) second before losing his balance and placing it on the ground. He then lifted it up again for

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On September 17th, 2025, at approximately 2103 hours I was conducting stationary traffic enforcement at the intersection of Temple Avenue and King Street when I observed a green Toyota pick up truck bearing Florida registration 04FDUN fail to come to a complete at the stop sign at King Street and Temple Avenue. I got behind the vehicle and conducted a traffic stop utilizing my overhead emergency lights and came to a final stop west bound from the intersection of Sebastian Blvd and Fleming Street.

I made contact with the driver and sole occupant, Christina Perez, identified by her Florida driver license. I noticed on the center console a multi colored glass marijuana pipe and a lighter within reach of Perez. Perez provided her registration and displayed her proof of insurance on her cell phone. Perez stated she did have a valid medical marijuana card, which was confirmed my Sebastian Police department dispatch. I asked Perez if there was anything illegal in the vehicle, Perez denied. I also observed an empty beer bottle and a full beer bottle on the passenger side floorboard. Perez was escorted out of the vehicle and stood by with Officer T. Keiser as myself and Officer Venegas conducted a search of the vehicle for contraband.

I observed the glass multicolored marijuana pipe on the center console and observed burnt marijuana residue and a lighter next to it on the console.

During the search of the vehicle, I began on the passenger side. I searched a black open workbag on the floor when I observed a black and blue sunglass case with a wooden stick poking out of the side. As I opened the sunglass case, I noticed a glass crack pipe with black burn residue on the inside. Also inside the case was a small plastic baggie with white residue, suspect fentanyl. Based on my training and experience, this is commonly identified as a drug user kit due to the type of paraphernalia together in an accessible container, the wooden stick was identified as a "push rod." A push rod refers to a instrument that is utilized to push narcotics through the pipe to one side. The pipe is then heated up at the end causing the narcotics to be inhaled in order for the user to achieve a high.

At this time Perez was detained with her hands placed behind her back in mechanical hand restraints that were double locked and checked for proper fit.

I continued my vehicle search on the passenger side in the black work bag when I observed another small multicolor neoprene zipper bag inside. I opened the zipper bag and observed a folded piece of aluminum foil. Due to my training and experience, a folded piece of aluminum foil is commonly used by drug dealers to dispense user amounts of drugs to users during transactions. I opened the aluminum foil and observed a small green and black square with a design on it. Based on my training and experience, I identified this as a tab of lysergic acid diethylamide commonly known as LSD. Inside the same bag was a small plastic baggie containing more white substance, suspect fentanyl.

On top of the driver seat a small torn plastic bag containing a half of a round orange colored pill was located, Sergeant Melius identified the substance as suspect MDMA.

I conducted a preliminary field test on the suspect fentanyl baggie inside of the neoprene zipper bag, which yielded positive results for fentanyl. I conducted a preliminary field test on the suspect MDMA, which yielded positive results for MDMA.

Sergeant Melius conducted a preliminary field test on the suspect LSD, which yielded positive results for LSD.

At this time, I found probable cause that Perez was in violation of F.S.S 893.13(6)(A) POSSESSION OF FENTANYL for the substance inside small plastic baggie that tested positive for fentanyl, F.S.S 893.13(6)(A) POSSESSION OF MDMA for the half of pill inside of the torn bag tested positive for MDMA, F.S.S 893.13(6)(A) POSSESSION OF LYSERGIC ACID DIETHYLAMIDE for the square tab of LSD inside of the folded aluminum foil that tested positive for LSD.

Perez was placed in the rear seat of my patrol and transported to Indian River County Jail without incident.

NARRATIVE

On September 17, 2025 at approximately 2146 hours, I was assigned as the Indian River County Sheriff's Office Sex Offender/Predator tracking detective.

At approximately 1600 hours, I was notified by IRCSO Registration Specialist, E Thomas that we had a possible sex offender from Duval County currently residing in Indian River County that has not reported to the Sheriff's Office for address update or registration. The residence was also within 2500 feet of two schools which is a violation of Indian River County Ordinance. According to Specialist Thomas, she identified the offender as David Robert Swartz and according to the sexual offender/predator system (SOPS), he updated his Florida ID Card to the address of 4330 14th Lane Vero Beach, Florida 32966 with the Department of Motor Vehicles on September 4, 2025 which alerted IRCSO of his presence in our county. Swartz received his sexual offender status in Georgia following a conviction back in 1996 and 2007. Swartz is a qualifying sex offender under Florida Statute 943.0435 and currently registers in Duval County, Florida.

At approximately 2146 hours, I responded to Swartz' updated address and made contact with Michael McCann. McCann told me that he was the "house manager" for the residence and that it was a "sober house." McCann stated that Swartz had been permanently living at the residence since July of 2025. I then made contact with Swartz who was very truthful and forthcoming with information. Swartz stated that he had been living in Duval County prior to moving to Vero Beach. Swartz stated that he moved in to 4330 14th Lane on July 27, 2025 and acknowledged that he should have reported the information to the Indian River County Sheriff's Office. Swartz also stated that he failed to report vacating his Duval County address to the Jacksonville Sheriff's Office. Swartz went onto say that he is a recovering alcoholic and did not want to report the information to the Sheriff's Office for fear of being "kicked out" of his permanent residence.

According to Florida Law, David Michael Swartz is a registered Sex Offender in the State of Florida required to report establishing temporary, transient or permanent residency within 48 hours to the respective county Sheriff's Office. Swartz failed to do so and has been living in Indian River County without reporting such information since July 27, 2025. David Swartz is in violation of 943.0435.2a Fail to Report at County of Residence (Sex Offender Offense).

Swartz also failed to report vacating residency in Duval County. I made contact with the Jacksonville Sheriff's Office and informed them of the incident due to jurisdictional requirements.

On September 17, 2025, at approximately 2218 hours, I was dispatched to reference to a runaway juvenile male.

Once at the intersection of Seaside Terrace and George Street, I observed a white Ford F-350 with a male driver traveling northbound on George Street. I observed the driver's side window of the truck to be rolled down, and the male was waving at me in a manner to get my attention. Upon stopping, the male stated he was the one who called. The male stated his son was last seen running North on George Street. I advised the male that I had just driven from that direction and did not see his son. I requested the male follow me back to his residence so I could gather further information from him.

Upon arrival at a process I observed an adult female and a juvenile female in the driveway of the residence. As I approached them, the juvenile female was hysterically crying and visibly upset. The adult female was irate and yelling. I also observed a black Cadillac sedan in the driveway with extreme damage to the driver's side door. I observed the vehicle door to be pushed forward toward the hood of the vehicle, with large dents and scrapes in the paint. The older female was identified as Susy Marie Sedatol due to her being the registered owner of the black Cadillac. Susy began yelling at me that her son had punched her and then run away.

Upon the arrival of the male in the white truck, he exited his vehicle and stood at the end of the driveway. Susy saw the male and pointed at him. Susy stated he was her ex-husband, and he also hit her. Susy then became increasingly upset with the male. Due to the incident escalating, I requested the male to sit in his truck until other officers arrived. The male complied and reentered his vehicle.

Susy stated she was at Earl's Hideaway (a popular bar in Sebastian), drinking alcoholic beverages. She stated she stayed out late, and upon returning home, her ex-husband and son were in the living room. Susy stated that she and her ex-husband began to argue, but her ex-husband went to his room. Susy stated that she and her son then began to verbally argue. Susy stated her son got into her face and began cursing at her. Susy stated her daughter then exited her bedroom and got in between them. Susy stated her ex-husband exited his room and also tried to separate them. Susy stated her son got past her daughter and charged her. Susy stated her son then struck her in her cheek with a closed fist. Susy stated all parties then went outside the residence. Susy stated that while outside, her ex-husband then struck her with a closed fist in the same spot as her son. Susy stated her son then ran back into the residence, grabbed his school bag, and ran away. It should be noted that Susy had the odor of alcoholic beverages emitting from her breath. Susy also continuously talked over officers and was argumentative with them. Due to this, Susy was offered a written statement form to make her line of events more transparent and easier to understand. Susy refused the form and became irate with the officers.

It should be known that there were no observable physical injuries to Susy's face at this time.

I then spoke with Susy's ex-husband. I identified him by his Florida-issued driver's license as Juan Jose Rodriguez (Florida driver's license number R42803660000). Juan stated that he and his son were watching television in the living room. Juan stated that Susy then returned home extremely intoxicated and began verbally arguing with him. Juan stated he separated himself from Susy by going to his bedroom. Juan stated that while inside his room, he heard Susy and his son yelling at one another. Juan stated he exited his bedroom and observed his daughter between his son and Susy, attempting to separate them. Juan stated that he then began to attempt to separate them. Juan stated his son and Susy then reengaged, but this time physically. Juan stated that somehow, they ended up outside the residence. Juan stated that his son then ran inside the residence, grabbed his school backpack, and ran away. Juan stated Susy and he began to argue. Juan stated Susy then struck him in his face, knocking him onto the ground. Juan stated Susy then got into her black Cadillac and attempted to start the vehicle. Juan stated that then, due to Susy's intoxication, he feared she would drive the vehicle, so he had already unplugged the vehicle's battery. Juan stated Susy then began to yell at him, so he got into his truck and attempted to leave the residence to look for his son. Juan stated Susy had left the driver's side door of the Cadillac ajar. Juan stated he could not see this, and when he began to drive, the rear passenger side fender of his truck struck the door, causing the damage. Juan stated that he and Susy have two juvenile children together and Juan stated that he and Susy still have an ongoing romantic relationship and were planning on remarrying.

It should be known that Juan's face was not injured, but he did have a cut on his knee consistent with falling down.

I then spoke with Juan and Susy's daughter. I identified their daughter as OR. OR stated Susy came home late from being out. OR stated that Juan and her brother were mad about Susy being out so late. OR stated she heard them all yelling at each other, so she exited her bedroom. OR stated she observed Susy and he brother arguing, so she got in between them in hopes they would not fight. OR stated Susy then spat her saliva onto her brother. OR stated her brother then stuck Susy, and then ended up on the ground. OR stated that she and her father then attempted to separate them and were successful in doing so. OR stated she stayed with her brother so he would not re-engage with Susy. OR stated they ended up outside the residence but could not recall how. OR stated Susy then attempted to start her vehicle, but Juan had unplugged the battery. OR stated her brother then ran away. OR stated her dad then got into his truck and began to look for her brother. OR stated she got Susy inside the residence, and began to run in the direction she saw her brother running. OR stated that Juan saw and told her to get into the truck with

OR stated that when her dad got out of the truck, Susy began to yell at him. OR stated that was when he called law enforcement. OR stated Susy then struck Juan, knocking him to the ground. OR stated Juan then reentered his vehicle and left.

Sergeant Melius (#208) located the son just down the road from the scene. Sergeant Melius observed several significant scratches on the right side of the son's face. Sergeant Melius identified the son as SR. Officer Keiser responded to Sergeant Melius and transported SR back to the scene. SR stated he was in the living room when Susy returned home late and highly intoxicated. SR stated Susy then went to her room, but soon came out and went to Juan's room. SR stated Susy then left Juan's room, and as she walked past, SR made a comment about his father, which he did not like. SR stated he was unable to remember the exact comment. SR stated his and Susy began to verbally argue. SR stated that Juan and OR then exited their rooms and got between Susy and his. SR stated Susy, then spat in his face. SR stated he and Susy got past Juan and OR. SR stated he then struck Susy. SR stated he and Susy, then both began striking each other. SR stated they somehow ended up outside, and he then grabbed his backpack and ran away.

Due to the physical injuries to SR, being consistent with his and OR's statements, Susy's statement not matching the physical injuries, and Juan and OR's statements of Susy striking him being consistent, Susy was placed under arrest. I placed Susy into Mechanical hand restraints, which were checked for a proper fit and ensured to be double locked.

NARRATIVE

On Thursday, September 18, 2025, at approximately 0012 hours, I responded to the Staybridge Suites located at 5155 20th Street, Vero Beach, Florida 32966 in reference to a disturbance.

Upon arrival I made contact with Sgt. D. Hoilett, Mr. Steven Parisi (Suspect/arrestee) and Ms. Sarah Buckely. Sgt. D Hoilett advised me of the following: While investigating a previous incident (refer to case number 2025-00100506), it was revealed that Mr. Parisi is the defendant in a Domestic Violence Protection Order where Buckley is the respondent. This information was verified by our Dispatch Center and Lowell PD's Dispatch team. Sgt. D. Hoilett read Mr. Parisi his Miranda Warnings. Mr. Parisi stated he understood. Post-Miranda, Mr. Parisi stated he was aware of the injunction out of Massachusetts and that it came about due to Child Protective Services requiring Ms. Buckley to issue it if she wanted to retain custody of her child. The child was not present during the investigation and is currently with Buckley's mother out of state.

I then made contact with Mr. Parisi who advised all of what Sgt. D. Hoilett had previously advised me to be true. I continued this investigation and determined Mr. Parisi to be in violation of the Lowell District Court "Abuse Prevention Order – Docket no. 2511R0771."

Mr. Parisi, further advised, he and Ms. Buckely had not been separated a day since the protection order got put in place and how they have been living together either in a car or at his parent's house in New Hampshire. While living in the house in New Hampshire, Mr. Parsi claimed the child he and Ms. Buckely have in common also resided with them. He continued by describing how the two are down in Florida for him to start working as a barber and get an apartment together.

I have probable cause to believe Mr. Parsi did violate F.S.S. 741.31.4a[2494] by violating numerous conditions of the "Abuse Prevention Order – Docket no. 2511RO771" which state Mr. Parsi is not to contact with Ms. Buckely, stay away from and leave Ms. Buckely's residence and Mr. Parisi not to have contact with the children listed within Ms. Buckely's custody.

Mr. Parisi was placed under arrest and transported to the Indian River County Jail without incident.

A copy of the "Abuse Prevention Order – Docket no. 2511RO771" is included in this arrest for referral.
