NARRATIVE

On Wednesday, October 23rd, 2024 at approximately 2111 hours Deputy Apollon and I were stopped in the left-hand turn lane at the 1400 block of US Highway 1, Sebastian, facing northbound. I observed a red 2017 Chevy Silverado bearing FL Tag #QHRK18 traveling northbound in the inside (left) lane of travel rapidly approaching my position. I visually estimated the vehicle to be traveling at approximately 60 mph in a posted 35 mph zone. I activated the rear antenna of my Stalker DSR 2X radar unit and received a speed of 60 mph.

We caught up to the vehicle at the 1500 block of US Highway 1. The vehicle moved into the left-hand turn lane and made a U-turn violating the right of way of a vehicle traveling southbound causing the vehicle to apply its brakes while he turned.

I made a passenger side approach to the vehicle and made contact with the driver and sole occupant of the vehicle Joshua Keith Walls. While speaking with Walls I could smell the odor of an alcoholic beverage emitting from inside of the vehicle. Walls had bloodshot and watery eyes. While Walls was speaking his speech was slurred. Walls initially stated that he never saw a vehicle when he was making a U-turn. Walls then advised he saw the vehicle with only one head light, which was the vehicle he turned in front of. I asked Walls if he consumed any alcoholic beverages, he stated that he has not.

I requested Walls exit the vehicle so that we could speak in a safer location. When Walls exited his vehicle, I observed a pocket knife in his left pant pocket. I removed the knife and observed that his zipper and pant button was undone. I conducted a pat down of Walls and informed him that his pants were undone, he stated, "I just took a piss, I forgot to put it up", he then asked if it was a problem. While speaking with Walls I could smell the strong odor of an alcoholic beverage emitting from his breath as he spoke. Walls was slow motioned and he had an orbital sway. I asked Walls if I could voluntarily look at his eyes further, he denied. I asked Walls if he uses any prescription medications or medical marijuana, he stated that he does not. I again asked Walls if he consumed any alcoholic beverages today, he stated that he did not. I asked Walls if he was willing to submit to the field sobriety exercises, he stated no. I informed Walls that if he refused to submit to the field sobriety exercises, his verbal statement could be used against him, he stated that he understood. I informed Walls that if he refused to submit to the standardized field sobriety exercises, I would have to base any arrest decision from my observations up to this point, he stated that he understood. I again Walls if he would submit to the exercises, he stated no.

A query through dispatch and DAVID revealed that on 06/10/2024 Walls was adjudicated guilty for DUI in reference to CASE/CITATION #1502XEJ in Indian River County. Walls was taken into custody for violation of FSS 316.193(6) DUI w/priors. Walls drivers license was also cancelled on 10/23/2024 for, "FAILURE TO COMPLETE BDI 322.0261". He was transported to the Indian River County Jail for booking.

At the county jail booking staff requested Walls provide a lawful breath sample and he refused. He was read implied consent and he again refused. A query through DAVID revealed the following:

NARRATIVE

On Wednesday, October 23, 2024, at 1832 hours, I responded to the front parking lot of the Indian River County Sheriffs in reference to a report of a past domestic violence incident.

Upon arrival, I made contact with the complainant, identified as Jeremy Collins. Collins stated that he was advised by [REDACTED] identified as William Vennetti, had physically assaulted her in the presence of [REDACTED]. Collins stated that [REDACTED] identified as Gabriella Gliatta, had sent him pictures of her injuries, which included a severe black eye. Collins continued to state he was advised by Gliatta that Vennetti had called [REDACTED] racial slurs, which started a verbal altercation between them.

Collins stated that Gliatta proceeded to spit at Vennettis face during the verbal altercation. Collins continued to state that Vennetti proceeded to grab Gliatta by her hair and began to punch her in the face several times. Collins expressed concern for the safety of [REDACTED] who were present during the incident. Collins stated that he had a [REDACTED] and had traveled from California to pick up [REDACTED] due to the emergency situation.

I then proceeded to the residence, which is located at [REDACTED] to investigate further. Upon arrival, I made contact with Vennetti and placed him in handcuffs. Vennetti was then placed in the back of my marked patrol vehicle for further questioning.

I then made contact with Gliatta. Gliatta initially denied that Vennetti had assaulted her, claiming that her injuries were the result of an accidental fall. Gliatta later admitted that Vennetti had pulled her hair and grabbed her by the neck.

After speaking with Gliatta, I made contact with Vennetti and advised him of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda Vennetti admitted to grabbing and pulling Gliattas hair but stated it was after she spit on him. Vennetti denied punching Gliatta in the face and that the injury to her eye was sustained due to her running into a countertop while playing with [REDACTED].

I made contact with Gliatta and advised her of her Miranda warnings, in which she acknowledged and continued to speak with me. Post Miranda, Gliatta admitted to spitting on Vennetti during the verbal altercation. Gliatta stated that injury to her eye was not sustained from Vennetti. Gliatta stated she sustained the injury to her eye from running into a countertop while playing with her so.

I then made contact with Gliattas [REDACTED] identified as Barbara Vennetti. Barbara corroborated Gabriela's account of the argument but initially denied any physical altercation. Barbara later admitted that she had to jump on Vennettis back while he was grabbing her hair.

Due to the above mentioned, I criminally charged Vennetti with the following charges:

F.S.S 784.03 Battery

Vennetti was transported to the Indian River County Jail without further incident

I then made contact with Gliattas [REDACTED] identified as Barbara Vennetti. Barbara corroborated Gabriela's account of the argument but initially denied any physical altercation. Barbara later admitted that she had to jump on Vennettis back while he was grabbing her hair.

Due to the above mentioned, I criminally charged Gabriela Gliatta with the following charges:

F.S.S 784.03 Battery

Gliatta was transported to the Indian River County Jail without further incident

NARRATIVE

On October 23rd, 2024, at approximately 1915 hours, I responded to the area of Outback Steakhouse, located at 6040 Elon Lane, Vero Beach, Florida, in reference to a criminal mischief.

While enroute, Indian River County Sheriff's Office (IRCISO) dispatch advised a white female with a shopping cart broke items at Outback Steakhouse and left without paying for her food. After arriving in the area, I located a female matching that description in the area of 6020 Elon Lane. The female was later identified as Ms. Kathy Bovett.

I made contact with Ms. Bovett and attempted to speak with her, but she was making incoherent statements and would not identify herself. As I continued to attempt to speak with her, a vehicle arrived in the area. Ms. Bovett was instructed to stay with me so Corporal Hatton could speak with the occupant; however, Ms. Bovett turned around and walked away from me, towards her shopping cart full of items. Ms. Bovett was subsequently placed into handcuffs and detained for officer safety and refusing to comply with lawful instructions.

I requested Ms. Bovett's name, to which she advised it was "Susan L Ferrera" and stated her date of birth was "01-01-1951." I requested her information again and she provided the same. During an NCIC/FCIC query of the name Ms. Bovett provided, IRCISO dispatch advised there were no records returned based on the name and date of birth given.

I also made contact with the manager of Outback Steakhouse, Ms. Barbara Guidice. Ms. Guidice explained that Ms. Bovett arrived at the restaurant and seated herself at a dining table outside by the restaurant entrance. Ms. Bovett subsequently ordered a beer and food and began consuming them while seated at the table. Ms. Guidice stated that Ms. Bovett started smoking a cigarette - when Ms. Bovett was advised that she cannot smoke a cigarette, she became belligerent and was yelling expletives and disturbing the restaurant guests. Ms. Bovett then threw her salad bowl (valued at \$10), glass (valued at \$10), and glass beer stein (valued at \$20), causing the glass beer stein to shatter. Ms. Guidice explained that the broken beer stein would have to be discarded, as well as, the bowl and glass due to them touching the ground. Ms. Guidice further stated that Ms. Bovett left the area without attempting to pay for her food or drink. Ms. Guidice provided a receipt for Ms. Bovett's food a drink that she did not pay for (valued at \$11.76).

While speaking with Ms. Guidice out front of the restaurant, I observed the broken beer stein, salad bowl, and glass lying on the sidewalk near the entrance. During the investigation, based on statements provided, it was determined that Ms. Bovett affected the peace and quiet of patrons who witnessed her actions and outraged the sense of public decency of the customers at the Outback Steakhouse.

Ms. Bovett was subsequently placed under arrest for the offenses of giving false name while detained, resisting an officer without violence, criminal mischief, disorderly conduct, and defrauding a food establishment. I read Ms. Bovett her Miranda Rights, during which time she continued yelling and screaming incoherently; therefore, I could gather her side of the story. Ms. Bovett was then transported to the Indian River County Jail.

After arriving at the jail, Ms. Bovett would not provide a name to booking staff. A Rapid ID query was conducted via Ms. Bovett's fingerprint, which provided her legitimate name and date of birth.

NARRATIVE

On Wednesday, October 23, 2024, at approximately 0908 hours, I was conducting an area check at 1150 5th Street SW, Vero Beach, Florida when I was flagged down for a disturbance.

Upon arrival, I made contact with Michael Thorne a county worker for Storm Water Division. Michael stated the suspect, Kimberly MacGregor, sped through the area which caught his attention. He left his office and saw her getting a dog out of the vehicle. Michael told Kimberly she could not walk her dog at this location, as it is not a service dog. Michael said Kimberly started to yell absurdities at him saying things like, "fuck you, you old man". Michael said he would like to have Kimberly trespassed from this area.

While obtaining a statement from Michael, Kimberly started going through her bag inside her vehicle. I told Kimberly to stop rummaging through her bag for officer safety reasons. Kimberly said, "I can reach for whatever I want", as she continued to reach in her bag. Kimberly was irate and uncooperative. For officer safety reasons, in not knowing what was in the bag I asked her to exit the vehicle, and simultaneously she started to roll the window up. I pushed down on the window to stop it from rolling up and opened the door from the inside. Kimberly grabbed my arm, and hand and tried squeezing it as she continued to push my arm out of the vehicle. I gave her multiple commands to exit the vehicle. Once I opened the door, I waited for backup to arrive before removing her from her vehicle.

Deputy Wolfe and Corporal Barcaro arrived on scene. I gave another verbal command for Kimberly to exit the vehicle on her own, she was not complacent. Myself and Deputy Wolfe went to remove her from the vehicle. Upon doing so, Kimberly kicked me in the chest, causing me to lose my balance and have to gain my footing. We were able to remove her from the vehicle. Deputy Wolfe and I detained Kimberly, searched her, and placed her in the rear of my patrol vehicle.

At the time of the incident Deputy Wolfe, Corporal Barcaro and myself were on duty as Deputies for the Indian River County Sheriff's Office. We were wearing Indian River County Sheriff's Office-issued patrol uniforms clearly marking us as law enforcement. Kimberly was aware we were Law Enforcement Officers.

Due to the totality of circumstances to include, Kimberly knowing we were Law Enforcement Officers, her resisting a verbal command, and physically grabbing my arm and kicking me, I placed Kimberly under arrest for resisting officer with violence pursuant to F.S.S. 843.01.

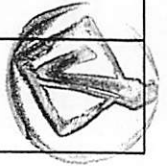



After running a query through dispatch, I was informed that there was no record of the female. I requested Corporal Radock at my traffic stop since he has Rapid ID. After a couple of unsuccessful attempts, we had Corporal Macias from the Indian River Sheriff's Office assist us with the Rapid ID.

Corporal Macias successfully obtained Karime's fingerprints, but he did not get any record back for her.

At this time, I placed Karime in mechanical restraints, double-locked, she was searched and placed in the back of my patrol car.

Karime was arrested because she was driving without a driver's license and never had one issued to her. Karime also does not have any ties to Sebastian or Indian River County since she stated she lived in Palm Bay, located in Brevard County.

Karime was transported to Indian River County Jail without any further incident.
