On June 6th, 2025, at approximately 1244 hours I responded to 1000 36th Street room number

stated that she was wearing gloves during the battery. I did not observe any injuries to her hand. No other witnesses were present during this incident. Dilks made it clear that the bit was intentionally from inmate Noce and she wished to pursue criminal charges.

I spoke with inmate Noce and read her Miranda warnings which she confirmed understanding. Noce denied biting Dilks hand.

I found probable cause that Noce committed battery on LEO. Noce remained in the custody of the Indian River County Sheriff's Office (corrections).

#### NARRATIVE

On June 16th, 2025, Indian River County Sheriff's Office (IRCSO) Detective Dylan Farinacci, hereinafter your affiant, was notified as the on-call detective of a domestic violence incident between Carey Newman and Fay Sierra that occurred at 700 Alexandra Avenue Southwest, Vero Beach, Florida.

On June 16<sup>th</sup>, 2025, your affiant secured a search warrant for 700 Alexandra Avenue Southwest for items that were used during the domestic violence incident. The search warrant was signed by the Honorable Judge Robert Meadows.

While searching Carey Newman's bedroom, your affiant located a yellow backpack in the closet. Upon opening on of the backpack's compartments, your affiant located a clear plastic bag that contained multiple rounds of ammunition. Your affiant contacted IRCSO's Public Safety Dispatch, who verified that Carey Newman was a three-time convicted felon via a criminal history check. Your affiant ceased the search of the residence due to the search warrant not including ammunition, and requested IRCSO Detective Leon Bennett to secure an amended search warrant for the residence.

Detective Leon Bennett secured an amended search warrant for 700 Alexandra Avenue Southwest. The amended search warrant was signed by the Honorable Judge Robert Meadows.

The search was resumed. The following items were located, photographed, and seized:

Various calibers of ammunition inside of the aforementioned yellow backpack by your affiant. Your affiant
also located a nylon duty belt, which your affiant determined to belong to Carey Newman due to his
statements about wanting to be a defensive tactics instructor for a nearby law enforcement agency.



On 06/19/2025 at approximately 0747 hours, I responded to 1005 21st St. (Citgo) in reference to a male that stole a beer (Natural Ice) and left on foot. The male described was located at Ironside (953 20th Pl.) and identified by his FL ID as, Paul Karol. Karol also had a can of Natural Ice next to him. At that time, the complainant/employee, Syed Raza, wished to trespass Karol from 1005 21st St. (Citgo). Karol was clearly notified verbally that he was now trespassed from Citgo and he acknowledged that he understood. A trespass warning was completed (cfs:061925-32) At 0929 hours, the same complainant/employee from the previous incident, Syed Raza, had returned to the property and entered the store. It was confirmed to be the same male from less than 2 hours prior, Paul Karol, and Raza wished to prosecute for trespassing and theft. Cpl. Lachowicz located Karol on the corner of 10th Ave and 20th Pl. and observed Karol "chugging" a 25 ounce can of Natty **PROBABLE CAUSE STATEMENT** Daddy as he made contact with him. Karol was placed into handcuffs and read his Miranda rights. Karol acted belligerent and yelled over Cpl. Lachowicz that he knew his rights. Post Miranda, Karol stated "yeah, I stole so bring me to jail." Karol was placed under arrest and transported to the Indian River County Jail. Karol was charged with FSS 810.09(2A) -Trespass on property, FSS 812.014(3A) - Petit theft, and City Ordinance 6-9 - Open container. Karol will be held on a \$1,500 bond.

### NARRATIVE

On June 19<sup>th</sup>, 2025, at 1810 hours, I was assigned a welfare check in reference to a bald, white male that appeared to having either a medical emergency or possibly under the influence, sitting in the driver seat of a black Ford F-150 bearing FL/ LZMF97. After an unsuccessful attempt at locating the vehicle, myself and assisting units cleared the call. At 1856 hours, I was dispatched to an auto accident leaving the scene at 9250 Island Grove Ter, reference the same vehicle and driver description, where the male struck a parked, unoccupied vehicle. Right in front of the registered owner of the damaged vehicle.

Upon my arrival, I made contact with the complainant, who provided me a suspect description. They advised the driver was a white male wearing glasses who was bald. It should be noted that their suspect description and vehicle description was the same given for the previous welfare check call for service. It should be noted that the driver description provided was consistent with the appearance of the registered owner. The victim stated that they attempted to get the driver of the vehicle to stop and discuss the crash but the driver responded by accelerating out of the parking lot, almost striking the victim's husband with his pickup truck.

After concluding the crash investigation with the victim, I requested additional units to assist in attempting to locate the suspect vehicle. Public Safety Dispatch provided a local address for the registered owner of the suspect vehicle, 9038 Castle Harbour Cir, too which assisting units responded to and located the suspect vehicle backed into the driveway of the residence, almost touching the garage door, with body damage consistent with the damage the vehicle would've sustained given the vehicle's positioning description that was provided by the victim who witnessed the incident.

After responding to the registered owner's residence, I made contact with assisting deputies and officers on scene that located the aforementioned vehicle. Upon our approach to the residence, while knocking on the door, an assisting officer observed the registered owner, Timothy Kudzma, inside his residence and requested he come speak with us. Kudzma complied and opened the door, but failed to exit his residence. While introducing ourselves, I observed Kudzma to stand in in the threshold of the doorway, bracing himself with his left arm. It should be noted that Kudzma appeared to sway back and forth as if he was having a difficult time balancing while standing still. After introducing myself, I requested Kudzma to exit his residence and speak with me. Kudzma responded by stating "I'm not coming out of my house" in an extreme slurred speech. Let it be noted that as soon as Kudzma spoke, I was met with an overwhelmingly sweet odor emitting from his breath. After Kudzma's first statement, I apologized to him due to my initial inability to understand what he stated due to how slurred his speech was. Kudzma repeated himself by stating "I'm not going to leave my house, why are you guys here."

Prior to explaining the reason for contact to Kudzma, I asked if he was okay, too which he replied

by stating "I'm fine." I then informed Kudzma that I had reason to believe that he was involved in a motor vehicle accident, and wished to discuss the details of the crash. Kudzma responded by stating in an extreme slurred speech, "alright, I'm not coming my house." Due to Kudzma's dismissive behavior I reexplained the reason for contact and attempted to reassure him that, at that time, I was solely investigation the auto accident, and asked Kudzma one final time if he would be willing to discuss the motor vehicle accident with me too which he replied by stating "no." I then advised Kudzma that I had concluding my crash investigation and that I would be changing hats, too which he turned away from me and retreated back into his residence.

After a brief moment where Kudzma was out of sight he returned to the threshold concealing his left hand in his pocket, after he had already been given a verbal command to keep his hands out of his pockets for officer safety reasons. Kudzma stated that he "would like to close my (his) door," then leaned out of the threshold and extending his left hand towards the right side of my hip, where my agency issued duty firearm is holstered. After observing Kudzma arm extending towards my duty pistol, I grabbed Kudzma's left arm and quickly detained him.

Once detained, I read Kudzma his Miranda Rights from my agency issued Miranda Rights card. Post Miranda, Kudzma expressed his understanding of his rights and advised he did not wish to speak with me. I then transported Kudzma to the Indian River County Jail where I advised Kudzma of his Taylor Warnings. Post Taylor Warnings, Kudzma stated he would still not participate in standardized field sobriety exercises. Kudzma was then read Implied Consent by Corrections Deputy Rodriguez too which he expressed his understanding and refused as well.

Through my investigation, I found Timothy Kudzma to be in violation of FSS 316.063(1), crashing leaving the scene of an unattended vehicle reference Citation #ADKMY8E, and FSS 316.193, dui (first refusal) reference Citation #AJ8SX8E.
