#### NARRATIVE

On June 27, 2025, at approximately 0307 hours, I, deputy Gabriel Muszynski, responded to in reference to a disturbance.

Upon my arrival I made contact with the suspect, Tyrell Gavin, who was outside of the residence. Gavin stated that he and the victim, Lakeria Leonard, had gotten into a verbal argument and that he had gone outside to call and Uber to leave the residence before things escalated. I asked Gavin if anything physical happened between him and Leonard to which he replied no.

I then made contact with Leonard, who was inside the residence. Leonard stated that everything was okay and that nothing physical happened between them. I advised Leonard that I had been advised by Indian River County Dispatch that a third-party caller had called in the disturbance due to receiving a phone call from her stated that she was being "beaten up" and "strangled," and that she needed help. Leonard denied ever calling for help from someone and continued to state that nothing happened between her and Gavin. As I interviewed both parties awaiting responding backup deputies, both repeatedly denied any physical altercation between the two of them.

Sergeant Thimmer arrived on scene at approximately 0327 hours and spoke with Leonard and convinced her to be truthful in telling me what had happened prior to our arrival. After speaking to Leonard, Sergeant Thimmer advised me to detain Gavin and place him in the back of my patrol car. I detained Gavin and myself and Deputy Montgomery conducted a search of his person. During the search, Gavin admitted to having a firearm on him, located in his front right pocket. I removed the firearms, a Glock model 42, bearing serial number AGAX455 from his pocket and placed him in the back of my patrol vehicle. The firearm serial number was checked through FCIC/NCIC and came back as not stolen.

Sergeant Thimmer then advised Leonard to be truthful to me about the incident, in which, Leonard stated the following; She had picked up Gavin to "hang out," at her residence. Leonard stated that she had been in a intimate relationship with Gavin for approximately one (1) year, and that they do not live together or share any children in common. At some point in the night, Gavin's attitude towards Leonard changed and he became aggressive. Leonard could not remember exactly when or why his behavior changed, only that it happened seemingly out of nowhere. Gavin began to then slap Leonard and punch her in the stomach area. Leonard demonstrated these actions by using both fist and making punching motions to both sides of her stomach, just below her ribcage. Leonard then tried to get away from Gavin by changing rooms, in which, Leonard stated Gavin followed her and continued to attack her. Leonard then stated that while in the living room of the residence, Gavin got on top of her and placed his hands around her neck, choking her multiple different times. Leonard stated that she had difficulty breathing and began to feel hot and light headed, as if she were about to pass out but did not lose consciousness. Leonard continued to state Gavin also grabbed her by the ankles are dragged her around the house. While being dragged around the residence, Leonard was unable to get away from Gavin as he was holding her down against her will. Leonard stated that during these events, Gavin produced a handgun and pointed it at her while threating her. Leonard stated that when Gavin pointed the firearm at her, he stated he would, "hurt her tonight." Which made Leonard fear Gavin would cause great bodily harm to her. Leonard described the handgun as a small, black pistol with a "stick," in the bottom. It should be noted that this description of the firearm matches what was removed from Gavin's

person, the "stick," being a magazine that extended past the grip of the firearm. Leonard continued to state that Gavin stopped attacking her when she, "gave up," trying to fight back. At this point, Leonard texted two (2) separate friends to ask for help. When asked why Leonard denied the claims when I first interviewed her, she stated that she was scared of Gavin and what he might do if she had told me. I observed bruising on both of Leonard's arms as well as on her right thigh. Leonard also had scratch mark on her neck from the necklace she was wearing during the incident, which likely imprinted on her skin due to the force of Gavin choking her.

During the interview with Leonard and Gavin, one of the friends that Leonard texted for help arrived on scene. This friend wished to remain anonymous but she was able to provide screen shots of her cell phone of the text messages of Leonard asking for help. In these messages, I observed Leonard ask this friend if she was awake and if she was able to come to her residence. When asked if she was okay, Leonard replied, "This man holding me hostage putting his hands on me."

Sergeant Thimmer made contact with the original caller, Yolanda Smith, who provided screen shots of her messages with Leonard. In these messages, I observed Smith text Leonard telling her to be careful and safe tonight at approximately 2146 hours on the previous day. Then at approximately 0232 hours Leonard text smith, "This man putting his hands on me." This prompted Smith to then Smith also provided a screen shot of her previous call log showing two (2) missed calls from Leonard at approximately 0309 hours, stating Leonard called her crying and Gavin was yelling at her and took the phone away from her and was, "grabbing her."

Deputy Montgomery advised me that he read Gavin his Miranda Rights and post Miranda continued to refuse all allegations, continuing to state that nothing happened between him and Leonard.

Due to the statements made and evidence gathered at the scene, I find Tyrell Gavin in violation of the following:

- FSS 784.031 Battery by Strangulation. Felony \$0.00 Bond
- FSS 784.021 Aggravated Assault with a Deadly Weapon Felony \$0.00 Bond
- FSS 787.02 False Imprisonment Felony \$0.00 Bond

#### NARRATIVE

On June 27, 2025 I was assigned as the Sex Offender/Predator Tracking Detective with the Indian River County Sheriff's Office.

Upon review of transient sex offenders in Indian River County, I noticed that registered sex offender, Kirk Brandon Lewis, had not conducted a transient check in since April 22, 2025 which was conducted by Sex/Criminal Registration Specialist with the Indian River County Sheriff's Office, E. Thomas. This information was documented in the Sexual Offender/Predator System (SOPS). Lewis is a qualifying sex offender registered in Indian River County under Florida Statute 943.0435 following a 2012 conviction for Lewd/Lascivious Battery victim 12-15. Lewis is also registered transient sex offender who is required to register every thirty (30) days per Florida State Statue. I last had contact with Lewis on May 9, 2025 where he was located establishing a transient residence in the wooded area of 5th Street SW and 6th Place SW in Vero Beach, Florida.

I received a tip from Deputy D. Hoffman that he had personal contact with Lewis on June 7, 2025 that Lewis was now residing in the wooded area near the intersection of 1st Street SW and 8th Avenue SW. All qualifying sex offenders under Florida Statute 943.0435 are required to report within 48 hours, establishing transient, temporary or permanent residence. The transient location that Deputy Hoffman reported to me had never been reported by Lewis. I then responded to the 8th Avenue location and discovered Lewis sleeping in a tent of a well-established camp. The camp was equipped with a makeshift roof, sleeping quarters along with storage for personal items. Lewis was detained and provided his Miranda Rights to which he understood and agreed to speak with me.

Post Miranda, Lewis stated that the reason why has not registered in the last two months was because he was dealing with mental health problems, drug abuse along with alcohol abuse. When questioned on why he had not reported his new transient address, he stated that he just stays there from time to time but does not live there. It should be noted that prior to his apprehension, I visited his last documented camp in the wooded area of 5th Street SW and found no evidence of sleeping quarters or any other homeless activity in the area.

Based on the above facts, I have determined the following; Kirk Brandon Lewis is a transient Sex Offender registered in Indian River County. Lewis is required to register every thirty days and has not done so since April 22, 2025. Lewis is in violation of F.S.S. 775.6g4 Failure of transient sex offender to register every thirty Days.

Kirk Brandon Lewis was found at an undocumented transient address to which he is required to report in person to the Indian River County Sheriff's Office within 48 hours of establishing. Lewis is in violation of F.S.S. 943.0435.4b2

#### NARRATIVE

On Friday, June 27, 2025 at approximately 1233 hours I responded to a suspicious incident at Publix, 5230 US Highway 1, Vero Beach, Florida 32967.

While en route to the call, dispatch comments advised a shirtless, shorter male had been seen by an employee within the bathroom with a rolled denomination of US Currency snorting something, believed to be drugs.

Upon my arrival I was directed to the bathroom at the front of an open place of business where I was told that the male was still inside of the restroom.

I entered the bathroom where I observed a medium build white male, wearing dark shorts – matching the description of call comments – standing in front of the mirror in the general area of where customers would wash their hands.

I immediately recognized physical and physiological signs of drug usage, which I knew from my previous training and experience; such as slightly constricted pupils, pock-mark style scratches or blemishes on and about his face and person, and generally nervous behavior.

Due to the confined space of the area and in order to avoid a de-facto arrest, I kept all of my questions vague initially. The male, later identified by social security number, as Mr. Eric Leroy Bennett, advised me he was the only person in the bathroom.

I explained the general reason I was in the bathroom and asked for consent to search Mr. Bennett, which he granted. Upon searching his left side front pocket, I located a rolled ten dollar (\$10.00) US Bill with a fine pinkish-brown powder inside of the makeshift tube of the bill. I immediately recognized this as fentanyl through my training and experience.

Mr. Bennett was placed in handcuffs for the purpose of an investigative detention.

When asked what the bill would test for, Mr. Bennett affirmed the substance was fentanyl.

I conducted a cursory search of Mr. Bennett and his items before placing him in the rear of my patrol vehicle and securing his belongings away from his person; as probable cause had been established for his arrest for 893.147.1b Possession of drug paraphernalia.

I conducted a field test of the substance within the rolled 10.00 bill, which yielded a field presumptive positive result by a distinct orange coloration change.

I informed Mr. Bennett of his constitutionally protected rights in the form of a Miranda Warning, where Mr. Bennett acknowledged the substance as fentanyl after agreeing to speak with me. A detailed synopsis will

supplement this report following a review of my body worn camera.

I conducted a more thorough search of Mr. Bennett's belongings, where I then located a folded piece of paper – which I recognized through my training and experience as one of the commonly used items to conceal illegal narcotics. I opened the folded piece of paper where I located another, weighable, amount of pinkish/brown powdery substance; which I again recognized to be fentanyl through my training and experience.

The substance inside of the rolled bill, and the substance inside of the white paper were identical.

In addition to the rolled 10.00 bill, a search of Mr. Bennett's phone case revealed two small pieces of aluminum foil with char markings; which I recognized to commonly be associated with the consumption of illegal drugs.

I noted Mr. Bennett initially informed me he had flushed this foil down the toilet during a post-miranda interview.

The substance was weighed in its paper packaging at .68grams.

My investigation was captured on body worn camera.

Mr. Bennett was issued a citation (AJ5RK3E).

Mr. Bennett was transported to the Indian River County Sheriff's Office Jail Complex on two counts of Possession of Drug Paraphernalia (893.147.1b) and one count of Possession of a Controll Substance (893.13).

#### NARRATIVE

On Friday, June 27th, 2025, at approximately 2155 hours, I responded to the 6000 Block of State Road 60 to assist with a traffic stop.

Upon arrival, I made contact with the driver, identified as Ms. Angela P. Strickland. I subsequently consulted with Sergeant D. Hoilett, who informed me that the driver of the vehicle stated she was a free nationalist. He noticed the vehicle had an improper license plate and conducted a traffic stop. Sergeant D. Hoilett advised while the vehicle was later determined to be registered, the tag affixed to the vehicle was not a valid Florida license plate. The displayed license plate on the black 2016 four-door Mazda 3 featured the word "FLORIDA" in red letters at the top, accompanied by the insignia of an eagle with an American flag crest beneath it. The letter "Z" was prominently displayed in the top corners. On the license plate it also states on the bottom center "Notice Private Automobile-Not for Hire".

I then interviewed Ms. Strickland. Prior to any questioning, she was read her Miranda rights, which she acknowledged and indicated her willingness to proceed with the interview. Ms. Strickland claimed to be traveling as a "living woman." When I inquired whether she had ever been issued a Florida driver's license, she responded no, she then stated that she possessed a valid driver's license from Connecticut. Strickland admitted that she knew that her Florida license was suspended. It was later verified through dispatch that she had been issued a Florida driver's license, which had been suspended indefinitely due to prior DUI offenses and unpaid traffic citations. Notably, Ms. Strickland's license had been suspended on August 17, 2021, in relation to Indian River citation #AD1SA1E. She also had a prior arrest for operating a vehicle with a canceled or revoked license.

I proceeded to ask Ms. Strickland about the origin of the counterfeit license plate. She stated, "I ordered it online" from FloridaStateNationalsOnline.com. She acknowledged that the Florida Department of Motor Vehicles had not granted her permission to place the tag on her vehicle and admitted to knowingly and willingly operating the vehicle with a counterfeit plate.

In light of the aforementioned facts, Ms. Strickland was found in violation of FSS 322.34 (2) (A) for Knowingly Driving While License Suspended or Revoked, and FSS 320.26 Counterfeit License Plates, Validation Stickers, etc.

Ms. Strickland was placed into hand restraints, searched by Deputy Kramer, and subsequently placed into the back seat of my agency's patrol vehicle. She was then transported to the Indian River County Jail.

#### NARRATIVE

On Saturday, June 28th, 2025 at 0034 hours, I responded to the area of 2715 1st Street in reference to a suspicious vehicle. The complainant stated he observed a red minivan parked in his drive way for ten minutes. Shortly after, the complainant stated he observed the vehicle leave his driveway and begin to travel Northbound on 27th Avenue Southwest.

I then located the aforementioned vehicle traveling Eastbound on 4th Street. The vehicle was identified as a red Dodge minivan bearing Florida tag# LXBY18. I continued to follow and observe the vehicle in the attempt to gather probable cause for a traffic stop however the driver pulled into the driveway of 585 11th Avenue. I then proceeded to make contact with the driver, who was later identified as James Bertram, through a consensual encounter. It should be noted that my emergency lights were not activated due to the interaction being a consensual encounter.

Upon approach of the vehicle, Bertram exited the driver seat of the vehicle and fell on the ground. Bertram then proceeded to get up and began to stumble around his vehicle. Bertram then proceeded to use his vehicle to maintain his balance. Throughout my interaction with Bertram, I was able to detect the strong odor of an alcoholic beverage that was emitting from his person aswell as his breath as he spoke. I also observed Bertram to have slurred speech and red, glossy watery eyes.

I then explained Bertram of my observations and asked him if he would submit to Standardized Field Sobriety Exercises (SFSTs), in which he stated no. I again informed Bertram of my observations, the adverse consequence of refusing the SFSTs, and that a refusal could be used against him in court. Finally, I again asked Bertram if he would perform the SFSTs, and he verbally stated, "No."

Due to the previously mentioned, I placed Bertram in handcuffs and in the back of my marked patrol vehicle. A search of the vehicle was then conducted in which, I located three open cans of Busch light beer in the front center console area.

I then made contact with Bertram and advised him of his Miranda warnings, in which he acknowledged and continued to speak with me. Post Miranda, Bertram admitted to consuming alcohol and that he consumed three of the Busch light beers that were found in the vehicle.

Bertram was then transported to the Indian River County Jail without further incident.


Once at the jail, Corrections Deputy Rodriguez requested Bertram to provide a lawful breath sample and he refused. Bertram was read implied consent and again refused. I then conducted a query using the DAVID program which revealed Bertram had a prior refusal to submit to a lawful test of breath, urine and blood.

Due to the above mentioned, I criminally charged Bertram with the following charges:

#### NARRATIVE

On Saturday, June 28th 2025 at 1330 hours, while conducting traffic enforcement in the area of 2495 27th Avenue SW, I observed a Gray in color Honda Van with a window tint violation.

As the vehicle passed my location heading North on 27th Avenue SW, I could not see the silhouette of the driver due to the darkness of the tint. The State of Florida has a limit of 28 percent on the front driver and passenger windows. I maneuvered behind the vehicle which was bearing FL Tag Y014FF on a Gray Honda Odyssey. The vehicle came to a stop in the 2600 block of 14th Street SW. I approached the driverside window which was partially rolled down and deployed my agency issued tint meter confirming a reading of 20 percent. I notified the driver of the reason for the stop and requested she provide me with her State issued driver's license. The driver advised me that she did not have it. I asked her if she could provide any documents with her name on it and she could not. I requested she give her name and date of birth for me to run the verification through FCIC/NCIC and DAVID. The driver identified herself as Karen Elizabeth Foster born 06/11/1966. I conducted a search through DAVID and did not find a match for the name and date of birth given. A search through FCIC/NCIC had a record with incomplete information and did not identify a driver's license number.

I returned to the driver and explained that I could not verify her identity based on the information given and then deployed my agency issued RAPID ID device and requested she provide her finger prints for verification. The driver complied with a right and left index finger. I returned to my agency vehicle and was notified of a finger print match for Katherine Ann Mitsakos born 06/27/1963. A warrant was associated with that name and a search through DAIVD confirmed the picture of Katherine Mitsakos was my driver. Katherine also had numerous suspensions on her driving record that still required action dating back to 07/07/2018. I took the driver into custody and informed her of my findings and she did admit to giving a false name to "see how far she could get". Katherine was also aware of her warrant for failing to appear for a driving while suspended with knowledge case on 12/01/2021.

Based on the totality, I found Katherine Mitsakos in violation of FSS 322.34(2) knowingly operating a motor vehicle with a suspended/cancelled/revoked drivers license as well as a violation of FSS 901.36.1 giving false name while detained.

I transported Katherine Mitsakos to the Indian River County Jail where I served her with Indian River County Warrant # 312021CT008558A CT-1 DWLS-Prior conviction-suspension not specified, NO BOND.

## NARRATIVE (Continuation)

The results of this exercise displayed 0 of the 6 possible clues.

During the exercise, I observed an orbital sway when Mr. Neugebauer was attempting the exercise.

WALK AND TURN EXERCISE

Prior to attempting this exercise, Mr. Neugebauer indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Neugebauer was instructed to put his left foot on the line and his right foot in front of it with his right heel touching the toe of his left foot. He was instructed to stand in this manner with his hands to his sides until the exercise instructions were completed and the exercise demonstrated. Mr. Neugebauer was instructed not to begin the exercise until told to start. He was instructed to take nine steps along the line in a heel-to-toe manner. After the ninth step he was to stop and turn around keeping his lead foot on the ground, taking several small steps with the other foot to turn around. After turning around, he was to take nine steps in a heel-to-toe manner back along the line, in the direction he had come from. Mr. Neugebauer was further instructed to watch his feet at all times while walking, keep his arms down to his side, and to count his steps out loud. After the exercise was demonstrated Mr. Neugebauer stated that he understood the instructions and was instructed to begin the exercise.

The results of this exercise displayed 5 of the 8 possible clues:

He was unable to maintain his balance in the instructed position. On the first set of steps, he incorrectly took 10 steps instead of 9. He did not touch heel-to-toe on steps 1, 6, 7, 8. He stepped off the line on steps 1, 6, 7, 8.

He turned improperly.

On the second set of steps, he incorrectly took 10 steps instead of 9. He did not touch heel-to-toe on steps 1, 2, 3, 4, 5, 6, 7, 8, 9. He didn't step off the line.

He didn't use his arms for balance.

ONE LEG STAND EXERCISE

Prior to attempting this exercise, Mr. Neugebauer indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Neugebauer was instructed to stand with his feet together and arms at his sides during the exercise. Mr. Neugebauer was asked not to begin the exercise until instructed. He was instructed to raise the leg of his choice by approximately 6 inches off the ground. While holding that position, he was to keep his leg straight and count out loud starting at one thousand one (one thousand one, one thousand two, one thousand three, ...) and so forth until instructed to stop (after 30 seconds). The exercise was demonstrated to Mr. Neugebauer.

After he indicated understanding the instructions, Mr. Neugebauer attempted the exercise and raised his right leg and was

NARRATIVE

On June 28th, 2025, at 2058 hours, I responded to the Dollar General located on 830 27th Avenue Southwest, Vero Beach, Florida, in reference to a wellness check.

While en route, I was advised that a white male wearing a red shirt and black pants had been observed behind the counter talking to himself and that the subject left the scene prior to law enforcement arrival.

Upon my arrival, I observed a white male, later identified as Jeramie Don Neugebauer, wearing a red shirt and dark-colored pants, sleeping behind the wheel of a black Chevrolet Colorado bearing FL tag #Y37IVA. Jeramie was bend forward and down in the driver's seat and appeared to be covered in chocolate. After several attempts to wake him, Jeramie opened his eyes, which appeared glassy, and his pupils were dilated.

While asking Jeramie if he was okay, I detected that his speech was slurred when he responded. I also observed, in plain view, loose marijuana inside a clear plastic bag and a blue crystal marijuana smoking device with marijuana in it, located in the driver-side door in the arm rest.

Deputy Barrientos arrived on scene and assisted in removing Jeramie from the vehicle. As Jeramie was exiting the vehicle, he grabbed the keys to his truck from in between his legs and walked to the back of the truck. A further search of the driver-side door revealed two broken pills. One was a circular, dark orange pill, and the other was a rectangular white pill. Additionally, I located a small metal container with several loose pills matching the description of the aforementioned broken tablets.

The orange pill was marked "b 974" on one side and "3/0" on the other. The white pill was marked "V" on one side and "2090" on the other. A query through Drugs.com/pill\_identification.html revealed that the orange pill was identified as Amphetamine and Dextroamphetamine, classified as a Schedule II controlled substance. The white pill was identified as Alprazolam, classified as a Schedule IV controlled substance.

Deputy Green arrived on scene and advised Jeramie of his Miranda rights, which he stated he understood and agreed to waive. When questioned about the pills, Jeramie stated that

did not have any prescription bottles in his person nor in the vehicle.

Jeramie was then placed in handcuffs and transported to the Indian River County Jail for the following charges:

1. Possession of a Controlled Substance (Two Counts), consistent with F.S.S. 893.13

While at the jail, Corporal Ruiz advised that, during Deputy Green's DUI investigation

#### NARRATIVE

On Saturday, June 28th, 2025 at 2058 hours, I responded to the Dollar General, which is located at 830 27th Avenue Southwest in reference to a welfare check. Prior to arrival, Public Safety Dispatch advised the complainant observed a white male subject wearing a red shirt and black pants walking behind the employee section in the store.

Upon arrival, Deputy Ballester and I made contact with a white male passed out behind the driver seat of his vehicle in the front parking lot of the Dollar General. It should be noted that the white male was wearing a similar outfit that was provided by Public Safety Dispatch. Deputy Ballester opened the door of the vehicle and observed a clear baggie containing a green leafy substance and two separate unidentified pills. Deputy Ballester proceeded to conduct a drug investigation on the male subject, identified as Jeramie Neugebauer.

Throughout the investigation, Deputy Brackett and Corporal Matthews made contact with the aforementioned male subject, identified as Jason Neugebauer, who was seen walking behind the employee section of the Dollar General. Deputy Brackett advised me of the following: "I went inside the store and spoke with an employee who was unaware Law Enforcement was called. Prior to entering the store Corporal Matthews (6226) spoke with a male subject who was later identified as Jason Neugebauer. He advised Corporal Matthews that he was in the area doing work with fire sprinklers. Corporal Matthews asked if he knew that subject in the black truck and he advised "no". He also advised Corporal Matthews that he had not been inside Dollar General.

Store employees advised a male wearing a black shirt and red pants entered into the store, went behind the counter and attempted to enter the employee breakroom and office area before being directed to leave. It should be noted that this area is clearly marked with a sign for employees only. The employee advised the male was wearing red pants and a black shirt. Corporal Matthews advised that was the subject he talked to prior to entering the store.

Once back outside Jason Neugebauer (Arrestee) was located again coming from the Cumberland Farms parking lot. Jason began speaking about working in the area again and stated he was working on the fire systems and was waiting for the 'Fire key." Jason was unable to explain the name of the company he worked for, and made claims he had a work van that was stolen. He claimed he was also in the company of another employee.

While speaking with Jason, I could smell the distinct odor of an alcoholic beverage (beer) emitting from his breath. His eyes were watery and glassy and his pants were soiled in the front. Jason denied consuming any alcoholic beverages. When asked if he went inside the Dollar General store, Jason denied it. Jason was also asked if he knew the male in the truck and denied any knowledge of him. Jeramie then called out and Jason acknowledged him as he began to walk towards the truck before being stopped. The investigation later revealed Jason and Jeramie are brothers and traveled in the same vehicle to the area.

Based on the above facts, I informed Deputy Green #6313 to detain Jason while we confirmed whether or not he had been involved in a shoplifting incident due to him denying being in the store, denying consuming alcohol, denying knowledge of the male who turned out to be his brother."

Shortly after gathering information from Deputy Brackett, Sergeant Flores advised me Jason pulled out a prescription pill container out of his pocket and handed it to him. The prescription pill container label stated Jason The pill container contained several of the prescribed medications however it also contained four other unidentified pills. One of the pills were observed as a white rectangle shape with 2090V lettering. I conducted a query of the pill using Drugs. com which was identified as a different dosage of Aprazolam, which Jason was not prescribed for. Aprazolam 2 mg is a schedule 4 controlled substance under the Controlled

On June 29<sup>th</sup>, 2025, at 0114 hours, I responded to a disturbance.

Upon arrival, I made contact with the caller, Samantha Beck, who informed me of the following: Beck stated that she was in the kitchen having a verbal argument with her boyfriend, Austin Maline, which escalated when Maline grabbed a laptop and smashed it on the ground. Beck stated that she was moving back and forth between her bedroom and the kitchen to ensure her son did not wake up due to the argument, while Maline continued yelling profanities at her.

At one point, Beck locked herself in her bedroom, at which time Maline began kicking the door, eventually breaking it apart from the frame. Beck stated that once Maline forced his way into the room, he headbutted her twice on the left side of her head.

Beck further advised that she has been in an intimate relationship with Maline for the past seven years

While interviewing Beck, I observed visible bruising and swelling on her left cheek, consistent with her statement.

I then made contact with Maline and advised him of his Miranda rights, which he stated he understood and agreed to waive. Maline admitted that after going out for drinks after work, he returned home and engaged in a verbal argument with Beck. He claimed that Beck struck him in the testicles and on the right side of his head after he told her he had been sleeping with other women. Maline admitted to headbutting Beck in response.

During my interview with Maline, I observed no signs of redness, bruising, or other indicators that he had been struck on the head. It should be noted that Maline is bald, providing a clear view of his scalp.

Due to the totality of the circumstances, Maline was placed in handcuffs and arrested for Battery (domestic violence), pursuant to F.S.S. 784.03(1)(a)1. He was transported to the Indian River County Jail without incident.

#### NARRATIVE

On June 29th, 2025, at 2227 hours, I responded to 2525 43rd Street, "Frederick Aikens Game Bar" in reference to a miscellaneous. Upon my arrival, I made contact with several subjects inside the aforementioned place of business holding red "solo" plastic cups containing suspected alcoholic beverages, some of which the subjects dumped out upon my approach, and multiple other subjects that were standing around the exterior of the business holding the same cups. As I walked around the place of business, I observed 3 separate, unattended, matching red plastic cups all containing suspected alcohol (due to the strong odor of liquor emitting from the cups). Behind the establishments counter, I located a chilled yet empty bottle of Grey Goose Vodka, a chilled yet partially empty bottle of Absolute Vodka sitting on the back counter near a stack of empty matching red plastic disposable cups, a chilled bottle of Heineken beer; and another chilled bottle of Budweiser beer.

After observing multiple open and emptied bottle of alcoholic beverages inside the establishment, I made contact with the owner of the business, Frederick Aikens. Aikens advised he rented the grounds out to an unidentified subject but denied ever serving alcoholic beverages. Aikens provided me a copy of his business licenses for "Frederick Aikens Game Bar" which is also known as Phase 2 Sports Bar & Lounge per the posted sign hanging in the front window of the establishment that read:

"BAR RULES"

- NO OUTSIDE DRINKS PERMITTED INSIDE ESTABLISHMENT (THIS INCLUDES DRINKS PURCHASED NO RENTRY)
- LOITERING OR STANDING OUTSIDE PROHIBITED
- NO ID NO ENTRY
- VIOLATORS WILL BE PROSECUTED

which identified the establishment as a #744 Type of Business bearing account #25526, expiring September 30, 2025; for the address of 2525 43<sup>rd</sup> Street, FL 32967. It should be noted that Aikens advised he was only selling empty cups of ice in the red plastic cups. Aikens continuously denied the allegations but then asked what would have happened if the bottles of alcohol weren't present.

After detaining Aikens, I escorted him back to my marked agency issued patrol vehicle and searched his person prior to placing him in the rear passenger compartment. While searching his person, I located 2 bags of a green leafy substance that appeared to be loose marijuana. I field tested the substance for the presence of THC by utilizing an agency issued field drug test kit, and was met with

positive results for the presence of THC. In the same pocket, I located half of a capsule shaped white pill with markings that read "M5 / 10/", which resembled markings identified via Pill Identifier on Drugs.com, to be consistent with the markings of Oxycodone and Acetaminophen, also known as a Percocet. I read Aikens his Miranda Rights too which he expressed his knowledge and understanding. Post Miranda, Aikens agreed to speak with me and admitted that both controlled substances were his for personal use. Additionally, Aikens stated that if law enforcement would've arrived an hour earlier, there would have been "liquor bottles all over the counter."

Per my investigation, I found Frederick Aikens to be in violation of FSS 562.12(1)(b) Beverages sold w/ improper license / without license or registration and two counts of FSS 893.13, possession of a controlled substance; reference Citation #ADKMYEE and #ADKMYGE.
