NARRATIVE

On August 6, 2025, at approximately 0216 hours, I observed a silver Chevrolet Malibu, bearing Florida tag DQ15MJ, traveling north on US Highway 1. The aforementioned vehicle was doing 26mph in a posted 55mph zone, unable to maintain a single lane of travel. I immediately activated my in-car camera to capture the drivers, driving pattern.

I observed the vehicle drift from the right lane into the left lane, then straddle the center line before entering back into the right lane. The vehicle drifted back over the center line and straddled it for a period of time, before correcting back into the right lane. The vehicle drifted right and began straddling the solid line of the right lane, with its right-side tires on the shoulder. The vehicle almost drove off the road before correcting. The vehicle proceeded north on US Highway 1, drifting from side to side of the right lane with its tires crossing over the center divided line and the solid white line of the right lane.

After observing the traffic pattern described above, I initiated a traffic stop at US Highway 1, and 53rd Street, Vero Beach, Florida.

I made contact with the driver, who was identified as Derrick Bynum. Derrick had bloodshot watery eyes. I also noticed the strong odor of burnt marijuana emanating from the vehicle. I asked Derrick for his driver's license, registration, and proof of insurance. I informed Derrick while he was driving, I observed an irregular driving pattern. While Derrick was gathering his required documents, I observed his sluggish movements, and a burnt marijuana cigarette inside the vehicle. I asked Derrick if he had a medical marijuana license, which he advised he did not. Derrick produced his driver's license and registration, but was unable to produce an insurance card.

I returned to my vehicle and conducted an NCIC/FCIC query of Derrick and the vehicle. During my query I learned there was no insurance on file. I later conducted a query of the Driver and Vehicle Information Database (DAVID), which also stated there was no insurance on file.

Due to Derrick driving pattern, the smell of burnt marijuana emanating from the vehicle, and a burnt marijuana cigarette in plain view, I requested Derrick to exit the vehicle. When Derrick exited the vehicle a burnt marijuana cigarette fell from his lap, onto the ground.

I asked Derrick to walk to the front of my patrol car. I informed Derrick, because of what I have observed, I would like him to conduct Standard Field Sobriety Exercises (SFSE). Derrick agreed.

Prior to beginning the exercises, I asked Derrick if he wears glasses, contacts, or has any medical issues. Derrick stated he does not wear glasses, contacts, or have any medical issues.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN). I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

When I initially started the exercise, Derrick was not moving his eyes, and was staring straight forward. I had to inform Derrick to move his eyes, and follow the stimulus. During his first attempt I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and Nystagmus prior to

45 degrees almost instantly. Derrick moved his head on several occasions and had to be reminded to follow the stimulus, with his eyes, and eyes only. Derrick also swayed back and forth while I conducted the exercise.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Derrick began to sway when he was in the start position, and failed to stay in the position he was instructed to.

During his first set of nine steps, he stepped off of the line on steps 2, 4, 6, and failed to conduct the proper turn as explained. During the second set of nine steps, he stepped off of the line on steps 2, 4, and 9. Throughout this entire exercise, Derrick swayed, and utilized his arms to keep his balance, instead of at his side like he was instructed, and informed me verbally that he understood. Derrick raised his arms above his waist as he walked to maintain his balance.

The third exercise I demonstrated and explained was the One Leg Stand exercise. During my instructions, he failed to stay in the position that he was instructed to. During this exercise he raised his right foot.

During his first attempt he did not maintain his arms to his sides. Derrick leaned and swayed throughout the exercise utilizing his arms for balance, until I informed him to stop. He reached count 18 in the timed 30 second exercise, while placing his foot down twice for balance.

Based upon the totality of the evidence Derrick was taken into custody for violation of FSS 316.193(1) DUI.

It should be noted, that prior to placing Derrick in my patrol car he informed me, he was on Federal Probation. A query of his Federal Charges revealed he was sentenced to 264 months, and 10 years of supervised release for possession with intent to distribute 50 grams or more of cocaine base.

Upon completion of the exercises, I advised Derrick of his Miranda Warnings from my agency issued Miranda Card. Derrick was transported to the Indian River County Jail for booking.

At the county jail Derrick provided a lawful breath sample to Deputy Canales ID# 6127. His first breath sample was 0.000 and his second breath sample was 0.000.

Based on the breath samples provided by Derrick; I requested Lieutenant Jaworski, a certified Drug Recognition Expert (DRE), respond to the jail.

Lieutenant Jaworski conducted a twelve (12) step evaluation on Derrick, and determined he was under the influence of cannabis and unable to operate a motor vehicle safely. See Lieutenant Jaworski's supplemental report for full detail.

It should also be noted, after Derrick was placed in the back of my patrol car, I recovered the burnt marijuana cigarette that fell out of his lap onto the road. A search of Derrick's vehicle was conducted prior to the vehicle being towed. Located on the seat where Derrick was sitting was burnt marijuana cigarette, and on the floorboard

The DRE investigation conducted by Lieutenant Jaworski was captured on the cameras located inside the Indian River County Jail.

The DUI packet for this case was submitted to records.

This investigation is cleared with the arrest of Derrick, for possession of marijuana less than 20 grams, and DUI.






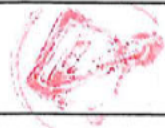

NARRATIVE

On Wednesday, August 6, 2025, at approximately 0928 hours, I responded to the area of 43rd Avenue and 9th Street Southwest, Vero Beach, Indian River County, Florida, 32968, in reference to a License Plate Reader alert.

While en route to the area, the communications center provided information regarding the alert, and advised a stolen vehicle crossed into Indian River County travelling northbound on 43rd Avenue. The vehicle was described as a red Ford Focus, bearing Florida tag 50EYH. As I approached the aforementioned intersection, I stopped at a steady red traffic signal and observed the Ford Focus turn eastbound onto 9th Street Southwest, then immediately northbound into the parking lot area of the Walgreens at 850 43rd Avenue. As I checked the parking lot of the businesses located there, I observed the red Ford Focus parked behind the Walgreens, and a white male as he walked away from the vehicle. The white male continued toward the front of the Walgreens, where he was later contacted and identified as Mr. Brennan Diana (Arrestee).

Initially, Mr. Diana provided false identifying information to the deputies on scene, though he was eventually identified after information was provided by the Riviera Police Department (RPD) regarding the stolen vehicle, and confirmed via the Driver and Vehicle Information Database (DAVID). NARRATIVE

On 8/6/2025, at approximately 1159 hours, I was dispatched to 4495 US Highway 1 (Wawa), in reference to a shoplifting incident.

Upon arrival, I learned the following information from Corporal Moore who was on scene:

Dennis Breslin admitted to stealing some drinks from Wawa to save five bucks. Dennis advised he has stolen from Wawa in the past, and did it again because he believed he could get away with it once again. Dennis claimed he concealed a Red Bull in his right pocket, and walked out with a Gatorade and a Core Power in his hands.

I then made contact with Wawa worker, Junior Gonzalez, who stated he recognized Dennis from previous shoplifting incidents as soon as he arrived on this date and time. Junior advised he observed Dennis once again grabbing multiple drinks, and rushing to his vehicle through the back entrance without paying. Junior claimed he notified his supervisor, and approximately ten minutes after the incident, Dennis came back to the store.

This Deputy then reviewed video footage from Wawa staff and observed the following:

Dennis parked his white pickup truck in the rear parking lot of the business and entered through the rear entrance. Dennis used the bathroom located next to the rear entrance door, and then headed to the cold drinks section. Dennis grabbed one drink that appeared to be a red bull, and walked in the middle of the snack isles. Dennis then goes back to the refrigerators and grabs two other drinks, and exits the store through the rear exit, passing all points of sale without paying for the items.

I then made contact with store manager, Richard Faxon, who stated Wawa wanted to press charges on Dennis. Richard advised Dennis has stolen from them several times in the past.

The itemized receipt of the stolen items is the following:

- GATORADE FRUIT PUNCH 28 OZ= \$3.39
- CORE POWER ELITE CHOCOLATE= \$6.19
- RED BULL ORIGINAL 12 OZ= \$3.79

TOTAL= \$13.87

Based on my investigation, I determined that Dennis violated F.S.S (812.015) Shoplifting/ Retail Theft.

Dennis was transported to the Indian River County Jail without incident.

NARRATIVE

On Thursday, August 7, 2025 at approximately 0005 hours, I responded to the address of [REDACTED] in reference to a disturbance.

On Thursday, August 7, 2025 at approximately 0005 hours, I responded to the address of [REDACTED] in reference to a disturbance.

Upon arrival I met with Mr. Djerlinson Cyrius, who advised the following, during a video recorded statement: The mother to his child, Ms. Michela Henry, came to the residence at approximately 2315 or 2330 hours on Wednesday, August 6, 2025 to pick up their two-year-old child. Mr. Cyrius and Ms. Henry have been separated for a little over a year now but routinely see each other to exchange their child in common. When Ms. Henry arrived, Mr. Cyrius buckled the two year old into the car seat and the two got into a verbal argument. The verbal argument turned physical when Ms. Henry started "yanking on" Mr. Cyrius's chain (necklace). Ms. Henry let go of the necklace and swung on Mr. Cyrius but Mr. Cyrius avoided the strike. Mr. Cyrius advised it looked like Ms. Henry had something in her hand when she swung on him. Mr. Cyrius could not describe the object other than the fact it was metal. When Ms. Henry missed the strike directed towards Mr. Cyrius the object flew out of her hand, which she retrieved then drove away.

Mr. Cyrius showed Deputies the scratch on his right forearm where he believed Ms. Henry actually did strike him with the unknown metal object. Mr. Henry had marks on the back of his neck consistent with that of his necklace being pulled from the front. Mr. Henry also had scratch marks near his left shoulder and down his left bicep. Mr. Cyrius was not aware of the scratch marks until Deputies brought them to his attention. These scratch marks appeared consistent and within the range of Mr. Cyrius' necklace and more specifically consistent with a hand coming off the necklace and dragging down and across Mr. Cyrius as a result.

Mr. Cyrius declined medical attention.

I then made contact with Ms. Henry who was located at 5725 59th Drive, Vero Beach, Florida 32967. Ms. Henry initially, post Miranda, did not wish to further speak with Deputies after already giving a statement to Dep. C. Scott. Moments later Ms. Henry retracted and advised she now did wish to speak with me and advised the following, during an audio recorded statement: she went to Mr. Cyrius' house to pick up their child and after a verbal argument she grabbed his, Mr. Cyrius, chain (necklace). Ms. Henry advised Mr. Cyrius was argumentative the entire time she was picking up their child but Ms. Henry stated she did not swing on or strike Mr. Cyrius. When asked about the scratch marks on Mr. Henry, Ms. Cyrius repeatedly asked Deputies to see the photos of the scratches.

I developed Probable Cause for the offence of Battery (F.S.S. 784.03.1a1) Domestic Violence with Ms. Michela Henry being the suspect. Ms. Henry was subsequently placed under arrest for such. Ms. Henry was placed into handcuffs, I ensured proper fit and tightness, as well as ensuring double lock before placing her in the back seat of my patrol vehicle.

Ms. Henry was transported to the Indian river County Jail Complex without incident.

On August 6, 2025, at approximately 2025 hours, I arrived at Walgreens located at 5755 20th Street, in reference to a hit and run. Upon my arrival, contact was made with Nairobi McGriff, who advised the following verbally:

Earlier in the evening, Nairobi parked her 2021 Blue Kia Forte on the east side of the Walgreens parking lot. Nairobi went inside the store and when she exited, she was informed by a person later identified as Kristina Howard, that another vehicle struck Nairobi's vehicle. Kristina told Nairobi she saw a black Toyota Highlander back into Nairobi's vehicle. Nairobi saw the vehicle in the parking lot and approached it. While Nairobi was approaching the vehicle, a white female that was approximately five foot eight or taller, was slender, wearing black and gray clothing, with brown hair entered the vehicle. The driver started the vehicle and drove off going east bound on 20th Street. Before the vehicle left, Nairobi was able to get a picture of the license plate for the Toyota Highlander, which was Y05GYT. Nairobi checked her vehicle and noticed she had damage to her rear bumper where part of the bumper was concaved in, and the left rear fender was partially separated from the vehicle. Nairobi stated she desired prosecution.

Contact was then made with Kristina via phone call since she was not on scene, but left her information with Nairobi. Kristina confirmed she saw the accident occur and said the driver of the black Toyota Highlander had pulled into a parking spot, but then backed up and the rear bumper of the vehicle struck the rear bumper of Nairobi's vehicle. Kristina also provided the same description of the suspect as Nairobi. Katrina did mention the suspect entered Walgreens and asked people if there were cameras around because her vehicle was struck by another vehicle. Katrina asked if the suspect was the driver of the black car and when the suspect said yes, Katrina told the suspect her vehicle was the one that struck someone else's and the suspect went back to her vehicle and left the store.

I was able to speak with the Walgreens manager, Scott Finch, who confirmed there was video of the incident that occurred. I viewed the video and observed Nairobi's vehicle parked on the east side of the parking lot. A black Toyota Highlander entered the parking lot and pulled into a parking spot. The black Toyota then backs out of the parking spot and backs right into Nairobi's vehicle, but then pulls forward again and pulls into the parking spot again. The driver, as described above, gets out of the driver seat of the vehicle, entered the Walgreens and then leaves shortly after.

An FCIC/NCIC check of the tag of the suspect's vehicle revealed the registered owner of the vehicle was Amanda Sammartano. The driver in the video was positively identified as Amanda by her Florida driver's license photograph. Amanda's address on her license was 761 46th Square. When I went to the address, I spoke to John Sammartano. John advised Amanda was his wife, but they recently got divorced. John said Amanda moved to 1537 38th Avenue and when I showed him a picture that I took from the store's surveillance cameras he confirmed it was Amanda.

Finally, I went to 1537 38th Avenue. I observed the black Toyota Highlander in the driveway and it had the license

plate provided by Nairobi. The vehicle had a very long scratch along the rear bumper that appeared to be where the paint of vehicle was coming off and I noticed the vehicle had a receiver hitch without the towing hitch, which was about the height of where the blue Kia's rear bumper was caved in.

Amanda eventually came out of the home. I verbally advised Amanda her Miranda Rights, which she acknowledged and waived. Post Miranda, Amanda advised the following verbally:

Amanda confirmed she was at Walgreens and believed she was involved in an accident. Amanda also confirmed she walked into Walgreens and spoke to people inside about an accident that occurred. Amanda claimed it was her vehicle that was struck and she denied striking anyone's vehicle. I informed Amanda I had witnesses and video of the incident that all confirmed she was the person who caused an accident and she still denied it. Amanda said she left the property because the person who struck her had left.

Based on the information above, I found probable cause Amanda was in violation of F.S.S 316.061(1); leaving the scene of an accident with property damage. Amanda was arrested and later transported to the Indian River County Jail without incident.




NARRATIVE

On Thursday, at approximately 0054 hours, I, Deputy M. Neill #6317 responded to the 7-11 located at 1201 Old Dixie Highway, Vero Beach, Indian River County, Florida, 32960 in reference to a suspicious incident.

The caller was the store clerk for the establishment. He reported that a Hispanic female wearing a pink shirt and blue pants was hysterical and attempting to get in to a vehicle in the parking lot. The female was having a difficult time gaining access to the vehicle.

Upon my arrival, I observed a gold Honda Accord leaving the parking lot on Old Dixie Highway. I then made contact with a witness, who stated the Hispanic female was in the gold Honda leaving now. The Hispanic female was intoxicated and attempted to gain entry in to her vehicle. She believed the female was so intoxicated she confused the two cars.

It should be noted that the witness was driving a silver Acura SUV and the subject we were called on was driving a gold Honda Accord.

I was able to catch up to the vehicle and conduct a wellbeing check on the subject, based on the concern she may be impaired. This stop was conducted at 14th Avenue and Old Dixie Highway, Vero Beach, Florida.

During contact with the driver, she confirmed that she had a mix up between the two vehicles and that she did attempt to get in to the other subject's vehicle, but it was just an accident. During my interaction with her I noticed that she had watery eyes and the odor of an alcoholic beverage emitting from her breath.

I asked the driver, who was later identified as Ms. Geslyn Morales Siezar to exit the vehicle. Upon exiting the vehicle, she stumbled and had to use the vehicle to stabilize herself. Upon getting closer to her the odor of an alcoholic beverage continued to grow stronger.

Ms. Morales Siezar agreed to perform Standardized Field Sobriety Exercises (SFSE's). These exercises go as follows:

Horizontal Gaze Nystagmus: Ms. Morales Siezar had a lack of smooth pursuit, distinct and sustained nystagmus, and distinct and sustained nystagmus at maximum deviation in both eyes. Additionally, she moved her head during the exercise.

Walk and Turn: Ms. Morales Siezar started before being told to do so, could not keep her balance in the instructional stance, missed heel to toe on multiple steps, stepped off line, and took the in-correct number of steps at one point.

One Leg Stand: Ms. Morales Siezar put her foot down once during the exercise and swayed. During the exercise,


