


**NARRATIVE**

On Tuesday, April 14<sup>th</sup>, 2026 at approximately 0443 hours, I responded to 1205 U S Highway 1 (Chase Bank) in reference to a welfare check. The caller stated that they observed a white truck sitting in the bank parking lot with a white male falling asleep behind the wheel.

Upon my arrival, I observed a white Toyota SUV bearing Florida license plates NJDF21 that was stationary, with a young white male asleep at the wheel. Upon inspecting the vehicle visually, I noted that the keys were inside the ignition in the "On" position, indicating that he had physical control of the vehicle. At any moment, if Mr. Joshua Shuck had awakened, he would have had the ability to operate the vehicle. As I approached the vehicle, the driver regained consciousness and identified himself as Mr. Joshua Shuck with a Florida driver's license. During the interaction, I detected a strong odor of alcoholic beverage emanating from his breath. I observed that Mr. Shuck had bloodshot and watery eyes, as well as slurred speech. When questioned, Mr. Joshua Shuck admitted to consuming alcohol.

Before beginning the exercise, Mr. Joshua Shuck was asked if he had any medical problems and he replied that he did not.

were checked and they displayed equal tracking and his pupils were equal sizes. Mr. Joshua Shuck was instructed to follow the stimulus with his eyes only, keeping his head still. After stating that he understood the instructions, Mr. Joshua Shuck attempted this exercise. No resting nystagmus was observed.

The results of this exercise displayed 4 of the 6 possible clues.

- A lack of smooth pursuit in the left eye
- A lack of smooth pursuit in the right eye
- A distinct and sustained nystagmus in the left eye at maximum deviation
- A distinct and sustained nystagmus in the right eye at maximum deviation

During this exercise Mr. Joshua Shuck became irritated and sternly stated "How long are we going to do this, dude?".

**WALK AND TURN EXERCISE**

Prior to attempting this exercise, Mr. Joshua Shuck indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Joshua Shuck was instructed to put his left foot on the line and his right foot in front of it with his right heel touching the toe of his left foot. He was instructed to stand in this manner with his hands to his sides until the exercise instructions were completed and the exercise demonstrated. Mr. Joshua Shuck was instructed not to begin the exercise until told to start. He was instructed to take nine steps along the line in a heel-to-toe manner. After the ninth step he was to stop and turn around keeping his lead foot on the ground, taking several small steps with the other foot to turn around. After turning around, he was to take nine steps in a heel-to-toe manner back along the line, in the direction he had come from. Mr. Joshua Shuck was further instructed to watch his feet at all times while walking, keep his arms down to his side, and to count his steps out loud. After the exercise was demonstrated Mr. Joshua Shuck stated that he understood the instructions and was instructed to begin the exercise.

  - He stopped once while walking.
- Does not touch heel-to-toe.
  - On the first set of steps, he did not touch heel-to-toe on steps 2, 4, 5, 6 and 7.
  - On the second set of steps, he did not touch heel-to-toe on steps 4, 5, 7 and 8.
- Steps off the line.
  - On the first set of steps, he stepped off the line on steps 3, 4, 6, 7, 8 and 9.
  - On the second set of steps, he stepped off the line on steps 4, 5, 7 and 8.
- Uses arm(s) to balance.
  - He used his arms 6 times for balance.
- Improper turn.

In the middle of my instructions to the Walk and Turn exercise Mr. Joshua Shuck requested to put his low top sneakers on because it was much more comfortable to perform the exercises in.

ONE LEG STAND EXERCISE

Prior to attempting this exercise, Mr. Joshua Shuck indicated he did not have any medical problems that would have prevented him from performing the exercise. Mr. Joshua Shuck was instructed to stand with his feet together and arms at his sides during the exercise. Mr. Joshua Shuck was asked not to begin the exercise until instructed. He was instructed to raise the leg of his choice by approximately 6 inches off the ground. While holding that position, he was to keep his leg straight and count out loud starting at one thousand one (one thousand one, one thousand two, one thousand three, ...) and so forth until instructed to stop (after 30 seconds). The exercise was demonstrated

During the instructions for the Walk and Turn exercise, Mr. Joshua Shuck requested permission to wear his low-top sneakers, citing increased comfort for performing the task.

The result of this exercise displayed 4 of the 4 possible clues:

- Swayed during the exercise
- Used arms for balance
- Hopped in order to remain on one foot
- Put foot down once during the exercise

MODIFIED ROMBERG EXERCISE

Prior to attempting this exercise, Mr. Joshua Shuck indicated he did not have any medical problems that would have prevented him from performing the exercise. He was instructed to stand with his feet together and keep his arms at his sides during the exercise. He was told not to begin until instructed and after the exercise had been demonstrated.

When instructed to start, Mr. Joshua Shuck was told to tilt his head back slightly, close his eyes and remain in that position until 30 seconds had passed. He was instructed to say 'stop' when 30 seconds had passed, after which he could open his eyes. He was further instructed to keep his eyes closed during the exercise. After the exercise was demonstrated Mr. Joshua Shuck stated that he understood the instructions and was asked to begin.

Mr. Joshua Shuck completed the task and stopped after 50 seconds.

During the exercise, the individual exhibited swaying from front to back as well as side to side. Mr. Joshua Shuck demonstrated body tremors, which were observed in his left hand.

Based on the facts and clues above Mr. Joshua Shuck was placed in hand restraints and was transported to the Indian River County Jail.

Upon arriving, to the jail Mr. Joshua Shuck was handed over to jail staff where they administered the states test.

On Tuesday, April 14, 2026, at approximately 0821 hours, while conducting routine patrol in the area of the 2600 block of 9th Street SW (Oslo Road), Vero Beach, FL, my Axon Fleet 3 license plate reader (LPR) alerted on a red 2008 Dodge pickup truck. The alert indicated that the registered owner (RO) had a suspended driver's license.

I conducted a query through NCIC and confirmed the RO's license status. During the same inquiry, I obtained the RO's driver's license photo. I then drove alongside the vehicle and visually confirmed that the driver matched the RO, later identified as Emmanuel Lee Ghent.

Based on this confirmation, I positioned my patrol vehicle behind the suspect vehicle and initiated a traffic stop by activating my overhead emergency lights. Ghent pulled into the Cumberland Farms gas station located at 880 27th Avenue SW.

Upon making contact with Ghent, I advised him of the reason for the stop. Ghent stated that he was currently paying court costs and believed his driver's license should be valid. I asked if he had his license on his person, and he provided it. Upon inspection, the license indicated "Learner's License." It should be noted that no other occupant or licensed driver was present in the vehicle at the time of the stop.

I asked Ghent if he had upgraded his license from a learner's permit to a valid operator's license. He stated he had not and said, "that is the license I use." I then requested proof of insurance and vehicle registration. Ghent provided the registration, which was found to be expired as of February 21, 2026. Ghent advised he did not have proof of insurance and could not provide a digital copy due to his cellular service being disconnected. He stated he had insurance through DairyLand Insurance.

I conducted a web search and contacted DairyLand Insurance. After providing the representative with Ghent's information, I was advised that the policy had lapsed and that there had been no active insurance coverage on the vehicle since April 10, 2026.

I asked Ghent about the last time a payment was made on the policy. Ghent was evasive and stated that both he and his mother contributed to the insurance payments, but he was unsure who made the payments or when they were due. Ghent claimed the insurance had been paid the previous month but could not provide a specific date. Ghent further informed that his mother currently resides in the Virgin Islands and was not present in the state of Florida.

I continued questioning Ghent regarding his driver's license status. Ghent again referenced paying court costs and spontaneously stated, "that's probably why it's not valid," before attempting to retract the statement.

During my initial contact at the driver's side window, I detected a strong odor of marijuana emitting from the vehicle. I asked Ghent if he possessed a medical marijuana card, and he stated that he did. He further stated there was no marijuana in the vehicle and consented to a search.

During the consensual search of the vehicle, I located marijuana stems and "shake" throughout the vehicle, including under both front seats and on the floorboards. A marijuana grinder and rolling papers were also located.



On 4/14/26 at approximately 1750 hours, I Ofc. Kriegner responded to [REDACTED] in reference to a disturbance.

Upon arrival, I spoke with Avalynn Jumping Eagle (DOB 11/23/11) on the sidewalk, outside of the residence, who advised her sister Katelynn Karper, was harassing her (calling her names and "bullying" her). I went to the front door of the residence to speak with Katelynn to listen to her side of the incident. The door was opened by the homeowner, Jacquelynn Anderson, and when Katelynn saw me at the door, she began to scream profanities. While attempting to speak with Katelynn (who would not answer questions and continued to scream profanities about her mother saying "Fuck you bitch") I was advised by Vero Beach Communications, she had been previously trespassed from the residence (CFS# 031026-80).

Katelynn was placed under arrest for FSS 810.08 Trespass Occupied Structure/ Conveyance. While she was being escorted to my patrol vehicle, she began to stop walking and had to be pulled by officers, to continue to walk. While being placed into the back of my patrol vehicle, she began to kick the back passenger window and had to be restrained by her legs to prevent damage to the vehicle and injury to herself. She was transported to the Indian River County Jail. Once I arrived at the jail, in the Sally Port, she spit on the back windshield of my vehicle and jail staff had to place a spit guard over her face to prevent her from spitting on anyone.

Due to Katelynn's behavior following being placed under arrest, which impeded Law Enforcement investigation and operations, she was also charged with FSS 843.02 Resisting Officer Without Violence.

 On **04/14/2026** , at **10:00** (Specifically include facts constituting cause for arrest.)

On April 14th, 2026, at approximately 0948 hours, myself along with the Sebastian Police Department Special Response Team (SRT) responded to 637 Braddock Street, Sebastian, Florida 32958 in reference to a warrant service. The warrant service was in reference to a Residential Search Warrant for this residence, in reference to Sebastian Police Department case #26-0401, signed on April 7th, 2026, by Honorable Judge Anastasia Norman.

Prior to the SRT making entry into the residence, they gave loud verbal commands for the residents of 637 Braddock Street to exit the residence and identified themselves as law enforcement officers, as well as communicated they were there in reference to a search warrant. Upon doing so, a white female and white male both exited from the residence and were safely taken into custody without incident. The female on scene was identified as Kathleen Cruz. Prior to the search beginning, Kathleen was advised of her Miranda Rights and stated to officers the only thing she knew about was what would be located in the front of the residence.

Once the SRT advised the residence was clear and no other individuals were located, I along with the search team began the search of the residence. The following items were located in the south west bedroom, the same room Kathleen mentioned prior to the search, referred to as room B:

- Wallet containing various credit cards for Kathleen Cruz and a Florida Identification Card for Kathleen Cruz
- Approximately 4 cut straws all containing white powder residue
- 1 glass mirror which held the straws up (used to ingest powder like controlled substances)
- 1 glass crack pipe containing burnt chore boy residue
- 1 glass pipe with cylindrical end containing burnt residue (meth pipe)
- "305" cigarette box stuffed inside a black woman's shoe that contained two plastic baggies, one containing a crystal-like substance and the other containing a white powdery substance

The crystal-like substance was field tested which was came back positive for the presence of methamphetamine. The white powdery substance was also field tested which came back positive for the presence of fentanyl.

Kathleen was transported to the Sebastian Police Department where she was interviewed by Officer Glines and Corporal Keskinen post Miranda. The following is briefly what she stated:  
 Kathleen stated she has stayed at the residence for approximately 2 months. Kathleen stated she last used fentanyl a couple of days ago and hasn't used methamphetamine for approximately 1 week. Kathleen stated the male she was in bed with, Justin Gielow, also uses drugs but usually crack cocaine. Officer Glines asked Kathleen about the plastic baggie containing fentanyl and small amount of meth, which Kathleen denied ownership and stated it was Justin's. Kathleen stated the meth pipe was a "bubble", and it was Pete's. Kathleen stated she does use it.

Based on the totality of all the circumstances which include what was located during the execution of the above-mentioned search warrant, I found probable cause to place Kathleen under arrest for violation of the following FSS:

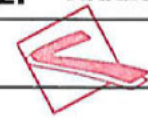

**PROBABLE CAUSE STATEMENT**

On April 14th, 2026, at approximately 0948 hours, myself along with the Sebastian Police Department Special Response Team (SRT) responded to 637 Braddock Street, Sebastian, Florida 32958 in reference to a warrant service. The warrant service was in reference to a Residential Search Warrant for this residence, in reference to Sebastian Police Department case #26-0401, signed on April 7th, 2026, by Honorable Judge Anastasia Norman.

Prior to the SRT making entry into the residence, they gave loud verbal commands for the residents of 637 Braddock Street to exit the residence and identified themselves as law enforcement officers, as well as communicated they were there in reference to a search warrant. Upon doing so, a white female and white male both exited from the residence and were safely taken into custody without incident. However, upon Deputy Matthews of the Indian River County Sheriff's Office deploying his drone into the residence prior to units making entry, it was discovered there was a third male inside the residence, laying down on a bed inside a room on the north east of the residence. The male was given three additional announcements from outside the residence utilizing a Public Address (PA) system which he did not comply with. Deputy Matthews gave the male multiple commands to exit the residence from his drone which he failed to comply with. The male was warned force would be used to which he even still, refused to comply with commands. This forced members from SRT to make entry into the residence, ultimately taking him into custody after making entry. The male in question was identified as Peter Iadarola.

Once the SRT advised the residence was clear and no other individuals were located, I along with the search team began the search of the residence. The following items were located in the bedroom Peter Iadarola was in when refusing to come out of, referred to as room H:

- Black digital scale with marijuana residue on the top
- Glass pipe with cylindrical end containing burnt residue (meth pipe)
- Small glass jars containing tetrahydrocannabinol (THC) wax and green leafy substance suspect marijuana
- Blue glass jar containing suspect marijuana with a stake containing label for strand
- Multiple plastic baggies used to package and store controlled substances, specifically marijuana
- Pieces of mail and personal documents addressed to Peter Iadarola

The THC wax and suspect marijuana located within this room were field tested were positive for the presence of THC.

Connected to this room was a restroom, referred to as room I. Inside of this room, the following was located:

- Approximately 0.48 pound of a green leafy substance, suspect marijuana, which equates to approximately 217 grams inside of a large plastic bag
- Another plastic containing more of the same green leafy substance, suspect marijuana
- More empty plastic baggies used to package/store-controlled substances, specifically marijuana
- Within close proximity of the recovered marijuana, was a rosin press and a "MagicalButter" machine which is used to manufacture, compound, convert, produce, process and prepare controlled substances such as THC wax or oil
- More documents addressed directly to Peter Iadarola with the address 637 Braddock Street listed

Also located within the residence, specifically in the garage and attic, multiple marijuana cultivation items were located. Officers located kits designed for planting and growing marijuana plants, lighting and hydroponic mediums used to cultivate marijuana, digital drug scales, gins and sifters used to remove seeds and twigs from marijuana. The equipment included marijuana residue and had marijuana cultivating stickers and instructions to accompany the equipment.

It should be noted, the amount of marijuana seized during the search of these rooms Peter resides in combined with the cultivation equipment also located by officers, is indicative of someone engaged in the cultivation, sale and delivery of controlled substances to make a monetary gain.

Peter was transported to the Sebastian Police Department where he was interviewed post Miranda Warning by Officer Glines and Corporal Keskinen. The following is what he stated in brief.

Peter denied growing marijuana in the state of Florida, and only use to grow it out of state. Peter stated he has never grown marijuana and sold it. Peter stated the only drugs in the house he had were THC-A, and some THC-A "Rosin." Peter stated the cultivation equipment found in the garage and attic were old and from 1990's to 2007. Peter stated he was unsure of the exact equipment because it was moved to the attic in 2007. Peter stated it was more likely old lights, reservoirs, fans, light controllers, and fan controllers. Peter stated he has not used the cultivation equipment and it was given to him in Fort Pierce when he was working for a hydroponic company that obtains used equipment from customers. Peter stated the Rosin pressed was used by him to press the THC-A to THC-A Rosin. When Officer Glines asked about the plant tags located inside of the residence, labeled "Honey Banana" Peter stated it was used for growing flowers from his ex-girlfriend. When asked about the SRT entry and announcements, Peter stated he thought it was a dream until the drone flew into his room and the flashbang went off.




NARRATIVE

On April 14, 2026, at approximately 1802 hours, I was sitting stationary with K9 Deputy McKay at approximately the 4100 Old Dixie Highway, Vero Beach, Florida, when a white Chevrolet pick-up truck bearing Florida tag JALG72 was observed failing to stop at the stop sign as it made a right hand turn onto Old Dixie Highway from 42<sup>nd</sup> Street, Vero Beach, Florida.

After observing the traffic infraction, K9 Deputy McKay initiated a traffic stop. Contact was made with the driver, Christian Green, and front seat passenger Deonte Streeter.

During contact the strong odor of burnt marijuana was smelled coming from inside the vehicle. Both occupants were removed from the vehicle and asked if they possessed a medical marijuana card, which they stated they did not.

A burnt marijuana cigarette was observed on the center console, and rolling papers on the floorboard. After the above was smelt and observed a probable cause search of the vehicle was conducted. During the search of the vehicle, 5.89 grams with bag of field test positive marijuana was removed from the driver's door, along with the burnt marijuana cigarette from the console, both items were removed from the truck, and later placed into evidence.

During the investigation it was discovered that the driver, Christian did not possess a Florida driver's license and had never been issued one. I had Christian placed in handcuff restraints and placed in the rear of my patrol car.

I contacted TELETYPE and had a query of Christian was conducted, they informed me Christian had a warrant for possession of controlled substance, reference warrant #WR2026288.

I read Christian his Miranda rights from my agency issued MIRANDA card, which he stated he understood and wished to talk.

I asked Christian about the marijuana, which he initialed denied. Christian then stated he was smoking the blunt when he observed us sitting on the side of the road, got nervous was trying to put it out, which is why he ran the stop sign.

The white Chevrolet pick-up truck bearing Florida tag JALG72 was towed from the scene by Nettles Towing, a tow sheet was provided to the tow truck driver, a tow sheet was placed into Christian's property, and one was placed into records.

A green and white dirt bike VIN: JKBKXFCC5GA007680, was removed from the rear of the pick-up truck, and transported to the Indian River County Sheriff's Office impound lot by Deputy Green.

Christian was transported to the county jail and charged accordingly.

This investigation was captured on my body-worn camera and the dash cameras of my vehicle.

This investigation is cleared by arrest.

On Tuesday, April 14, 2026, at 1838 hours, I Deputy Apollon responded to [REDACTED] in reference to disturbance.

Upon arrival, I made contact with [REDACTED] **F.S 29.072(3)(a)** stated [REDACTED] had been involved in a physical altercation with [REDACTED]

[REDACTED] further advised during the altercation [REDACTED] later identified as Kenetha Holmes, approached and struck [REDACTED] in the face with a closed fist.

While speaking with [REDACTED] I observed [REDACTED] red lace front wig had been forcibly removed during the altercation. I did not observe any additional visible injuries such as cuts, swelling, or bruising at the time of contact.

I then made contact with London Tolbert, who stated she witnessed the incident and recorded the altercation on her personal cellular phone. I reviewed the video footage, which depicted [REDACTED] wearing green t-shirt and blue jean shorts. The video showed [REDACTED] approaching [REDACTED] and stating words to the effect of, "You want to fight, run me one."

The footage then showed both [REDACTED] engaging in mutual physical combat by striking each other. During the altercation, Kenetha Holmes was observed verbally encouraging [REDACTED] to continue fighting. Shortly thereafter, Holmes attempted to intervene between the [REDACTED] However, while doing so, Holmes struck [REDACTED] in the face with a closed fist.

I then made contact with Kenetha Holmes, who resides at [REDACTED] Holmes was read her Miranda rights by Deputy Consalo and agreed to speak. Holmes stated the incident was initially a verbal disturbance between [REDACTED] She further stated [REDACTED] had told her that [REDACTED] and others had been making threats, including statements about having a pit bull attack [REDACTED] while [REDACTED] was riding [REDACTED] scooter.

Holmes stated she was on her way for a walk when [REDACTED] and another [REDACTED] identified as [REDACTED] approached and began making derogatory comments toward her and [REDACTED] Holmes denied striking anyone and claimed she was only attempting to protect [REDACTED] from being attacked by multiple [REDACTED]

Based on my review of the video evidence, I observed Holmes actively encouraging [REDACTED] to engage in the physical altercation. Although Holmes later attempted to separate the two [REDACTED] the video clearly shows Holmes striking [REDACTED] in the face with a closed fist. **F.S 29.072(3)(a)**

Based on the totality of the investigation, including victim statements, witness statements, and video evidence, I have probable cause to believe that Kenetha Holmes committed the following offenses:



Woodard stated she was involved in a physical altercation with [REDACTED] claiming her actions were in defense of her [REDACTED] whom she believed was going to be attacked.

Based on the totality of the investigation, including the victim's statement, witness statement, observed injuries, and video evidence, I have probable cause to believe that Keiya Woodard did knowingly and willfully commit an act that could reasonably be expected to result in physical or mental injury to a child.

Therefore, Keiya Woodard is being charged with the following offense:

- F.S.S. 827.03(1) – Child Abuse

Keiya Woodard was subsequently taken into custody without incident.

**NARRATIVE**

On Tuesday, April 14, 2026 at 2248, I Deputy Apollon and Cpl Chamberlian responded to 4425 34<sup>th</sup> Court Vero Beach Fl in reference follow-up past auto accident.

Upon arrival I made contact with a female subject who identified herself as Briana Scott. During the course of my investigation, the subject was later positively identified as Shalawna Snyder.

Snyder was advised of her Miranda Rights, which she stated she understood, and she agreed to speak with me without an attorney present.

During a post-Miranda interview, Snyder admitted that she intentionally provided a false name to law enforcement. Snyder stated she did so because she knew her driver's license was suspended at the time of the crash. Through my investigation, I confirmed Snyder's Florida driver's license has been suspended since 2013.

Snyder further stated that Briana Scott is her ex-girlfriend. When asked if she had permission to use Scott's identity, Snyder stated she did not.

Based on Snyder's own admissions, along with my independent verification of her driver's license status, I have probable cause to believe that Snyder knowingly and willfully provided false identifying information to a law enforcement officer during the lawful execution of my duties. Additionally, Snyder knowingly operated a motor vehicle while her driver's license was suspended.

Probable Cause is established as follows:

- The defendant knowingly provided a false name during a lawful investigation, in violation of Florida Statute 901.36(1).
- The defendant admitted knowledge of her suspended license status and operated a motor vehicle, in violation of Florida Statute 322.34(2).

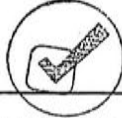

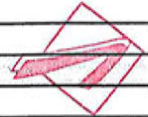

On Wednesday, 04/15/2026, at approximately 0206, I conducted a pedestrian stop on two individuals after observing both individuals walking southbound with the flow of traffic at 4600 33rd Avenue, Vero Beach, Florida 32967, building probable cause for a violation of F.S.S. 316.130(4) – Pedestrian fail to walk left side when no sidewalk.

Both individuals did not have physical identification on them, I asked them to provide me with their names. One individual identified himself as Kyon L Hudson and the other male identified himself as Jaefous Taylor (later discovered to be William Edd Robertson II). I ran both individual's names and date of births through the Indian River County Sheriff's Office Public Safety Dispatch. After verifying Hudson's information, he was released from the stop.

I was informed by Dispatch that Jaefous Taylor's Florida driver's license was showing as a deceased person as of 03/30/2024. I asked Robertson, who was identifying himself as Taylor to provide me with his social security number, upon running the social security number there was no record associated with it. Robertson continued to claim that he was Taylor and refused to provide his information to other deputies on scene due. I compared a picture of Taylor to Robertson and there where distinct differences between the both of them. Based on the totality of the circumstances probable cause exists for a violation of F.S.S. 901.36 – False Identification provided to Law Enforcement.

I attempted to have Sergeant Flores utilize Rapid ID to run the finger print of Robertson however the system was down.

I placed William Edd Robertson II under arrest and transported him to the Indian River County Jail without further incident. Upon arrival, Robertson provided his name to the correction deputies in booking, solidifying probable cause for a violation of F.S.S. 901.36 – False Identification provided to Law Enforcement.

William Edd Robertson II was placed under arrest for the following charges:

- F.S.S. 901.36 – False Identification provided to Law Enforcement.
