I informed David and Darlene that I would like to sit down with them and [redacted] at a later date when [redacted] was home to discuss [redacted] conversations with the sexual predator. I asked David and Darlene not to discuss the matter with [redacted] until we were all together.

I was able to go to ██████████ videos in ██████████ library and view the video sent from ██████████ to Robert. The video depicts ██████████ in a ██████████ walking in front of the camera and spinning around.

It should be noted that the law enforcement tool used to extract the information from ██████████ phone had linked the video with the above chat exchange between ██████████ and Robert; it was marked with an orange dot in the left-hand corner of the video.

During my search of usernames that Robert had in his phone linked to social media accounts, I searched some of the usernames and located females that appeared to be minors. Due to this limited search warrant, limiting me to just usernames, I was unable to access his social media to determine if there was any harmful communication.

Robert is fully aware that he needs to register internet identifiers, phone numbers, changes of address, and all other stipulations related to his sex offender status. Reference Indian River County Sheriff's Office case # 2017-00002071 and case # 2018-183326, where Robert was arrested for failure to register email addresses and internet identifiers. The sexual offender registration form that Robert has signed, contains the following statement:

**"PER FLORIDA STATE STATUTE 775.21(J)- "INTERNET IDENTIFIER" INCLUDES, BUT IS NOT LIMITED TO, ALL WEBSITE UNIFORM RESOURCE LOCATORS (URLS) AND APPLICATION SOFTWARE, WHETHER MOBILE OR NON-MOBILE, USED FOR INTERNET COMMUNICATION, INCLUDING ANONYMOUS COMMUNICATION, THROUGH ELECTRONIC MAIL, CHAT, INSTANT MESSAGES, SOCIAL NETWORKING, SOCIAL GAMING, OR OTHER SIMILAR PROGRAMS AND ALL CORRESPONDING USERNAMES, LOGINS, SCREEN NAMES, AND SCREEN IDENTIFIERS ASSOCIATED WITH EACH URL OR APPLICATION SOFTWARE. Robert utilizes social media platforms with unregistered internet identifiers to solicit women for sexual acts. He offers them money for sexually explicit pictures and videos.

Robert also solicits women for sexual acts, as described in the conversation with ██████████

At the conclusion of my investigation into the conversations between Robert and [REDACTED] I found probable cause that Robert, a thirty-two (32) year-old male, used a computer online service, internet service, or any other device capable of electronic data storage or transmission to seduce, solicit, lure, or entice [REDACTED], in violation of F.S.S. 847.0135(3)(a) and in violation of F.S.S. 847.0138, by soliciting [REDACTED] to commit an illegal act described in chapters 794 and 827 while using an online service, internet service, or other electronic devices, "Snapchat" and "TikTok."

I also substantiated probable cause for one thousand two hundred thirty (1,230) failure-to-register felonies with the execution of the cell phone search warrant signed by the Honorable Robert Meadows on September 16, 2025.

It should be noted there are several more unregistered internet identifiers not listed in the above list, in reference to online children's games, that could substantiate probable cause for likely hundreds, if not thousands more felony charges.

After reviewing Robert's previous cases involving sex crimes and failure-to-register crimes, along with the evidence collected in this investigation, one thing has become very clear. Robert is a sexual predator who utilizes unregistered internet identifiers, emails, usernames, and phone numbers to prey on women and minor females. Despite being arrested for the aforementioned crimes, Robert continues a pattern of behavior that puts females at serious risk if they come in contact with him.

This investigation was captured on my body worn camera.

This investigation is cleared by arrest.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 04/23/2026, at 02:36 (Specifically include facts constituting cause for arrest.)

On 4/23/26 at approximately 0236 hours, I, Officer W. Brumley conducted a traffic stop in the 2700 block of 20th St, on a white 4 door sedan bearing FL tag# 20VCNP, in reference to the vehicle not having any tag lights.

Upon approach, I made contact with the driver and sole occupant of the vehicle, identified as David Grant (defendant), who stated he was coming from Stix Billiard Club (939 14th Ln) and heading home. The defendant then stated he had approximately two drinks while at Stix. He did not specify what kind of drinks. I observed the defendant's speech to be slightly slurred, eyes to be glossy, and I could detect the odor of an alcoholic beverage emanating from his breath as he spoke. When the defendant was asked about how long ago he consumed the drinks at Stix, he stated I just left there.

Due to the defendant stating he had a few alcoholic drinks while at Stix and stated he was just leaving from there. The defendant agreed to conduct the Standard Field Sobriety Exercises to dispel any fears I may have of him being impaired. The defendant stated he did not have any medical injuries or illnesses that would prevent him from completing the Field Sobriety Exercises. Each exercises was explained and demonstrated prior to having the defendant conduct them, the defendant stated he understood the instruction prior to each exercise. The Field Sobriety Exercises are as follows:

- Horizontal Gaze Nystagmus (HGN)
  - slight head movement at beginning of exercise
  - slight side to side sway
  - equal tracking and pupil size (both eyes)
  - lack of smooth pursuit (both eyes)
  - distinct and sustained nystagmus at maximum deviation (both eyes)
  - onset of nystagmus prior to 45 degrees (both eyes)

- Walk and Turn
  - raised arms for balance at the start
  - stepped off the line on step 2 on the first 9 steps
  - turned other than instructed
  - missed heel to toe on step 3 on the second 9 steps.

- One Leg Stand
  - did not raise foot to proper height like instructed
  - raised arms for balance
  - only counted to 21
  - asked if he should pick his foot back up to continue after telling him he could stop



Based on the aforementioned the defendant was placed under arrest for suspicion of DUI. While putting the defendant in my patrol vehicle and explaining to him that he was under arrest, Officer Kriegner and Cpl Dominguez conducted an inventory of the defendant's vehicle prior to it being towed. Cpl Dominguez located a fanny pack on the front passenger floor board, resting against the center console, upon opening it he observed it to contain a large amount of cash with a clear plastic baggie manipulated to look as if it were used to contain illegal narcotics. Cpl Dominguez also located a box containing a firearm with a loaded magazine inserted in the firearm, on the back right passenger floor board.

I searched the defendants fanny pack and from the main pocket I located and counted \$1600 in cash and observed a clear plastic baggie containing a purple cylinder shape pill with a monkey face on it. Through my training and experience, I identified the pill to be MDMA. The purple cylinder shape pill was field tested and had a positive reaction to the presence of MDMA/ Ecstasy.

I also located a clear plastic baggie in the front pocket of the fanny pack containing 1 round blue pill and a half of a round blue pill. Both pills shared the same imprint on it. Using the website Drugs.com, I was able to identify the pill to be an Amphetamine. The round blue pill was field tested and had a positive reaction to the presence of Methamphetamine.

A criminal history check was done on the defendant to rule out any felony convictions. VBPD communications advised the defendant had two previous felony convictions. His first conviction on 7/22/21 and the second on 12/06/21.

Based on the totality of the circumstances, the defendant was placed under arrest for violation of FSS. 316.193(1A) DUI, 2 Counts Of 893.13(6A) Possession Of A Controlled Substance Without A Prescription, 790.23(1A) Possession Of A Firearm By A Convicted Felon, and 790.23(1A) Possession Of Ammunition By A Convicted Felon.

The defendant was transported to the Indian River County Jail without incident. While at the jail, the defendant was provided an opportunity to give a sample of his breath to which he refused, before and after being read implied consent.

The defendant also received an additional charge for violation of FSS. 316.1939(1) DUI Refusal To Submit To Breath Test.

NARRATIVE

On Wednesday, April 22, 2026, at approximately 2216 hours, I responded to [REDACTED] in reference to a report of an injunction violation.

Upon arrival I made contact with the complainant Sonia Gourd. Gourd stated she had an active temporary order of protection against her ex-boyfriend Glenn Haraldsen which was put in place on April 10, 2026 reference Indian River County Court case number 31-2026-DR-000325. Gourd stated on the date of this report she had a court hearing in reference to the injunction, but Haraldsen requested a continuance which was granted. Gourd stated she and Haraldsen had been separated for almost two and a half years, but he recently began stalking her due to her getting a new boyfriend. Gourd received a text message from the father of her child Nathan Hines. Hines advised Gourd that Haraldsen texted him and provided Gourd with a screenshot. Gourd provided me a copy of the screenshot and the text message which was received at 1746 hours on the date of this report and read as follows:

"Hey, will you please do me a favor and call me. I want you to know the truth. I want you to know what I did for her and your little girl, I'm not some fucking weirdo oh a guy that wanted some answers because I forked out a shit load of time, effort, and money to make sure a woman was safe and her bills were paid and I think I deserved a little bit more than a threat an immediate threat cause that's what she did. She immediately threatened me with the police and I want you to know how it really went down and you can talk to her about it. Tell her what I said I'm not trying to get you to change your mind I'm not trying to like threaten you in anyway I just wanted to say my side of the story this way you know what really happened I appreciate if you called me."

Hines responded "Do not contact me in any form of communication."



Haraldsen responded "I didn't you just contacted me asshole."

I then responded to the residence of Hines. Hines provided me access to the text messages on his phone. I confirmed the messages received were the same as the messages on the screenshots provided by Gourd. Hines stated Haraldsen had previously come to his residence to confront him about Gourd and Hines had to call the Sheriff's Office due to Haraldsen refusing to leave his property. Hines additionally stated Haraldsen regularly drives past his residence and sits down the street staring at him.

I reviewed the injunction which prohibited any contact between Haraldsen and Gourd including third party contact. Based on the message which Haraldsen sent to Hines I find probable cause that Haraldsen violated the

On April 23, 2026, at approximately 1056 hours, I was dispatched to 1550 Indian River Drive (Crab Stop Seafood Restaurant), Sebastian, FL 32958, in reference to a suspicious person.

The caller advised there was a male acting suspicious on the property of Crab Stop, which is a seafood restraint that is currently closed out of business. The caller Kaylee stated the male was a white male wearing red basketball shorts and grey t-shirt. Kaylee stated she witnessed the individual enter the closed business through the back of the building and saw him inside.

Upon arrival, I made contact with the individual who stated he did not work for the business or have permission to be on the property. The male stated he was homeless and was living at the closed business due to being homeless. The male stated he works at Captain Hiram's restaurant down the road and was identified by his Florida identification card as Kenny Doke. Kenny stated he has been living in the building for approximately 30 days or less and did not know where else to go as he could not afford housing. Upon my arrival, Kenny was sitting in the corner of the wooden bar area on the east side of the restaurant. Kenny stated there was to be nobody else in the building and he was living there alone. A protective sweep of the building deemed this to be true and Kenny did appear to have belongings and signs of living there in the building. Burnt marijuana "roaches" were located in the building next to Kenny's belongings. The business did appear to have items left in the building such as alcohol beverages and furniture and such. There was a can of white claw seltzer next to the area where Kenny used to sleep but the can was unopen at this time. There were still utensils and such in the building but unknown if Kenny was using them. The rear patio screen appeared to be cut or ripped which allowed access into the rear of the building but Kenny stated it was previously like that and he did not cut it.

Kenny was run through FCIC/NCIC which led to an active warrant out of Arkansas for wanted on parole violation, breaking and entering, battery 2nd degree, possession-controlled substance schedule L, Meth, Cocaine & amp; LT;2G, possession drug paraphernalia meth cocaine. The warrant was confirmed through Sebastian Police dispatch for full extradition and Kenny was placed into handcuffs which were double locked and checked for fit.

Kenny was transported to Indian River County Jail without incident.

Kenny's belongings were given to a co-worker per his request and handed over to Tatiana Cournia.

Kenny was charged with Fugitive from justice; duty of governor FSS 941.05.

This incident is cleared by arrest.

**NARRATIVE**

On Thursday, April 23, 2026 at approximately 2102 hours was dispatched to 2000 9<sup>th</sup> Street Sw in reference to a traffic stop initiated by Deputy T. Lowell.

Deputy T. Lowell advised the following for probable cause to initiate the traffic stop: "on 04/23/2026 at approximately 21:00 hours, I was informed by an off duty IRCSO employee, B. Byrd that she observed a black Mercedes sedan traveling Eastbound on Oslo Road at speeds of approximately 20 mph in a designated 45mph zone. B. Byrd stated the male driver behind the wheel was all over the roadway. B. Byrd stated she observed the black Mercedes sedan pull into the BP gas station located at 1999 Oslo Road. B. Byrd stated the black Mercedes had a handicap Florida tag.

Upon my arrival to the gas station, I observed a black Mercedes sedan with a handicap tag (bearing FL tag VA4XT). I observed the vehicle pull out of the plaza onto 19<sup>th</sup> Avenue SW without coming to a complete stop before entering the roadway. From the complaints of a possible intoxicated driver and the infraction observed, I conducted a traffic stop with my marked agency issued patrol vehicle equipped with flashing red and blue emergency lights after the vehicle exited the plaza."

I then arrived on scene and was behind Deputy T. Lowell's patrol vehicle when as he was attempting to stop the vehicle. I observed the vehicle stopped on 19<sup>th</sup> Avenue SW before turning east onto 9<sup>th</sup> street SW while Deputy T. Lowell was behind with the vehicle with his emergency lights activated. I, along with Deputy T. Lowell continued to follow the vehicle with my emergency lights and siren activated from the 1900 block to the 1500 block of 9<sup>th</sup> Street SW.

Upon initial contact with the driver of the vehicle, Arnaldo spoke with a slurred speech and had watery eyes. I observed a closed alcoholic beverage in the passenger seat of the vehicle, to which Arnaldo attempted to cover up with a jacket. A strong odor of an alcoholic beverage was emitting from the vehicle. Arnaldo was asked to step outside of the vehicle to conduct a DUI investigation. While speaking with Arnaldo, a strong odor of an alcoholic beverage was emitting from his breath. I observed Arnaldo's jeans to also be covered with urine, and his zipper to be down. When asked, Arnaldo advised he had just been at his friend's house and drank one beer today. (Arnaldo changed this answer to two beers when asked again later.) Due to this statement along with his driving patterns, and odor of alcoholic beverages emitting from his breath, Arnaldo was asked to perform standard field sobriety exercises to which he replied he would.

Arnaldo is an [REDACTED] it could be observed that Arnaldo had a problem with walking and standard field sobriety exercises would not be possible. Lieutenant K. Jaworski responded to the scene to assist and administer seated battery exercises due to his physical condition.

Lieutenant K. Jaworski stated the following in his report "On April 23, 2026 at approximately 2135 hours, I responded to the area of 1900 block of 9<sup>th</sup> Street SW to assist with a DUI investigation. Upon my arrival I made contact with Deputy Goodrich and Deputy Lowell who were conducting a DUI investigation. Due to the driver having a [REDACTED] they asked me to respond to conduct the seated battery exercises which I am trained in.

I made contact with Arnaldo Sanchez. As I approached the subject, I could smell the strong odor of urine and an alcoholic beverage emitting from his breath. I observed that his pants were wet and he appeared to have urinated on himself. His

eyes appeared watery. I continued to smell the odor of an alcoholic beverage emitting from his breath as he spoke. Sanchez admitted to having (2) beers at a friend's house. I asked him if he had more than two and he stated only two. I asked him if he was a diabetic or epileptic and he stated, "No." I asked him if he took any medications or drugs and he stated he took several [REDACTED]. He tried listing his medications but he was hard to understand at times. I asked him if he spoke and understood English and he stated, "Yes." I asked him if he needed a translator and he did not need one and that he understood me. I asked him if he had any physical defects and he [REDACTED].

Based on the admission of drinking several beers and the above observations I asked Sanchez if he would be willing to perform several field sobriety exercises. Sanchez agreed to the exercises. Due to his [REDACTED] decided to conduct the seated battery exercises. The observations from the exercises are listed below.

All exercises were conducted on a stable metal bench. When I asked if he was stable, he responded, "I'm with Jesus." Sanchez advised he was stable. All exercises were explained and demonstrated prior to the subject starting them. The subject indicated that he understood the instructions for each exercise before attempting them.

I checked Sanchez's eyes for horizontal gaze nystagmus. I asked him if he wore glasses and he stated he did for reading. I observed lack of smooth pursuit in both eyes. I observed distinct and sustained nystagmus at maximum deviation. I observed the onset of nystagmus prior to 45 degrees. Vertical nystagmus was not present. Lack of convergence was present. Sanchez's eyes swung outward away from the stimulus. During the exercise, Sanchez moved his head from left to right with the stimulus. He needed to be constantly reminded to keep his head still. He also needed to be reminded to keep looking at the stimulus.

The second exercise I explained and demonstrated was the finger to nose. During my instructions, Sanchez was observed closing his eyes and tilting his head back before being told to start. I observed the following observations:

Left: Sanchez was observed searching for his nose. When his finger approached, he opened his eyes. He also did not return his hand to his side. He was reinstructed.

Right: Sanchez opened his eyes as his finger approached.

Left: Sanchez touched the side of his nose and then the tip.

Right: Sanchez hesitated to return his hand to his side.

Right: Sanchez began raising his left hand and then his right. He also touched his nostril before the tip of his nose.

Left: Completed properly.

The third exercise I explained and demonstrated was the palm pat. I asked him again if he'd like a deputy to translate for him and he stated no and he understood. During my instructions, Sanchez began before being told to do so. During the

exercise, Sanchez did not count as instructed. He had an improper pat with a slow, exaggerated pat. He also did not increase speed. After several pats he stopped and asked if he needed to do more.

The fourth exercise I explained and demonstrated was the hand coordination. Cpl. Ballester translated this exercise from English to Spanish. Cpl. Ballester also demonstrated the exercise. Sanchez stated before being told to begin. Sanchez stated that he understood the four tasks. Sanchez did not count as instructed. He asked what to do after he reached the 4<sup>th</sup> position with his fists. Sanchez did not clap until the very end of the exercise. He did not count on the return steps. He did not place his hands on his lap and put them back down at his sides. He then clapped three times to end the exercise.

Based on the above observations I advised Deputy Goodrich to place Sanchez under arrest for driving under the influence."

Arnaldo Sanchez was arrested and was transported to the Indian River County Jail without incident.

Upon arriving to the jail, Arnaldo was handed over to jail staff where they administered the states test. Jail staff advised the following results: Sample 1 at 2303 hours yielded 0.064 g/210L of breath and sample 2 at 2307 hours yielded .061 g/210L of breath which was inconsistent with his level of impairment observed on scene. Arnaldo was further asked to provide a urine sample due to his statements of taking anti-anxiety / anti-depressant medication today. Arnaldo initially denied providing a urine sample but later agreed after being read implied consent, results of this urine test are pending

Due to the listed facts above I charged defendant Arnaldo Sanchez with F.S.S. 316.193 (1) (A) – DUI.

NARRATIVE

On Thursday, 04/23/2026, at approximately 2359, I was dispatched to [REDACTED] in reference to a trespassing investigation.

Upon arrival I made contact with Antaeus Markeec Brown, resident of [REDACTED] and ex-boyfriend of the suspect, Katrina Joy Voll. Brown stated that while he was inside the living room of the residence eating, he heard a noise coming from the garage. When going to the garage he found Voll had lifted open the garage door and came into the residence through the door connecting to the living room from the garage. I asked Brown if Voll ever resided at the residence, Brown stated she never lived at or paid any living expenses at the residence. Brown also stated that he did not invite Voll over to the residence and that she did not have any means of accessing the residence on a normal basis. Brown advised that Voll started yelling at him and threw a glass hot sauce bottle at a cabinet door, causing the bottle to shatter and damage to the cabinet door. Based on the information probable cause exists on Katrina Joy Voll for a potential violation of F.S.S. 810.02(3)(d) – Burglary of Occupied Conveyance.

Brown and his roommates told Voll to leave the residence and that they were calling the police. While Brown's roommate was on the phone with [REDACTED] Voll left the residence in a blue Toyota Yaris bearing Florida tag 42BXPX and went southbound on 43rd Avenue. While speaking with Brown he started to receive multiple phone calls with no caller ID, Brown stated that he believed it was Voll because she had been calling him all night. I told Brown to answer the phone and go with what she says to get her back to the residence. Voll told Brown she heard them giving her information to [REDACTED] and wanted to know if she was going to go to jail. I told Brown to try to get her to come back to the residence. Voll started to ask Brown if he would have sex with her, which he told her to come back to the residence.

When Voll arrived at the residence I immediately gave verbal commands for Voll to exit the vehicle. I gave Voll multiple chances to comply and told her that if she continued to refuse, I would remove her from the vehicle. Voll got out of the vehicle and when told to put her hands up she said no and started to walk around the vehicle, at which time I told Voll not to run. I grabbed Voll's arms and told her to put her hands behind her back, to stop resisting and that she was under arrest. Voll continued to tense up, state "let go of me" and refuse to comply with my lawful direction. When Voll was told she was under arrest and to stop resisting, Voll replied "No I'm not", "I did not do anything". I used Voll's forward momentum to redirect her to the ground and continued to issue her commands to put her hands behind her back, which she refused and stated "I did not do anything" as she attempted to tuck her arms under her stomach. While on the ground I was able to gain control over Voll and take her into custody for a violation of F.S.S. 843.02 – Resist arrest without violence.

After Voll was placed in the back of my patrol vehicle, she was advised of her Miranda rights by Deputy

Perez and voluntarily waived them to speak. Voll stated to Deputy Perez she was invited to the residence for group sex and the parties inside became upset when she refused. Voll denied any allegations of coming in through the garage door and breaking items inside of the residence.

I asked Brown if he or anyone inside of the residence had called or spoken with Voll earlier in the evening. Brown stated that he briefly spoke with Voll about the location of their child while he was driving back from Jacksonville, when he found out their child was at Voll's parent's house, he hung up on her and did not speak with her further. Brown also stated that everyone else was asleep inside of residence at the time this occurred. I checked Brown's call logs and saw an outgoing phone call earlier in the day and then saw multiple missed incoming phone calls from a no caller ID spanning from 2000 hours to the time of the investigation.

At the time of the investigation, Voll entered the residence without permission or invitation and remained inside after being told to leave. While inside the residence, Voll destroyed a bottle of hot sauce (valued at \$5.99) and damaged a cabinet door (estimated value of \$50.0) building probable cause for a violation of F.S.S. - 806.13 Criminal Mischief. While these events took place there was 3 individuals inside of the residence.

Based on the totality of the circumstances, I placed Katrina Joy Voll under arrest for the following offenses:

**NARRATIVE**

On Friday, April 24, 2026 at approximately 0033 hours, I responded to the 1200 block of 43<sup>rd</sup> Avenue in reference to a potential impaired driver. Prior to my arrival, I spoke with Corporal R. Thomas and he advised that the driver's breath smelled like an alcoholic beverage and was showing other signs of impairment. See with Corporal R. Thomas supplement for more information.

Upon my arrival, I observed the driver seated on the motorcycle, which was still on the ground bearing Florida license plate MVDP19. When I spoke to the driver, he introduced himself as Gary Szejnrok. During the course of my investigation, I detected a strong odor of alcohol emanating from his breath. Additionally, Mr. Szejnrok face exhibited bloodshot and watery eyes, and his speech was slurred.

I assisted him in stabilizing his motorcycle and, for his safety, instructed him to step away from the vehicle. Upon standing, he attempted to walk but was unable to maintain his balance, frequently stumbling and holding onto his chair for support. He eventually moved toward the patrol vehicle, nearly falling to the ground. While on scene he would laugh unprovoked and mumble unrecognizable words to himself.

When asked to perform field sobriety exercises, he declined. I informed Mr. Szejnrok that refusal to comply could result in a decision being made based on the observations from this encounter. He continued to refuse, and as a result, he was placed under arrest for driving under the influence. Based on my training and experience, I believe that Mr. Szejnrok was under the influence of alcohol or drugs. He placed into the back of my agency issued patrol vehicle and transported to the Indian River County jail.

When we arrived to the jail Mr. Szejnrok was placed into custody of the jail staff and while at the jail, the jail staff administered the states breath test. Shortly afterwards jail staff advised that he refused to provide a sample of his breath. Subsequently I requested for lawful sample of his urine he advised that he did not want to provide a sample and I then read him implied consent and he still refused to provide a urine sample.

Based on the facts above Mr. Szejnrok is in violation of F.S.S. 316.193(1)(a) Driving Under the Influence and F.S.S. 316.1939(1)(E) Refusal to Submit DUI Testing.





