The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: On 04/29/2026 at 02:59 (Specifically include facts constituting cause for arrest.)



PROBABLE CAUSE STATEMENT

I conducted a traffic stop on a silver Chevrolet Impala bearing FL tag # RFGQ96 at the 500 block of 20th Street. Prior to the stop, I was traveling behind the vehicle when I conducted a query of the license plate. My agency laptop alerted that the vehicle registration was expired as of 03/12/2026 and that the registered owner Jacinda Irene Holloway (B/F DOB: 03/12/1997) did not have a valid drivers license and that there was no insurance information on file.

Upon conducting the stop, I made contact with the driver and sole occupant of the vehicle. I advised the driver the reason for the stop and requested her drivers license and additional documents. The driver was unable to provide proof of insurance and claimed that the vehicle belonged to her "older cousin." The driver also stated she did not have her wallet with her and that she did not have her drivers license but stated she could provide her information verbally. The driver verbally identified herself as Taniya Alana Perry (B/F DOB: 09/03/1999), provided an address of 2264 3rd St. SW Vero Beach, FL, 32962, and a phone number of 772-453-6911. In asking the driver for her social security number, she hesitated, remained silent and then proceeded to say she could not remember due to having a "traumatic brain injury." I then requested the driver to provide any other form of identification to confirm she was Taniya to which she stated she did not have any documents with her at the time.

I then provided dispatch the information and conducted my own query search on ELVIS. Upon entering the information, the photo identification for "Taniya Perry" did not match the driver. Upon looking at the photograph of the registered owner (Jacinda Irene Holloway B/F DOB: 03/12/1997) associated to the silver Chevrolet Impala, it appeared identical to the driver. I then searched Jacinda Holloway's name on the Indian River County Sheriff's office inmate search website, where I located a recent booking for Holloway on 04/07/2026. The booking photograph showed Holloway to have light brown/blondish braids and was a confirmed match to the drivers appearance.

Due to my findings, I approached the driver once more and advised her that I knew she had provided false information. The driver then admitted to providing false information to me and acknowledged the reason she had done so was because of her drivers license being suspended. The information was relayed to dispatch and they confirmed that Holloway had the following suspensions:

Another query of Holloway's driving history was conducted through DAVID which showed the following:

While placing Holloway in the rear of my patrol vehicle, she requested to bring her wallet and phone with her. It should be noted that Holloway previously had stated to me that she did not have her wallet in her possession, however it was located under her front driver seat and contained two Florida drivers licenses that had the right corners cut.

Based on the foregoing, Holloway was placed under arrest for Driving While License Suspended (DWLS) - Habitual Offender F.S.S. 322.34(5) and Give False Name to LEO - F.S.S. 901.36(1). Holloway is to be held on NO BOND.

Upon my arrival, I made contact with Madison Landers and Jeremy Trotman. They stated that, according to their Ring camera footage, at approximately 0816 hours their neighbor walked up their driveway and cut through their front yard toward a brown dog and a tan-and-white dog that were near the front door.



NARRATIVE

On April 29, 2026, at 1713 hours, I was dispatched to a disturbance at 13405 US Highway 1, Sebastian, Florida.

Upon my arrival, I made contact with Ana Pinto, who stated she had been arguing with Adrian Castillo Garcia, the father of her child. Ana advised they had recently separated, and she had been living on her own for approximately two weeks in an effort to create distance in the relationship. She stated Adrian had been very confrontational with her.

Ana stated that today they were in the rear area of the restaurant where they are both employed when Adrian began following her around. She stated that at one point he struck the center of her chest with his hand, pushing her backward, and positioned himself in a manner that prevented her from entering the building. Ana stated she tried going inside and was unable to get past him to enter the building, but he continued blocking her from doing so. She further stated that he pushed her aside, shut the door closed, and grabbed her by the wrist. Ana stated she was able to break free and began pacing in the rear parking lot in an attempt to evade him.

While speaking with Adrian, who had limited English proficiency, his aunt assisted with translation over the phone. Adrian stated they were arguing because he did not want Ana to drive due to her not having a driver's license, and he was attempting to stop her from driving. He stated that was the reason for the argument.

I then spoke with the restaurant owners, who provided surveillance footage from the rear of the business at approximately 1512 hours. The video showed the confrontation beginning near a vehicle. Ana attempted to walk around Adrian several times, but he repeatedly blocked her by positioning himself in front of her and preventing her from entering the building. At one point, Adrian stepped in front of her and struck the center of her chest with his palm, pushing her backward. He then grabbed her wrist, at which time Ana rotated free. She continued making several attempts to move around him to the left and right, but Adrian repeatedly stepped in front of her, preventing her from entering the building. Ana then walked away in another direction, and Adrian continued following her until she returned to the vehicle.





NARRATIVE

On April 29, 2026, at approximately 2229 hours, I conducted a traffic stop on a black BMW X5 bearing Ohio tag KEX5173 in the 4300 block of 26th Avenue for a headlight violation.

Upon making contact with the driver, later identified as Jeremy Hester, I introduced myself and explained the reason for the stop. I then asked Hester for his credentials, at which time, he stated, he did not have his driver's license in his possession. I asked if he had any form of identification, and he provided a Michigan identification card. Once again, I asked if he had a valid driver's license, to which, he stated, he did not. Hester explained his license was not valid and was in the process of having it reinstated. Hester also stated, he had contacted the appropriate agency, in December of 2025, to check on the status of his license and was advised, that it would not be valid for one year.

I then asked Hester if he had proof of registration and insurance. He stated that he was currently working on obtaining registration and insurance though his mother, who resides in Michigan. When asked again if the vehicle was registered and insured, Hester stated he recently purchased the vehicle and had not yet been able to register or insure his vehicle.

I ran a query of his Michigan identification card, and the Ohio tag, through Indian River County Public Safety Dispatch. The query yielded a suspended drivers license out of Michigan, and an expired registration to a Dabo Fatmata that expired December 7th, 2024. Hester has not insured the vehicle since he purchased it approximately one month ago.

Post Miranda Hester stated he purchased the vehicle approximately one month ago from Facebook Market Place, from a large male whose name he does not remember. Hester informed me he sent the vehicle's title and proof of purchase to his mother in Michigan.

Based on my investigation, Hester was knowingly in violation of the following Florida state statute:

1. F.S.S. 322.34(2) Knowingly driving while license suspended.
2. F.S.S. 320.02(1) operating with no motor vehicle registration.
3. F.S.S. 324.221(1) failure of owner operator to maintain required insurance.

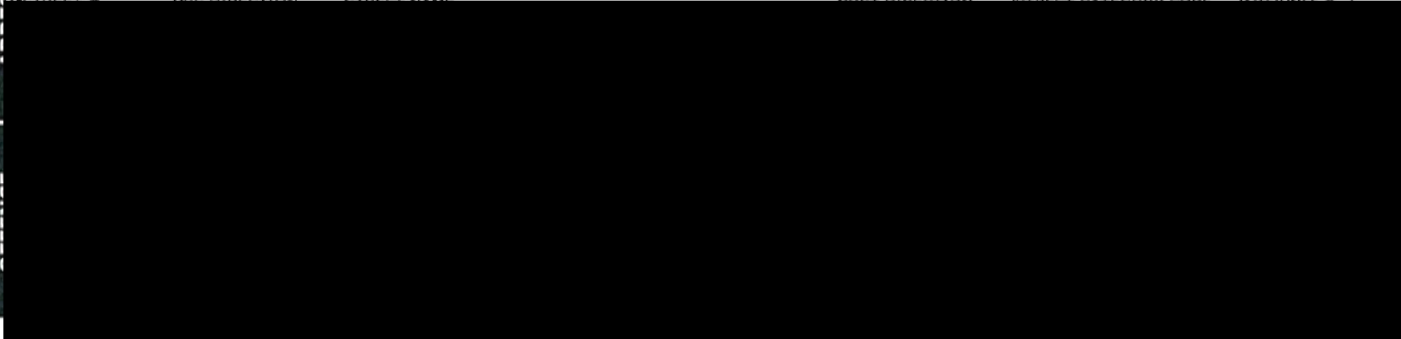

Nicole stated that she did not want to call the police because she believed we wouldn't take her complaint seriously. Nicole stated that she didn't have anything further to say to the on-scene officers. Nicole proceeded to use derogatory language towards the officers, and she proceeded to say racial slurs such as (Nigga) towards Benjamin in the presence of on-scene officers.

I made contact with the boyfriend/victim, Benjamin, who stated that he removed Nicole's car keys from her purse because she was heavily intoxicated and was not going to allow her to drive. Benjamin stated that they went out for drinks at a few bars to celebrate Nicole's birthday, and when they returned to the residence, he took her car keys to prevent her from driving drunk. Benjamin stated that when he went to remove the car keys, Nicole bit him on the lower right wrist. Benjamin stated that he did not touch Nicole in any way.

Benjamin stated he was struck with a closed fist on the top of his hand and the left side of his face. But I saw no obvious evidence of injury. Apparent injury on the lower right wrist was consistent with the bite mark allegation and the injury was able to be observed.

Based on the totality of circumstances, Nicole being combative with officers, I found probable cause to place Nicole under arrest for violation of FSS 784.03(1A1) BATTERY DOMESTIC VIOLENCE and FSS 843.02 RESISTING AN OFFICER WITHOUT VIOLENCE.

Nicole was placed in mechanical restraints, which were double-locked and checked for proper fit.

Nicole was transported to the Indian River County Jail without further incident.

The domestic violence packet will be submitted along with the arrest affidavit.

The lethality assessment revealed that Benjamin was not in a potentially lethal situation.

Officer Glines took the pictures of the injuries Benjamin sustained from Nicole.
