On 12/18/2024 at approximately 1957 hours, I was traveling east on Sebastian Boulevard near Delaware Avenue when I observed what appeared to be a motorcycle (Black 2021 Harley Davidson bearing Florida Tag MYKU92) in the left turn lane of Sebastian Boulevard west. The vehicle was stopped in the turn lane with the left turn signal active for several seconds. As my patrol vehicle and the vehicle in the outside lane next to me got in close proximity to the intersection, the motorcycle then proceeded to make the left turn south onto Delaware Avenue, causing myself and the vehicle next to me to come to almost a complete stop to avoid the collision. Based on my observation of the motorcycle almost causing a collision, I conducted a traffic stop on the vehicle.

I made contact with the operator and registered owner of the motorcycle, Chris Levale, later identified via Florida Driver License. I requested Chris provide me with his driver license which yielded in Chris handing me his military I.D. card. Chris then handed me a [REDACTED] Chris finally produced his driver license after being reminded. Chris was asked if he had the registration and insurance for the motorcycle which yielded in him stating "Yes", but then folding his hands in front of him and not retrieving the items. I again asked Chris if he had the registration which he replied "It's through Geico and I don't have my passwords." After being asked more about the paper registration for the motorcycle, Chris finally stepped off the motorcycle to attempt to locate it. While speaking with Chris, I observed him to have slurred speech, and a strong odor of alcoholic beverage emitting from his breath as he spoke, and Chris' front zipper (Fly) on his pants was also down. The odor of alcoholic beverage was strong enough to be detected despite Chris chewing gum. When asked about alcohol consumption for the day, Chris stated "Probably three beers" and later stated he went to two bars. Chris removed his goggles which yielded in me observing him to have slightly red, glossy eyes. Chris had to be reminded several times through the interaction to keep his hands out of his pockets.

Based on the totality of the circumstances, Chris was asked if he would perform Standardized Field Sobriety Exercises which he refused. After I advised Chris of his Taylor Warning, he became agitated and stated "That's not fair" and that he "Knows the law." Chris was once again asked if he would complete field sobriety exercises which he refused. Based on the totality of the circumstances, Chris was operating a motor vehicle and was under the influence of an alcoholic beverage or controlled substance and was affected to the extent his normal faculties were impaired. With the intention of placing him under arrest, I instructed Chris to stand at the front of my patrol vehicle which he stated no. I then gave Chris multiple lawful orders to stand at the front of my patrol vehicle which he ignored. Chris was then placed into mechanical hand restraints next to his motorcycle.

Chris was placed under arrest, searched, and seated in the rear of my patrol vehicle. Chris was then transported to the IRC Jail. When removing Chris from my vehicle, there was a strong odor of alcoholic beverage in the back seat area where he was seated. At the IRC Jail, Chris refused to provide any breath samples to IRC SO Deputy M. Rodriguez. It should also be noted Chris is currently on Probation in Indian River County for Aggravated Assault.

Chris was issued DUI Citation ADI1VLE.
