NARRATIVE

On Friday, November 21, 2025 at approximately 0026 Hours I responded to 14415 U.S. Highway 1, Sebastian (Sebastian Sands Motel) in reference to a suspicious person.

Dispatched advised me that an approximate 21 Year Old white male wearing black shorts, a white T-shirt and a tan back pack was looking in cars at the motel.

Upon my arrival I drove around the motel and was unable to find the suspect when Complainant, Dustin Allen Woods advised me that a white male had been looking into cars and Woods asked the unknown Suspect later identified as Camron Michel Cummins, what he was doing and Cummins took off and ran across the street.

I circled the immediate area and noticed a white male with black/red shorts, a tan T-shirt and a tan backpack walking southbound in the Orlando Health Sebastian River Hospital Parking Lot hurriedly. I immediately drove behind Cummins and ordered him to sit down on the ground shining my spot light on him.

As I was calling out my location Cummins put his hands in the backpack pocket as I drew my gun ordering Cummins several times to get out of the pocket with Cummins continuing to go in the backpack. Cummins cupped something in his hands and put it in his mouth and started chewing it aggressively.

Cummins was arrested, handcuffed and walked to the front of Deputy Mangel's patrol car and searched. I then ordered Cummins to open his mouth and I saw a small piece of blue plastic in the left lower side of Cummins mouth. I then grabbed Cummins mouth squeezing his mouth bending him over the patrol car ordering him to spit it out.

An approximately 3/4"x1" blue piece of plastic had been spit on the hood of my car filled with saliva. Illegal substances are known to be placed in small baggies used by people who use illegal substances.

The blue piece of plastic and contents that appeared to be empty was field tested by Deputy Pollacek on scene with Cobalt that had a negative result.

Cummins was read Miranda while he was in the back of my patrol vehicle. Cummins advised me that he would talk with me. Cummins told me at first that he was looking for somewhere to charge is phone and then later told me he was confused and was doing circles in the parking lot. Cummins advised me that he did not look in the parked cars.

Cummins also told me that white Rhino (male enhancement supplement) was allegedly in the baggie that he placed in his mouth so he was assured he would get a dose.

Complainant/Witness, Dustin Allen Woods advised me that Cummins had been looking in the cars and when Woods confronted him Cummins ran across the street and crouched down trying to not be seen.

Cummins was seen by two witnesses in the motel parking lot with low to no lighting in the early morning hours walking between multiple cars looking in windows of vehicles. When Cummins was approached by management, Cummins fled the scene.

Per Woods Sworn Written Statement;

"The Young white male was pacing back and forth at our driveway at Sebastian Gardens..." "he was walking

NARRATIVE

On November 21, 2025, at approximately 1735 hours deputies responded to 600 block of 8th Street in reference to a physical altercation resulting in the discharge of a firearm. Upon arriving, Detective Sergeant Brandon Dean observed both subjects crossing the 6th Avenue and 8th Street intersection and attempted to make contact. Emergency sirens could be heard in the distance in response to the call for service, which caused the subjects to flee the scene away from Detective Sergeant Dean. Detective Sergeant Dean chased one of the subjects in his vehicle, who was later identified as the victim, Federico Bustos, a white male born 02/19/1999. Saint Lucie County (SLC) Deputy Alex was also in the area and pursued the second subject — who was riding an electric bicycle — in his patrol vehicle with active emergency lights and sirens. The second subject was later identified as the suspect, Gavin Brugger, a white male born 04/07/1997. SLC Deputy Alex lost visual of Brugger for approximately twenty (20) seconds near the 500 block of Indian River Boulevard, and regained visual once inside the Fountainhead Gardens Villas complex. Brugger was stationary, still on his electric bicycle, shirtless. Brugger was taken into custody without further incident.

Detective McKenzie and responded to the 600 block of 8th Street and made contact with complainant and witness, Michelle Burberry. Burberry stated she and her husband were driving east on 8th Street through the intersection of 6th Avenue when they saw Brugger and Bustos involved in a physical altercation. Burberry could not identify them by name due to her not knowing who they were but stated the male without the shirt drew a firearm and fired it off into the air while he and Bustos were physically engaged. Burberry described the suspect as a slender white male with short sandy hair.

Detective McKenzie made contact with Bustos who stated he was walking back from the Speedway gas station when he saw Brugger, whom he could not identify, but knew of him from working at the Speedway. Brugger allegedly swung on Bustos after a brief verbal altercation. Bustos engaged in a physical fight with Brugger and placed him in a head lock. Bustos saw Brugger brandish a firearm and fire one round into the air. Afterward the fight ended and the two began walking away. Bustos stated he was never in fear for his life and stated he did not wish to pursue criminal charges against Bustos if any were developed.

Detective McKenzie made contact with Brugger inside the Fountainhead Gardens Villas complex. Brugger was read his Miranda Rights and verbally stated he understood and agreed to be interviewed. Brugger stated he was attacked by Bustos and engaged in a fight, however; he never brandished a firearm and denied any involvement in possessing a firearm or firing a round off. Brugger further denied having knowledge that law enforcement was in pursuit of him, even though, SLC Deputy Alex confirmed that Brugger waved to him, while his emergency lights and sirens were activated, while pursuing him.

NARRATIVE

On Friday, November 21, 2025, at approximately 2151, Corporal Lang and I responded to
in reference to a disturbance. Deputy Cox was already on scene at
the door attempting to make contact. Deputy Cox advised that he heard a female making verbal threats inside
the house.

Upon arrival I made contact with Robert Dillon, who advised he received a call advising him to pick up his sister, Krislyn Dillon, from a bar in Fort Pierce due to her being intoxicated and causing a disturbance. Robert reported that he retrieved Krislyn, placed her in his truck, and began driving her back to his residence. During the drive, Krislyn made multiple attempts to jump out of the vehicle due to her level of intoxication. Robert stated he repeatedly had to restrain her and place her back inside the truck, during which she was combative.

Upon arriving home, Robert escorted Krislyn inside, where the physical altercation continued. Robert stated the two "wrestled for approximately three hours" as he attempted to restrain her. Robert initially stated that Krislyn bit him near his right wrist but then recanted, claiming the bite mark—and multiple bruises on his upper and lower arms and neck—were old injuries. Robert stated he did not wish to pursue criminal charges against his sister.

I observed numerous fresh bruises and marks on Robert's arms and neck consistent with a recent struggle.

I then made contact with Krislyn Dillon and advised her of her Constitutional Rights via an agency-issued Miranda card. She stated she understood her rights and agreed to speak with me.

Krislyn stated that Robert picked her up from the bar and brought her to his home. She claimed Robert was "trying to ruin her life." Krislyn admitted that a physical altercation occurred both outside and inside the residence. Krislyn stated numerous times that she lost her "shit", which caused her to act out. Krislyn also stated Robert grabbed her by both shoulders during the incident.

I observed fresh scratches on Krislyn's right and left forearms, which she attributed to her pet rabbit, and cuts and bruising on both knuckles.

Corporal Lang and I re-contacted Robert for further clarification. Robert continued to deny that any battery occurred, but he reported that Krislyn caused property damage inside the residence. Robert stated that he and Kristlyn are brother and sister and lived together as young children

Robert granted us consent to view the damage inside. We observed the hole in the wall and his broken phone.

Robert continued to deny the battery despite the visible fresh injuries. His denial appeared to be based on the realization that his sister was going to be arrested..

NARRATIVE

On Saturday, November 22, 2025, at approximately 1829 hours, I responded to the 1800 block of 8th Street, Vero Beach, Florida in reference to a Reckless driver who was driving off the roadway. Communications advised the vehicle had turned south onto 18th Court, then turned around and was Eastbound on 8th Street towards Old Dixie Highway. Communications advised the subject vehicle was a white in color Van bearing Florida tag#: Y269DR, per the complainant. The provided tag came back to the 1998 Toyota Sienna, which resides at 785 Old Dixie Highway, Vero Beach, Florida.

Deputy Rollando was able to locate the vehicle as it was traveling East on 8th Street, and observed the vehicle driving off of the roadway. Deputy Rollando conducted a U-turn, at which point he got behind the vehicle, and conducted a traffic stop at the 700 block Old Dixie Highway. The driver and Sole occupant pulled into the driveway of the aforementioned residence, and contact was made by Deputy Rollando and I.

The driver, Richard Graham, stated he had left his place of work this morning, The 19th Hole, a bar and restaurant located at, 1225 Barefoot Blvd, Barefoot Bay, Florida.

Deputy Rollando expressed his concerns that Richard was operating the motor vehicle while under the influence to me, at which point I made contact with Richard.

As I interacted with Richard, I observed several physical signs of impairment: Glossy-watery eyes, heavy slurred speech, repetitive statements, and stated he had been drinking.

Richard stated he had consumed approximately five tall beers and some cocktails with his friends in the span of approximately three hours. Richard stated he had left the 19th hole, at approximately 1700 hours, and believed the time of encounter was approximately 1730. It should be noted that Richard continued to state, "I bet my wife is getting a kick out of this as she is watching from the window."

I became concerned Richard was impaired beyond his normal faculties by alcoholic beverages or chemical or controlled substances.

To dispel my concerns, I asked Richard if he would participate in a series of standardized field sobriety exercises, to which he agreed after I had asked him numerous times as he was unable to understand what was being stated. I requested Richard exit the vehicle in order to complete the Field Sobriety Exercises, and as he was exiting his vehicle, I had to catch him to prevent him from falling face first.

As Richard exited the vehicle he stated, "sorry I'm extremely drunk" as he was barely able to walk, at which time I guided him to the front of my patrol vehicle. Richard continued to state how "drunk" he was and almost fell over numerous times.

I began to have Richard stand in the starting position to complete the Field Sobriety Exercises, at which point, Richard stated I can't do this I am too drunk. Richard began to again fall over as he placed his feet together heel-to-heel, and toe-to-toe, resulting in me again catching him from falling.

NARRATIVE

On 11/22/2025, the Affiant responded to 800 US Highway 1, which is a location within Indian River in Vero Beach, FL for an Exhibition of a Weapon. Prior to arrival, Dispatch advised that a male suspect wearing a blue shirt and blue jeans threatened staff with a knife and was sitting on the sidewalk in front of the location.

Upon arrival, the Affiant then located the suspect who matched the same physical description as the one detailed by Dispatch. The suspect had his pants around his ankles and male anatomical parts were exposed as he had just finished defecating next to the sidewalk. The suspect still had a knife in his hand and was told to drop it. The suspect was then detained.

The Affiant then spoke with the Victim who provided a sworn statement. The Victim stated that location (Speedway Gas Station) told the Defendant to leave the business. The Victim stated that the Defendant then pulled a knife and proceeded towards him while pointing the knife at him and then threatened to stab him. After the Victim backed away from the Defendant, the Victim stated that he then went into the store to avoid further conflict and contacted the Sheriff's Office.

An independent witness corroborated the Victim's statement.

The suspect was then mirandized and stated that while he was in the store he was told to leave or an employee was going to beat him up. He stated that he pulled a knife out for protection to defend himself because he was scared.

Based on the Victim's sworn statement, the fact that the Victim was in fear for his life, and the fact that the Defendant threatened physical harm with the present ability to harm, there is probable cause to believe the Defendant committed Aggravated Assault which is a violation of FSS 784.021.

On 11/22/2025, at approximately 2254 hours, Corporal McElvy and I were traveling North bound on Indian River Drive, approaching the intersection of Indian River Drive and Main Street, Sebastian FL. While doing so, I observed a grey, Toyota, sedan style vehicle turning West bound onto Main Street, clearly and completely not come to complete stop behind the stop bar of the stop sign located at this intersection. The vehicle only slowed down as it turned the corner and did not come to a complete stop.

I conducted a traffic stop on the vehicle. The vehicle did not stop along the shoulder of the road, and stopped in the lane of traffic. Once the vehicle came to a complete stop at 1225 Main Street (City Hall), I conducted a passenger side approach. Upon initial contact on the passenger side of the vehicle, both Corporal McElvy and I immediately detected a strong smell of an alcoholic beverage emanating from within the vehicle. The driver was identified as Joseph Pratas by Rhode Island DL.

I requested Joseph's registration and insurance for the vehicle multiple times. While Joseph attempted to do so he stated the following in summary: Joseph was just coming from Earl's Hideaway Lounge (a bar located at 1405, Indian River Drive, Sebastian FL). Joseph and his wife, which was located in the car with him, have both been drinking tonight.

It should be noted that when I would ask Joseph for his registration and insurance, I also asked other follow up questions. During these follow up questions, Joseph would not be searching for, or attempting to grab neither his registration or insurance. Joseph struggled to multi task and based on my training and experience, I recognized this behavior to be a sign impairment. During the course of our interaction, Joseph was irate and became frustrated very easily. Joseph's eyes were glassy and his speech was slurred at times throughout the interaction.

I requested Joseph to exit the vehicle. While he did so, I observed him display great difficulty getting out the vehicle and using the vehicle itself for balance. Joseph admitted to me that he "had a couple of beers" at Earl's. I explained to Joseph that his behavior created concern in me that he might be impaired. I offered Joseph the opportunity to perform field sobriety exercises to dispel my concerns, to which he declined. It should be noted that while speaking to Joseph, I detected a strong odor of an alcoholic beverage emanating from his breath as he spoke.

Based on the observations I made on scene, I was able to determine that Joseph's normal faculties were impaired. Joseph was placed into mechanical restraints which were double locked and check for proper fit and transported to Indian River County Jail. While at the Jail, Joseph refused submit to a lawful sample of his breath to determine alcohol content.

Based on the totality of the circumstances, I determined that there is sufficient probable cause to charge Joseph with the following crimes:

On November 23rd, 2025, at approximately 0204 hours, 1, Ofc. 2 Dominguez, responded to the area of Dom's bar (1436 Old Dixie Hwy) to assist Ofc. Covarrubbias with a traffic stop he had conducted in the parking lot. According to Ofc. Covarrubbias, he had a black male subject fleeing from his traffic stop on foot and gave chase. Ofc. Covarrubbias described the male as a black male last seen wearing a blue shirt, blue pants, black shoes, with dreadlocks, approximately 6 feet tall. After a short foot pursuit, Ofc. Covarrubbias advised the black male subject ran into a heavily wooded area southeast of where he conducted his traffic stop. Upon my arrival, a perimeter was established around the wooded area and at approximately 0255 hours after an extensive search, the black male subject was located and placed under arrest.

On scene, I spoke with Ofc. Covarrubbias who informed me of the reason for the stop. He observed the vehicle heading south from Filthy's bar in the northbound lanes. Upon observing this, he made a U-turn at 16th St. & Old Dixie Hwy, got behind the vehicle, and attempted a traffic stop on the vehicle as it pulled into a parking spot at Dom's bar (1436 Old Dixie Hwy). Once parked, the defendant, Blaise Fenelon, exited his vehicle and walked away from Ofc. Covarrubbias while he was attempting to conduct his traffic stop. Ofc. Covarrubbias told Fenelon to "Stop" and that "He was conducting a traffic stop." Fenelon ignored Ofc. Covarrubbias's commands and fled on foot behind Dom's Bar thus initiating a foot pursuit. During the foot pursuit, Ofc. Covarrubbias observed Fenelon run southbound, where he advised the subject had ran into a wooded area. I then arrived on scene, and assisted with establishing a perimeter. After approximately 1 hour, the subject was located in the wooded area and appeared to have climbed up a tree. The subject was given several verbal commands to climb down, while climbing down the subject appeared to get stuck and was assisted down the tree. Once on the ground, the subject was placed under arrest, escorted out of the wooded area, and placed in a marked patrol vehicle. Ofc. Covarrubbias read Fenelon his Miranda Rights, he acknowledged, and said "Yes, I understand my rights."

Once in the marked patrol vehicle, the subject was transported back to the scene of the traffic stop, where Ofc. Covarrubbias conducted a post-miranda interview. When asked if he saw Ofc. Covarrubbias get behind him and turn his emergency lights on, Fenelon advised he did not see them. Fenelon also claimed he was coming from Filthy's bar and had a few drinks prior to the interaction. Ofc. Covarrubbias asked why Fenelon ran away to which he responded, "I didn't want to go to jail." Fenelon also admitted to driving on a suspended license during this interview. A records check through Vero Beach Police Dispatch showed Fenelon with a suspended license on 03/04/2024 due to a non-judgement suspension. After the interview, the subject's vehicle (white 2020 Hyundai 4D Bearing FL temp. tag #DWY9559) was secured in the parking lot of Dom's bar.

It should be noted, I observed in plain-sight, an open 24 oz. can of Corona Extra in the center console next to the driver seat that was still cool to the touch and approximately 2/3 full. Due to having an open alcoholic beverage in the vehicle, the subject was issued a non-criminal traffic citation for open container in violation of F.S.S. 316.1936(2a). (Citation #ALZPJ7E)

Subject was arrested for resisting without violence (F.S.S. 843.02) and Driving With License Suspended with Knowledge (F.S.S. 322.34(2)) (Citation #ALZPJ6E) and transported to the Indian River County Jail for booking and to be held on a \$1000 bond.

NARRATIVE

On Sunday, November 23, 2025 at approximately 2323 hours, I was conducting stationary traffic enforcement in the area of Roseland Road and Airport Drive West in Sebastian, Florida.

I observed a single vehicle approach from the East at a high rate of speed, I visually estimated the vehicles speed to be 72 miles per hour and captured the vehicles speed on my forward mounted radar. I locked the vehicles top speed at 75 miles per hour in a posted 45 mile per hour zone. The vehicle was a white 2016 Hyundai Sonata bearing Florida tag "FDZB31."

I initiated a traffic enforcement stop and made contact with the driver and sole occupant of the vehicle, who was later identified through D.A.V.I.D. as Mr. Jeremy Collins (Arrestee). I asked Mr. Collins for his Driver's license and he stated he didn't have it. When I clarified and asked if he had a license he stated no, and stated he only had an ID Card.

A query of D.A.V.I.D. revealed Mr. Collins is a Habitual Traffic Offender (UTC: ADKN8ZE eff. 08/02/2023).

Mr. Collins has six (6) prior convictions for Driving while license suspended: 5955EZO (2007), A8NZJ5E (2021), A8NZL6E (2021), ADKN8ZE (2023), AH3DEVE (2023), and AIBZ79E (2024). Mr. Collins also has nine (9) active suspension cases.

Mr. Collins was placed under arrest and transported to the Indian River County Jail Complex without further incident. Due to Mr. Collins status as a Habitual Traffic Offender, Mr. Collins' is being held on a NO BOND status.

Mr. Collins was issued the following citations: Knowingly DWLSR (Habitual Traffic Offender) (AM2NJOE) and County - Speeding 30 or more (AM2NJPE).
