On 10/24/25 at approximately 1927 hours, 1, Officer W. Brumley, conducted a traffic stop in the 1800 block of 9th Ave, on a grey 4 door sedan (FL tag# CH72EE), in reference to the passenger side headlight being out.

Upon approach of the driver's side of the vehicle, I explained to the driver and sole occupant of the vehicle, later identified as Alec Reece (defendant), the reason for the stop. The defendant stated he did not have a driver's license or an ID card on him. The defendant then provided me with the name of Chris Stokes. After VBPD communication advised they were unable to find anything on the name and date of birth provided, out of Florida or New York, the defendant was detained at 1936 hours. Once the defendant was detained and placed in my patrol vehicle the defendant provided me with his real name and date of birth (Alec Reece DOB:05/24/1997) and stated he provide me with a false name. After a records check on the defendants real name and date of birth, VBPD advised me the defendant did not have a valid driver license.

While on scene The defendants girlfriend, identified as Ketiyah Pollock (who is the registered owner of the vehicle) responded to take possession of the vehicle. While I was turning the vehicle over to the registered owner, Officer Covarrubias advised the defendant if he had anything illegal on him when we get to the jail he would receive an extra charge. The defendant then stated he had some "weed" tucked in his pants, in the crotch area. Officer Covarrubias handed me a small clear baggie containing a green leafy substance, which through my training and experience I identified to be marijuana.

The defendant was placed under arrest for violation of FSS. 322.03(1) No DL, FSS 901.36(1) False Name to LEO, and FSS 893.13(6B) Possession of Marijuana Less Than 20 Grams. The defendant was transported to the Indian River County Jail without incident to be held on a \$1500 bond.

NARRATIVE

On Friday, October 24, 2025, at approximately 1916 hours, I, Deputy M. Neill #6317 conducted a traffic stop near 3rd Court SW and 7th Lane SW, Vero Beach, Indian River County, Florida.

Upon the vehicle passing my patrol car, I received a LPR (License Plate Reader) hit in reference to the registered owner of Florida tag RRRM49 not having a valid license. This tag was attached to a gray Toyota Corolla. Upon running the tag in FCIC/NCIC, the registered owner did have a valid license, but the tag was assigned to a 1996 White Ford pickup.

I conducted a traffic stop on the vehicle for the tag not matching the vehicle attached to it. The driver and sole occupant was identified as Mr. Michael Goddard. Mr. Goddard provided his Florida Drivers license as well as a large bag of raw marijuana, which was on his front passenger seat.

Mr. Goddard was removed from the vehicle. Upon conducting a search of his person, another bag of raw marijuana was removed from his right pants pocket.

The first bag of marijuana weighed 28 grams. The second bag weighed 14 grams. The first bag of raw marijuana field tested presumptive positive as marijuana. The total weight of raw marijuana is 42 grams.

I advised Mr. Goddard of his Miranda Rights. He advised he understood his rights and was willing to speak to me. He advised the marijuana was his and he had just purchased the marijuana. He went and purchased one ounce (one ounce is 28 grams) of marijuana today and was coming home. The other 14 grams is what he previously had in his possession. The vehicle was recently purchased from his son. Mr. Goddard advised he placed the tag on this vehicle as his wife was supposed to register the vehicle today. We were able to call his wife and confirm that this was not done today.

I ran the VIN attached to the vehicle in DAVID and confirmed the vehicle was unregistered.

Based on the above information, I believe there is probable cause to arrest Mr. Goddard for the offense of Possession of Marijuana Greater than 20 Grams, pursuant to FSS 893.13.6a.

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 10/24/2025 23:14 On (Specifically include facts constituting cause for arrest.)

On 10/24/2025 at 2314 hours, I conducted a traffic stop in the 1500 block of US Hwy 1, on a blue chevy sedan bearing Fl tag #36DESY for inoperable taillights.

Upon my approach, I made contact with the driver who was identified as Jason Rice and the front seat passenger who was identified as Carla Smith (defendant). While speaking with Rice, he immediately advised me that he does not have a valid drivers license. As a result, Rice was removed from the vehicle and detained.

While speaking with Rice, I observed Smith making several overt movements inside the vehicle and in her purse that she was holding. Due to this, I asked her to place her hands on the dashboard in front of her for my safety.

I then asked Smith if she had anything illegal on her because I could tell that she was uncomfortable and nervous. Smith made several statements but subsequently stated to me that she has "Ice" in her breast area and her vaginal area.

A female deputy responded to assist in the search. Dep. Moon conducted a probable cause search and located a plastic bag with a white crystal substance in her breast area as well as a zip bag in her front lower extremities containing several different narcotics.

The narcotics located on her person are as follows:

- 5 individual bags of fentanyl (4.0 grams)
- 11.3 grams of crystal meth
- 4.0 grams of crack cocaine
- 4 xanax bars

PROBABLE CAUSE STATEMENT

- 2 diazapam pills

All narcotics above were field tested and had positive reactions to the listed identifiers.

While continuing to converse with Smith, she further stated to me that there was a gun in her purse that she was holding. A search of her purse revealed a tan/black Glock 19 handgun (#BHCF085). A records check revealed the firearm was stolen out of Lee County, Missouri.

A records check of Smith revealed she was a convicted felon in Florida.

I advised Smith of her Miranda Rights to which she stated she understood and agreed to speak with me. Smith advised that the gun was just given to her prior to the traffic stop but would not provide further information. Smith was cooperative throughout the investigation and took ownership of all narcotics located on her person.

Smith received citations for the narcotics.

The narcotics and the firearm were placed into evidence at VBPD.

Smith was subsequently placed under arrest for F.S.S. 893.135(1C4A) trafficking in Fentanyl, F.S.S. 893.13(6)(A) possession of Methamphetamine, F.S.S. 893.13(6)(A) possession of Cocaine, F.S.S. 893.13(6)(A) possession of Xanax, F.S.S. 893.13(6)(A) possession of Diazapam, F.S.S. 790.23(1A) possession of a firearm by convicted felon.

Ms. Boone then went inside the residence, started drinking and fell asleep. At approximately 2200 hours, Ms. Boone was awoken by Ms. Jorden demanding Ms. Boone give her a ride home. Ms. Boone once again told Ms. Jorden to gather her belongings from her car and leave the property. Moments later Ms. Boone noticed Ms. Jorden still in her vehicle. Ms. Boone went out to the vehicle as Ms. Jorden was still in the backseat of the vehicle, to tell Ms. Jorden, once again, to leave. Ms. Jorden then became aggravated and struck Ms. Boone on her nose.

Ms. Boone advised she then left Ms. Jorden and her vehicle to go inside and call Law Enforcement.

I then made contact with Ms. Jorden, who was actively sitting in the back seat of Ms. Boone's white 2017 Mitsubishi SUV. Ms. Jorden appeared to be intoxicated and upset. Ms. Jorden advised she was aware she was supposed to be out of the vehicle but advised she needed to pack up her things. Ms. Jorden was aware of the fact Ms. Boone had requester to leave the vehicle several hours prior to Deputies arrival. Ms. Jorden stated she needed to get a ride but could not find one nor could she order a taxi as she did not have money for a taxi.

When asked why it was taking so long for her to get out of the vehicle with her belongings, Ms. Jorden stated she had a lot of belongings. I observed a small black backpack and a car seat accompany Ms. Jorden once she finally removed herself and her belongings from the vehicle. When asked why she continued to remain in the vehicle and go in and out of the vehicle, Ms. Jorden advised she needed a ride and that her two-year-old son was in the vehicle. Ms. Jorden also expressed how she did not want to go into Ms. Boones residence as there are bed bugs in her house and her and Ms. Boone were arguing.

I inquired with Ms. Jorden if anything physical had occurred between Ms. Boone and herself but Ms. Jorden only described the verbal argument between them and insisted nothing of physical nature occurred.

Ms. Jorden did explain how Ms. Boone came out to the vehicle, while she was in the vehicle and that was when the verbal argument ensued. Ms. Boone did not have any physical evidence, such as redness, marks or bruising that led me to believe she was struck on her nose. Although a battery may have occurred between Ms. Boone and Ms. Jorden, due to conflicting statement, lack of physical evidence and lack of independent witnesses, I was unable to develop probable cause for an arrest for Battery Domestic Violence.

I however, was able to develop probable cause for the offence of Auto Burglary with Ms. Jorden being the suspect due to Ms. Jorden entering or remaining in Ms. Boone's white 2017 Mitsubishi SUV bearing Florida tag number RRAB02, after

Upon my arrival I made contact with Mr. Andres Rosa, who is the owner of the above residence. He provided the following sworn statement: Just prior to his neighbor, Mr. David Bailey, came over and started a disturbance. This disturbance was over a supposedly faulty firing pin for a rifle. Mr. Bailey banged on the front door of the residence very loudly. After Mr. Rosa answered the door, Mr. Bailey threw the firing pin at Mr. Rosa. He then in turn threw it back to Mr. Bailey after catching it. Mr. Bailey then barged in to the residence, uninvited, entering the doorframe of the residence. Mr. Bailey got in to Mr. Rosa's face, and was yelling and screaming. Mr. Rosa pushed Mr. Bailey out of his residence. Mr. Bailey then walked back in to his residence and got in to his face, now touching face to face with Mr. Rosa. Mr. Rosa called over his service dog, which caused Mr. Bailey to retreat out of his residence. Mr. Bailey picked up the firing pin and threw it in the rocks as he was walking away.

Mr. Rosa did not have any marks or injuries.

Mr. Rosa advised that Mr. Bailey threw the firing pin in the rock bed approximately twenty feet away from his front door. Deputies were able to locate the firing pin in the rock bed.

I also spoke with Mr. Richard Arreola, who was visiting Mr. Rosa at the time of this event. He advised the following during a sworn recorded statement: Mr. Arreola was in the residence when he heard loud banging on the door. Mr. Rosa answered the door which led to Mr. Bailey being confrontational. Mr. Bailey entered the residence and got in to Mr. Rosa's face. Due to his position, he did not see if any contact was made but did advise it appeared as if he was trying to ram or speak Mr. Rosa with Mr. Bailey's head. Mr. Arreola had pulled his firearm out due to the unlawful entry in attempts to defend himself and Mr. Rosa if needed. Mr. Bailey had left prior to needing to use the firearm.

I then made contact with Mr. David Bailey, who resides at 1545 16th Court SW. Mr. Bailey answered the door and began speaking with law enforcement. He denied any physical confrontations occurring at Mr. Rosa's residence. He advised he went over there to confront him about him selling a faulty firing pin. He handed Mr. Rosa the firing pin. Mr. Rosa then threw the firing pin at him, but did not strike him with it. The firing pin then landed in the rocks approximately 20 feet away. Mr. Bailey then left.

Neither Mr. Bailey or Mr. Rosa have working video surveillance systems which captured the incident. I canvased the area and no other subjects witnessed the event or captured it on their video surveillance.

Based on the statements and area where the firing pin was recovered, it appears that Mr. Rosa's and Mr. Arreola's statements appear consistent. For this reason, I believe there is probable cause to arrest Mr. David Bailey for the offense of Burglary with a Battery, pursuant to FSS 812.02.2A.

Mr. Bailey was transported to the Indian River County Jail without incident.

On October 26th, 2025, at approximately 2021 hours I was conducting stationary traffic enforcement at the 1200 block of Sebastian Boulevard, Sebastian, Florida, when I observed a black Chevrolet corvette bearing Florida registration RSMD31, traveling eastbound passing my vehicle. I was able to observe the windshield of the vehicle which appeared to be illegally tinted and lower than the AS/1 line. I got behind the vehicle and activated my overhead emergency lights to conduct a traffic stop. While behind the vehicle, it activated the passenger side blinker to indicate the vehicle was going to yield. The vehicle continued to travel south bound in the 900 block of Barber Street, Sebastian, Florida and was not yielding. I activated my siren multiple times with different tones in attempts to get the vehicle to stop. The vehicle then turned into the parking lot of Barber Street Sports Complex, 1115 Barber Street, Sebastian, Florida and continued to slow roll through the parking lot before coming to a complete and final stop.

I made contact with the driver and sole occupant of the vehicle, William Bepler, I explained the reason for the stop and pointed at the AS/1 line marking indicated on the passenger side of the front windshield which was approximately inch past the AS/1 line violating F.S.S 316.2952(2)(b). Bepler immediately utilized his cell phone and called his Aunt. Bepler appeared to be nervous, Bepler's speech was rapid and rushed, Bepler's eyes were also darting around the vehicle while I was speaking to him. Bepler provided his driver license, I then went back to my vehicle to conduct a driver license query and complete my electronic warning for the windshield tint violation.

Sergeant Melius and Corporal Revis arrived on scene. Sergeant Melius requested Bepler to get out of the vehicle due to his elevated demeanor and for Corporal Revis to utilize his K9 parter Reno to conduct a drug sniff of the vehicle.

Bepler then got upset and began yelling and clenching his fists at Sergeant Melius while outside the vehicle, placing Sergeant Melius in fear of being struck, Bepler was then placed into mechanical hand restraints behind his back for officer safety.

Corporal Revis stated there was a positive alert on Bepler's vehicle for the presence of narcotics.

Sergeant Melius located a \$5 US Dollar bill located under the driver seat containing approximately 1 gram of suspect crack cocaine.

I stood by with Bepler who stated he wished to talk to me specifically in regards to his vehicle. Bepler stated he wanted to "work this off." I asked Bepler to explain what he meant or what would we locate in the car, which he denied anything illegal being in his car. Based on my training and experience, Bepler was indicating he was in possession of narcotics due to him stating he wanted to be given leniency and assist law enforcement in purchasing larger quantities of illegal substances due to his prior knowledge and associates.

Bepler was placed under arrest and transported to the Indian River County Jail for processing.

While at Indian River County Jail, I utilized a cobalt cocaine dropper test kit on the suspect crack cocaine, which yielded to positive results for cocaine.

Bepler was issued UTC AMAHDIE F.S.S 893.13(6)(A) POSSESSION OF CONTROLLED SUBSTANCE WHILE IN PHYSICAL CONTROL OF MOTOR VEHICLE.

Bepler was issued a written warning for F.S.S 316.2952(2)(b) windshield tint violation.



On October 27, 2025, at approximately 0005 hours, I was dispatched to reference to a physical disturbance. Prior to my arrival, Dispatch advised me that the parties were separated and the complainant was waiting outside the residence.

Upon my arrival, I observed a white male in the driveway. Due to previous incidents at the residence, I knew him to be William D'Amaro. William stated that his now ex-wife, Ashley Hagan (Whom I also knew from previous incidents), came home from being out with her new boyfriend. William stated that when Ashley entered the residence, she was intoxicated. William stated Ashley then placed her phone on the table in the living room, where he had placed dinner for him and their son. William stated he observed Ashley received a text message. William stated he picked up her phone to read the text. William stated Ashley became upset and attacked him. William stated that Ashley began to scratch him with her fingernails and strike him. William stated he then went into the bathroom and locked the door. William stated he could hear Ashley throwing things in the living room. William stated Ashley then began to attempt to unlock and open the bathroom door with a butter knife. William stated that when he exited the bathroom, he observed Ashley with the butter knife and tried to get away from her. William stated as he tried to get away, Ashley began to hold the knife above her head and bring it down in a striking motion. William stated Ashley then began to strike him with the butter knife in his back using the same downward motion.

William stated this continued until he returned Ashley's cell phone. William stated that upon his returning Ashley's phone, she went to her bedroom. William stated he observed the items in the living room, he heard being thrown was his and his son's dinner. I observed several bright scratches on William's chest and arms. I observed a bleeding laceration on William's right wrist. I also observed several scratches on Williams' back.

It should be noted that Ashley and William are divorced but

have two children in common.

I then entered the residence. Upon entering, I observed Ashley exiting her bedroom, which was located at the right rear of the residence. Upon addressing Ashley, I observed her son exit his bedroom,

Ashley's son requested to speak to me in his bedroom. Due to this, Sergeant Melius spoke to Ashley in the kitchen.

I knew Ashley's and William's son from previous incidents. Due to his being a juvenile, he will be referred to by his initials. CAD stated he was in the living room with William when Ashley returned home. CAD stated William and Ashley went to Ashley's bedroom to talk. CAD stated he observed William pick up Ashley's phone. CAD stated Ashley then began to attack William. CAD stated William, then went to the bathroom and locked himself inside. CAD stated he observed Ashley then throw their dinners in the living room. CAD stated that he then went to his bedroom.

I then walked through the living room. I observed food scattered from one side to the other, appearing as if one plate of food was being thrown one way and another plate thrown the other way. There was also a large area around the table in front of the couch where no food was located. As I walked into the kitchen, I observed a silver butter knife by itself on the counter. I observed that the butter knife was clean, indicating it was not used when William and CAD were eating their dinner.

I then stood by while Sergeant Melius spoke with Ashley. Ashley repeatedly told Sergeant Melius that William was stalking her and her new boyfriend. Sergeant Melius asked Ashley what had occurred tonight. Ashley told Sergeant Melius that nothing had occurred tonight. Sergeant Melius asked Ashley again what had happened, and Ashley stated again that nothing had happened, but William was stalking her. Sergeant Melius asked Ashley where she had gone tonight. Ashley stated she went to Publix. Sergeant Melius asked Ashley how long ago she had left for Publix. Ashley stated that it was one hour prior to our arrival. When advised that all Publix's in Sebastian close at 2200 hours and she would have arrived at 2300 hours, Ashley could not answer.

Sergeant Melius then asked Ashley about the food all over the living room. Ashley stated William was upset at her because she did not return home on time. Ashley stated William had in one motion pushed all the food off the table. Sergeant Melius advised Ashley that William could not have done it in one motion with how the food was scattered, but Ashley insisted that was what happened. Sergeant Melius asked Ashley what had happened next. Ashley stated nothing; she just went to her bedroom.

Sergeant Melius then turned the interview over to me. I read Ashley her Miranda Warning. Ashley stated she understood and wanted to continue speaking with me. Ashley again told me nothing happened, and William threw the food on the floor. When asked if she or William had struck each other, Ashley stated no. When asked if anything had happened with her phone, she stated, "Yes, William had taken it." When asked what happened after he took her phone, Ashley again stated nothing.

At this time, due to Ashley's story not matching the scene nor the injuries to William, I placed Ashley under arrest. Ashley was placed into mechanical hand restraints, which were checked for proper fit and ensured to be double locked.
