NARRATIVE

On April 7, 2026, at approximately 0100 hours, I responded to the area of 7-11 (1201 12th Street, Vero Beach, Florida), in reference to a crash leaving the scene.

Upon arrival I began to patrol the area of 20<sup>th</sup> Avenue and 12<sup>th</sup> Street. Dispatch advised, the suspect vehicle was a tan-in-color Ford pickup truck, which drove west on 12th Street, after crashing into the business.

The clerk described the occupants of the pickup to be two Hispanic males. The driver had a neck tattoo and was heavy set. The passenger to also be heavyset and wearing glasses. The clerk watched the driver drove forward and over the parking space barrier that is mounted to the concrete. The Ford pickup then continued moving forward up onto the sidewalk until it collided with the front brick exterior wall of 7-Eleven. The Ford pickup missed the driveway exit and instead collided with two vertical traffic poles that were shielding a tall metallic light pole. The Ford pickup drove through the two vertical traffic poles, ripping the light pole from the ground.

Vero Beach Police K9 Officer Doty stated he was possibly behind the tan Ford, at 20th Avenue and 20th Street. Sergeant Thimmer then conducted a traffic enforcement stop in the 5200 block of 20<sup>th</sup> street on the above-mentioned vehicle bearing Florida Tag "19FTBP".

I arrived a short time later. While on scene, I confirmed the driver and passengers description that the clerk provided, and Sergeant Thimmer advised me of the following:

The Ford truck started swerving across the solid white line and almost hit a curb. He then conducted a traffic enforcement stop on the vehicle.

Sergeant Thimmer approached on the driver's side, where he made contact with two Hispanic males. The driver appeared highly intoxicated, having glassy eyes, slurred speech and a strong odor of alcohol was emitting from inside the vehicle. Sergeant Thimmer noticed the front bumper damaged and questioned the driver about the bumper, at which time, he stated his bumper was fine. Sergeant Thimmer asked the driver for his driver's license. The driver pulled out two cellphones first, but later retrieved his wallet and attempted to hand over his whole wallet. Sergeant Thimmer requested the driver to pull out his driver's license from his wallet and to turn the truck off. Sergeant Thimmer turned over the investigation to me at this time.

I then made contact with the driver Mr. Angel Miranda-Casco (arrestee), who I identified by his Florida Driver's License, while speaking with Angel, I could smell the distinct odor of an alcoholic beverage

emitting from his breath, his eyes were watery and bloodshot, and his speech was slurred. Angel was asked to step out of the vehicle, he stumbled slightly as he walked towards Sergeant Thimmer's patrol vehicle. Angel stated numerous times "he was about two blocks away from his house".

Due to my observations, I requested Angel to submit to Standardized Field Sobriety Exercises (SFSE's) to which he agreed. Angel was questioned about his medical history and provided he was a type "A" Diabetic and wore contacts, but he was not currently wearing contacts. None of the provided responses would affect his ability to properly complete SFSE's.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the instructions to Angel which he stated he understood. Angel's pupils were of approximately equal size and tracked simultaneously. I did not observe resting nystagmus. During this exercise, I observed the following clues of impairment: Lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of Nystagmus prior to 45 degrees at approximately 30 degrees. Angel had to be reminded several times not to move his head. I observed Vertical Gaze Nystagmus in both eyes.

The second exercise I administered was the Walk and Turn (WAT) exercise. Angel was directed into the starting position and I explained and demonstrated the exercise to Angel; who stated he understood the instructions and did not have any questions regarding the exercise. During the instructional phase, I observed the following validated clues of impairment: Angel failed to maintain the starting position, and started before being told to do so. During the walking phase, I observed the following validated clues of impairment; Missed heel to toe, Incorrect number of steps (6 / 5), and Improper turn, stopped while walking, stepped off the line, used his arms to balance. Angel DID NOT complete this exercise to standard.

The third exercise I administered was the One Leg Stand (OLS) exercise. I explained and demonstrated the exercise to Angel; who stated he understood the instructions and did not have any questions regarding the exercise. Angel began the exercise by raising his right foot off of the ground. During this exercise, I observed the following validated clues of impairment; Put foot down, and Sway, Arms for balance. Angel placed his foot on the ground after approximately 2 seconds, he then attempted to pick up his left foot and continued to count from 3-7 seconds and placed his left foot down and picked his right foot back up and continued his count. Angel DID NOT complete this exercise to standard.

Deputy Coon arrived on scene to Speak with Mr. Angel regarding the crash. Mr. Angel was read his Miranda-Rights: Angel told Deputy Coon he consumed two Bud-Lights at Dom's Bar. He then drove his

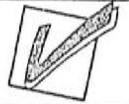

NARRATIVE

On Tuesday, April 7, 2026, at approximately 2011 hours, I responded to [REDACTED] in reference to a threat of suicide. The caller, Vanessa Salazar stated her brother whom she refers to as her sister was intoxicated on narcotics, was acting crazy, and had a knife.

I arrived at the aforementioned location, and made contact with Vanessa. Vanessa stated her brother, Jaime Salazar, had been making suicidal statements that he was going to kill himself, and had repeatedly grabbed a knife before locking himself in the bedroom.

Jaime was located on the living room couch, and was unarmed at the time of contact. When asked, Jaime stated nothing had occurred and he was "just chilling" when his mother, Elena Salazar asked him to give her the knife. Jaime denied making any suicidal or homicidal statements.

I proceeded to speak with Vanessa, Elena, and their step-father, Oscar Vite-Nava, to obtain further information. While I spoke with Oscar, he stated Jaime was acting crazy and grabbed a knife from the kitchen. Oscar stated after Jaime grabbed the knife, he put the knife against Oscar's back and stated he was going to kill him and Vanessa. Oscar stated Elena was able to get the knife away from Jaime, and they were scared he was going to kill them.

I then met with Elena who spoke little English, and Vanessa assisted me in translation. Elena stated Vanessa had left the residence to go to the store, and Jaime had grabbed the knife from the kitchen, and was concealing it behind her back. Elena stated Jamie then held it out stating, "are you looking for this." Elena then stated Jaime put the knife against Oscar's back while he was in the kitchen washing dishes, at which point she ran and grabbed the knife from her. Elena stated she did not hear Jaime say anything to Oscar, but stated she was laughing while holding the knife.

It should be noted that there were no visible marks on Oscar's back where the knife had been; however, he stated he was in fear for his and his family's safety as Jaime was crazy.

The family was overall in fear of their safety stating Jaime had been previously arrested for domestic violence, and has a history of being baker acted.

It should also be noted that Elena and Oscar have been married for approximately 10 years, [REDACTED] Oscar is Jaime and Vanessa's Step-Father. The knife was a red and black filet style knife with four diamonds on the handle.

Due to the aforementioned testimonies, I placed Jaime into custody and placed him into my agency issued patrol vehicle. I advised Jaime of his Miranda Rights to which he stated he understood. Jaime again denied all allegations stating Elena asked him for the knife at which point he handed it to her.

NARRATIVE

On Wednesday, April 8, 2026, at approximately 0100 hours, I responded to [REDACTED] in reference to a disturbance. The caller, Christopher O'Brien, stated his mother's fiancé was in a physical altercation with his mother, April O'Brien.

I arrived at the aforementioned location, at which point I made contact with April. April appeared intoxicated, had slurred speech, and glassy-watery eyes. April stated her and her fiancé, Eric Alexander, had been drinking and arguing all afternoon. April stated Eric had broken her wine bottle while trying to take it from her to prevent her from drinking more, at which point she struck him causing Eric to hit her back.

I went to speak with Christopher who stated he had heard April and Eric arguing, at which point he left his room and witnessed Eric strike April prompting him to call law enforcement. While speaking with Christopher, Deputy Hitchcock informed me that he had spoke with Eric who stated they had been drinking and arguing over finances. Eric further stated he was trying to take the wine away from April resulting in the physical altercation. Eric also stated to Deputy Hitchcock that the large welt under his eye was from a door; however, Deputy Hitchcock stated Eric did not want April to get into trouble.

I returned to speak with April, and advised her of her Miranda Rights to which she stated she understood. I asked April how Eric got the large knot on his eye to which she stated, "because I hit him, he broke the wine bottle so I hit him then he hit me." April also stated numerous times that she was a Hell's Angels Legacy (Motorcycle Club) and that if she wanted Eric to bleed, he would bleed. April again stated that they were arguing over finances while drinking. April stated she had been drinking since 1430 hours on April 07, 2026, and when Eric took the wine bottle from her it broke. April stated after the wine broke, she struck Eric in the face resulting in Eric and April shoving each other.

It should be noted that Eric had a large knot on his right eye where he was struck by April. It should also be noted that Eric and April have been in an intimate relationship for 10 years [REDACTED]
