On _____, at _____ (Specifically include facts constituting cause for arrest.)

On April 15, 2024, at approximately 2236 hours, I responded to _____ in reference to a report of a disturbance. Upon my arrival, I made contact with Sergeant Mills who advised after interviewing both the victim, Dawn Ford, and the defendant, Allea Freeman, that it was determined that Allea threw water on Dawn.

I asked Allea what occurred prior to officers' arrival, and she stated she was engaged in a verbal argument with her mother, Dawn, over Dawn not allowing Allea to use her cell phone. Allea stated she became upset and threw water at her mother who was sitting on the couch, and not on her mother, and she stated she had no malicious intent.

I stepped into the residence located at the listed location, and observed a gray mop bucket in the hall way and a large dark wet spot on the couch. I spoke to Officer McElvy who was speaking with Dawn, and Officer McElvy advised me that Dawn's shorts were soaked with water.

I interviewed Dawn, who stated that her daughter, Allea, requested to use her cell phone due to Allea's phone being broken or lost. Dawn denied Allea access to her cell phone, at which time Allea became irate. Dawn stated that Allea retrieved a large gray bucket full of dirty mop water from the hallway, and threw it all over her, causing her clothes and couch to be soaked.

Dawn stated that in the past _____ Dawn appeared to be upset by Allea's actions and stated she was concerned that the next step would be Allea trying to physically take Dawn's phone away, and Dawn stated she contacted law enforcement to report the incident.

I assisted Dawn in completing a domestic violence packet, and provided her with victim's brochures. Dawn also completed a written statement.

Due to the aforementioned facts and statements, Allea was placed under arrest for battery and transported to the Indian River County Jail for processing.

On 04/15/24 I, Ofcr. S. Gonzalez (471), was stationary in the vacant lot at the corner of 32nd street and U.S.-1 facing west conducting stationary radar on north and southbound traffic on U.S.-1 when I observed a silver 4-door vehicle go past my location traveling northbound on U.S.-1 in the curb lane.

I visually estimated the vehicle's speed to be approximately 60 mph. I activate my hand-held laser speed measuring device, obtained a steady audible tone and digital reading of 59 mph, 14 mph over the posted 45 mph speed limit.

Maintaining a visual of the vehicle, I pulled out onto northbound U.S.-1 and proceeded to close on the vehicle and caught up to the vehicle just north of 37th Street.

As we approached 41st Street, I initiated a traffic stop by activating the emergency lights on my fully marked police vehicle. The vehicle, which I now observed to be a silver Toyota 4-door continued north on 41st Street before turning right onto eastbound 41st Street.

Initially it appeared as though the vehicle was not going to stop as it had turned at speed and did not appear as though it would stop. I then activated the siren on my vehicle after which the vehicle came to a full and complete stop approximately 50 60 yards east of U.S.-1.

I exited my police vehicle and initially approached the vehicle on the driver side as I illuminate the interior of the vehicle with my flashlight which allowed me to see that the sole occupant and driver of the vehicle was a black male I later identified as Devin Deshawn Hillsman ("Defendant").

As I approached the trunk, the Defednant's head go down and right shoulder dip giving me cause for concern that Defendant was reaching under his seat possibly for a weapon. As a result, I changed my approach and instead approached on the passenger side of the vehicle whereupon arriving at the passenger door I made contact with the Defendant. I looked at the Defendant's hands and saw that he was not holding a weapon. I also noted a very strong an pungent odor of what I recognized to be that of

marijuana emanating from within the vehicle.

I then asked the Defendant for his driver's license and vehicle registration as I scanned the immediate area of front compartment of the vehicle and while doing so, I observed a clear plastic baggie containing green clumped substance which, based on my training and experience I recognized and determined to be marijuana however, I did not lead on to the fact that I had seen it and continued speaking with the Defendant.

The Defendant informed me that he did not have his license. When I asked the Defendant to clarify if he didn't have it with him or did not have one, the Defendant affirmed that he did not have it with him. Then, when I asked the Defendant for the vehicle registration, the Defendant informed me that the vehicle was a rental.

Based on the totality of my observations as well as safety concerns, I asked the Defendant to exit the vehicle in order to obtain his name, date of birth and other information to radio in to dispatch for a license, wants & warrants check.

The Defendant exited the vehicle and walked to the rear of the vehicle where he provided me with his information; during this time Corporal O. Dominguez (498) arrived on scene.

I then radioed in the information provided by the Defendant and was informed that the Defendant had no Florida license.

As I spoke to the Defendant, I inquired about the rental agreement for the vehicle and asked the Defendant for consent to look for the rental agreement which the Defendant gave me.

I left the Defendant with Corporal Dominguez while I returned to the vehicle whereupon opening the glove compartment discovered two (2) more plastic bags with more marijuana as well as a box of plastic sandwich bags.

I then returned to the Defendant and took him into custody, placing him under arrest and informing him accordingly and then placed him in the back of my patrol vehicle after being pat down during which I found \$432 in cash in various denominations from \$20 to \$1.

K-9 Officer C. Hatfield (416) arrived on scene subsequent to the Defendant being taking into custody and assisted me with a search of the vehicle.

While searching the vehicle K-9 Officer Hatfield located an undetermined quantity of loose marijuana in the center console glove box and a torn baggie. Also in the center console glove box was the Defendant's birth certificate. A digital scale was also found in the cup holder of the center console.

As we continued to search the vehicle, K-9 Officer Hatfield located a firearm under the driver's seat. I then came around and observed a black handgun under the driver's seat which I recognized to be a Sig Sauer semi-automatic handgun. In addition, the firearm was found to be loaded with one round already in the chamber.

Once retrieved, I subsequently ran the firearm's serial number through dispatch and was informed that the firearm was stolen and later confirmed as such by the Palm Beach County Sheriff's Office as having been stolen and reported stolen on 06/28/2022.

The total packaged weight of the marijuana was approximately 63 grams.

Based on a totality of the foregoing, I had probable cause to believe that the Defendant was in possession of more than 20 grams of marijuana and a stolen firearm while in the City of Vero Beach and possessed said marijuana with the intent to sell/ distributing the same. Therefore, the Defendant was charged accordingly.

The foregoing was recoded with the use of body-worn cameras the video of which was subsequently uploaded to a secure server.

The marijuana, firearms and cash was subsequently entered into Property & Evidence at the Vero Beach Police Department. Also, the vehicle was towed to Charlie's Towing as we were unable to contact its owner.
