



NARRATIVE

On Wednesday, July 2, 2025 at approximately 0612 I responded to the Indian River County Sheriff's Office Jail Complex, 4055 41st Avenue, Vero Beach, Florida 32960 in reference to a disturbance.

Upon my arrival I met with jail staff where I was informed an instance of Battery had been captured on security footage, occurring with [REDACTED]

I reviewed the security footage. I observed a darker skinned male, later identified as Mr. Guscenie Boston, grab something from a shelf before returning and splashing water on to another male, later identified as Mr. Todd Fredrick Gais, who was laying on the ground or bottom bunk. The two then stood and briefly engaged in a pushing/grabbing match. The video appears to depict Mr. Gais being pushed against the wall and cell door. Each person had ahold of the other, however, the physical altercation started based upon the initial throwing of water by Mr. Guscenie.

I interviewed a third individual who was within the cell, Mr. Steven Phillip Roth. I informed Mr. Roth he was under no obligation to speak with me; as a precaution I informed Mr. Roth of his constitutionally protected rights in the form of a Miranda Warning. Mr. Roth informed me of the following in essence:

Mr. Roth did not observe Mr. Gais laying on the ground. He observed Mr. Gais and Mr. Boston engaged in a pushing match standing toward the cell door.

I then interviewed Mr. Todd Fredrick Gais. I informed Mr. Gais he was under no obligation to speak with me; as a precaution I informed Mr. Gais of his constitutionally protected rights in the form of a Miranda Warning. Mr. Gais informed me of the following in summation:

Mr. Gais finished his breakfast and laid back down. At which point, Mr. Boston said something regarding Mr. Gais' daughter, to which Mr. Gais replied something to the effect of "Fuck you." A brief verbal exchange occurred shortly before Mr. Boston splashed Mr. Gais with water. Mr. Gais then stated he stood up because he wasn't sure what else Mr. Boston was going to do to him, at which point Mr. Boston grabbed ahold of Mr. Gais.

I then spoke with Mr. Guscenie Boston. I informed Mr. Boston he was under no obligation to speak with me; I informed Mr. Boston of his constitutionally protected rights in the form of a Miranda Warning, as he was being questioned regarding a new criminal offense. Mr. Boston acknowledged his rights and stated he did not wish to speak with me.

I reviewed the security footage again, where the footage clearly depicts Mr. Boston as the aggressor in the situation. As a result of evaluating all available evidence, security footage, statements, the water which was thrown

On July 2, 2025, at approximately 1334 hours, I responded to a reported vehicle theft at [REDACTED] which was later determined to be domestic in nature.

Upon locating the suspect vehicle a red Smart car bearing Florida tag ESW9 at the intersection of Indian Avenue and Harris Drive, Officer Brandes and I initiated a high-risk traffic stop.

Upon contact with the driver, I identified him as Chandler Keeler. Chandler immediately became irate and began panicking. He claimed he was allowed to take the vehicle; however, after Officer Martinez spoke with Chandler's mother, Sherrena Keeler, we learned this statement was false.

After further discussion with Sherrena, she declined to pursue charges related to the vehicle theft. However, due to the domestic nature of the incident and the physical contact reported, Chandler Keeler was placed under arrest for domestic battery on Sherrena Keeler.

I then placed Chandler into handcuffs in which he was transported to county jail without incident.

Chandler Keeler was charged for 1 count of domestic violence battery F.S.S 784.03.

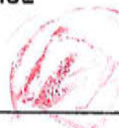

NARRATIVE

On July 2nd, 2025, at approximately 1847 hours, I was traveling westbound in the 900 block of Oslo Road Southwest, Vero Beach, Florida, when I observed a black Volkswagen SUV bearing Florida tag #KWTZ54 with dark tinted windows, making it impossible to see inside the vehicle. I then positioned my patrol unit alongside the vehicle to confirm the lack of visibility. Upon confirming that I could not observe the driver, I initiated a traffic stop.

Deputy Cherubin and I conducted a driver-side approach and made contact with the driver, later identified as Tyrell Sterling Smith. While speaking with Smith, I detected a strong odor of what I recognized, based on my training and experience, to be fresh marijuana emitting from the vehicle.

Smith was removed from the vehicle and escorted to the front of my patrol unit. A subsequent search of the vehicle revealed a green and black fanny pack on the driver's side floorboard. Inside the bag, I located a digital scale and a clear plastic bag containing a white powdery substance which, based on my training and experience, appeared to be cocaine. I conducted a field test on the substance, which yielded a positive result for cocaine.

I then tested the window tint using my agency issued tint meter and obtained readings of 1% on the rear window and 7% on the front window.

Smith was placed in handcuffs and secured in the back of my patrol unit. I read Smith his Miranda rights, which he stated he understood before invoking his right to remain silent. Prior to transport, I advised Smith that if he had any additional narcotics or contraband on his person, now would be the appropriate time to disclose it before entering the jail, or he would face additional charges. Smith stated he had nothing on him.

Upon arrival at the Indian River County Jail, Smith was turned over to Corrections deputies. During a search conducted by jail staff, a clear bag of fresh marijuana was located tucked in his boxers. Please refer to Deputy Burns' case #2025-1011 for additional information.

Based on the totality of circumstances. Smith was charged with the following:

1. Possession of controlled substance, consistent with FSS 893.13.
2. Introduction of contraband to a county detention facility, consistent with FSS 951.22.1h.

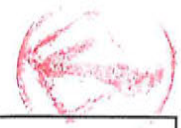

On 2 July 2025, at approximately 1922 hrs, I, a police officer for Sebastian, responded to the area of Sebastian Blvd West and High Street for a reckless driver.

While en route, dispatch advised me the caller, Maria, was behind a silver Dodge pickup truck that was swerving on US Hwy 1. The caller stated the truck turned onto High Street from Sebastian Blvd West.

As I arrived at the area, I proceeded south on High Street. I located the truck, a silver Dodge Ram bearing FL license plate DU42DT, in the 600 block of High Street, driving south. Due to no traffic in this part of town and it being primarily commercial, I did not immediately stop the vehicle. As we proceeded south on High Street, the vehicle was unable to maintain its lane, crossing the center line, weaving back, and striking the grass with the passenger side tires. As we came to the stop sign at High Street and Woodmere Road, the vehicle stopped; however, it was after the stop bar, partially in the middle of the intersection.

The vehicle proceeded east on Woodmere Road and went North on Old Dixie Hwy. The vehicle then turned East back onto Sebastian Blvd. We were stopped by the traffic light at Sebastian Blvd and US HWY 1. Once the light turned green, we sat at the light for approximately a minute without moving. At this point I activated my emergency lights and approached the driver side of the vehicle. In the driver seat, vehicle running and still in drive, I observed a white male, Hervy Gullede III, slouched over and asleep.

I woke Hervey up and advised him to shut the vehicle off, which he complied. Hervey was very slow to answer any question; his eyelids were droopy, and his speech was lethargic.

I requested Hervey's required documents. Hervey took his driver's license out of his wallet and placed it on his lap. Hervey then proceeded to look in his glovebox and center console. Hervey grabbed his registration and handed it to me. Hervey then started looking again in his glove box and center console. I asked him what he was looking for at this point, and he stated insurance. I asked Hervey about his Driver's License again at which time he briefly looked in his wallet, then handed it to me from his lap. I asked Hervey about his insurance once more, and he stated it was on his phone; Hervey proceeded to start looking through his emails.

Once Ofc. Vazquez arrived on the scene; I asked Hervey if he would conduct some field sobriety exercises, and he stated yes. Due to the location of where we were, I requested Hervey to exit the vehicle and go to the On the Fly gas station to conduct the excersies which he agreed.

Before starting the exercises, I asked Hervey if he had any medical issues that would affect him, and he stated no. I then asked if he was taking any medications, and again, he stated no.

I placed Hervey into the starting postion to conduct HGN. I instructed Hervey to stand with his feet together and hands down to his side. Hervey initially was in the position but, then immediately got out of it. I attempted to use the stimulus, black, the approximate size of an ink pen, and requested him to follow it with only his eyes, not moving his head. As I made my first pass, checking for equal tracking, Hervey continued to move his head. I was unable to complete the exercise due to Hervey moving his head. I stopped and requested Hervey to try the excersises again. Hervey agreed, and I again had to place Hervey into the starting position. After attempting a second time, I did not see any clues for nystagmus.

I then proceeded to the following exercises lack of convergence: I again placed Hervey in the starting position. I advised Hervey again he needed to stay in that position throughout the excersise. I instructed Hervey to stand with his feet together and arms down by his side. I instructed Hervey again to follow the stimulus with only his eyes. I started the exercise as I did the first pass; Hervey's right eye followed the stimulus; however, his left bounced back as it came to the inside corner of his eye. This behavior is indicative of someone who is under the influence of marijuana. On the second pass, Hervey did not follow the stimulus as instructed. Hervey did not stay in the starting position as instructed.

The following exercise I conducted was the modified romburg. I instructed and placed Hervey into the starting postion. I then proceeded to explain the exercise to Hervey. As I was explaining the exercise, Hervey continually left the starting position. After explaining and demonstrating the exercises, I instructed Hervey to begin; Hervey just stood there and did not conduct the exercise as instructed. After approximately 45 seconds, I asked Hervey if he remembered the instructions, and he stated yes. I placed Hervey back in the starting position again and again instructed him to start. After approximately 50 seconds, I asked again if h e remembered the instructions, and again, he stated yes. I again instructed and demonstrated what I needed Hervey to do. Hervey again did not complete the exercises correctly.

At this time, I moved on to the walk-and-turn exercises after I was able to get Hervey in the starting position. I explained the instructions to Hervey and then demonstrated what I needed Hervey to do. I again placed Hervey in the starting position. I told Hervey to start the exercise. Hervey proceeded to walk, missing his heel to toe on every step. Hervey took approximately 20 steps and was unable to keep his balance. At this time, I asked Hervey if he remembered the instructions, and he replied, "Count to 9". I instructed Hervey to start the exercise again. I explained the instructions again and told Hervey to start. Hervey proceeded to walk again, missing heel to toe on all steps; after 15 steps, he stopped and

asked if that was 9; he was instructed if he believed that was 9 to turn and walk back. Hervey did not turn as instructed and walked 13 steps back.

The following exercise I conducted was the one-leg stand. I placed Hervey into the starting position. I instructed Hervey to stay in that position while I explained and demonstrated what I needed him to do. I advised Hervey to start the exercise; Hervey briefly stood there and then asked if he needed to walk forward. I explained the directions again to Hervey and requested him to start and Hervey just stood there. After approximately 30 seconds, I advised Hervey that he could stop. At no time did Hervey do as I instructed.

At this time, I placed Hervey under arrest for the following:

FSS 316.193 Driving under the Influence - Due to the totality of circumstances, I believed Hervey was operating his vehicle on the public roadways of the city of Sebastian while under the influence of alcohol and or drugs.

Hervey was mirandized and placed in the back of a marked patrol vehicle. I again asked Hervey if he had anything to drink that day, and they stated one beer at approximately 5:00 pm. I asked Hervey if he had used any drugs, and he stated he had smoked a marijuana cigarette a couple of hours prior.

While transporting Hervey to the Indian River County Jail, Hervey was unable to stay awake.

Upon arrival at the jail, Hervey did present a breath sample. The results were .008 on both samples. Due to Hervey's behavior, I requested Hervey to provide a urine sample, which again he complied with, and a DRE to conduct an investigation. Deputy Hackett from the Indian River County Sherriff office responded. Deputy Hackett believed Hervey was under the influence of a narcotic.

NARRATIVE

On Wednesday, July 2, 2025, at 2120 hours, I responded to [REDACTED] in reference to a disturbance.

Upon arrival, I made contact with the caller/victim, Paulina Lopez Tzun. Lopez advised her boyfriend, Andres Mendez Jimenez, battered her. Lopez stated Mendez threatened to kill her and hit and kneed her in the stomach several times. Lopez stated she is approximately a month pregnant and Mendez is aware she is pregnant and that Mendez is the father. Lopez also stated Mendez grabbed her by her arm and lifter her left arm and pointed to a bruise in her inner bicep on her left arm. Lopez advised she and Lopez have been together for approximately four months [REDACTED] Their relationship is sexual in nature. Lopez stated Mendez had been physically abusive the entire time of their relationship. She made a comment stating when Mendez is sober he talks about wanting the baby, but when under the influences he hits her and does so in her stomach.

[REDACTED] Lopez indicated a Hispanic male next to the trailer was Mendez. Mendez had his hands within his pockets and had to be asked several times to remove his hands. He failed to keep his hands out of his pockets and was detained.

While Mendez sat in the back of my patrol vehicle, Mendez's nine-year-old son approached us. I spoke to Mendez's son and he stated he only witnessed his father, Mendez shove Lopez on her shoulder and then shut the door on Lopez. Mendez's son described the incident as Lopez trying to "escape" from the trailer.

I then returned to Mendez and read him Miranda warnings. Mendez advised he understood. Mendez stated Lopez wanted to leave and he informed her she could leave. Mendez denies hitting Lopez. Mendez confirmed he and Lopez have talked about her possibly being pregnant. Mendez was informed of his son's statements and still denied shoving Lopez.

Based on the statements provided, the bruise on the victim, and the knowledge Mendez has of Lopez possibly being pregnant, Mendez was placed under arrest for aggravated battery (on a pregnant person, domestic violence).

Andres Mendez Jimenez was transported to Indian River County Jail.
