NARRATIVE

On 04/30/2024, at approximately 2129 hours, I responded to [REDACTED] in reference to a physical disturbance.

Upon my arrival, I made contact with Tammy Newman who stated the following;

Approximately 10 minutes prior, she was in her bed room helping [REDACTED] Walter Newman, look for a key fob to their vehicle, when Walter became upset and started yelling at her for losing it. During the course of the argument, Tammy was on the bed searching for the key, when she grabbed her cellphone, and Walter snatched it out of her hand and threw it in an unknown direction. Due to Walters cellphone being at the same location, she reached for it and was pinned onto the bed by Walter, who used his left elbow, to apply pressure on the left side of her face, preventing her from moving. Tammy then stated, that in self-defense, she was able to hit Walter in his face, several times, as an effort for him to let her go. When Walter removed his elbow from her face, he struck Tammy on the left side of her face, with the bottom portion of his elbow.

While interviewing Tammy, I observed that the entire left side of her face was flushed red and I noticed that her left eyebrow was cut and actively bleeding, due to droplets of blood running down her face. At the same area on Tammy's face, I noticed that it started to swell and discolor. I also noticed on Tammy's left hand, she had a small abrasion that was bleeding.

Tammy declined medical attention on scene.

Post Miranda Warnings, Walter advised that he was in an argument with [REDACTED] over her not finding a key fob to their vehicle, when she punched him in his mouth. After being punched, Walter advised that he only simply nudged Tammy with his elbow in her face and is not sure how the left side of her face and eyebrow became injured.

Due my interview of Walter I observed a small cut at the top of his lip, that was not bleeding.

During my investigation I determined that Walter was the primary aggressor.

Walter was transported to the Indian River County Jail for processing.

NARRATIVE

On Tuesday, April 30, 2024, at approximately 0928 hours, while conducting traffic enforcement near the 1300 block of S. U.S Highway 1, The LPR alerted me of an expired registration for a black Honda sedan FL bearing AL62GJ.

The aforementioned license plate was searched through DAVID which resulted to a black Ford sedan registered out of Lauderdale Lakes.

I conducted a traffic stop on the vehicle and made contact with the sole occupant who was later identified as Alton Christian.

I asked Christian for his driver's license, registration, and insurance and he immediately stated that he did not have a license. Christian provided me with his permanent residence card which was issued in 2018.

Christian's license was suspended on 1/4/24 and he had full knowledge of the suspension.

While inventorying his vehicle, I also found a letter from the FLHSMV **NOTICE OF ORDER OF SUSPENSION AND FINAL ORDER** on December 20/2023 stating that his driving privilege and/or vehicle registration (s) will be suspended effective January 4, 2024.

Post Miranda, Christian stated that he knew that he was driving while his license was suspended. He also stated that he lost his tag and it was reported. Even though the license plate for his vehicle (VIN: 1HGCR2F39GA070179) is valid he could not go to the DMV to get it because of his suspended DL; therefore, he found a license plate (AL62GJ) and attached it to his vehicle. Christian also had a decal (FL N3588Y) in the attached license that did not belong to his vehicle nor the unassigned tag that he found.

Christian could not state where he located the tag that he attached to his vehicle.

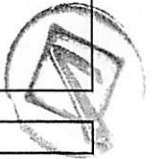
