

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **10/06/2025**, at **02:20** (Specifically include facts constituting cause for arrest.)

On **10/06/2025**, at approximately **02:20** hours, I was patrolling a high crime area located near 43rd Avenue and 19th Street. This area has ongoing issues regarding property crimes and drug activity.

While in the area, I observed a bicyclist riding in the dark with no lights attached to their bicycle. The person operating the bicycle had a white ski mask that was concealing their entire face. I observed that the bicyclist was activating a hand held flashlight sporadically while riding through the neighborhood. I then drove towards the bicyclist, and upon observing my presence, the bicyclist turned onto an adjacent street and removed their ski mask. I subsequently conducted a traffic stop on the bicyclist for the aforementioned offenses in the 1900 block of 44th Avenue.

I then made contact with the male bicyclist, who was identified as the defendant by his Florida Identification Card. I verified that the defendant did not live in this neighborhood, and he told me that he was making his way home to 517 10th Place. The defendant was nervous, and he claimed that he was leaving a friends house in the area. The defendant could not provide me with the general address for the house he visited, and he stated that he did not know the full name of his female friend. While speaking with the defendant, he began to sweat and fidget with his personal belongings. The defendant possessed a small bag that was suspended across his chest. I asked the defendant if he had any weapons on him, and he replied that he possessed knives. I then asked the defendant if I could look inside of his bag, to which the defendant consented and began to sort through his bag and pull items out. I asked the defendant to stop digging through the bag and asked him if he would remove the bag and allow me to look through it. The defendant then provided me the bag and allowed me to look at the contents inside. I then located a glass smoking pipe with a heavy amount of burnt residue in the front compartment of the bag, which I recognized to be paraphernalia that is commonly used to smoke narcotics.

At this time, the defendant was placed into handcuffs. I then conducted a search on the defendant's person. In the defendant's front pants pocket, I located a second pipe with residue along with a disposable butane lighter. Inside the defendant's wallet, I located approximately six pieces of aluminum foil that were folded into small squares. I recognized that these folded squares of aluminum are a common way to contain and transport narcotics. Upon closer inspection, these squares did not contain residue to attempt a reactive field test on.

PROBABLE CAUSE STATEMENT

The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:
On **10/06/2025**, at **02:20** (Specifically include facts constituting cause for arrest.)

At **02:43** hours, the defendant was placed under arrest and transported to the Indian River County Jail. Upon arriving at the jail, I observed that the defendant was slumped forward in his seat, and that he had managed to manipulate his handcuffs underneath him (repositioning his hands in front of his person). The defendant was removed from the rear transport of my agency vehicle and I observed that there was pieces of plastic discarded on the floorboard where the defendant was sitting. I retrieved the plastic and observed that it was a small plastic Ziploc bag that was torn in half. There was a small amount of fine powder in one half of the bag, and I conducted a reactive field test on this powder. I subsequently received a strong positive reaction for the presence of Cocaine from the residue that was collected with the discarded plastic bag. I utilized my agency BWC to document the testing of the evidence. It should be noted that an inventory of my vehicle and the prisoner transport cage was conducted at the start of my shift, and that no other persons were present in my agency vehicle prior to my contact with the defendant. The appearance of the tampered evidence occurred during the arrest and transport of the defendant.





NARRATIVE

On Monday, October 6, 2025 at approximately 1338 hours, I responded to the residence of [REDACTED] in reference to a disturbance.

Upon my arrival, I met with the victim/complainant, Rhondonette Tory. Tory advised me of the following:

She was beaten up by Ashley Pound in front of 4225 38th Court. Tory stated that she and Pound used to have an intimate relationship in the past, however are no longer together. Tory stated she has since ceased all communications with Pound. Tory informed me she is still good friends with Pounds daughter, Anevea Pound. Tory stated she went to pickup Anevea and her boyfriend from their residence, 4256 28th Court. Tory informed me Anevea needed a ride to where her mother, Ashley Pound is residing. Tory informed me the address was 4225 38th Court. Tory stated she drove her mothers black Jeep Wrangler to Anevea's residence and went to Ashley's residence at approximately 1300-1330 hours. Tory informed me she waited in her vehicle while Anevea went inside with her boyfriend to pick up [REDACTED] and other personal belongings. Tory stated Anevea, Anevea's boyfriend, and Ashley all walked towards her Jeep Wrangler. At this point, Tory remained inside the vehicle and was approached by Ashley on the driver's side of the Jeep Wrangler. Tory stated she opened the drivers side door while Ashley was standing nearby in order to take custody of [REDACTED] from Anevea. Tory stated she received custody of the [REDACTED] from Anevea and Ashley stated "I'm not going to bother you. You think I'm a monster". Tory stated Ashley grabbed her dreads on the right side of her head and began swinging closed fists at her head. I observed a small scratch on Tory's right forearm and small amount of redness on her right forearm.

It should be noted, Tory's mother, Bonita Richardson, informed me she had video footage of the incident. I then viewed the video footage, which depicted, Ashley Pound, wearing a brown hoodie and swinging her left arm up and down. I observed Tory's head tilted to the right as though her head was being pushed downwards due to the placement of her left ear. I observed Anevea standing in between Ashley and Tory with her left arm on Ashley's chest in what appeared to be a motion to separate both Ashley and Tory. I observed Ashley swing her left arm downwards with a closed fist striking Tory's head and a loud thump was heard. I could hear Anevea yelling "stop! Let go!" and a child screaming and crying. I sent Bonita a AXON online evidence link for the video footage to be upload to AXON online evidence.

Myself and assisting Deputies traveled to 4225 38th Court to interview Ashley Pound. Upon my arrival, I immediately read Ashley Pound her Miranda Rights from an agency issued Miranda card. Ashley stated she understood her rights and agreed to speak to me. I asked Ashley if she knows Rhondonette Tory, which she stated "yes". I asked if she and her daughter arrived in a black Jeep Wrangler, which she stated "they did". I then asked what the purpose of them coming to her residence was for. Ashley stated Tory came to the residence to provide her food and to pick up her [REDACTED]. Ashley stated she and her daughter, Anevea were walking personal belongings and [REDACTED] to Tory's vehicle. I asked Ashley what happened at the driver's side door of Tory's vehicle, which she stated they were exchanging words about a prior incident that occurred, however she was pointing her hand and waving it back and forth. At which point she stated Tory likely "believed that I was going to hit her or something". Ashley stated Tory grabbed her hand and "we kind of like tussled, because what are you grabbing my hand for? I did not touch you". I informed Ashley that the term "tussle" is vague, which she stated "we locked in a little bit". I then stated did you exchange closed fist or grab each other's hair, which she stated "no".

I then went to 4256 28th Court to speak with Anevea. Anevea provided me with the same video footage that Bonita provided

me with. Anevea stated "she doesn't want to snitch on her mom, but showed me the video footage and stated "you can see Tory has the [REDACTED] in her hand and my mom is pulling her hair. You can see Tory's head leaned to the side". Anevea stated "that's me, I'm trying grab my mom's hand from Tory's hair". Anevea then stated, "but she still went around me and hit the back of her head, referring to Tory". I asked if Tory ever exited her vehicle to walk up to the residence of 4225 38th Court, which Anevea stated "no, I always tell Tory to stay in the car, roll the windows up, and lock the door because Ashley likes to come outside and do the most". Anevea stated today Tory had her window halfway down and her mother, Ashley was trying to convince Tory to come out of the vehicle and give her a hug. Anevea stated Tory initially stated "no, I think you'll do something" and Ashley stated "you can check me I don't have anything". Anevea stated "well I don't think she'll hit you with the [REDACTED] in your hands". Anevea stated Tory opened the door slowly and her feet were slightly hanging out and Tory still had the [REDACTED] in her hands. Anevea stated Ashley gave Tory a hug and Anevea noticed Ashley had one of her hands behind her back, so she grabbed Ashley's right arm to thwart off any sort of physical threat. Anevea stated Ashley then utilized her left arm to grab Tory's hair and Anevea let go of Ashley and she began hitting Tory in the head.

I then sent a crimescene in-field acquisition request to view video cameras from Pole #5 and #6 on 38th Court. I observed the follow from the two different angles. Tory's black jeep arrived on scene. Anevea and her boyfriend exit the vehicle and walk to the residence of 4225 38th Court. Anevea, her boyfriend, and Ashley come outside. Ashley can be seen standing near the driver's side door and the drivers side door opened. At this time, I observed Ashley wearing the same outfit in the video footage as when I conducted the mirandized interview. I observed Ashley move closer and a physical altercation occurred. I observed Anevea run to get in between Ashley and Tory within the ajar door jam. Anevea is seen pushing Ashley away from Tory. Tory then closed the driver's door and pulled forward in a hurried manner.

Based on the video footage provided, I determined Ashley POUND by culpable negligence neglected [REDACTED] without causing great bodily harm or permanent disfigurement.

Based on the totality of the circumstances, I determined probable cause exist for for Battery Domestic Violence pursuant to F.S.S. 784.03 and Child Neglect pursuant to F.S.S. 827.03.2D.



The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On **10/06/2025**, at **21:39** (Specifically include facts constituting cause for arrest.)

On 10/6/25, while on routine patrol traveling southbound on Indian River Blvd, CPL. D. Brumley stated he observed a black SUV bearing FL Tag# (RD666) traveling ahead of him in the far left lane. CPL. D. Brumley advised when approaching the intersection of 20th St. and Indian River Blvd, he observed the black SUV run the red light.

CPL. D. Brumley then initiated a vehicle stop by activating the emergency lights on his patrol vehicle. Once stopped, CPL. D. Brumley made contact with the vehicle's passenger who was later identified as (W1) Robert D. Piatt (DOB: 9/21/1961). CPL. D. Brumley advised when asking W1 what was going on, he observed the driver seat to be unoccupied. CPL. D. Brumley stated he then asked W1 who was driving the vehicle to which W1 responded that the person now located in the back seat was driving the car and said he (D1) had no driver's license.

I then arrived on scene and made contact with (D1) Michael J. Sailor (DOB: 4/5/1982) who initially advised "I was in the back seat, I didn't do anything wrong." I questioned D1 if he had a driver's license to which he advised he did not have a valid driver's license. D1's information was then run through Vero Beach Communication which confirmed D1 did not have a valid Florida Driver's License and that it was suspended indefinitely on 10/2/2023.




I then detained D1 for further investigation. D1 said "can I be honest with you" and stated he was picked up by W1 to help him retrieve clothes from a different location. On the way there he did not like the way W1 was driving to which he asked to drive the vehicle. D1 said he then got in the driver seat and started driving. D1 advised once approaching the intersection of 20th St. and Indian River Blvd he ran the red light and observed he was being stopped by Law Enforcement to which he then stopped the vehicle and jumped to the back seat.

I then made contact with W1 who advised he was driving around in Gifford and approached D1 in the road. W1 said he was looking for people to fish with and asked D1 if he would join him. W1 stated D1 later asked him to drive and allowed him to do so. W1 explained once being stopped for running the red light D1 said to him "I don't have a driver's license" and jumped to the back seat. W1 said he was unaware that D1 did not have a valid driver's license before being pulled over. W1 provided no further information.

I then placed D1 under arrest for violation of F.S.S.322.34 (10b1) - Driving With Suspended or Revoked License and issued a criminal citation reference Citation# (ALZPC1E). I later issued D1 a warning for running the red light reference Warning#(W116728).

D1 was then transported to the Indian River County Jail for processing and booking held on a \$500 bond.

On 10/07/2025, at 00:52 (Specifically include facts constituting cause for arrest.)

On September 6, 2025, at approximately 2100 hours, while on routine patrol at the 1300 Indian River Drive, Sebastian, Florida 32958 (Main Street Boat Ramp), I observed a younger female running south on the sidewalk. I then observed a dark colored sedan pull into the parking lot of the boat ramp. I observed the dark colored sedan stop several times, double-parking, and then driving further south. I then observed the dark color sedan pull out of the boat ramp parking lot and continue southbound on Indian River Drive. I observed the vehicle quickly catch up to the female walking south and then slow down. I observed the dark colored sedan begin to travel south at the same speed as the female. I began to catch up to the dark colored sedan to run the Florida registration plate. As I got behind the vehicle, it quickly pulled into a driveway. Officer Keiser (#418) stopped out with the female. The female stated she did not know the car and believed it was following her. The female stated the vehicle had been behind her for some time. Officer Keiser advised me of this. I observed the vehicle back out of the driveway and began to travel northbound on Indian River Drive. I observed the vehicle to be bearing Florida registration plate FKTM09. I then observed the dark colored sedan pull into 1532 Indian River Drive, Sebastian, Florida 32958 (Fisherman's Landing). Due to this being for commercial fishermen only and closed at sundown, I stopped out with the vehicle.

I observed a man in the driver's seat of the vehicle. I observed the male to be the sole occupant of the vehicle. I requested the male's identification. The male provided me with an Indian Union Driving License (License number #AP03120240018579). I identified the male in the photograph as Feroz Khan. Feroz stated that this was the only driver's license he had issued to him. Feroz stated he was recently pulled over, and the officer told him it was okay. I advised Feroz that this was not a valid driver's license in the State of Florida. Feroz stated he understood. Feroz stated he was not trying to follow the female but was actually lost and trying to meet a friend at one of the docks on Indian River Drive. Feroz then showed me Instagram messages he had with a female, where he sent a Google link to a dock. Throughout my conversation with Feroz, he was visibly nervous and even shaking. Feroz's statements did not make sense about what he was doing in the area, but Feroz was advised to get a ride and go home for the evening. At this time, I ended my interaction with Feroz.

On September 6, 2025, at approximately 2148 hours, I was conducting a business check at 1451 Sebastian Boulevard, Sebastian, Florida 32958 (Publix). While driving westbound through the parking lot, I observed a dark colored sedan pull out of a parking spot and began to also travel westbound. I observed the vehicle make a right-hand turn out of the parking lot onto Sebastian Boulevard. I observed there to be a "One Way sign with a black arrow pointing east in the positive median of Sebastian Boulevard. I observed the dark colored sedan turn on its left-hand turn signal (indicating a west-hand turn out of the parking lot). I observed the vehicle pull out onto the eastbound traffic of Sebastian Boulevard and turn westbound. I observed the vehicle, then backed up and made a three-point turn, now facing back into Publix. During the vehicle's time on Sebastian Boulevard, I observed that two vehicles had to change lanes to avoid a collision with the dark colored sedan.

I quickly exited my patrol vehicle and directed the vehicle to get off of Sebastian Boulevard. The vehicle's front driver's side window rolled down, and I observed the driver to be Feroz Khan. Due to my knowledge that Feroz did not possess a valid license, I directed him to get the vehicle off of Sebastian Boulevard and had him turn the vehicle off. Upon the arrival of Officer Keiser, I directed Feroz out of the vehicle, and Officer Keiser removed it from Publix's exit and into a parking lot. I requested Feroz to call someone with a valid license to come to the scene and remove his vehicle. Feroz complied and began to call his friends. Upon the arrival of Sergeant Melius, Feroz was read his Miranda Warning. Feroz stated he understood his Miranda Warning. Feroz asked if he was in trouble. I told Feroz that we are still investigating. Feroz then reestablished contact with all officers at the scene as I walked to my patrol vehicle. Sergeant Melius began to speak with Feroz. Feroz stated the female from the messages contacted him again, and they decided to meet at the 7/11 across the street from Publix. Feroz stated he knew he was advised not to drive, but he wanted to meet her, so he drove to the 7/11. Feroz stated once there, they spoke for a while, but her mother wanted her to return home, so she left. Feroz stated he went to Publix to get a drink before driving home. When asked what drink he got, Feroz stated he did not get a drink but decided just to go home. Feroz stated he became confused by his Google Maps and went to the wrong exit of Publix, so he decided to just turn around on Sebastian Boulevard. Feroz stated he did not possess an international driver's license, nor did he have a valid Florida Driver's license.

At this time, Feroz was placed under arrest for driving without a valid license and transported to the Indian River County Jail.
