#### NARRATIVE

On 03/12/24 at approximately 2009 hours I responded to a Disturbance at

Upon my arrival I met with the victim Luis Ignacio Perez. He told me he had gotten into a fight with is son. He told me he and his wife arrived at their home and went inside. Once inside he was talking with his son Luis F Perez Jr about some business. He said during that discussion an argument began. Luis Sr said that his son then began to attack him. He said Luis JR began to hit him with an open hand on the top of his head. He said Luis JR hit him repeatedly using both of his hands. Luis SR said his son pushed him backwards causing him to fall to the ground. He said once on the ground Luis JR kicked him at least once on the shin. Luis SR confirmed that Luis Jr is his biological son who has been living in the house with him and his wife since December 1, 2023. As Luis SR was more fluent in Spanish his statement was translated by Officer Guzman of the Fellsmere Police Department. Luis SR is 81 years of age at the time this incident occurred. Deputy Chouinard who assisted me with this case noted swelling in Luis SR left wrist. He took photographs of the swelling.

I spoke with Liliana Perez who witnessed the altercation between her son and husband. Her statements were also translated by Officer Guzman. Liliana stated she came home with her husband and he got into an argument with her son Luis JR. She said she saw Luis JR repeatedly strike her husband in the head. He then fell to the ground. Liliana

I spoke with Luis JR about the altercation. He said he had a disagreement with his father over business related matters. He said while he was speaking with his father the family dog appeared to be aggressive. Luis JR said he was concerned that the dog was going to attack him. He said he rushed forward to get a hold of the dog before it could attack him. He said while he was attempting to get to the dog he pushed his father. Luis JR said he wasn't trying to push his father he was trying to get to the dog.

After speaking to Luis JR I had Officer Guzman ask Luis Sr about the dog and if it tried to attack his son. Luis SR said the dog did walk past them in the hallway. He said that had nothing to do with the attack or him being pushed down. Luis JR provided a written statement regarding the events. His wife Liliana refused to provide a written statement, but her verbal statement was recorded on body worn camera.

Luis JR is currently on pre-trial release for a felony charge in Broward County. He is on an ankle monitor and is on house arrest in relation to that case.

Based on the above facts Luis JR was charged with one count of Battery of a person 65 years of age or older with a

### NARRATIVE

On March 12th, 2024 at approximately 2019 hours I was conducting a routine patrol in the area of 43rd Street and 27th Avenue.

While conducting my patrol I observed a Black male who is identified as Isiah King. I know King from previous encounters and am aware he lives down in the 12th Street and US Highway One area. This area is approximately 4.5 miles away and King just rides his bicycle. I observed King walking south on 27th Avenue and as he made eye contact with me I observed him walk into an empty field that had very little light. I turned my patrol vehicle around and as I approached King he began to walk at a faster pace into the empty field.

I got out of my patrol car and initiated a consensual encounter with King as he stood behind a pole. We spoke about him being from the 12th Street area and why he was up 4.5 miles away from his home. I observed a pack of Cigar's in his hand and asked him what was in the package. I shined my flashlight on the package and noticed a white powdery substance was falling from his hand which I believed to be MDPV. Also, it should be known in the area specifically MDPV is a very common Drug that is found.

As I went to detain King he threw the rest of the substance on the ground after he smashed it in his hand to a powder. I asked King why he did that and he stated it was a reaction.

Deputy Le and Deputy Barrientos arrived on scene shortly after and assisted in placing King in wrist restraints. On King's hands was a powdery substance that matched what I observed him throw on the ground. Le utilized an agency-issued test kit and tested the substance that was on the hands of King. The substance tested positive for MDPV (Molly as it is commonly referred to).

King was read his Miranda Rights by Deputy Le and acknowledged an understanding of them. Post Miranda King advised the substance was Molly and he had purchased it for 5 dollars as that was all he had. King advised he normally smokes Molly with cigars and when I approached him he got scared and his reflexes caused him to throw the substance on the ground.

I determined that King was attempting to destroy, the MDPV that was in his hand with the purpose to impair its availability in such proceeding or investigation.

Due to the above-listed facts, I found probable cause to arrest and charge King with the following:

1 Count F.S.S. 893.13 Possession of a Controlled Substance (MDPV) (No Bond).

1 Count F.S.S. 918.13 Tampering with or Fabricating Physical Evidence.

King was transported to the IRC Jail without incident.

#### **NARRATIVE**

On March 12th, at approximately 1827 hours, I was conducting a routine patrol in the area of 31st Avenue and 43rd Street.

While conducting patrol I observed a Silver Mitsubishi truck bearing Florida tag Y069JK fail to come to a complete stop at the stop sign located at the aforementioned intersection.

While approaching the vehicle I could smell the odor of burnt marijuana emitting from within the cab of the vehicle. The driver was identified as Erman Hinton and was the only occupant within the vehicle.

I observed Marijuana ash throughout the vehicle and asked Hinton If he had a medical marijuana card. Hinton advised he did not and was asked to step out of the vehicle so it could be searched.

On the seat he was sitting I observed a straw with burnt ends and residue inside which due to my training I know to be a common way to snort narcotics. Due to locating the drug paraphernalia, Erman Hinton was searched incident to arrest.

The search on his person was conducted by Deputy Bennett. Bennett advised on his left ankle tucked inside his sock there was a baggie with multiple rocks inside. I looked at the baggie and believed the substance to be Cocaine. The substance was field tested utilizing my agency issued test kit and gave a positive indication to Cocaine.

Hinton was read his Miranda Rights and after acknowledging them provided me with the following information:

Inside the baggie was 4 rocks of "Hard stuff". I asked him to explain what that was and he advised it was Cocaine. Hinton further added the rocks were purchased by him for 10 dollars a rock and he likes to smash the rocks up and either snort them or mix them with his Marijuana.

The total weight of the Cocaine was .85 grams inside the baggie.

Due to the above-listed facts and the totality of the circumstances, Hinton was placed under arrest and transported to the IRC Jail without incident.

On 02-09-24 at approximately 1614 hours I responded to in reference to a disturbance. Upon arrival, I made contact with the complainant/victim Anthony Baffuto. Anthony provided a written statement with the following details:

#### NARRATIVE

On the night of 03/11/24, the Indian River County Sheriff's Office Dispatch Center received a witness Paul Barattini regarding a reckless driver. Mr. Barattini provided a vehicle description as well as the license plate number of HWIB61. He maintained visual contact of the vehicle until law enforcement arrived in the area and located the vehicle. Mr. Barattini advised dispatch he had observed the suspect vehicle swerving while traveling. D/S Rollando made contact with the vehicle at 555 24th Court moments after the witness informed dispatch he no longer had visual contact.

D/S Rolland informed me he initially observed the vehicle stopped in the yard with the brake lights illuminated. He told me he turned his patrol vehicle around and made contact with the white male, that was now exiting the vehicle. D/S Rollando stated he observed a strong odor of an alcoholic beverage emitting from the subject's person and breath. He also stated the subject's speech was slurred as he spoke. Finally, D/S Rollando informed me the front of the subject's shorts were wet as if he had urinated himself. Prior to making contact with the defendant, I called the witness Mr. Barattini to obtain a (recorded) statement from him. He informed me he had been following the defendant's vehicle on southbound Indian River Blvd then west on 4th Street. He informed me the vehicle failed to maintain a single lane of travel by striking the median curb with the driver's side tires of the vehicle. He also stated that at one point the vehicle was in the turning lane and continued straight.

I then made contact with the subject who was now identified as the defendant Donald Mitchell using his Florida Driver's License. I informed him that I would be conducting a DUI investigation at which time he informed me he would not be able to perform the exercises due to having medical conditions and his feet being swollen. While speaking to him I observed his eyes to be red, bloodshot, and glassy. I observed very strong odor of an alcoholic beverage emitting from his person and breath as he spoke. He speech was also slurred. I asked the defendant to walk to the front of my patrol vehicle which he did however the whole time he repeatedly informed me that he could not walk. I informed him that I would have him perform alternate exercises due to his inability to walk and his feet being swollen.

Once at the front of my patrol vehicle, I began with the Horizontal Gaze Nystagmus. The defendant's pupil size was equal, he was able to track the stimulus equally, there was no resting nystagmus observed. While checking the defendant's eyes, I observed him swaying forwards and backwards. I observed the lack of smooth pursuit in both eyes, as well as the distinct and sustained nystagmus at maximum deviation in both eyes. Finally, there was onset of nystagmus prior to forty-five degrees (approximately thirty degrees) in both eyes. There was no vertical nystagmus observed. It should be noted, the defendant had to be reminded several times to focus on and follow the stimulus throughout the entire exercise.

The next exercise I requested the defendant to do was to stand with his head tilted back with his eyes closed and state the letters of the alphabet from the letter "E" to "P." He stopped at the letter "Q." instead of "P" as instructed.

I then asked the defendant to stand with his head tilted back with his eyes closed and count backwards from "87" to "68." He attempted to do so twice, however failed. He counted from 87 down to 80, stopped because he was confused and started counting upwards again from 84. The lowest count he stated was 77.

The last exercise I explained and demonstrated was the finger count. I asked him to count one through four as he was touching the tip of his finger to his thumb beginning with his index finger then middle finger, then ring finger, and little "pinky" finger. I explained and demonstrated that once he had done that to count backwards from four to one and reversing the fingers from little "pinky", ring finger, middle finger, and end with his index finger.
