Due to my observation and his inability to stand to follow basic instruction. He was placed into custody for suspicion of DUI.

NARRATIVE

On July 25, 2025, at approximately 2215 hours, I responded to Pointe West Drive and 20th Street, Vero Beach, in reference to a traffic hazard.

The caller, advised a black Infinity four door bearing Florida tag RWRI45 was blocking the left lane on 20th Street. The caller advised driver was passed out and he was trying to wake him up. The caller advised he was able to get the vehicle into the entrance of Pointe West.

Upon arrival, I observed a black truck and vehicle with their hazards on near the entrance of Pointe West Urgent Care. I walked up to the truck and made contact with the driver. The driver was the caller and wheel witness. The caller advised the black vehicle in front of him, the driver was intoxicated. The caller advised he was traveling westbound in the 7600 block of 20th Street. He turned into the left turning lane to enter Pointe West Drive. While waiting for the traffic to clear, the caller advised he observed a black Infinity four door car that was stopped in the middle of roadway on the eastbound side of 20th Street. The caller advised he turned around to check on the driver due the vehicle blocking the turning lane into Pointe West.

Once the caller turned around, he parked behind the vehicle and approached the driver's window. The caller advised the driver was passed out with his head against the steering wheel. The caller knocked and called for the male several times but unable to wake him up. The caller advised after a few minutes of knocking on the windows, the male woke up. The caller advised the male advised he was sleeping. The caller advised the male he needed to turn into the community due to being in the middle of roadway. The caller advised as the male spoke to him, he could tell he was intoxicated. The caller believed this due to the driver's behavior. He stated the male was slurring his words and not making any sense. The caller advised the driver pulled into the community and parked in front of the entrance with his hazards on. The caller stayed with the male until law enforcement arrived on scene. The caller identified driver as the sole occupants of the vehicle.

After speaking with the caller, I made contact with the driver of Infinity. The driver and sole occupant was identified as Mark Ziegler by his Florida Driver's License. While speaking with Mark, I detected the odor of alcohol emitting from within his vehicle. Mark was also slurring his words and looked confused. I verified Mark was not suffering from a medical emergency and asked him if he needed EMS. Mark stated, "No." I asked Mark if he understood why we were speaking with him. Mark advised he did not understand. I explained to Mark that he was sleeping in the middle of the roadway on State Road 60. I asked Mark for his driver license so I could run him through dispatch. While Mark was looking for his driver license, I noticed he was trying to start his vehicle again. Due to Mark's behavior and the possibility of him operating a motor vehicle intoxicated, I instructed him to exit the vehicle. Mark acted confused and did not understand why I was asking him to step out of his vehicle. I explained to Mark that I needed him to exit the vehicle and we would speak near my patrol vehicle. Mark finally understood and exited his vehicle.

After exiting his vehicle, I instructed Mark to walk to the front of my patrol vehicle. As Mark walked to my patrol vehicle, he was stumbling and wanted assistance from deputies to help him walk. I advised Mark that he needed to walk by himself and stand in front of my patrol vehicle. Mark complied but walked and leaned against my vehicle hood to balance himself. I instructed Mark to step back and stand up without leaning on my hood. Mark complied and attempted to stand up straight. However, Mark began to sway back and forth. At one point, Mark almost lost his balance and fell to the ground.

After getting Mark to stand without falling, I asked him a few questions. I asked Mark if he knew where he was

located at. Mark stated, "Vero Beach." I asked Mark why he was so far from his house in Winter Springs, Florida. Mark advised a full story about him visiting his mother who was sick and he was on his way to her house which is located in south Vero Beach. I asked Mark if he consumed any alcohol before driving his vehicle. Mark advised he had a "few" before driving but felt he was "okay" to drive. As Mark spoke to me, I detected the odor of alcohol emitting from his breath. Mark's eyes were also bloodshot and watery.

Based on the evidence gathered, I asked Mark if he would submit to the Standard Field Sobriety Exercises (SFSE). Mark verbally advised, "No." I informed Mark of my observations, the adverse consequence of refusing the SFSE, and that a refusal could be used against him in court. Finally, I again asked Mark if he would perform the SFSE, and he verbally stated, "Yes."

Before starting the exercises, I asked Mark some preliminary questions. I asked Mark if he was sick or injured and if he was being treated by a doctor or dentist. He advised, "No." I asked Mark if he was diabetic, taking insulin or epileptic. Mark advised, "No." Finally, I asked Mark if he had any physical impairments and he stated, "No."

During the Horizontal Gaze Nystagmus, I explained the task to Mark. Mark stated he understood. Before attempting this exercise, Mark indicated he had no medical problems that would have prevented him from performing the exercise. Mark advised she was not wearing contacts. Mark' eyes were checked and displayed equal tracking, and her pupils were equal in size. After stating that he understood the instructions, Mark attempted this exercise. Mark was asked several times to follow the instructions. However, Mark moved his head several times and could not stand without stumbling during the exercise. I was able to observe a lack of smooth pursuit in both eyes. Mark had distinct and sustained nystagmus in her left and right eyes at maximum deviation. Finally, Mark had onset of nystagmus prior to 45 degrees. Mark also had vertical nystagmus.

During the Walk and Turn Exercise, I asked Mark to stand in the instruction phase of the exercise. Mark attempted several times but was unable to stand straight without almost falling over. At one point, Deputy Lowell had to assist Mark so he did not fall to the ground. Mark attempted several steps but was unable to walk past his third step without also failing to the ground. Due to Mark's safety and others, we were unable to complete the exercise.

Due to Mark's safety and others, I did not attempt the One Leg Stand exercise. This was due to his performance on his Walk and Turn exercise.

During the Finger to Nose Exercise, I explained and demonstrated the task, and Mark stated he understood. Before attempting this exercise, Mark indicated he had no medical problems that would have prevented him from performing the exercise. Mark was asked to touch his nose six times in the following order: left, right, left, right, left. During the first pass, Mark opened his eyes and touched his left eye. I had to explained to Mark that he needed to touch his nose, close his eyes, and lean his head back. As soon as Mark leaned back, he again also fell to the ground. Due to Mark's safety and others, we were unable to complete the exercise.

Based on the evidence gathered Mark was arrested for violation of F.S. 316.193 (1) - DUI.

During an inventory search of Mark's vehicle, I located on the passenger seat floor board a tumbler cup with ice and liquid in it. I opened the lid and detected the strong odor of alcohol emitted from within the cup. The outside of the cup was still cold to the touch.

After the search, I transported Mark to the Indian River County Jail. Upon arrival, Mark was turned over to

NARRATIVE

On July 25, 2025, at approximately 2331 hours, I was dispatched to 4715 38th Court, Vero Beach, Florida, in reference to a gray Dodge Durango that had crashed into the rear gate of Taylor Pointe Apartments, located at 4885 38th Circle, Vero Beach, Florida.

Prior to my arrival, Indian River County Sheriff's Office Dispatch informed me the caller advised the driver of the vehicle was intoxicated, and attempting to leave the scene.

As I traveled north on 38th Court, towards the scene, I observed a gray Dodge Durango leaving the scene. I conducted a Uturn on 38th Court and proceeded south after the Dodge Durango. The Dodge Durango made a left hand turn onto 45th Street running the stop sign, and proceeded east at a high rate of speed.

I conducted a traffic stop on the gray Dodge Durango bearing Florida tag LHZP08, at the intersection of 45th Street and 33rd Avenue, Vero Beach, Florida.

I approached the passenger side of the vehicle and made contact with the driver, Melissa Boulahanis. I immediately noticed her blood shot water eyes, and slurred speech as she spoke to me. I informed Melissa that I pulled her over, because the Sheriff's Office was informed, she struck a gate. I asked Melissa to exit the vehicle, I walked to the rear and made contact with her at the rear bumper of the Durango and asked her to stand in front of my patrol car. I could smell an alcoholic beverage emanating off of her breath as she spoke to me.

I conducted an NCIC/FCIC query of Melissa, as I waited for another Deputy to arrive on scene.

After I conducted the query, I requested Melissa submit to the field sobriety exercises, she verbally stated that she would. Prior to beginning the exercises Melissa stated that he does not have any physical defects. I asked Melissa if he wore glasses or contacts, she informed me she wore contacts.

The first exercise I demonstrated and explained was the Horizontal Gaze Nystagmus (HGN). I observed equal pupil size, equal tracking, and no resting Nystagmus in both eyes.

During her first attempt I observed a lack of smooth pursuit in both eyes, distinct and sustained Nystagmus at maximum deviation in both eyes, and Nystagmus prior to 45 degrees almost instantly. During the exercise I had to keep reminding her not to move her head. During the exercise I had to grab her shoulder, so she did not fall down.

The second exercise I demonstrated and explained was the Walk and Turn exercise. During the instructional phase Melissa had difficulty maintaining her balance, and staying in the position she was instructed to. She swayed side to side, and raised her arms to stabilize herself.

During her first set of nine steps, Melissa took fifteen steps, her first step she started her count on three instead of one as instructed. She failed to keep her feet heal to toe, and her arms by her side as instructed, on step 1, 6, and 7 she stepped off of the line. During the second set of nine steps, Melissa took fifteen steps, her first step she started her count on three instead of one as instructed. She failed to keep her feet heal to toe, and her arms by her side as instructed, she stepped off the line on step 3. Throughout the exercise Melissa failed to follow instructions.

NARRATIVE (Continuation)

The third exercise I demonstrated and explained was the One Leg Stand exercise.

During her first attempt she put her foot down 3 times, in the timed 30 second exercise, and was only able to count to 7. Throughout the exercise she utilized her arms for balance and continually swayed, until I informed her to stop.

Based upon the totality of the evidence Melissa was taken into custody for violation of FSS 316.193(1) DUI. After Melissa was taken into custody, she spontaneously uttered that she drove into the gate at the location mentioned above.

Melissa was transported to the Indian River County Jail for booking.

At the county jail Deputy Rodriguez #5661 requested Melissa to provide a lawful breath sample. She refused to provide a lawful breath sample. Melissa was read implied consent. Melissa refused to provide a lawful breath sample again after being read implied consent.

Melissa became very belligerent, and was placed in a holding cell, she screamed, yelled, and called Deputies names.

It should be noted, that after Melissa was taken into custody, she informed me her children were home alone. I contacted Deputy Glading who drove to Melissa's residence and made contact with the children. I provided Deputy Glading Melissa's fathers phone number. Deputy Glading informed me Mr. Boulahanis arrived at the residence to stay with the children. Mr. Boulahanis contacted me while I was at the Indian River County Jail, and asked what Melissa was being arrested for. I informed him, and he stated when she drinks, she becomes very belligerent. I asked Mr. Boulahanis if he could hear the screaming in the background, which he stated he could. I informed him that was his daughter being uncooperative. Mr. Boulahanis thanked me and advised he would get her at a later time.

Deputy Pollacek contacted Taylor Pointe Apartments, See his supplemental report for his involvement.

This investigation was captured on my agency issued body worn camera, and the front view camera of my marked patrol car.

The DUI packet for this case was submitted to records.

This investigation is cleared with the arrest of Melissa, for DUI with property damage, and accident leaving the scene.

NARRATIVE

On the afternoon of 07/25/25, I responded to 720 4th Street in reference to a disturbance past. Upon my arrival I made contact with the caller and staff member Marty Marcado. She explained that she called in reference to a incoming client had been physically abused by her husband. She further advised me the victim had several bruises. She directed me to a room where I made contact with the victim and identified her as Michelle Cambron. As I got closer to the victim, I observed several bruises on her arms.

While speaking to Mrs. Cambron she explained that the altercation with her husband Dean had been ongoing since 07/23/25. According to Mrs. Cambron the altercation began as verbal when Mr. Cambron accused her of cheating. Mrs. Cambron stated Mr. Cambron has struck her with both open and closed hands as well as kicked her numerous times over the last two days. More recently, she stated he came home for lunch and again engaged in a verbal altercation accusing her of having men run out the back door. Mrs. Cambron stated the altercation became physical when he began striking her in the back of the head and in her back. She pulled the back of her shirt down at which time I observed redness, swelling, and a small abrasion that appeared to be recent as it appeared to be wet blood on the surface of the abrasion.

On the morning of 07/26/25, Mr. Cambron was located at his residence He was taken in to custody without incident. Post Miranda Mr. Cambron stated that he and and his wife Michelle have been separated but are trying to work things out. He also stated that they do get in to arguments about cheating, that sometimes get out of control but he is not a "woman beater." When asked about Mrs. Cambron's bruises, he stated she bruises easily and often runs in to walls. It should be noted that the bruises I observed did not appear to be from "bumping in to walls" but that of being grabbed and struck or kicked.

Mr. Cambron is charged with Battery, Domestic Violence.

NARRATIVE NARRATIVE

On July 26th, 2025, at 1930 hours, I was dispatched to a trespassing in progress call, where the complainant advised to Public Safety Dispatch (PSD) that 3 male subjects, were attempting to force entry into her residence to recover a backpack containing controlled substances. The complainant told the male subjects she which she believed prompted them to leave. While enroute to her location, I located the suspect vehicle, a black Kia Soul bearing FL/ QZGH24, with 3 male subjects inside the vehicle none of which were wearing a seatbelt, traveling southbound on 27th Ave from Oslo Road. I spun around and got behind the vehicle to conduct a traffic stop when the suspect vehicle abruptly made a right-hand turn into the Shell gas station located at 975 27th Ave SW, and pulled into a parking spot in front of the store. After initiating the traffic stop, the driver, jumped out of the driver seat and attempted to exit the vehicle.

After issuing the driver verbal commands to stay seated inside the vehicle, I requested that he provide me with his valid driver's license, vehicle registration, and valid proof of insurance for the vehicle; too which the driver expressed he did not have his driver's license with him. Shortly after initiating the traffic stop, I arrested the driver for violation of FSS 322.03(6), Expired DL (more than 6 months).

After detaining the driver, I spoke with the two passengers prior to searching the suspect vehicle, and asked both of them, if there were any items in the vehicle I should know about. Both subjects stated there were not. Once I began searching the vehicle, I asked both passengers when was the last time they had smoked marijuana inside the vehicle, due to the strong odor of burnt marijuana emitting from the interior of the vehicle. One of the passengers, later identified as Gary J. Gregory, stated that he had just smoked earlier in the day prior to leaving to travel to the complainant's house. Upon searching the vehicle, I located a large amount of loose marijuana shake scattered on the front passenger seat where Gary was seated. Additionally, I located a mostly burnt marijuana joint commonly referred to as a "roach" in the passenger front door panel. I collected some of the green leafy substance and utilized an agency issued drug field test kit to test the substance for the presence of THC. After testing the green leafy substance, the field drug test kit changed to an orange color, positively indicating the presence of THC.

After testing the loose marijuana, I located a used vape cartridge in the center console of the suspect vehicle. Gary observed me collect the cartridge and place it on my patrol vehicle's hood, too which he informed me that the cartridge belonged to him and that it was only nicotine. I then replied that I was going to test the substance for THC and that I did not believe the cartridge was a nicotine cartridge. Gary then backtracked and stated that the cartridge did not belong to him and he had no idea where it came from.

I then utilized an agency issued field drug test kit and tested the vape cartridge's contents for the

The vehicle continued to travel westbound on Main Street passing Easy Street at a pace speed of 40mph and at one point 41mph. The vehicle maintained the speeds of 40mph as it approached the intersection of Main Street and Fleming Street. At that time, I activated my emergency lights on my marked patrol vehicle and initiated a traffic stop on the white SUV bearing Florida Tag of 90ETEP. The vehicle came to a complete stop at 278 Main Street located in Sebastian Florida. I made a driver side approach and made contact with the driver. I identified myself and informed the driver of my reasoning for the traffic stop. The driver stated he was only doing 37mph in a posted 30mph zone. I explained my reason and he proceeded to hand me his Florida Driver's License. The Driver was identified as Michael Arthur Pierro Jr. (DOB of 06/20/1978). As the driver continued to search for his registration and proof of insurance, I asked the driver if he consented to me to searching his vehicle. The driver stated no. Once I received his registration and proof of insurance, Canine Officer Smith (K959) was also on scene and I informed him about the driver not providing consent to search the vehicle. I proceeded to my vehicle and continued the flow of the traffic stop as K9 Officer Smith made contact with Michael. Officer Smith made contact with Michael while I was in my patrol vehicle. Officer Smith said he explained to Michael that he was going to perform an exterior sniff of his vehicle with his K9 partner. Michael refused to exit the vehicle. Officer Smith said he explained to Michael that he was legally required to step out of the vehicle during a traffic stop to which Michael refused once again. Officer Smith told Michael that if he did not exit the vehicle that he was under arrest. Knowing this, Michael refused once again and said that he was just going to have to go to jail. Officer Smith reached in the open window and unlocked the door. Once it was opened Michael was restrained in handcuffs. - Driving or in actual physical control of a motor vehicle upon a public road/ highway within this state to wit 12th Court and 19th Place in the City of Vero Beach, Indian River County;

- Under the influence of alcoholic beverages; and

 Affected to the extent that the person's normal faculties were Impaired.

On 07/27/25 at approximately 0200 hrs. I, Ofcr. S. Gonzalez (471), was traveling east on 19th Place approaching 12th Court when I observed the Defendant make a right turn onto eastbound 19th Place in the City of Vero Beach, Indian River County, Florida.

What drew my attention was that the Defendant failed to stop at the stop sign at the corner of 12th Court and 19th Place before making her turn.

Upon observing the violation, I caught up to and fell in behind the Defendant's vehicle once across the railroad tracks where 19th Place then becomes 20th Street in the center lane approaching 11th Avenue.

As we approached and came to a stop at the traffic light at 10th Avenue, the Defendant activated her left turn signal, indicating that she intended to turn left onto 10th Avenue from the center lane, however, shortly after stopping, the Defendant deactivated her turn signal. Once the light turned green, the Defendant appeared to pause momentarily before proceeding through the intersection.

Once though the intersection, the Defendant changed lanes to the dedicated right turn lane to southbound U.S.-1.

Once traveling south on U.S.-1 I initiated a traffic stop by activating the emergency lights on my fully marked police vehicle. In response, the Defendant slowed and drifted over the sold white line to the left such that both right side tires momentarily rode on and crossed over the line fore correct back to the left and then turning into the parking lot of the McDonald's restaurant located at 1925 U.S.-1 in the City of Vero Beach.

The Defendant came to a full stop in the parking lot's through-way as opposed to pulling into a parking space. Once stopped, I exited my vehicle and made a driver side approach.

As I approached, I noted that the Defendant was the sole occupant and driver of the vehicle.

Upon making contact with the Defendant, I requested her driver's license and registration.

At this time, I noted that there was a strong odor of alcohol emanating from within the vehicle.

The Defendant stated "Sure baby" and handed me her license but not her registration which I asked for again; the Defendant provided me with two expired registration slips.

After confirming that the information on her license and registration was current and correct, I informed the Defendant as to the reason for the stop in that she had failed to stop at the stop sign as described herein-above. I was able to identify the Defendant by her Florida drivers license as JESSICA NINOSKA SANCHEZ.

The Defendant then began to allege that she ran the stop sign because she was unfamiliar with the area because she lives in Port Saint Lucie.

I asked the Defendant as to her whereabouts prior to being stopped, however, the Defendant had difficulty explaining where she had been and reiterated multiple times that that she was on her way back to Port Saint Lucie.

During my initial contact with the Defendant at her vehicle, she stated that she worked for Port Saint Luce Human Resources and further made statements to the effect that she was involved in the hiring of police officers.

During this time Corporal O. Dominguez (498) arrived on scene as well as Ofcr. I. Covarubia (450).

As I retreated to my vehicle to conduct a license and registration check, I asked Ofcr. Covarubia to try to obtain a current registration from the Defendant.

After checking the Defendant's license and registration, I exited my vehicle and re-approached the Defendant's vehicle and observed as Ofcr. Covarubia was asking the Defendant to exit her vehicle and it appeared that the Defendant was not

wanting to comply, however, after Ofcr. Covarubia repeated his request, the Defendant exited her vehicle.

Once out of the vehicle, I attempted once again to determine the Defendant's whereabout's prior to being stopped. However, once again, the Defendant appeared to have difficulty recalling or coherently explaining where she had been and so therefore, here whereabouts prior to being stopped remained unclear to me.

When I asked the Defendant how much [alcohol] she had to drink she insisted that she had only one [alcoholic] drink.

During this time, I noted that that the Defendant displayed a noticeable and obvious sway while standing, there was a strong odor of an alcoholic beverage emanating from her breath as she spoke, her speech was thick tongued and confused and her eyes appeared red and glassy.

Based on the totality of the foregoing as well as my training and experience, I had a reasonable suspicion to believe and concern that the Defendant was impaired.

I informed the Defendant of my concern and that as such I wanted to afford her the opportunity to dispel said concern by performing some [Field Sobriety] exercises ("FSE's".

Throughout my contact with the Defendant to this point, the Defendant repeatedly interrupted and spoke over me as I spoke and repeatedly asserted that she was involved in the hiring of officers.

Before administering FSE's, I asked the Defendant if she was taking any medications. The Defendant stated that she took anxiety medication and indicate that she did so sporadically.

I then asked the Defendant if she had any injuries illnesses or disabilities to which the Defendant again went off on a tangent about usual aches and pains before stating that she had some sort of left wrist injury and a bruise on her leg. The Defendant later indicated that she suffered from Carpal Tunnel Syndrome on her wrist. Also, the Defendant stated that she did not wear contact lenses.

I then administered Field Sobriety Exercises ("FSE's")

The area was well lit and the ground was level and free of debris. An approximately 12 ft. length of masking tape was used for the walk and turn.

HGN (Horizontal Gaze Nystagmus)

The instructions were explained and partially demonstrated multiple times because the Defendant kept interrupting and starting the exercise too soon before the Defendant stated that she understood them.

- Noticeable and obvious sway:
- Equal tracking and pupil size (Both eyes);
- Lack of smooth pursuit (Both eyes);
- Distinct and sustained nystagmus at maximum deviation (Both eyes);
- Onset of nystagmus prior to 45 degrees (Both eyes).
- Defendant repeatedly failed to keep her head still and moved her head during the exercise.

WALK AND TURN (WAT) The instructions were explained and partially demonstrated multiple times because the Defendant kept interrupting and starting the exercise too soon before the Defendant stated that she understood them.

- Noticeable sway during instruction phase;
- Unable to maintain balance
- Repeatedly stepped off the line during instruction phase;
- Missed heel-to-toe throughout the entire exercise;
- Stepped off line x3;
- Failed to count steps out loud;
- Improper turn (turned other than as instructed);
- Failed to keep arms by her sides / Used arms for balance.

ONE LEG STAND (OLS) The instructions were explained and partially demonstrated multiple times because the Defendant kept interrupting and starting the exercise too soon before the Defendant stated that she understood them.

- Noticeable sway:
- Right leg up;
- Failed to Raise leg or perform exercise as instructed.
- Failed to keep arms by her sides / Used arms for balance

- Used wrong hand

Based on the totality of the foregoing, I placed the Defendant under arrest for DUI and informed her accordingly.

While enroute, the Defendant repeatedly asserted her employment and position.

Once at the jail and after a 20 minute observation, the Defendant was asked to submit to a test of their breath for the purpose of determining its alcoholic content.

The Defendant refused to consent to a lawful test of her breath and was read her implied consent after which the Defendant maintained her refusal to submit to a test of her breath.

The Defendant was then turned over to the custody and control of detention personnel for further processing and booking.

As I walked by on one occasion, the Defendant thanked me for ruining her life and stated in an ominous tone "I never forget a face". The Defendant was then lead away by corrections personnel moments later.

Roadside contact with the Defendant was recorded with the use of my body-worn and in-car cameras as well as the bodyworn cameras of Ofcr. Covarunbia and Cpl. Dominguez.
