Parker stated the following: "I, API Jacob, while conducting routine CCTV surveillance of the grocery self-checkout observed an individual now known to me as Haley Berg underringing while at self-checkout register #46. I observed Haley Berg hold a pack of bacon underneath a pack of chicken drumsticks passing both items across the scanner at the same time effectively only scanning the bottom item before bagging both items. I also observed Haley Berg hold multiple like items, such as two apple sauces, only scan one item before bagging multiple. This method was used throughout the transaction. Upon completion of the transaction Haley Berg passed all points of sale by exiting the Grocery Exit where I stopped Haley Berg while identifying myself as Wal-Mart Asset Protection. Haley Berg was escorted into the AP office where all merchandise was sorted and recovered. Haley Berg scanned (19) items totaling \$96 while failing to scan (12) items totaling \$85.78. IRC SO was notified. Wal-Mart wishes to prosecute and trespass Haley Berg. End of Statement."

I made contact and identified the subject as Haley Berg Laverack. I read Laverack and read her Miranda rights, and she acknowledges that she understood. Laverack stated that she paid for the some of the items but forgot to pay for the other 11 items that was in his cart. Laverack said she intentionally did not pay for the chicken. Laverack stated that she did have the money and was willing to pay for it.

Laverack passed all point of sale and failed to pay for 12 items from Walmart totaling \$85.78 and paid for (19) items totaling \$96.00.

Laverack is being charged with Florida statute 812.015(1)(d).


It should be noted that Laverack is currently married but goes by her maiden name Berg.

NARRATIVE

On August 11, 2025, at approximately 15:12hrs, I responded to 3109 1st Street in Vero Beach in reference to a disturbance. The caller, Brittany Mayer, advised she had received a call from her mother stating she was attacked by her sister.

Upon arrival, I made contact with the two involved females, identified as Brenda Decker and Trisha Mayer. Trisha advised she had picked Brenda up earlier in the day, and stated Brenda had been drinking all day. Trisha stated she went to pick her 4-year-old grandson up from school, and when she returned to the residence, Brenda began arguing with her. Trisha stated at one point, Brenda was standing near the front door outside of the residence. Trisha stated she attempted to shut the front door on Brenda, at which time Brenda shoved her way into the door, knocking Trisha onto a chair just inside the residence. Trisha stated she started trying to stand and get away from Brenda. Trisha stated Brenda then wrapped her arm around Trisha's neck and would not let her go. I asked Trisha if at any time she could not breathe, but she said at no point was her airway restricted.

As I was speaking with Trisha, Brenda was becoming increasingly belligerent. I advised Brenda several times to stop talking while I questioned Trisha, but she neglected to follow instructions. Brenda was seemingly heavily intoxicated, and kept yelling and interrupting my conversation with Trisha. I told Brenda to stand up and place her hands behind her back, as she was being detained. Brenda complied, and was placed in handcuffs and escorted to the back seat of my patrol vehicle. Several attempts were made to read Brenda her Miranda Warnings, but she was increasingly argumentative.

I spoke with Brenda and Trisha's mother, Carol Decker, who was inside the residence where the incident took place. Carol stated Brenda and Trisha were arguing, and the argument escalated to the point that Brenda began physically touching Trisha.

Brenda was informed she was being placed under arrest for violation FSS 784.03 – Battery DV. She was transported to the Indian River County Jail without incident.



NARRATIVE

On Monday, August 11, 2025 at approximately 2152 hours, I conducted a traffic enforcement stop of a white Dodge Ram 1500 bearing Florida tag "NPQW75."

While waiting for the light to change at the intersection of Main Street and US Highway 1, I observed the above vehicle fail to stop at the stop sign located on the North side of Indian River Dr and Main Street. The vehicle then proceeded North on US Highway 1 and accelerated at a high rate of speed. I paced the vehicle in my patrol car (IRCSO Unit #379) reaching approximately 65 miles per hour in a posted 35 mile per hour zone. I continued to pace the vehicle into a posted 45 mile per hour zone at over 60 miles per hour as the vehicle weaved through traffic. At one point the vehicle was well within one car length of the vehicle in front of it. The vehicle then attempted to make a U-turn at a high rate of speed and narrowly missed a collision with a road sign in the center median. I initiated a traffic stop as the vehicle turned, the vehicle pulled into the parking lot at McDonalds where it ran over a curb and came to a final rest outside of the marked stall with no other vehicles around.

I made contact with the driver and sole occupant of the vehicle, who I identified as Mr. Richard Brognano (Arrestee). Richard was attempting to light a cigarette. I introduced myself and explained the reason for the lawful traffic stop, further requesting his driver's license and registration documents. I could smell the distinct odor of an alcoholic beverage emitting from his breath as he spoke with me, his eyes were watery and his speech was slurred.

When I asked Richard where he was coming from, he told me his residence. I asked him to clarify where his residence was and he was uncooperative and refused to provide any further details. I confronted Richard on his direction of travel which was opposite of the direction of his house and he stated in substance: "the route I travel is no business of yours!" Richard denied consuming any alcohol and stated he takes prescription medication to help him sleep. Richard refused to provide the dosage or the last time he consumed his medication.

I asked Richard to exit his vehicle, and when he did, he immediately leaned on the vehicle lost his balance, almost falling down. While outside of his vehicle, I continued to question Richard and while speaking with him, I could still smell the distinct odor of an alcoholic beverage emitting from his breath. I explained to Richard my suspicions of impairment and requested he complete Standard Field Sobriety Exercises (SFSE's), which he refused. I provided Richard with a Taylor warning and explained my probable cause, Richard still refused and was placed under arrest for Driving Under the Influence.

Richard was placed in handcuffs and placed in the rear seat of my patrol vehicle. Richard stated he had to urinate and was advised multiple times he would have to wait until he was processed into the jail.

Upon arrival to the Indian River County Jail, Richard was uncooperative with jail intake staff and refused to provide his information to the jail nurse and booking deputy when they retrieved him from the vehicle.


