I read Bove her Miranda Rights which she understood. She admitted to not ringing the items. She advised she knew it was wrong but continued to proceed with the transaction.

Bove was transported to the IRCSO Jail without incident, and turned over to Booking Deputies where she was charged with MISD 2ND DEG PETIT THEFT.

This was recorded on my agency-issued body worn camera.

### NARRATIVE

On Tuesday, August 12 <sup>th</sup> 2025, at 1205 hours, I responded to
Justin Ellis, pointed a firearm at her. Floyd advised she was inside of the residence from approximately 11:15 hours until 11:40 hours. At approximately 11:40 hours, Ellis exited his room, observed Floyd, then walked into his mother's room. He came out with a plack gun box and pulled out a black handgun. Floyd advised Ellis pointed the black handgun at her. While pointing the irearm at Floyd, Ellis yelled at her to get out of the residence. She advised she was in fear of being shot and she left immediately. When asked where Ellis got the firearm from. She advised he got it from his mother's room, possibly from the closet. Floyd advised the black handgun was possibly a Beretta, due to Ellis telling her about it before. Floyd advised she was only in the residence due to being invited over by Ellis' mother to help care for their son Aed Ellis. Floyd said she is afraid that when Ellis is released, he will kill her.
When I approached Ellis, he was seated on the front steps of the residence. I asked him if he had a firearm on him. He advised he did not, and that there were firearms in the residence. While talking to Ellis, I observed him to be wearing baggy dothes. At one point, prior to being searched, Ellis reached into his pocket, which prompted me to secure him in handcuffs. Ellis provided consent to search his person. No weapons were located. I secured Ellis in the rear of my marked Indian River County Sheriff's Office patrol vehicle. I read Ellis his Miranda Rights. He advised he did not understand.
Vhile clarifying some information with Floyd, I was approached by Sergeant K. Taylor of the Fellsmere Police Department. He dvised he contacted Ellis' mother and she advised there were only two rifles inside of the residence.
responded to the residence and contacted Ellis' mother Lynette Kirk. I advised Kirk that I knew there were more firearms han what she told the Fellsmere Officers about. She advised if there was another firearm in the residence, it would be in her boom behind her headboard. I asked Kirk for consent to go into her room to recover the firearm, she provided verbal consent. It should be noted that her room does not have a door that can be locked to secure it. Kirk was seated inside of the ving room when I entered her room. The room is attached to the main living space where Kirk was seated. I stepped into the corway and immediately to my right I observed the headboard to be leaning on the wall that separates the bedroom from the main living space. Under the headboard on the floor, I observed what appeared to be a gun box. I observed one of the wo clasps on the box to be unclipped. There was no lock or locking ability attached to this gun case. Kirk advised that no rearm was pointed at anyone. She further advised this event occurred because of her accidentally asking Floyd to come wer. She advised that all of the firearms in the house are unsecured. She further advised that she was unaware that Ellis bould not have immediate access to the firearms.
nside of the box that was located in Kirk's room, I located a black Beretta handgun bearing serial number BER461857. I located multiple loaded 9mm magazines with (عَلَى الْمُعَامِّ rounds in total. The handgun was unloaded. I secured the box containing the firearm and the magazines in the rear of my aforementioned patrol vehicle.
returned to my patrol vehicle. I asked Corporal L. Newberry to re-read Ellis his Miranda Rights. At first Ellis advised he did of understand again. After a moment, he advised he understood his Rights. I asked him to tell me what happened. He dvised he woke up and observed Floyd inside of his residence. He advised he told her to get out of his residence, but denied

having the firearm in his possession. I asked him if he knew where the firearm was. He advised that approximately one week
ago, he cut open the safe that was located in the residence and had access to all of the firearms and ammunition inside of the
safe. He advised Kirk pawned or sold all of the firearms from the safe except two rifles and one pistol. However, he denied
knowledge of the location of the firearm. Ellis advised he only wanted Floyd out of his residence.

### NARRATIVE

On Tuesday, August 12 2025 at approximately 2205 hours, I conducted a traffic enforcement stop on a grey Ford F150 bearing Florida tag "HFWL43."

I was traveling South on US Highway 1 near Main Street in Sebastian when I observed an unknown white male leaning over near the hood of his truck, bracing himself with his hand and appeared to be urinating on the tire of his truck. I made a U-turn at the light and observed the vehicle traveling East through the parking lot towards Indian River Drive. I followed the vehicle northbound on Indian River Drive, I paced the truck (IRCSO Unit# 379) traveling at over 40 miles per hour in a 30 mile per hour zone. I also observed the truck travel across the double yellow lines.

I initiated a traffic stop and made contact with the driver and sole occupant of the vehicle, Mr. Ronald Romeo, who I identified by his Florida Driver's license. I observed Mr. Romeo was wearing sunglasses while driving at night and when he spoke to me, his speech was slurred. I could smell the distinct odor of an alcoholic beverage emitting from his breath when he spoke. Ronald stated he was coming from the 'Tiki bar" and had consumed approximately 3 alcoholic beverages over the span of approximately 3 hours.

I asked Ronald to exit his vehicle. When Ronald exited his vehicle, I observed a large stain in the crotch of his shorts, consistent with urination. While standing, Ronald had an approximately 2 Inch orbital sway. I explained my suspicions of Ronalds impairment and requested he complete Standard Field Sobriety Exercises (SFSE's). Ronald initially refused and stated his right eye was fake and caused balance issues. Ronald requested to take a breathalyzer on scene. I explained the exercises to Ronald who then agreed to complete them. I questioned Ronald about his medical history and he did not disclose any other information other than his eye. Ronald denied taking any medications or being under the care of a physician.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the exercise and instructions to Ronald, who stated he understood. Ronald had extreme difficulty following the stimulus and had to be instructed multiple times to follow the stimulus and also to not move his head. Ronald also had to be instructed into the starting position several times. I observed Lack of smooth pursuit, and Distinct and Sustained Nystagmus at maximum deviation in Ronald's left Eye. Ronalds right eye remained focused straight ahead during the exercise. Ronald swayed while completing this exercise.

The second exercise I administered was the Walk and Turn (WAT) exercise: I explained the exercise and instructions to Ronald. Ronald was unable to assume the starting position as instructed and refused to complete this exercise. Ronald made a comment during this exercise and stated "I couldn't do this even if I was super sober!"

### NARRATIVE (Continuation)

The third exercise I administered was the One Leg Stand (OLS) exercise: I explained the exercise and instructions to Ronald. Ronald refused to attempt this exercise.

The fourth exercise I administered was the Modified Romberg Balance (MRB) exercise: I explained the exercise and instructions to Ronald who stated he understood. Ronald was given instructions to tilt his head back, close his eyes and count inside his head to thirty (30) before tilting his head forward and saying the word "stop." Ronald began counting aloud and was reminded of the instructions. Ronald had an orbital sway while completing this exercise and counted to twenty-six (26), within the allotted +/- five (5) seconds. However, Ronald failed to use the instructed word "stop" and instead stated "okay."

Based on the above indicators of impairment, I placed Ronald under arrest for Driving Under the Influence. Ronald stated he would submit to sample of his breath upon arrival to the jail. Ronald was transported to the Indian River County Jail without incident.

Upon arrival to the Indian River County Jail Complex, Ronald was taken into the DUI processing room. Deputy Shuren (5930) requested Ronald to provide a sample of his breath and he refused. Deputy Shuren advised Ronald of implied consent and again requested Ronald provide a sample of his breath. Ronald refused again.

Ronald was charged with Driving Under the Influence (AJ8SYAE) and issued a citation for crossing the median strip (AF1V82E). Ronald was booked into the Indian River County Jail on a total bond of \$1,000.00.
