NARRATIVE

On May 14, 2025 at approximately 03:45 hours, I responded to 4055 41st Avenue (Indian River County Jail), in reference to a physical disturbance between inmates within a jail cell.

Upon my arrival, I spoke with booking jail staff who informed me that a physical disturbance had occurred and the victim wanted to press charges. The suspect was later identified as Lieb Santi Wexler and the victim was identified as Philip Cimmino. I observed a video from a security camera footage inside of the jail cell that clearly showed Wexler physically attack Cimmino while he was laying on his bed. From the camera footage, I observed Wexler to be the primary aggressor and the only individual that was being aggressive. Wexler attacked cimmino to the point he was bleeding from his face and his clothes had fallen off. Cimmino was seen in the video laying defenseless on the bed trying to defend himself against Wexler's attacks.

Furthermore, into the investigation, I questioned both Wexler and Cimmino.

Cimmino stated that while he was inside of his cell, Wexler stated he couldn't take it anymore and did not want to share his cell with another person. Cimmino stated that Wexler took out his anger on him and began to attack him. Cimmino stated he tried to defend himself and Wexler continued to hit him in the head and face while he was laying on his bed. Cimmino had a cut on his forehead where he was bleeding from.

Wexler was read his Miranda Warnings and he advised he understood them. Post Miranda, Wexler advised there was an altercation inside of the cell and he stated that Cimmino was talking inappropriate. Wexler stated Cimmino's language bothered him, therefore he got confrontational with Cimmino and went up to him to "subdue" him.

Cimmino stated he wanted to press charges for being attacked inside of his jail cell.

The camera footage of the fight was captured on my agency issued Axon body worn camera as well as the rest of the investigation.

NARRATIVE .

On Tuesday, May 13, 2025, at approximately 1220 hours I was dispatched to 1459 20th Street in reference to a violation of a no-contact order. Upon arrival, I contacted the complainants, Valerie A. Muth and Carmen P. Carpio. They reported observing Milton Leroy Grier at 4207 28th Court, despite an active no-contact order issued by Judge R.D. White on May 11, 2025.

Valerie and Carmen explained that they were at Jimmeara Grier's residence (4207 28th Court) to conduct a welfare check when they saw Milton park his vehicle at 4221 28th Avenue. He then walked across to 4207 28th Court and tried to enter the home through the front door but was unsuccessful.

While speaking with Valerie and Carmen, I requested Deputy Newman to locate Milton at 4207 28th Court. Upon his arrival, Deputy Newman found Milton standing in the driveway of Jimmeara Grier's home.

As Milton was located within 500 feet of the victim's residence, I placed him under arrest for violating his pretrial release conditions (312025CF000520AXXXVB), which prohibit him from approaching the victim's residence. Milton acknowledged his awareness of the no-contact order, having signed the relevant form prior to his release from custody.

Upon arrival, I contacted the complainant, Burlington manager on duty, Steven Hutchison, who advised a black female shoplifted from the store. I observed video footage of the event. In the video footage I observed a black female wearing a green shirt, white hooded jacket and black pants. In the video, she takes a dark clothing item and place them into her green shopping bag.

While speaking to Hutchison, I was alerted by Sergeant (Sgt) A. Scranton, that he located the suspect. I approached the suspect and Sgt. Scranton. I asked the suspect for consent to search her bag. She provided consent. I observed a dark blue pair of shorts and a pink pair of shorts in the bag. I did not observe any tags on the items.

I walked down the covered area where Sgt. Scranton located the suspect, now identified as Claudia Craig. Where she was seated, we located a tag bearing the same name as the clothing item "Dakota Blue". I returned to Craig and advised her of her Miranda Rights. Craig advised she understood. I asked Craig where she got the shorts, she advised the clothes were given to her from a church service.

I returned to the store to review the footage. While viewing the footage, I was advised by Sgt. Scranton that she confessed to the crime. I reviewed the video for the times of each event. At 0832 hours, Craig places the clothing item in her bag. At 0836 hours, she passes all points of sale, leaving the store. I returned outside and placed Craig into handcuffs that were checked for fit and double locked. I asked Craig why she took the items. She advised she was extremely hot last night and she needed to change her clothes. She did not want to wait for the church service to open at 11am. Craig advised she knew that she passed all points of sale. I secured Craig in the rear of my marked Indian River County Sheriff's Office patrol vehicle.

I returned into the store to confirm the values of the items. Due to the Burlington price tag being removed, I was forced to use items that resembled the clothing that was stolen. The dark pair were listed for sale at \$11.39. The pink pair of shorts were listed at \$9.99.

Based on the information above, I found Claudia Craig to be in violation of F.S.S. 812.015 Retail theft. I transported Craig to the Indian River County Jail without incident.

being on her knees trying to stand up when Kevin was on top of her. There was one scratch on the right side of her arm under her shoulder. We did not observe any red marks or abrasions around McLaughlin's neck.
We attempted to make contact at Kevin's residence to which no one answered the door. We announced ourselves as the Sheriff's Office repeatedly and were met with no results. We attempted to knock on all windows and doors of the residence with no response. We staged two marked patrol vehicles at the front of the residence with our lights on and Kevin did not answer. Deputy Martinez used the PA system to make announcements both in Spanish and in English with no response. After speaking with Mclaughlin she attempted to call Kevin but he did not answer. Mclaughlin later stated was sending her screenshots of their messages to which Kevin was telling her he was scared. We made multiple attempts to get Kevin to come out. Eventually, he came to the front door.
Kevin predominately spoke Spanish so Deputy Martinez was able to translate Kevin's statement. Kevin stated that Mclaughlin was the aggressor. Kevin said that he was hit with the hammer on both sides of his shoulders. Kevin explained that the conversation escalated after Mclaughlin found out Corporal Lang examined Kevin for injuries but Kevin had no signs of swelling, redness, or bruising to corroborate his statement.
Mclaughlin viewed Kevin and was able to postively identify Kevin as the suspect.
