NARRATIVE

On September 10 th , 2025, at 1803 hours, I located Xvaria Lanera Thornton at a homeless camp situated between 3rd Street and 5th Street Southwest, Vero Beach, Florida, just north of 5th Street Southwest near the canal. A query through the Indian River County Public Safety Dispatch (IRCPSD) revealed that Thornton had an active Indian River County warrant (#312011DR1395) for Failure to Pay Child Support, with a purge amount of \$100.00 Thornton was taken into custody and transported to the Indian River County Jail without incident. IRCPSD further advised that Thornton also had an active Saint Lucie County warrant (#562005DR003526A) for Failure to Pay Child Support, with a purge amount of \$100.00. A hold was placed on Thornton on behalf of the Saint Lucie County Sheriff's Office following extradition.

NARRATIVE

On September 10th, 2025, at approximately 1951 hours, I was located in the area of Highland Drive SE and Old Dixie Highway SE. I observed a vehicle drive Westbound on Highland Dr. SE without the rear of the vehicle illuminated at all. The tail-lights were not on, nor were the vehicles registration plate lights. The vehicle was difficult to see when it was not illuminated by other vehicle's headlights. It should be noted sunset was at 1932 hours according to Google and it was dark outside due to the lack of sunlight. Due to the observed violation, I conducted a traffic stop on the vehicle in the area of the 600 block of Highland Drive SW.

The vehicle was identified as a Nissan bearing Florida registration 0693UE. I approached the operator, identified as Nelson Celin, informed him the reason for the stop, and asked for his license, registration, and proof of insurance. He was unable to produce any of the requested documents. I asked if he had a license, which he stated yes. I collected his name, date of birth, and social security. During the conversation, he informed me this was not his vehicle, and his vehicle was supposed to have an interlock device.

I returned to my agency vehicle, where I ran his information through DAVID. I observed his license to be canceled due to a failure to complete substance abuse treatment. I conducted multiple queries of the vehicle through law enforcement databases, which resulted in no active registration. I conducted a query of the VIN, identified as 3N1AB7AP3FL690294, in DAVID. This resulted in no active registration, and no insurance on file. The registration plate came back to a VIN which was different from VIN of aforementioned Nissan. The registration plate which was displayed on the vehicle expired on July 17th, 2023.

Nelson was asked to exit the vehicle and walk to the hood of my agency vehicle. I spoke with him regarding his license and interlock device. He explained during the time I was checking information within my vehicle, his brother who he was on the telephone with stated he did not have insurance or the registration for the vehicle. I asked Nelson about his license which he stated his license was probably suspended due to him not completing a substance abuse class. I also asked about the interlock device, which he stated his vehicle was broken and thus he could not drive it. Nelson was detained, handcuffed (double locked/checked for fit), and placed into my agency vehicle's back seat.

Corporal K. Kramer responded to assist. During my conversation with Nelson, he demonstrated a clear knowledge of his license status, and admitted that the Nissan had a no registration and insurance. I also observed a lack of an interlock device within the vehicle.

Dispatch would run Nelson. They advised his license was suspended and canceled, along with a

restriction on his license. The restriction showed "probation-interlock."

The vehicle's tag was seized and a tow was a called for the vehicle. Nelson was transported to the IRCSO Jail. Cpl. Kramer radioed me and advised during the inventory of the vehicle she discovered what was identified as cocaine folded up within a dollar bill on the passenger side floor. The substance was field tested, which resulted positive for cocaine. The dollar bill with the cocaine rolled up inside it, was packaged in a brown paper bag. Cpl. Kramer submitted the cocaine packaged as such with a total package weight of 10.87 Grams.

It should be noted, Nelson was the sole operator of the vehicle at the time of the arrest. Additionally, he stated multiple times his brother is away in another state, and thus he was the one driving the car.

An interview was conducted with Nelson on September 11th, 2025, at approximately 0245 hours. Nelson was read his Miranda rights, where he acknowledged he understood every line of it. He chose to speak with me after understanding all of his rights. He ultimately stated the cocaine was his. He explained he was given it approximately 2 weeks ago by a friend. He stated his wife found it approximately 2 weeks ago, where he hid it within his phone case. He explained the dollar bill with the cocaine stayed in the phone case, until I pulled him over. He stated he then threw it on the passenger floor.

NARRATIVE

On September 11, 2025, at 0231 hours, I conducted a traffic stop at the 6900 block of 66th Avenue in reference to a vehicle hit on the Flock cameras (vehicle registered owner had active warrants).

I located the vehicle traveling south bound on 66th Avenue from the 7300 block. Conducted the traffic stop at the 6900 block of 66th Avenue. The driver and sole occupant of the vehicle was identified as Denise Nicole Smith. I check Smith's information via dispatch. I was informed Smith had an active warrant out of our agency for two counts for possession of controlled substance (Oxycodone).

Smith was asked to exit the vehicle. A search of Smith's person was being conducted prior to being transported to the county jail. Smith was asked to separate her legs. Smith moved her right leg out to her side. A cracking sound was heard and a long thing cylinder glass pipe was seen broken next to her right foot. The item was picked up. The glass pipe was observed to have black markings through my training and experience are consistent with burn marks observed on items used to burn/melt down drugs. Through my training and experience, I was able to determine the glass pipe with the black markings was an item commonly used to consume illicit drugs. The pipe also had blood on and in it.

Denise Smith was placed under arrest and transported to Indian River County Jail and arrested for 1 count for possession of drug paraphernalia. Once at the jail, I overheard the Smith needed a sanitary pad due to her being on her menstrual cycle.



The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law: 09/11/2025 01:25 On , at (Specifically include facts constituting cause for arrest.)

1) BATTERY in that the Defendant did:

- Actually and intentionally
- Touch or strike the Victim, Marvin Matthew Byrd
- Against the will of the Victim, and
- Did intentionally cause bodily harm to the Victim, to wit, various cuts and abrasions
- Contrary to Florida Statute 784.03(1). (1 DEG MISD)

II) DISORDERLY INTOXICATION in that the Defendant was:

- Was intoxicated; and
- Endangered the safety of another person or property; and
- Was intoxicated and drank an alcoholic beverage in a public place or in or upon a public conveyance; and
- Caused a public disturbance, contrary to Florida Statute 856.011(1)

On September 11, 2025, I, Officer S. Gonzalez (471), was dispatched to Dom's Bar, located at 1436 Old Dixie Highway in Vero Beach, Florida, in response to a physical altercation.

Upon arrival, I was informed that the defendant had left the scene on foot, walking south on Old Dixie Highway. He was described as wearing khaki shorts, no shirt, and being intoxicated.

I located an individual matching the description walking south on the sidewalk along Old

Dixie Highway, across from Crestlawn Cemetery. As I approached the Defendant, I observed that he appeared unsteady and was staggering.

When I made contact with the Defendant, I immediately detected a strong odor of an alcoholic beverage emanating from his breath and person. He was also sweating heavily and had abrasions and appeared to be bleeding from his lip and right eye.

When I spoke with the Defendant, he rambled incoherently. His speech was nonsensical and unintelligible. For my safety and his, I secured the Defendant and placed him in the back of my patrol vehicle. I then requested that EMS respond to the scene to assess him for any injuries.

I then made contact with the victim, who also had a strong odor of alcohol on his breath. The victim stated that the Defendant had confronted him for unknown reasons, initiating a heated verbal altercation. This then escalated, with the Defendant throwing a punch and taking the victim to the ground. The victim stated that he engaged the defendant in order to defend

The Victim sustained some abrasions to the back of his left shoulder and appeared to have minor cuts on his face, specifically on the bridge of his nose and forehead, which indicated to me that he was likely hit in the face during the altercation.

I then spoke with a witness who stated that, although she did not see the fight start, she did observe the defendant swing at the victim.

During this time, Indian River County Fire Department (IRCFD) arrived on the scene and assessed the Defendant, who ultimately chose not to be transported to the hospital.

I then attempted to speak with the Defendant and read him his Miranda warnings. However, he was so intoxicated that he could barely form a complete sentence, except to acknowledge that he did not want to talk to me. Therefore, based on the totality of the circumstances, I placed the defendant under arrest and informed him accordingly.

The Defendant was transported to the Indian River County Jail without incident and was turned over to corrections personnel for processing and booking.

The incident described occurred within the City of Vero Beach, Indian River County, Florida.
