NARRATIVE

On 7/28/2025, at approximately 0753 hours, I was dispatched to 4055 41st Avenue (Indian River County Jail), In reference to a use of force incident.

Upon arrival I then made contact with Cpl., Osmay Acosta, who was in uniform, on duty, and acting in his Official capacity, and learned the following information:

Cpl. Acosta stated while assisting with medication distributions, Inmate Terry Smith was refusing to show proof that his medications were ingested as required by jail policy. Cpl. Acosta stated Smith walked away and returned only after several repeated commands to comply. Cpl. Acosta stated that based on Smith's non-compliance, he removed Terry from his housing area to handcuff him. Cpl. Acosta advised that while trying to restrain Terry, he began to physically resist efforts to be handcuffed. Cpl. Acosta stated he attempted to take Smith down to the ground by pulling Smith's head down at which point Smith shoved Acosta, causing Acosta to fall onto the ground away from Smith. Cpl. Acosta stated that with the assistance of Deputy Cuevas, they were able to restrain and secure Terry.

I then made contact with Deputy, Jacob Cuevas, who was also in uniform, on duty, and acting in his Official capacity, and learned the following information:

Deputy Cuevas stated while also assisting with medical distributions, he observed Deputy Acosta getting pushed to the ground. Deputy Cuevas advised he quickly responded to assist, and restrain Terry.

I then made contact with Inmate Smith, who denied all allegations of aggressiveness. Smith stated he complied with the Deputy's request and was grabbed out of his assigned house for no reason. Terry advised Cpl. Acosta tried to grab his head and fell down on his own.

I then made contact with Jail L.P.N, Brooke Besancon-Acosta, whose story was consistent with that of Cpl. Acosta's.

I then reviewed IRCSO Jail surveillance video from the area and observed video footage of the incident, which showed the following information:

After Cpl. Acosta removed Smith from the room, he began to escort Smith across the hallway, away from the Jail Nurse, towards an opposite corner wall. As Cpl. Acosta was escorting Smith, I could see on the video that he was attempting to gather Smith's hands behind his back as though he was going to handcuff Smith. As they neared the corner wall, Smith began to resist Acosta, refusing to keep his hands behind his back and turning his body to face Acosta while having his back against the wall. I observed that Acosta then grabbed Smith around his head/neck area, and began trying to pull Smith down towards the ground. I observed that Smith shoved both arms forward as Acosta was trying to pull him down, resulting in Acosta being pushed back onto the ground, sliding backwards from the force of the push. Smith remains in the corner, while Deputy Cuevas responds and deploys OC Spray in an effort to take Smith into custody. Deputy Cuevas is successful in taking Smith to the ground, where he is eventually handcuffed by both deputies.

Based on my investigation, I determined that Terry violated F.S.S (843.01) Resisting with violence.

Terry is already housed at the Indian River County Jail.



On Monday, July 28, 2025, at approximately 2212 hours, I, Deputy M. Neill #6317 responded to the Hammock Lakes neighborhood, located near the intersection of 1st Street SW and 58th Avenue SW, Vero Beach, Indian River County, Florida, in reference to a reckless driver.

The complainant called in to report that a Black Ford F150 had caused a disturbance at the neighborhood pool and appeared to be intoxicated. The subject, who they described as a heavy-set white male with multiple tattoos to be intoxicated, and now behind the wheel of the vehicle. The subject was driving around the neighborhood. At one point in time, an witness informed Mr. Woods he was driving without any lights on after dusk. Mr. Woods was slow to respond, eventually shrugging them off and continuing to drive around the neighborhood. The caller stated Mr. Woods pulled in to the driveway at 5235 E 1st Square SW, Vero Beach, Florida, which is located in the neighborhood.

I responded to the location and observed the vehicle the complainant was calling about. I observed a black 2013 Ford F150 bearing Florida tag IHEJ63 sitting in the driveway of the residence. Mr. Woods was observed slumped over in the driver's seat. The vehicle was on, the windows were down, and the music was blaring.

I approached the vehicle. As I made it to the window, I observed an open container in the driver's cup holder. Additionally, there were multiple empty containers in the passenger seat. The open containers were later identified as "Florida Man Double IPA" which contained a 9% ABV rating. There was a total of three empty Florida Man IPA's and one-half empty container, which is the one which was located in the cup holder. Additionally, I located two Fireball shooters.

I then made contact with Mr. Woods. Upon him awaking, he had very slow movements as well as watery eyes. I then asked him to step out of the vehicle. He turned the vehicle off and stepped out. Mr. Woods had trouble stepping out of the vehicle, and had to use the door and vehicle for assistance as he was unsteady on his feet. As he was outside of the vehicle, he had to continue to use the vehicle for balance. He had a large slur in his speech, and the odor of an alcoholic beverage emitting from his breath. While conversing with Mr. Woods, he made multiple statements which did not make sense and was sometimes incoherent.

I requested Mr. Woods submitted to Standardized Field Sobriety Exercises (SFSE's), Mr. Woods refused to complete the SFSE's. Mr. Woods was advised that his refusal to complete the SFSE's could be used against him in court if an arrest was made. He stated he understood and again refused to complete SFSE's.

Mr. Woods was then arrested for Driving Under the Influence. He was secured in handcuff restraints. He was then transported to the Indian River County Jail.

While at the jail, Corrections Deputies requested that Mr. Woods submit to a lawful test of his breath to determine its alcoholic content. Mr. Woods refused to take a breath test. Mr. Woods was advised of implied consent and again refused to take the breath test. It should be noted that during this time, Mr. Woods had a large sway in his stance, and lost his balance multiple times just from attempting to stand still. Additionally, he urinated on himself, without

On Monday, July 28, 2025 at approximately 2249 hours, I conducted a traffic enforcement stop on a white Nissan SUV bearing Florida tag "RFJR36."

While on the side of the road, I observed a Nissan exit the parking lot of an establishment known to serve alcoholic beverages. The vehicle was further observed traveling approximately 35 in a posted 50 mile per hour zone and failed to drive within a single lane. The vehicle traveled to the left of the lane and crossed the white lane divider before traveling to the shoulder and crossing the white solid lane line.

I initiated a traffic stop and the vehicle failed to immediately yield to my emergency lights and siren. The vehicle finally activated its emergency flashers and slowly came to a stop in the middle of the driveway to Port St. Lucie Battery and Tire.

I approached the driver's side window and made contact with the female driver and sole occupant of the vehicle, Ms. Deborah Cuevas (Arrestee), who I identified by the Florida driver's license she provided me. As I approached, Ms. Cuevas immediately placed hand sanitizer on her hands twice, which I believed was a tactic to mask an odor of alcohol inside the vehicle. I asked Ms. Cuevas to provide her License, Registration and Proof of insurance and she questioned if I was going to give her a ticket and challenged my authority to request her documents. After she provided her documents, I asked her to exit the vehicle and wait with Cpl. J. Lang (6136). Ms. Cuevas refused to exit the vehicle. I opened her door and ordered her out of the vehicle. She again refused and was advised of Supreme Court case Pennsylvania V. Mims by Cpl. Lang and she replied "but we aren't in Pennsylvania. I grabbed Ms. Cuevas' wristed and she had to be physically removed from the vehicle.

Once outside the vehicle, Ms. Cuevas continued to be "Stand-Offish" and was speaking to an unknown person on the phone. Ms. Cuevas was argumentative, continually talking over me and stood with her arms crossed. I explained to Ms. Cuevas that I needed her to hang up the phone and pay attention to my instructions, which she refused. I explained to Ms. Cuevas that I believed she was impaired and requested she submit to Standard Field Sobriety Exercises (SFSE's). Ms. Cuevas initially refused, I issued Ms. Cuevas a Taylor warning, and she hesitantly agreed to complete SFSE's, stating "What do you want me to do, walk a line?"

I maneuvered my vehicle into the parking lot ad walked Ms. Cuevas to the area. I instructed her to stand on the blue line painted in the handicap stall. Ms. Cuevas immediately walked down to the far end of the line, spun around and walked back towards me, so close I had to instruct her to step back.

I began to ask Ms. Cuevas about her medical conditions to rule out the possibility of any issues of

medical impairment. I asked Ms. Cuevas if she had any major medical issues, which she replied "yes," I followed up to clarify if they impacted her daily lifestyle or functions and she stated "no." I asked is she took and medications and she stated "yes" but refused to tell me what she takes, and blankly stared at me with her arms crossed.

I instructed Ms. Cuevas into the starting position to administer the Horizontal Gaze Nystagmus (HGN) exercise. Ms. Cuevas refused to maintain the starting positions after being instructed multiple times to stand with her feet together and arms down by her side. As I was providing the instructions, Ms. Cuevas scoffed and stood with her arms crossed across her chest. I asked Ms. Cuevas if she under stood the instructions and she challenged me by asking, "Is that a law?" After providing the instructions multiple times, it appeared Ms. Cuevas was impaired to the extent she was unable to satisfactorily perform the exercises requested and Ms. Cuevas was placed under arrest.

Ms. Cuevas was placed under arrest for Driving Under the Influence and Resisting Arrest without Violence. Upon arrival to the jail, Ms. Cuevas' demeanor completely changed. MS. Cuevas was talkative and engaged multiple corrections deputies in attempts of friendly banter.

Ms. Cuevas fully cooperated with IRCSO jail staff and provided two lawful samples of her breath: 0.000 g/210L and 0.000 g/210L. Based on the conversations and demeanor of Ms. Cuevas' interaction with jail staff, she was able to properly dispel my suspicion of Driving Under the Influence.

Ms. Cuevas was ultimately charged with resisting arrest without violence and booked into the IRCSO jail without further incident.
