





On April 8, 2025, at approximately 1754 hours, I arrived at 2310 42nd Street, near the dead end of the road, in reference to a suspicious vehicle. Call notes stated a female in a blue Ford vehicle had been sitting there for hours and was speaking to herself.

Just prior to my arrival, D/S A. Binner had located the vehicle and contacted the female in the front driver seat, later identified as Rosalina Mueller. As I approached the vehicle, D/S A. Binner gave a lawful order to exit the vehicle, which Rosalina complied with. D/S A. Binner advised there was a clear/white, crystal like substance in a see-through plastic container located inside the vehicle which was underneath the driver side air vent. I looked inside the vehicle and observed the same substance in plain view. Through my training and experience, I believed the substance was an illegal narcotic. It is to be noted, no one else was inside the vehicle and Rosalina was in constructive possession of the suspected illegal narcotics.

Rosalina was immediately detained and verbally advised her Miranda Rights, which she acknowledged and said she would like to speak about the incident. Post Miranda, Rosalina advised the following verbally:

Rosalina was asked if the substance located in the vehicle was an illegal narcotic and she said it was. Rosalina said the illegal narcotic was methamphetamine and she consumes it while listening to music to self-medicate because

The suspected narcotic was collected and tested by D/S A. Binner via field test kit, which confirmed it was methamphetamine. The total approximate weight of the methamphetamine was .42 grams.

Based on the information above, I found probable cause Rosalina was in violation of F.S.S 893.13; possession of a controlled substance. Rosalina was arrested and later transported to the Indian River County Jail.





NARRATIVE

On Tuesday, 4/8/2025, at approximately 1436 hours I responded to the 4100 block of Indian River Boulevard, in reference to a crash.

I made contact with one of the parties involved in the crash, later identified as David Lussier who handed me another females driver's license as well as the rental agreement for the vehicle. When asking about the crash the female began answering the question as if she was driving. At no point did David correct me and advise that he was driving. I asked David for his identification due to being in the vehicle during the crash. David provided me with a Veterans Affairs card. I continued my crash investigation and requested that the Indian River Real Time Crime Center (RTCC) review traffic camera footage for the crash. RTCC advised me that there was footage of the crash and that it was uploaded to evidence.com.

I filled out a driver's exchange form for the three vehicles involved. On the form I put the driver of the Nissan Sentra as the other female in the vehicle. I provided the driver's exchange forms to each of the parties involved. When I provided David the exchange form he still had not corrected that the female was not the driver and that he was. I was unable to review camera footage due to the cellular service in the area not being strong enough.

I then cleared the scene and went to another area in order to review footage and begin typing the crash report. Once I reviewed footage I observed that after the crash the driver of the Nissan Sentra was not the other female but actually David. I returned to the scene to see if David was still there. David and his wife were still at the location with a tow truck. I approached David and his wife. I asked them who was driving the vehicle to which both responded that it was the wife. I then asked David again if he was sure that his wife was driving the vehicle. David insisted multiple times that his wife was driving the vehicle. I informed David again as I did while originally on scene that the crash was captured on camera. David then advised that if it was on camera then he was the driver. David advised me that his Rhode Island drivers license was suspended. I ran David through dispatch by name and date of birth who verified that his Rhode Island drivers license was cancelled.

I then placed David under arrest for providing false information in a crash and driving on a suspended/cancelled license with knowledge. I transported David to the Indian River County Jail but he was refused entry due to medical clearance after the car crash.

I transported David to Indian River Cleveland Clinic (IRCC). While at IRCC I read David his Miranda warning to which he advised he understood. I asked David why he lied about who was driving the vehicle he advised that he did due to the fact that his license was suspended and that he did not want to mess up the insurance on the rental vehicle. David explained that the rental car was in his wife's name and that he was not on the agreement.

Once medically cleared I transported David back to the Indian River County Jail where he was booked.

David was issued to Uniform Traffic Citations for driving on a suspended license with knowledge and providing false information in a crash.

PROBABLE CAUSE STATEMENT

On 04/08/2025, at approximately 2009 hours, I, Ofc. Retiro responded to 1615 US1 (Shell Gasoline) in reference to a shoplifting. Prior to arrival, VBPD dispatch advised that the store clerk observed a male individual dressed in a black hoodie, grey jeans, with black and white sneakers take a Monster energy drink and a pack of blue Nerds candy and proceed to exit the store without paying. The store clerk advised they had last saw the individual proceed on foot northbound US1.

Upon arriving to the area, I spotted an individual matching the clothing description provided by VBPD dispatch, black hoodie with the hood on, grey jeans, and black/white sneakers walking westbound along 18th ST and US1 near Dunkin Donuts. Upon approaching the individual, after stepping out of my patrol vehicle, verbal commands were given to individual to stop where they were at. The individual visually observed my attempt at an investigative stop and continued to walk westbound on 18th ST. I proceeded to get back into my patrol vehicle, pulled ahead of the individual, emergency lights activated, and attempted another investigative stop. Upon stopping the vehicle, the individual proceeded to flee and headed in a southwest direction into the Tropical Sun Square (861 18th ST) parking lot.

I pursued the individual on foot southbound through the parking lot, where the individual jumped a chain-linked fence and proceeded southbound through the Howard Johnson (1725 US1) west parking lot towards Walgreens (1705 US1). Multiple verbal commands were given to the individual to stop running or face consequences. Upon reaching Walgreen's parking lot, both department issued tazer cartridges were deployed with negative effects. The individual proceeded to backtrack northbound towards Howard Johnson and attempted to jump another wall. It was at this wall where the individual was apprehended and placed into custody.

The individual was later identified as Jonathan E. Jones. Both deployed tazer cartridges had negative effects due to inability to penetrate Jonathan's clothing. IRCFD EMS was called upon for removal of the probes and to medically evaluate Jonathan. Jonathan advised he was fine and did not sustain any injuries as a result of the pursuit and did not require further medical attention.

After advising Miranda, Jonathan agreed to answer questions and stated he had been dropped off at Shell after spending time with his friends. Jonathan admitted to having taken a Monster energy drink and proceeded to walk off without paying. When asked about the Nerd candy he advised he had not taken any candy. Total value of the property is listed as \$6.71.

Upon further investigation, the business advised they would like to press charges for the incident. A surveillance system was in place for the incident. The clerk advised she was unable to obtain the footage due to the manager being out for the day. She advised the manager would be able to obtain the footage the following day. A show up form was completed and a show up was conducted in which the store clerk confirmed the clothing in which Jonathan was wearing matched the suspect description she had provided. It was noted that the clerk also advised she did not get a clear view of the suspects face during the incident.

In speaking with Jonathan, he had advised the Monster energy drink he had taken was located by the air conditioning units near the fence line that Jonathan had jumped crossing over from Tropical Sun Square into Howard Johnson. The Monster energy drink can was located in the area Jonathan had advised and pictures were taken which were later uploaded to Evidence Library.

Jonathan was subsequently charged with Resisting without Violence FSS 843.02 and Petit Theft FSS 812.015. Jonathan was transported to the Indian River County Jail for booking.

This event was captured on department-issued BWC and later uploaded to Evidence Library.
