

NARRATIVE

On Wednesday, May 27, 2026 at approximately 1808 hours, I responded to the area near mile marker 142 on South Interstate 95 in Vero Beach, Florida.

Upon my arrival, I was briefed by Deputy A. Fettig (6331) who stated Deputy M. Szott (5919) discovered the vehicle on the side of the road and upon initial contact, Mr. Daniel Fuentes (Arrestee) was seated in the driver's seat. Deputy Fettig indicated that Mr. Fuentes was impaired and stated he was advised of his rights in accordance with Miranda v. Arizona.

I made contact with Mr. Fuentes, who was leaning on the outside of his truck. Mr. Fuentes was extremely sunburned and covered in sand. His clothes and appearance were disheveled. His eyes were watery, his speech was slurred and I could smell the distinct odor of an alcoholic beverage emitting from his breath as he spoke with me.

Daniel stated he left work, went to the beach where he fell asleep and "got some good sun." Then he stated his truck stalled out, he stated, "I don't understand it. I don't know how to start it up"

Daniel stated he was coming from Daytona Beach and travelling home to Orlando. When I asked Daniel if he knew where he was, he stated "I am on the side of I-4." When I asked if he knew what city or county he was in, he stated "Not exactly" then stated "Volusia." Daniel then stated he had "not a lot" of alcohol, and then clarified stating "I had two (2) beers earlier." Daniel stated he consumed those beers at 1300. When I asked Daniel what time it was currently, he stated "three o'clock, four o'clock?" The actual time was 1821 hours.

I explained my concern to Daniel for his ability to operate a motor vehicle and requested he complete Standard Field Sobriety Exercises (SFSE's) to which he agreed. Daniel agreed to be transported to an alternate site for safety reasons, however the decision was made by Deputy Fettig to take Daniel into custody for Leaving the scene of a crash with damage to property of another person.

The following was provided by Deputy Fettig in support of his probable cause arrest for Leaving the scene of a crash with property damage:

On May 27, 2026 at approximately 1734 Hours Indian River County Communications Center received reports of a hit and run crash that occurred near the 9800 Block of HWY 60 in Vero Beach.

The complainant was identified as Zachary Polke. Polke stated he was traveling south on I95 when he took the HWY 60 exit. Polke stated he was stopped on the off ramp waiting for the signal light to change, when a small white truck rear ended him. Polke stated both vehicles then continued through the intersection when the light turned green, however when Polke pulled off the side of the road, the driver of

the white truck continued to drive west on HWY 60. Polke attempted to follow the truck, and took pictures of the license plate which showed "FL Dk97AX" Polke stated the truck then made a U-Turn and drove back east on HWY 60, before turning down the I95 South Ramp and merging back onto the interstate. Polke pulled his vehicle over and waited for responding deputies. Myself and Cpl. Szott arrived on scene with Polke, who provided us with a description of the suspect vehicle, to include a picture of the license plate. I remained on scene with Polke as Cpl. Szott checked the surrounding area for the suspect vehicle. Cpl. Szott located the white truck which was pulled onto the shoulder of I95 South near mile marker 145. Cpl. Szott identified the driver as Daniel Fuentes, who was seated in the driver seat.

When I arrived on scene with Cpl. Szott, I began to speak with Fuentes. I advised Fuentes of his Miranda Rights, which he stated he understood and agreed to speak with. I questioned Fuentes about the crash that Polke reported. Fuentes confirmed it was his vehicle that was involved, and also confirmed he was the one driving. I asked Fuentes if he pulled over to exchange any information with the other driver involved, and he stated "No". I then asked Fuentes if he made any attempt to report the accident to law enforcement, to which he again stated "No".

Deputy Hackett then arrived on scene and Fuentes was placed under arrest. Deputy Hackett transported Fuentes to the Indian River County Jail to continue his DUI investigation.

Daniel was placed in handcuffs and transported to the Indian River County Jail Complex (IRCJC).

Upon arrival to the IRCJC, Daniel was given the opportunity to complete SFSE's.

The first exercise I administered was the Horizontal Gaze Nystagmus (HGN) exercise. I explained the exercise to Daniel who acknowledged he understood the exercise. I observed the following validated clues of impairment: Daniel's pupils were of approximate equal size and tracked simultaneously. Daniel had Lack of Smooth Pursuit, Distinct and Sustained Nystagmus at Maximum Deviation and onset of nystagmus at 35 degrees. I observed Vertical Gaze Nystagmus (VGN). Daniel had an orbital sway while completing this exercise and had difficulty tracking my stimulus.

The second exercise I administered was the Walk and Turn (WAT) exercise. I explained and demonstrated the exercise to Daniel who stated he understood the instructions and did not have any questions. During the Instructional phase, I observed no clues of impairment. During the walking phase, I observed the following clues of impairment: Raised Arms, Missed Heel to Toe, Stepped Offline, Improper Turn to the right, and stopped walking to steady. Daniel DID NOT complete this exercise to standard.

The third exercise I administered was the One Leg Stand (OLS) exercise. I explained and demonstrated the exercise to Daniel who stated he understood the instructions and did not have any questions. Daniel

began the exercise by raising his Right foot off the ground. I observed the following clues of impairment during this exercise: Sway and used arms for balance. Daniel DID NOT complete this exercise to standard.

The fourth exercise I administered was the Modified Romberg Balance exercise. I explained and demonstrated the exercise to Daniel who stated he understood the instructions and did not have any questions. Daniel counted to "30" seconds in the real time of 44 seconds. I observed the following clues of impairment: Daniel swayed while completing this exercise.

The fifth exercise I administered was the Finger to Nose (FTN) exercise. I explained and demonstrated the exercise to Daniel who stated he understood the instructions and did not have any questions. Daniel made the following movements:

- L1: Did Not Return
- R2: Tip of finger to tip of nose
- L3: Tip of finger to tip of nose
- R4: Tip of finger to tip of nose
- R5: Tip of finger to tip of nose
- L6: Tip of finger to tip of nose

Daniel was requested to provide a sample of his breath to determine its alcoholic content. Daniel provided the following two (2) lawful samples of his breath: 0.178g/210/L and 0.184 g/210L.

A query of D.A.V.I.D. revealed Daniel has a prior DUI conviction from Virginia in which Daniel was adjudicated guilty on October 12, 2017.

Based on the above indicators of impairment and observations, Daniel was ultimately charged with Failure to Give Information at Scene of Crash (ANHBACE), Driving Under the Influence with a BrAC above 0.15 (ANHCB3E), Driving Under the Influence Causing Property Damage (ANHBAAE).

In addition, Daniel was issued the following citation: Failure to notify Law Enforcement of Crash involving Property damage of at least \$500 (ANHBABE)

NARRATIVE

On Thursday, May 28th, 2026, at approximately 1141 hours, I observed a gray 2016 Nissan Altima (FL-6230TI) traveling northbound on 34th Court in the 4400 block. As it came to a stop at the intersection of 45th Street, the Altima came to an improper stop in the crosswalk and not prior to the stop line at the stop sign.

I conducted a traffic stop in the 4500 block of 34th Avenue and spoke to the driver, named Tyrell Gavin. Quickly when initially speaking to Tyrell, he told me he did not have a valid license and that it was recently suspended.

I ran Tyrell on IRCSSO Public Safety Dispatch and on DAVID (Driver and Vehicle Information Database), where it was confirmed Tyrell's license had a status of 'revoked' on 02/20/2019.

Tyrell was placed into handcuffs and transported to the Indian River County Jail and charged with violation of FSS 322.34(2)(A) Driving While License Revoked with Knowledge.





NARRATIVE

On May 28th, 2026, at approximately 1915 hours, I responded to the Green Marlin (1475 US Highway 1, Vero Beach, Florida, 32960), in reference to a disturbance.

Public Safety Dispatch was advised by Ms. Ronda Polca there was a male and female in a disturbance at the business, and the female slapped the male.

Upon arrival, Ronda pointed out Mr. Ryan Skipton across the parking lot as the male involved in the disturbance. I met with Ryan and he stated the following: Ryan is separated from his wife, Michelle Skipton. He was out at the Green Marlin with his new girlfriend, Ms. Emily McDaniel, when Michelle approached the two seated at the Green Marlin bar. Michelle began yelling and screaming at Ryan and Emily while accusing Ryan of cheating on her. Ryan and Michelle went around the side of the building and continued to argue, when Michelle slapped Ryan. Ryan stated Michelle slapped him once with an open hand and he was not injured.

Ryan confirmed he is currently married to Michelle [REDACTED] with three children in common. Ryan and Michelle's children were in Michelle's vehicle parked away from this incident when it occurred, and they did not witness it. I did not observe any injuries to Ryan.

I met with Emily who stated the following: She corroborated Ryan's version of events as far as the initial disturbance at the bar. She was not a witness to Ryan being slapped by Michelle when they walked around to the side of the restaurant.

I met with Ronda, the Green Marlin manager, who stated the following: She witnessed Michelle in a disturbance with Ryan and Emily at the Green Marlin bar. Ryan and Michelle went around to the side of the building and continued arguing with each other. She witnessed Michelle slap Ryan in the face. Michelle tried to walk back over to Emily who was still seated at the bar, but Ronda prevented Michelle from approaching Emily [REDACTED] and observed Michelle get into a white GMC SUV and leave the scene. Ronda directed me to video surveillance footage of the incident.

Upon review of the video surveillance footage, I observed Ryan and Michelle arguing with each other on the west side of the Green Marlin building. Michelle appears very animated as she is arguing with Ryan. Michelle suddenly open-hand slaps Ryan on the right side of his face with her left hand. Michelle walks away from Ryan out of view of camera footage shortly thereafter. Ryan takes no aggressive posturing towards Michelle or touches her in anyway prior to, or after, being slapped.

Deputies met with Michelle at her residence (4131 56th Lane, Vero Beach, Florida, 32967) and detained her until I could arrive and complete my investigation.

I met with Michelle and she stated the following in a post-Miranda interview: After I explained the circumstances


Upon arrival, I met with [redacted] outside [redacted] is the complainant and victim. [redacted] swore verbally to the following statement in summary:

This evening, [redacted] and Marissa were talking in the kitchen area that adjoins the living room. Only the two of them were at the home [redacted] remembers preparing a grilled-cheese sandwich at the time. An argument ensued and Marissa became aggressive; she began to break down mentally. As both were standing and facing each other, Marissa lunged forward and used both hands to push on [redacted] front torso. This forced [redacted] to fall backwards onto the tile floor. [redacted] landed on [redacted] back, and the back-center section of [redacted] head also struck the tile floor. Marissa did not assist [redacted] or help [redacted] to [redacted] feet. Instead, Marissa merely retreated to the living room where her outburst continued. [redacted] climbed to [redacted] feet. [redacted] did not strike, push, or touch Marissa in any way. [redacted] grew fearful for [redacted] so [redacted] phoned police. I photographed [redacted] face/head/hands. I could not visually detect the any wound, but I was able to feel a large scalp hematoma (goosebump) on the back of [redacted] head. I offered to summon paramedics, but [redacted] declined and insisted that [redacted] was fine. [redacted]

stated that [REDACTED] does not want to press charges or see Marissa arrested.

I then interviewed Marissa, who was seated on the living room couch. Upon entering the living room, deputies could hear her frantically speaking on the phone with her doctor. Marissa was overheard stating that she pushed [REDACTED]. I had her conclude her phone call, but she was reluctant to be interviewed. I asked her directly what had occurred between she and [REDACTED] before our arrival. Marissa acknowledged having a discussion in the kitchen with [REDACTED]. She denied having an argument or touching [REDACTED] in any way. Marissa acknowledged that [REDACTED] had prepared a grilled-cheese sandwich and had several items in [REDACTED] hands. Suddenly [REDACTED] just fell backwards onto the tile floor. Marissa stated that she did not assist [REDACTED] or help [REDACTED] to [REDACTED] feet. The interview was very fragmented. Marissa was extremely evasive and changed the subject constantly. It was difficult for her to focus on my direct line of questioning. Marissa complained of a broken right big-toe (hallux); however, she said that this sustained earlier in the day and not related to the incident with [REDACTED]. I photographed Marissa's face/hands/toe. She declined medical attention.

Based on my investigation, it was determined that a domestic battery had occurred and Marissa Blair Burge was the primary aggressor. There was probable cause that Marissa Blair Burge did maliciously and unlawfully push [REDACTED] to the floor, causing a minor injury to the back of [REDACTED] head. I placed Marissa under arrest for:
